Determination of Offer Price and Allocation of Hong Kong Public Offering Shares

The Offer Price is expected to be fixed on or about Monday, 30 September 2019. Applicants are required to pay the maximum Offer Price of HK\$3.00 for each Hong Kong Public Offering Share together with 1% brokerage, 0.0027% SFC transaction levy and 0.005% Stock Exchange trading fee. If the Offer Price is not agreed between the Company and Joint Global Coordinators (acting for themselves and on behalf of the Underwriters) on or before Monday, 30 September 2019, the Global Offering will not proceed.

Applications for Hong Kong Public Offering Shares will not be processed and no allotment of any Hong Kong Public Offering Shares will be made until the application lists close.

The Company expects to announce the final Offer Price, the indication of the level of interest in the International Placing, the level of applications under the Hong Kong Public Offering and the basis of allocation of the Hong Kong Public Offering Shares on Thursday, 10 October 2019 on the website of the Hong Kong Stock Exchange at www.hkexnews.hk and the Company's website at www.xypm.hk. Results of allocations in Hong Kong Public Offering, and the Hong Kong Identity Card/passport/Hong Kong business registration numbers (where applicable) of successful applicants will be available on the above websites.

The allocation of Offer Shares between the Hong Kong Public Offering and the International Placing is subject to adjustment as detailed in the subsection headed "Structure and Conditions of the Global Offering – The Hong Kong Public Offering – Reallocation" in the Prospectus.
