AVIC International Holding Corporation, AVIC International Shenzhen Company Limited and Beijing

Raise Science Company Limited, pursuant to which, the Company agreed to acquire certain equity interests

in 12 companies at an aggregate consideration of RMB4,159,057,193 (the "Acquisition"). Upon completion

of the Acquisition and pursuant to terms and conditions of the Agreements, the Company allotted and issued

437,264,906 consideration shares and issued perpetual subordinated convertible securities ("PSCS") in the

aggregate amount of RMB2,781,672,739 convertible into 801,634,795 conversion shares on 5 September

2012. For details of the Acquisition, please refer to the circular dated 31 December 2010 and the

announcement dated 5 September 2012 of the Company. On 26 October 2017, Beijing Raise Science

Company Limited and AVIC International Holding Corporation entered into the PSCS transfer

agreement, pursuant to which all of the PSCS issued by the Company held by Beijing Raise

Science Company Limited were assigned to AVIC International Holding Corporation. As at the date

of this monthly return, 801,634,795 outstanding conversion shares may be issued subject to the minimum

public float requirement under the Rules Governing the Listing of Securities on the Stock Exchange of Hong

Kong Limited.
