ANNOUNCEMENT

POWER GENERATION FOR NOVEMBER 2019

This announcement is made pursuant to Rule 13.09 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited and the Inside Information Provisions under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

The board of directors (the “**Board**”) of Huadian Fuxin Energy Corporation Limited (the “**Company**”) announces that, according to the preliminary statistics of the Company, the gross power generation of the Company for November 2019 amounted to 3,506,322.5 MWh, representing a decrease of 5.1% over the corresponding period of 2018, of which, the wind power generation was 1,576,161.2 MWh, representing an increase of 12.6% over the corresponding period of 2018; the solar power generation was 124,192.4 MWh, representing an increase of 8.9% over the corresponding period of 2018; the hydropower generation was 235,911.9 MWh, representing a decrease of 61.0% over the corresponding period of 2018; the coal-fired power generation was 1,287,613.6 MWh, representing a decrease of 2.6% over the corresponding period of 2018; the natural gas-fired (distributed) power generation was 269,691.8 MWh, representing an increase of 12.5% over the corresponding period of 2018; and the power generation of other clean energy was 12,751.6 MWh, representing a decrease of 20.2% over the corresponding period of 2018.
