IF YOU WISH TO ABSTAIN FROM VOTING ON ANY RESOLUTION, PLEASE TICK A ("/") IN THE BOX MARKED "ABSTAIN". If you have more than one voting intention on certain resolution, the sum of the votes cast shall be equal to the number of H shares registered in your name(s) to which this supplemental form of proxy relates. If the sum of the votes cast is less than the number of H shares registered in your name(s) to which this supplemental form of proxy relates, the difference shall be regarded as abstention votes. If the sum of the votes cast is more than the number of H shares registered in your name(s) to which this supplemental form of proxy relates, all the votes cast on such resolution shall be regarded as abstention votes. If no direction is given, your proxy will vote at his/her discretion. Your proxy will also be entitled to vote at his/her discretion on any resolution properly put to the EGM other than those referred to in the notice or the supplemental notice convening the EGM.
- 5. Resolutions No. 2 and No. 3 are special resolutions which shall be passed by more than two-thirds of the voting rights held by the shareholders of the Company present at the meeting.
- 6. This supplemental form of proxy must be signed by you or your attorney duly authorised in writing. In the case of a corporation, the same must be either under its common seal or under the hand of its director(s) or duly authorised attorney(s). If this supplemental form of proxy is signed by an attorney of an H shareholder of the Company, the power of attorney authorising that attorney to sign or other authorisation document must be notarised.
- 7. In order to be valid, this supplemental form of proxy together with the power of attorney or other authorisation document (if any) must be deposited at the H share registrar of the Company, Computershare Hong Kong Investor Services Limited, the address of which is set out in note 9 below, not later than 1:00 p.m. on Thursday, 26 December 2019 (or if the EGM is adjourned, not less than 24 hours before the time fixed for holding of the adjourned EGM).
- 8. This supplemental form of proxy is applicable to the supplemental resolutions as set out in the supplemental notice of the EGM dated 11 December 2019 and supplements the original form of proxy. This supplemental form of proxy will not affect the validity of the original form of proxy duly completed by you in respect of the resolutions set out in the notice of the EGM dated 12 November 2019. If you have validly appointed a proxy to attend the EGM but do not complete and deliver this supplemental form of proxy, your proxy will be entitled to vote at his/her discretion on the special resolutions set out in the supplemental notice of the EGM dated 11 December 2019.
