PROFIT WARNING

Reference is made to the profit warning announcement made by S&P International Holding Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) on 31 January 2020, pursuant to Rule 13.09(2)(a) of the Rules Governing the Listing of Securities on the Stock Exchange (the “**Listing Rules**”) and the Inside Information Provisions (as defined under the Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

The board of directors of the Company (the “**Directors**” and the “**Board**”, respectively) wishes to update and provide additional information to the shareholders (the “**Shareholders**”) and potential investors of the Company that based on the preliminary review of the Group’s unaudited consolidated management accounts for the financial year ended 31 December 2019 (“**FY2019**”) and the current available information, the Group is expected to record a loss after tax for FY2019 of not more than RM5.0 million, as compared to its profit after tax of RM6.3 million for the financial year ended 31 December 2018.

The Company is currently in the process of finalizing the consolidated annual results of the Group for FY2019. The information contained in this announcement is only based on a preliminary assessment by the Board of the unaudited management accounts of the Group for FY2019 and the information currently available to the Board, which have not been confirmed, audited nor reviewed by the Company’s auditor and is subject to finalization and necessary adjustments. The finalized audited consolidated annual results of the Group for FY2019 are expected to be announced by the end of March 2020.

Shareholders and potential investors of the Company are advised to exercise caution when dealing in the shares of the Company.
