On 18 March 2020 (after trading hours), the Placing Agent and the Company entered into the Placing Agreement pursuant to which the Company has conditionally agreed to place through the Placing Agent, on a best effort basis, up to 2,490,000,000 Placing Shares at the Placing Price of HK\$0.0140 per Placing Share to not less than six Placees who and whose beneficial owners shall be Independent Third Parties. The Placing Shares will be allotted and issued pursuant to the General Mandate granted to the Directors at the AGM held on 17 June 2019.

Assuming that there will be no change in the issued share capital of the Company between the date of this announcement and the completion of the Placing, the maximum number of Placing Shares under the Placing represent (i) approximately 19.95% of the existing issued share capital of the Company of 12,480,291.446 Shares as at the date of this announcement; and (ii) approximately 16.63% of the issued share capital of the Company as enlarged by the allotment and issue of the Placing Shares. The aggregate nominal value of the maximum number of Placing Shares under the Placing will be HK\$2,490,000.

The Placing Price of HK\$0.0140 per Placing shares represents a discount of approximately 19.54% to the benchmarked price of the Shares, which is the higher of (i) the closing price of HK\$0.0160 as quoted on the Stock Exchange on the date of the Placing Agreement; and (ii) the average closing price of HK\$0.0174 in the last five trading days prior to the date of the Placing Agreement.

Subject to completion of the Placing, it is expected that the maximum gross proceeds and net proceeds from the Placing will be approximately HK\$34.9 million and HK\$33.1 million respectively. On such basis, the net issue price will be approximately HK\$0.0133 per Placing Share.

Since completion of the Placing is subject to the fulfillment of the condition as set out in the Placing Agreement, the Placing may or may not proceed. Shareholders and potential investors are reminded to exercise caution when dealing in the Shares.

The principal terms of the Placing Agreement are set out below.

Pursuant to the terms of the Placing Agreement, the Company has conditionally agreed to place through the Placing Agent, on a best effort basis, up to 2,490,000,000 Placing Shares to independent Placees. The terms of the Placing Agreement were arrived at after arm’s length negotiations between the Company and the Placing Agent under normal commercial terms and with reference to the prevailing market conditions. The Directors are of the view that the terms of the Placing Agreement are fair and reasonable based on current market conditions.

To the best of the Directors’ knowledge, information and belief, having made all reasonable enquiries, the Placing Agent and its ultimate beneficial owner(s) are Independent Third Parties. The Placing Agent is a wholly-owned subsidiary of Central Wealth Group Holdings Limited (“**Central Wealth**”), a company incorporated in Bermuda with limited liabilities and the issued ordinary shares of Central Wealth (“**Central Wealth Shares**”) are listed on the Main Board of the Stock Exchange.

As disclosed in the announcements of the Company dated 25 April 2018, the Company and CWSI entered into the Master Services Agreement in relation to the provision of the Brokerage Services, the Margin Financing and the Corporate Finance Services by CWSI to the Group on an ongoing and non-exclusive basis.

Reference is also made to the announcement of the Company dated 19 September 2017 in relation to the entering into of the First Supplemental Loan Agreement between Globally Finance (a direct wholly-owned subsidiary of the Company) as lender and Central Wealth as borrower. Pursuant to the First Supplemental Loan Agreement, the Loan Facility amount under the Original Loan Agreement available was increased to up to HK\$150,000,000. As disclosed in the announcement of the Company dated 25 April 2018, Globally Finance and Central Wealth entered into the Second Supplemental Loan Agreement to further increase the Loan Facility amount under the Original Loan Agreement to up to HK\$270,000,000. Please refer to the announcements dated 25 April 2018 and circular dated 16 July 2018 for further details.

Save for that (i) the Group (through its subsidiaries) is interested in 946,721,316 Central Wealth Shares, representing approximately 5.93% of the issued share capital of Central Wealth immediately prior to the entering into of the Placing Agreement; (ii) Central Wealth and its subsidiaries are interested in 373,053,636 Shares, representing approximately 2.99% of the issued share capital of the Company immediately prior to the entering into of the Placing Agreement; (iii) Mr. Yu Qingrui, an executive Director both of the Company and of Central Wealth, is holding 53,404,425 Shares and 5,610 Central Wealth Shares.

Mr. Yu Qingrui, being common director of Central Wealth and the Company, has abstained from voting on the relevant board resolutions relating to the Placing Agreement and the transactions contemplated thereunder.

The Placing Agent will charge the Company a placing commission equivalent to 5% of the Placing Price in respect of such number of Placing Shares successfully placed by the Placing Agent plus any other out-of-pocket charges and expenses by the Placing Agent in relation to the Placing.

Placees

The Placing Agent will, on a best effort basis, place the Placing Shares to not less than six Placees, who and whose ultimate beneficial owner(s) (if applicable) shall be Independent Third Parties.

Number of Placing Shares

Assuming that there will be no change in the issued share capital of the Company between the date of this announcement and the completion of the Placing, the maximum number of Placing Shares under the Placing represent (i) approximately 19.95% of the existing issued share capital of the Company of 12,480,291.446 Shares as at the date of this announcement; and (ii) approximately 16.63% of the issued share capital of the Company as enlarged by the allotment and issue of the Placing Shares. The aggregate nominal value of the maximum number of Placing Shares under the Placing will be HK\$2,490,000.

Ranking of Placing Shares

The Placing Shares under the Placing will rank, upon allotment and issue, *pari passu* in all respects with the Shares in issue on the date of allotment and issue of the Placing Shares.

Placing Price

The Placing Price of HK\$0.0140 per Placing shares represents a discount of approximately 19.54% to the benchmarked price of the Shares, which is the higher of (i) the closing price of HK\$0.0160 as quoted on the Stock Exchange on the date of the Placing Agreement; and (ii) the average closing price of HK\$0.0174 in the last five trading days prior to the date of the Placing Agreement.

The Placing Price of the Placing was determined with reference to the prevailing market prices of the Shares and was negotiated on an arm's length basis between the Company and the Placing Agent. The Directors consider that the terms of the Placing are on normal commercial terms and are fair and reasonable based on the current market conditions. Hence, the Placing is in the interests of the Company and the Shareholders as a whole.

Subject to completion of the Placing, it is expected that the maximum gross proceeds and net proceeds (after deducting placing commission and other relevant costs and expenses) from the Placing will be approximately HK\$34.9 million and HK\$33.1 million respectively. On such basis, the net issue price will be approximately HK\$0.0133 per Placing Share.

General Mandate to allot and issue of the Placing Shares

The Placing Shares will be issued under the General Mandate to allot, issue and deal with Shares granted to the Directors by resolution of the Shareholders passed at the AGM subject to the limit up to 20% of the then number of Shares in issue of the Company as at the date of the AGM. Accordingly, the issue of the Placing Shares is not subject to the approval of the Shareholders.

Under the General Mandate, the Company is authorized to issue up to 2,496,058,289 Shares. Up to the date of this announcement, the General Mandate has not been utilized. The maximum 2,490,000,000 Placing Shares to be allotted and issued will utilize approximately 99.76% of the General Mandate.

Application for listing of Placing Shares

Application will be made by the Company to the Stock Exchange for the grant of the listing of, and permission to deal in, the Placing Shares.

Condition of the Placing Agreement

Completion of the Placing is conditional upon the Stock Exchange granting the listing of, and permission to deal in, the Placing Shares to be placed pursuant to the Placing Agreement on or before 8 April 2020 (“**Long Stop Date**”).

If the above condition is not satisfied on or before the Long Stop Date, the obligations of the Placing Agent and of the Company under the Placing Agreement shall cease and determine and neither the Placing Agent nor the Company shall have any claim against the other in relation to the Placing Agreement (save in respect of (i) any antecedent breaches of any obligation thereunder; and (ii) any liabilities in respect of the representations and warranties made by the Company, undertakings by the Placing Agent, indemnity and reimbursements).

Completion of the Placing

Completion of the Placing shall take place on the third Business Day after the fulfillment of the above condition or on such other date as the Company and the Placing Agent may agree in writing.

Force majeure

The Placing Agent reserves its right to terminate the Placing Agreement by notice in writing to the Company at any time up to 8:00 a.m. on the date of completion of the Placing if, in the reasonable opinion of the Placing Agent, after consultation with the Company:

- (1) there is any change in national, international, financial, exchange control, political, economic conditions in Hong Kong which in the reasonable opinion of the Placing Agent would be materially adverse in the consummation of the Placing; or
- (2) there is any breach of the warranties, representations and undertakings given by the Company in the Placing Agreement and such breach is considered by the Placing Agent on reasonable grounds to be material in the context of the Placing; or
- (3) there is any material change (whether or not forming part of a series of changes) in market conditions which in the reasonable opinion of the Placing Agent would materially and prejudicially affect the Placing or makes it inadvisable or inexpedient for the Placing to proceed; or
- (4) any statement contained in this announcement and the previously published announcements by the Company has become or been discovered to be untrue, incorrect or misleading in any material respect which in the opinion of the Placing Agent would be materially adverse in the consummation of the Placing; or
- (5) there is any suspension of dealings in the Shares on the Stock Exchange for more than five consecutive Business Days (other than as a result of or in connection with the Placing); or
- (6) any event of force majeure (being an event beyond the control of the parties and which is unforeseeable or unavoidable), including but without limiting the generality hereof, any act of God, war, riot, public disorder, civil commotion, fire, flood, explosion, epidemic, terrorism, strike or lock-out, occurs which prevents the performance of the contractual obligations of the parties under the Placing Agreement.

Upon termination of the Placing Agreement as described above, all liabilities of the parties to the Placing Agreement shall cease and determine and no party thereto shall have any claim against the other party in respect of any matter or thing arising out of or in connection with the Placing Agreement save in respect of (i) any antecedent breach of any obligation under the Placing Agreement; and (ii) any liabilities in respect of the representations and warranties made by the Company, undertakings by the Placing Agent, indemnity and reimbursements.

The Directors are not aware of the occurrence of any of such events as at the date of this announcement.

Since completion of the Placing is subject to the fulfillment of the condition as set out in the Placing Agreement, the Placing may or may not proceed. Shareholders and potential investors are reminded to exercise caution when dealing in the Shares.

REASONS FOR THE PLACING AND USE OF PROCEEDS

The principal activity of the Company is investment holding. The subsidiaries of the Company are principally engaged in (i) investment property; (ii) provision of financing services; (iii) securities trading and investment; (iv) trading business and related services and (v) e-commerce business.

It is expected that the maximum gross proceeds and net proceeds from the Placing will be approximately HK\$34.9 million and HK\$33.1 million respectively.

The net proceeds from the Placing are intended to be used for as to approximately HK\$5million for development of its existing trading business, as to approximately HK\$10 million for money lending business development of the Group, as to approximately HK\$5 million for repayment of loan interest and as to the remaining balance for general working capital.

The Directors are of the view that the Placing can strengthen the financial position of the Group and provide funding to the Group to meet any future development opportunities and obligations. The Placing also represents good opportunities to broaden the Shareholders' base and the capital base of the Company.

The Board has considered other alternative fund raising methods such as debt financing, rights issue or open offer. The Board considered that debt financing may incur interest burden on the Group and may be subject to lengthy due diligence and negotiations with the banks with reference to the Group's financial position and the then financial market condition and it may be relatively uncertain and time-consuming. On the other hand, rights issue or open offer will involve the issue of prospectus with other application and administrative procedures (such as arrangements for nil-paid rights shares) which may lead to relatively longer time and additional administrative cost to complete as compared to the equity financing through issue of new Shares under General Mandate.

The Directors (including the independent non-executive Directors) consider that the terms and conditions of the Placing Agreement are fair and reasonable and are on normal commercial terms and the Placing is in the interest of the Company and the Shareholders as a whole.
