Notes:

- 1. Please insert the total number of Shares held by you. If you have Shares entered against your name in the Depository Register, you should insert that number of Shares. If you have Shares entered against your name in the Depository Register and Shares registered in your name in the Register of Members, you should insert the aggregate number of Shares entered against your name in the Depository Register and registered in your name in the Register of Members. If no number of Shares is inserted, this Proxy Form will be deemed to relate to all the Shares held by you.
- 2. A member entitled to attend and vote at the AGM is entitled to appoint one (1) proxy or two (2) proxies to attend and vote on his behalf. Such proxy need not be a member of the Company.
- 3. Where a member appoints two (2) proxies, the Company may treat the appointment as invalid unless the member specifies the proportion of his shareholding (expressed as a percentage of the whole) to be represented by each proxy.
- 4. This Proxy Form appointing a proxy or proxies must be under the hand of the appointor or his attorney duly authorised in writing. Where the Proxy Form is executed by a corporation, it must be executed either under its common seal or under the hand of any officer or attorney duly authorised.
- 5. Where a Proxy Form is signed on behalf of the appointor or by an attorney, the power of attorney (or other authority) or a duly certified true copy thereof must (failing previous registration with the Company) be lodged with the Proxy Form, failing which the Proxy Form may be treated as invalid
- 6. A corporation which is a member of the Company may authorise by resolution of its directors or other governing body, such person as it thinks fit to act as its representative at the AGM in accordance with Section 179 of the Act. The representative attending the AGM must produce evidence of his authority.
- 7. Whether or not you intend to attend the meeting, you are requested to complete the accompanying Proxy Form in accordance with the instructions printed thereon and return it to the registered office of the Company at 80 Raffles Place #33-00 UOB Plaza 1 Singapore 048624 (for Singapore Shareholders) or the office of the Company's Hong Kong branch share registrar, Tricor Investor Services Limited, at Level 54, Hopewell Centre, 183 Queen's Road East, Hong Kong (for Hong Kong Shareholders) as soon as possible but in any event not less than 48 hours before the time appointed for the holding of the meeting or any adjournment thereof in order for the proxy or proxies to be entitled to attend and vote at the AGM. Completion and return of the Proxy Form will not preclude you from attending and voting in person at the meeting if you so wish and, in such event, the Proxy Form shall be deemed to be revoked.
- 8. The Company shall be entitled to reject this Proxy Form if it is incomplete, improperly completed, illegible or where the true intentions of the appointor are not ascertainable from the instructions of the appointor specified in the Proxy Form. In addition, in the case of members of the Company whose Shares are entered against their names in the Depository Register, the Company may reject any Proxy Form deposited if such members are not shown to have Shares entered against their names in the Depository Register 72 hours (for Singapore Shareholders) or 96 hours (for Hong Kong Shareholders) before the time appointed for holding the AGM as certified by The Central Depository (Pte) Limited to the Company.
- 9. The submission of a Proxy Form by a member of the Company does not preclude him from attending and voting in person at the AGM if he so wishes, and in such event, the Proxy Form shall be deemed to be revoked.
- 10. Terms and expressions not defined herein shall have the same meanings ascribed to them in the Circular to the Shareholders dated 26 March 2020.
