NOTICE OF 2019 ANNUAL GENERAL MEETING

NOTICE IS HEREBY GIVEN that the 2019 annual general meeting (the “**AGM**”) of Bank of Tianjin Co., Ltd. (天津银行股份有限公司) (the “**Bank**”) will be held at Geneva Hotel (No.32 Youyi Road, Hexi District, Tianjin, the PRC), at 9:30 a.m. on Tuesday, May 12, 2020.

In order to implement the decisions and arrangements of the Central Committee of the Communist Party of China and the State Council, the Bank will make every effort to prevent and control the pandemic of COVID-19 and safeguard the health and safety of Shareholders and the attendees. The board of directors of the Bank (the “**Board**”) recommends that the Shareholders vote on the relevant resolutions by appointing the chairman of the AGM to attend the AGM (rather than in person).

Based on the current needs of prevention and control of COVID-19 pandemic, the Bank will also adopt a series of disease prevention measures at the AGM venue. The Bank reminds Shareholders and the attendees participating in the on-site meeting to perform personal protective precautions, and actively complies with disease prevention and control requirements by detecting body temperature and wearing surgical masks.

The following resolutions will be considered and, if thought fit, approved by the Shareholders of the Bank at the AGM:

ORDINARY RESOLUTIONS

1. to consider and approve the Work Report of the Board of Directors for 2019;
2. to consider and approve the Work Report of the Board of Supervisors for 2019;
3. to consider and approve the Report for Final Financial Accounts for 2019;

4. to consider and approve the Profit Distribution Plan for 2019;
5. to consider and approve the Report for Financial Budget for 2020;
6. to consider and approve the appointment of external auditor to review and audit the financial statements for 2020;
7. to consider and approve the appointment of Ms. Dong Guangpei as a non-executive Director of the sixth session of the Board;
8. to consider and approve the appointment of Mr. Wang Shunlong as a non-executive Director of the sixth session of the Board;

TO RECEIVE THE RELEVANT REPORTS

9. to listen to the Appraisal Report on the Performance of Duties by the Board, the Directors, Supervisors and Senior Management of the Bank for 2019;
10. to listen to the Work Report of independent non-executive Directors for 2019; and
11. to listen to the Report of related party transactions and management of related party transactions for 2019.

2. **Registration procedures for attending the AGM**

Individual Shareholders who wish to attend the meeting in person shall produce their identity cards or other effective document or proof of identity and stock account cards. Proxies of individual Shareholders shall produce their effective proof of identity and proxy form. A corporate Shareholder should attend the meeting by its legal representative or proxy appointed by the legal representative. A legal representative who wishes to attend the meeting should produce his/her identity card or other valid documents evidencing his/her capacity as a legal representative. If appointed to attend the meeting, the proxy should produce his/her identity card and an authorisation instrument duly signed by the legal representative of the corporate Shareholder.

3. **Reply Slip**

Holders of H Shares who intend to attend the AGM in person or by proxy should return the reply slip in person, by post or by facsimile to the H Share Registrar, Computershare Hong Kong Investor Services Limited, on or before Wednesday, April 22, 2020.

4. **Proxy**

Any Shareholder entitled to attend and vote at the 2019 AGM is entitled to appoint one or more persons (whether such person is a shareholder or not) as his/her proxy or proxies to attend and vote on his/her behalf.

The instrument appointing a proxy must be in writing under the hand of the Shareholder or his/her attorney duly authorised in writing. For a corporate Shareholder, the proxy instrument must be affixed with the common seal or signed by its director or attorney duly authorised in writing.

The proxy form (together with a notarially certified copy of the power of attorney or other authority (if any) if this proxy form is signed by a person on behalf of the appointor) must be delivered by the holder of H shares to the H Share Registrar, Computershare Hong Kong Investor Services Limited, at 17M Floor, Hopewell Centre, 183 Queen's Road East, Wan Chai, Hong Kong not later than 9:30 am on Monday, May 11, 2020 (Hong Kong time). If no direction is given, the proxy will be entitled to vote or abstain as he/she thinks fit. The proxy will also be entitled to vote at his/her discretion on any resolution properly put forward at the 2019 AGM other than those referred to in the notice convening the 2019 AGM.

Where there are joint holders of any Shares, any one of such persons may vote at the 2019 AGM, either personally or by proxy, in respect of such shares as if he/she were solely entitled thereto. However, if more than one of such joint holders is present at the 2019 AGM, either personally or by proxy, then one of the said persons so present whose name stands first in the register of members in respect of such shares shall alone be entitled to vote in respect thereof.

Completion and return of a proxy form will not preclude a Shareholder from attending in person and voting at the AGM or at any adjournment thereof if he so wishes, but in such event the instrument appointing a proxy shall be deemed to be revoked.

5. Closure of register of members

In order to determine the list of Shareholders who are entitled to attend and vote at the 2019 AGM to be held on Tuesday, May 12, 2020, the register of members of the Bank will be closed from Sunday, April 12, 2020 to Tuesday, May 12, 2020 (both days inclusive). The holders of H shares of the Bank who intend to attend and vote at the 2019 AGM must lodge all the transfer documents accompanied by the relevant H share certificates with the H Share Registrar, Computershare Hong Kong Investor Services Limited at Shops 1712-1716, 17th Floor, Hopewell Centre, 183 Queen's Road East, Wan Chai, Hong Kong to process the registration not later than 4:30 p.m. on Thursday, April 9, 2020. The Shareholders whose names appear in the Bank's register of members at the close of business on Thursday, April 9, 2020 shall be entitled to attend and vote at the AGM.

In order to determine the list of Shareholders who are entitled to receive the 2019 final dividends, the H shares register of members of the Bank will be closed from Saturday, May 16, 2020 to Thursday, May 21, 2020 (both days inclusive). Shareholders whose names appear on the register of H share register of members and domestic share register of members of the Bank on Thursday, May 21, 2020 will be entitled to receive the final dividends. The holders of H Shares who intend to qualify for receiving the final dividends must lodge all the transfer documents accompanied by the relevant H share certificates with the H Share Registrar, Computershare Hong Kong Investor Services Limited at Shops 1712-1716, 17th Floor, Hopewell Centre, 183 Queen's Road East, Wan Chai, Hong Kong to process the registration not later than 4:30 p.m. on Friday, May 15, 2020.

6. Publication of poll results

Pursuant to the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited, each of the resolutions set out in the Notice of the 2019 AGM will be voted by poll. Results of the poll voting will be published on the Bank's website at www.bankoftianjin.com and the website of Hong Kong Exchanges and Clearing Limited at www.hkexnews.hk after the AGM.

7. Others

The 2019 AGM is estimated to last no longer than half a day. Shareholders who attend the meeting in person or by proxy shall bear their own traveling, dining and accommodation expenses.
