Dear Shareholders,

On behalf of the board of directors (the "Board"), I am pleased to present the annual results of Dragon Crown Group Holdings Limited (the "Group" or "Dragon Crown") for the year ended 31 December 2019.

SOLID FOUNDATION OVERCOMES UPCOMING CHALLENGES

China has experienced a challenging year in 2019 under the impact of the Sino-US trade war. Although the export and import trade amount increased by 3.4% when compared to that in 2018, the GDP growth of China declined from 6.4% in the first quarter to 6.0% in the last quarter in 2019. With the solid foundation of Dragon Crown established by our management team over the years, the Group has successfully achieved a stable performance under various adversities this year.

Dragon Crown recorded revenue of HK\$229.8 million (2018: HK\$262.5 million) and net profit of HK\$45.5 million (2018: HK\$76.2 million) for the financial year ended 31 December 2019. The decrease in net profit was mainly attributable to the decrease in revenue in respect of ethylene, methanol and acetic acid, the absence of one-off gain on disposal of financial asset at fair value through profit and loss and the share of losses of joint ventures for the year ended 31 December 2019.

With a solid business foundation and a steady business development strategy, Dragon Crown has been serving as a leading liquid petrochemical storage and integrated terminal service provider, attracting world-class chemical enterprises, such as Celanese Corporation, and other large-scale petrochemical enterprises as our loyal business partners. The revenue secured from such partners was in itself sufficient to ensure satisfactory financial results for the year. Given that the liquid petrochemicals handled by the Group are applicable to various daily consumer products on the markets, the demand will grow with the demand of the players in the plastics, paints, textiles, solvents and petroleum industries.

致列位股東：

本人謹代表董事會（「董事會」）欣然呈報龍翔集團控股有限公司（「本集團」或「龍翔」）截至2019年12月31日止之年度業績。

以堅實基礎克服即將到來之挑戰

受中美貿易戰之影響，中國於2019年經歷了充滿挑戰的一年。儘管進出口貿易額與2018年相比增長了3.4%，但中國的GDP增長從2019年第一季度的6.4%下降至最後一個季度的6.0%。於本年度集團成功在各種逆境中取得了穩定的業績有賴龍翔的管理團隊在過去多年建立了穩固基礎。

截至2019年12月31日止之財政年度，龍翔的收入為2.298億港元（2018年：2.625億港元）及淨溢利為4,550萬港元（2018年：7,620萬港元）。淨利潤下降主要歸因於，截至2019年12月31日止年度，乙烯、甲醇與醋酸的相關收入減少、缺少出售按公允價值計入損益的金融資產的一次性收益及應佔合營企業虧損。

憑藉堅實的業務基礎及穩健的業務發展策略，龍翔一直是領先的液體石化品儲存及綜合碼頭服務供應商，吸引世界級化工企業（如塞拉尼斯）及其他大規模石化企業等成為忠實業務夥伴。從該等夥伴獲取的收入可確保本集團得以在年內取得理想財務業績。基於本集團處理的液體石化品適用於市場上各類日常消費品，服務需求可望與來自塑料、塗料、紡織品、工業溶劑及石油行業廠商的需求同步增長。

The Group adopts a strategy of maintaining business stability and sustainability by consolidating present business operations as well as exploring new opportunities in these years. Through investment in Weifang Liquid Terminal, the Group is determined to establish a new business driver. In August 2018, Weifang Liquid Terminal has entered a new era as Weifang Port was opened to foreign trade. With the opening of the Weifang Port to foreign users, Weifang Liquid Terminal will be able to allow the entrance of foreign vessels and attract more foreign customers, which signified the opening of a gateway to Northeastern Asian economic powerhouses for the Group. The Phase I and II Project of the Bulk Liquid Terminal at The West Operation Zone, Central Port Area of Weifang Port have already commenced operation. In order to cohere with the business development of the Group and better utilize the Group's resources, the Group will appropriately adjust the construction progress of the Phase III Project, which is currently under construction, according to the industry environment and the Group's business need. The Group regards Weifang Liquid Terminal as an important cornerstone for the long term development of the Group and expects the operation scale and profitability of Weifang Liquid Terminal will be enhanced after the completion of construction of Phase III. In addition, the completion and operation of the surrounding railways in 2019 will definitely enhance the flexibility and reliability of the terminal, as well as more convenience for customers in the future.

Weifang Liquid Terminal meets the stringent safety requirements and is a state-of-the-art terminal project dedicated to developing for bulk oil and chemicals storage and distribution business. It is located at a gateway to North-eastern Asian economic powerhouses such as Japan and South Korea and a strategic junction between Bohai Economic Basin and Yangtze Economic Basin. As such, the superior position of Dragon Crown in China's liquid petrochemical industry can be consolidated.

DIVIDENDS

In recognition of the long-term support of our shareholders, the Group sticks to the dividend policy as before, an interim dividend of HK1.5 cents (2018: HK2.0 cents) per share was declared and paid during the year. In addition, the Board has proposed a final dividend of HK1.0 cent (2018: HK2.0 cents) per share. The total dividends per share in 2019 was HK2.5 cents, which represents 78.6% of the earnings per share attributable to owners of the Company for the year. The dividend distribution is consistent with the Group's dividend policy. The Group has maintained the annual dividend payout ratio exceeding 50% since its listing.

通過鞏固目前的業務運營並探索新機遇，本集團這些年來採取可維持業務穩定性及可持續性的策略。通過投資濰坊液化品碼頭，本集團決心建立新的業務動力來源。隨着濰坊港於2018年8月對外貿開放，標誌著濰坊液化品碼頭進入新紀元。濰坊港對外國用戶開放將允許外國船舶進入並吸引更多國外客戶，為本集團開啟了通往東北亞經濟強國的門戶。濰坊港中港區西作業區的散裝液化品碼頭一期及二期項目已經開始營運。為配合集團的業務發展及更有效利用集團資源，本集團將會按照行業環境及業務需要適切地調整正在建設中的三期項目之施工進度。本集團視濰坊液化品碼頭為集團長遠發展的重要基石，預期三期項目建成後，濰坊液化品碼頭的經營規模及盈利能力將提高。此外，周邊鐵路於2019年竣工及投入營運勢必提高該碼頭的靈活性及可靠性，在將來為客戶提供更多便利。

濰坊液化品碼頭符合嚴格安全規定及屬國家先進碼頭項目，致力發展散裝石油及化工產品儲存及分銷業務。該碼頭位於通往東北亞經濟強國（如日本及南韓）的關口，並為環渤海經濟圈與長江經濟帶的戰略性交匯點。因此，龍翔於中國液體石化行業的卓越地位得以鞏固。

股息

為感謝股東的長期支持，我們貫徹以往的派息政策，於年內已宣派及派付中期股息每股1.5港仙（2018年：2.0港仙）。此外，董事會建議宣派末期股息每股1.0港仙（2018年：2.0港仙）。2019年股息總額每股2.5港仙，佔本年度本公司擁有人應佔每股盈利的78.6%。派息與本集團的派息政策相符，本集團自上市以來一直維持年度派息比率超過50%。

SAFETY

The Group pays high attention to employee safety of employee and production, and this has been our top priority for many years now. Therefore, all liquid petrochemical terminals and storages of the Group have to be approved by the relevant monitoring departments of government. Furthermore, we provide regular training to all of our staff members, as well as develop and implement HSE (Health, Safety and Environment) policies in accordance with national and industry standards. Due to our utmost attention to safety, we did not experience any material incidents in 2019. In the future, we intend to seek further improvements in this area, with the ultimate goal of providing safe services to our customers and safe workplace to our employees.

MARCHING FORWARD WITH CONFIDENCE AND PRUDENCE

Looking forward, although the US and China have signed the phase one trade agreement, the future development of the trade negotiation is still full of uncertainties. The outbreak of coronavirus disease (COVID-19) is yet under full control and is expected to bring tremendous impact on global economy. The oil price dropped significantly in 2020, reflecting a slump of demand for oil in China. Major oil refinery companies in China have already announced a decrease in production of petroleum products, it is expected that the demands for daily consumer products such as plastics, paints, textiles, solvents and petroleum industries shall diminish, leading to a decrease in demand for liquid petrochemicals. Despite the challenging economic environment, with support from our loyal customers as well as the opportunities coming along with the opening of Weifang Port to foreign customers, we are prudently optimistic about the prospects for the liquid petrochemical industry and believe that demand for our services will remain stable.

With our world-class expertise and excellent facilities and services, we have built a strong reputation and earned the trust of our customers, which include renowned large-scale multinational chemical enterprises and oil refineries. Capitalizing on the global trend for outsourcing logistics arrangements, we see the opportunity to introduce new cost-effective solutions that enable our customers to reduce costs, increase flexibility and raise efficiencies as a whole.

安全

本集團高度重視員工及生產安全，並一向將之置於首位。因此，本集團所有液體石化品碼頭及儲存均通過政府相關監管部門批准。再者，本集團亦為所有員工提供定期培訓，並根據國家及行業標準制定及執行健康、安全及環保的政策。正因我們如此重視安全，我們於2019年並沒有經歷任何重大事故。未來，本集團將進一步致力於這方面的改善，並貫徹向客戶提供安全服務及向員工提供安全工作場所的宗旨。

懷著信心及謹慎態度邁步向前

展望未來，儘管中美已經簽署了第一階段貿易協議，但貿易談判的未來發展仍充滿不確定性。新型冠狀病毒(COVID-19)的爆發尚未得到完全控制，預計將對全球經濟產生重大影響。2020年油價大幅下跌，反映出中國對石油的需求下降。中國主要的煉油廠已宣布減少出產石油產品，預計對塑料、油漆、紡織品、溶劑及石油工業等日常消費品的需求將減少，從而導致對液體石化產品的需求減少。儘管經濟環境充滿挑戰，憑藉忠實客戶的支持以及濰坊港向外國客戶開放帶來的機遇，我們對液體石化行業的前景仍持謹慎樂觀態度，並相信對我們服務的需求將保持穩定。

憑藉我們世界級水平的專業知識、高標準的設施及服務，本集團建立了良好的聲譽並贏得包括知名大型跨國化工企業及煉油廠在內的客戶的信任。隨着外包物流業務成為全球趨勢，本集團緊握商機，引入有成本效益的解決方案，為客戶降低成本、增加靈活性及提升效率。

The Group's flagship operation, which is located in the Nanjing Jiangbei New Materials High-tech Park, the Nanjing terminal, has contributed a stable and satisfactory profit to the Group for a continuous period. We also commit to the continuous upgrading of the terminal and storage facilities and services so as to better serve our customers and maximize our profitability. Besides, the Nanjing terminal has sufficient land reserve for further expansion and development so that we are ready to seize the opportunities upon high potential projects with good investment returns arise.

The opening of Weifang Port to foreign vessels signified a new chapter for the Bohai Economic Basin as well as North-east Asia as it acts as a logistic hub in the region. Through our investment in Weifang Liquid Terminal, the Group has achieved obvious logistic advantage in Shandong Province. The Group has a comprehensive planning on the development and business direction of Weifang Liquid Terminal. While the operation scale of the terminal will continuously expand in the future, we expect that it will become another base with great business growth potential of the Group.

In addition, we will continue to monitor the cash flows closely to ensure the Group has sufficient liquidity, so as to maintain a strong financial position. Besides, we have sufficient funding to support the sustainable development of the Group. The Group will continue to strengthen its superior position in the industry, improve the profitability of its business operations and explore investment opportunities for shareholders.

EXECUTIVE DIRECTORS

Mr. NG Wai Man, aged 63, is an executive director, the chairman and the chief executive officer of the Company. Mr. NG is the founder of our Group and is principally responsible for operation of our Board and is the key decision-maker of our Group. He is responsible for formulating the overall business strategic development for our Group. Mr. NG has accumulated around 31 years of management and operation experience in the terminal and storage of liquid chemical products industry. Mr. NG is the founder of Dragon Source Industrial Limited and its invested entity, Ningbo Haixiang Liquid Chemical Store Co., Ltd. (the predecessor of Ningbo Xinxiang Liquid Chemical Store Co., Ltd. ("Ningbo Xinxiang")), and has managed its operation since 1988. Mr. NG was the president and legal representative of Nanjing Dragon Crown Liquid Chemical Terminal Co., Ltd ("NJDC") from April 2004 to 2007 responsible for overseeing strategic development and management of resources. From December 1993 to September 2004, Mr. NG was a director of Ningbo Huaxiang Inspection Co., Ltd, a company which provides inspection, certification and testing services. He served as the chairman and general manager from October 1997 to October 2006 and legal representative from October 1997 to October 2007 for Ningbo Free Trade Zone Dragon Crown Chemical International Trade Company Ltd., a trading company, responsible for strategic business management. Mr. NG was appointed as a director of the Company on 16 July 2010 and was re-designated as an executive director and the chairman of the Company on 30 November 2010. Mr. NG was then appointed as the chief executive officer of the Company on 22 September 2017.

Mr. CHONG Yat Chin, aged 58, is an executive director of the Company. Mr. CHONG joined our Group in 1994. Mr. CHONG is principally responsible for business and strategic development, major decision-making and communications with major customers. He has accumulated around 25 years of experience in the liquid chemical products terminal and storage industry. Prior to joining our Group, Mr. CHONG worked for Mitsui & Company (Hong Kong) Limited, an international conglomerate engaging in various businesses, including worldwide logistics and financing, development of infrastructure, for over seven years. He was in the chemicals division and undertook business support centered around petrochemical products chain for logistics and distribution. He was also responsible for developing strategic partnerships and customer relations. Mr. CHONG graduated from The Chinese University of Hong Kong in 1986 with a Degree of Bachelor of Business Administration. Mr. CHONG was appointed as an executive director of the Company on 30 November 2010.

執行董事

吳惠民先生，63歲，本公司執行董事、主席兼行政總裁。吳先生為本集團的創始人，主要負責董事會運作，且為本集團主要決策者，負責制訂本集團整體業務策略發展。吳先生在碼頭和儲存液體化學品行業中擁有約31年的管理和運作經驗。吳先生為龍翔化工有限公司及其投資企業－寧波海翔液體化工倉儲有限公司(寧波新翔液體化工倉儲有限公司(「寧波新翔」)前身)的創始人，並自1988年起管理其運作。吳先生自2004年4月至2007年間任南京龍翔液體化工儲運碼頭有限公司(「南京龍翔」)的總裁兼法人代表，負責監督策略制訂及資源管理。自1993年12月至2004年9月，吳先生擔任寧波華翔檢驗有限公司(一家提供檢測、認證及測試服務的公司)董事。彼自1997年10月至2006年10月間擔任寧波保稅區龍翔化工國際貿易有限公司(一家貿易公司)的董事長兼總經理負責策略業務管理及自1997年10月至2007年10月間出任該公司的法人代表。吳先生於2010年7月16日獲任命為本公司董事，並於2010年11月30日調任為本公司執行董事及主席。吳先生及後於2017年9月22日獲委任為本公司行政總裁。

莊日青先生，58歲，為本公司執行董事。莊先生於1994年加入本集團。莊先生主要負責業務及策略制訂、主要決策及與主要的客戶聯絡。彼在液體化學品碼頭和儲存行業擁有約25年的經驗。在加入本集團前，莊先生於三井物產(香港)有限公司(一家國際綜合企業，從事多種業務，包括全球物流及融資服務以及基礎設施建設)任職逾七年。彼任職於化學品部門，為化工產品物流及分銷鏈提供業務支持。彼亦負責開發戰略夥伴及客戶關係。莊先生於1986年畢業於香港中文大學，獲頒工商管理學士學位。莊先生於2010年11月30日獲委任為本公司執行董事。

Ms. CHAN Wan Ming, aged 54, is an executive director of the Company. Ms. CHAN is responsible for our Group's day-to-day management, administration as well as human resources management. She joined our Group in 1988. Ms. CHAN has accumulated around 31 years of management and operation experience in the terminal and storage of liquid chemical products industry. Prior to joining our Group, Ms. CHAN worked for Wai Hing Company, a trading company, from November 1986 to July 1988 responsible for arrangements in trading of chemicals. Ms. CHAN was appointed as an executive director of the Company on 30 November 2010.

INDEPENDENT NON-EXECUTIVE DIRECTORS

Mr. FENG Jianping, aged 66, was appointed as an independent non-executive director of the Company on 29 June 2018. Mr. FENG is also a member of the audit committee, remuneration committee and nomination committee of our Board. Mr. FENG was the executive director and vice president of Sinopec Shanghai Petrochemical Company Limited (formerly known as Shanghai Petrochemical Complex), a company listed on the Main Board of The Stock Exchange of Hong Kong Limited (the "Stock Exchange") (collectively the "Main Board"), from January 1996 to April 2004. Mr. FENG was also the general manager and secretary of party committee of the Guangzhou branch of China Petroleum & Chemical Corporation, a company listed on the Main Board, from April 2004 to July 2013. He also served as the group leader of the third supervisory group in China Petroleum & Chemical Corporation from June 2013 to December 2014. Mr. FENG has considerable experience in operations management. He graduated from Shanghai Industry University in 1983 majoring in business management and is a senior economist.

Mr. HOU Xiaoming, aged 57, was appointed as an independent non-executive Director of the Company with on 1 July 2019. Mr. HOU is also a member of the audit committee, remuneration committee and nomination committee of our Board. Mr. HOU served various positions in Sinopec Shanghai Gaoqiao Company (formerly named as Shanghai Gaoqiao Petrochemical Company), a subsidiary of China Petroleum & Chemical Corporation (a company the H shares of which are listed on the Hong Kong, London and New York stock exchanges and the A shares of which are listed on the Shanghai stock exchange), from July 1985 until his resignation in September 2017 with his last positions as deputy secretary of the party committee, director and general manager. Mr. HOU has extensive experience in the petrochemical industry and corporate management. He graduated from East China University of Science

獨立非執行董事

馮建平先生，66歲，於2018年6月29日獲委任為本公司獨立非執行董事。馮先生亦為董事會審核委員會、薪酬委員會及提名委員會之成員。自1996年1月至2004年4月，馮先生為一間於香港聯合交易所有限公司（「聯交所」）主板（統稱「主板」）上市之公司中國石化上海石油化工股份有限公司（前稱上海石化總廠）的執行董事及副總經理。自2004年4月至2013年7月，馮先生為一間於主板上市之公司中國石油化工股份有限公司廣州分公司的總經理及黨委書記。自2013年6月至2014年12月，彼亦擔任中國石油化工股份有限公司的第三督導組組長。馮先生具有豐富的經營管理經驗。彼於1983年畢業於上海工業大學企業管理專業，且為一名高級經濟師。

Mr. LAU was an engineer of ExxonMobil Hong Kong Limited from 1988 to 2004 and he assumed management roles in HSE, logistics, operations and maintenance. Mr. LAU graduated from The University of Hong Kong with a degree of Bachelor of Science in Engineering in 1979. Mr. LAU was elected as a Graduate of the Institution of Engineers, Australia on 10 January 1985 and has been included in the list of competent persons for Class 2-inspection and certification of LPG compound and cylinder stores by Electrical & Mechanical Services Department, Government of Hong Kong since 6 November 1996. He joined our Group in April 2005 as a project manager.

Prior to joining our Group, Mr. XIANG served as deputy director the factory, division deputy chief of Human Resource and Security and an office administrator in Ningbo No.2 Pharmaceutical Factory of Zhejiang Province from February 1988 to October 1992. During the period from November 1992 to September 1995, Mr. XIANG served as an office administrator handling selection and recruitment of new staff, finance management and observing compliance of HSE policies of Zhejiang Chemicals Factory (Yongxin Company). Mr. XIANG has served as a deputy director and director of tank field, business manager and general manager assistant in Ningbo Ningxiang and Ningbo Xinxiang since October 1995. Mr. XIANG completed administration management course of Self-Study Examination of the Higher Education of Zhejiang Province in October 1990.

Mr. LIU Bing, aged 51, is the General Manager of WSDL. Mr. LIU has joined WSDL since December 2018, principally responsible for the overall operational management of the company. Mr. LIU has accumulated around 26 years of management and operation experience in the terminal and storage of liquid chemical products industry and gained valuable experience in operation, safety, maintenance, customer service, and business of this industry. Prior to joining WSDL, Mr. LIU was a Terminal Manager of Vopak SDIC Terminal Yangpu Co., Ltd. He has extensive experience within the area of company's operation and management.

BUSINESS REVIEW

Dragon Crown is one of China's leading storage and integrated terminal service providers that specialized in the handling and storage of liquid petrochemical products, operating a total of three terminals that are located in Nanjing, Ningbo and Weifang. Strategically situated in two of the major petrochemical industry hubs of China, the Group has set up jetties and tank farms (together, the "Terminals") along the coastal area to seize the rising demand from the petroleum and chemical industries. Dragon Crown offers a high quality and comprehensive range of liquid petrochemical terminal and storage services to customers through its own jetties, storage tanks and dedicated pipelines.

During the year ended 31 December 2019, the throughput volume of liquid petrochemical products handled by the Group's Nanjing, Ningbo and Weifang terminals reached 1,529,000 metric tonnes, 379,000 metric tonnes and 4,877,000 metric tonnes, respectively (2018: 1,542,000 metric tonnes, 339,000 metric tonnes and 5,730,000 metric tonnes, respectively), with a combined throughput volume of 6,785,000 metric tonnes (2018: 7,611,000 metric tonnes).

業務回顧

龍翔為中國領先的儲存及綜合碼頭服務供應商之一，主要專注於處理及儲存液體石化品，在南京、寧波及濰坊共營運三個碼頭。本集團策略性地處於中國其中兩個主要石油化工行業的樞紐，已在沿海地區建立了碼頭及罐區(統稱「碼頭罐區」)以把握石油化工行業日益增長的需求。龍翔透過其自有碼頭、儲罐及專用管道向客戶提供高品質及全面性的液體石化產品碼頭及儲存服務。

於截至2019年12月31日止年度，本集團於南京、寧波及濰坊碼頭處理的液體石化品吞吐量分別為1,529,000公噸、379,000公噸及4,877,000公噸(2018年：分別為1,542,000公噸、339,000公噸及5,730,000公噸)，合併吞吐量6,785,000公噸(2018年：7,611,000公噸)。

Management Discussion and Analysis

管理層討論與分析

The main source of the Group's revenue and profit is derived from its flagship terminal, situated in the Nanjing Jiangbei New Materials High-tech Park. The Group's major customer, Celanese Corporation (NYSE: CE), a world leading producer of acetyl products, is also situated in the same high-tech park, contributed HK\$198.7 million (2018: HK\$217.4 million) in revenue to the Group, which is equivalent to 86.5% (2018: 82.8%) of the total revenue during the year. The business operation in Nanjing continues to contribute stable revenue as we have established long term relationship with our customers.

The opening of Weifang Port to foreign vessels signified a new chapter for the Bohai Economic Basin as well as North-east Asia as it acts as a logistic hub in the region. With the obvious geographical and logistic advantage of Weifang Port to oil refineries and chemical production plants located within its 300km radius, Weifang Liquid Terminal allows the entrance of vessels with higher Dead Weight Tonnage so as to effectively control customers' costs. The Phase I and II Project of the Bulk Liquid Terminal at the West Operation Zone, Central Port Area of Weifang Port have already commenced operation. In order to cohere with the business development of the Group and better utilize the Group's resources, the Group will appropriately adjust the construction progress of the Phase III Project according to the industry environment and the Group's business need. The Group regards Weifang Liquid Terminal as an important cornerstone for the long term development of the Group and expects the operation scale and profitability of Weifang Liquid Terminal will be enhanced after the completion of the construction of Phase III. In addition, the completion and operation of the surrounding railways in 2019 will definitely enhance the flexibility and reliability of the terminal, as well as more convenience for customers in the future.

The Group regards Weifang Liquid Terminal as a significant milestone for our business development. The operation and development of Weifang Liquid Terminal will be beneficial to the profit of the Group in the future and will consolidate the superior position of Dragon Crown in China's liquid petrochemical industry.

Dragon Crown is in a strong financial position as at 31 December 2019, with total assets of HK\$1,339.9 million (2018: HK\$1,341.4 million) and total equity of HK\$1,076.0 million (2018: HK\$1,103.9 million). As at 31 December 2019, the Group has cash on hand of HK\$243.2 million (2018: HK\$194.9 million) and in a net cash position. Such a healthy financial backup ensures the Group's sustainability.

本集團收入及溢利的主要來源來自本集團座落於南京江北新材料科技園的旗艦碼頭。本集團的主要客戶塞拉尼斯(紐約證券交易所:CE)為世界領先的乙醯產品生產商,亦位於該科技園,於本年度向本集團貢獻收入1.987億港元(2018年:2.174億港元),相當於總收入之86.5%(2018年:82.8%)。由於我們與客戶確立了長期的關係,在南京的業務經營保持貢獻穩定收入。

濰坊碼頭開放予外國船舶,作為地區物流樞紐,為環渤海經濟圈以及東北亞揭開了新篇章。濰坊港有著顯著的地理及物流優勢,可為其300公里半徑範圍內的煉油廠及化工廠提供服務,並可容納較高載重噸位的船舶進入,協助客戶有效控制成本。濰坊港中港區西作業區的散裝液體品碼頭一期及二期項目已經開始營運,為配合集團的業務發展及更有效利用集團資源,本集團將會按照行業環境及其業務需要適切地調整三期項目之施工進度。本集團視濰坊液體品碼頭為集團長遠發展的重要基石,預期三期項目建成後,濰坊液體品碼頭的經營規模及盈利能力將提高。此外,周邊鐵路於2019年竣工及投入營運勢必提高該碼頭的靈活性及可靠性,在將來為客戶提供更多便利。

本集團視濰坊液體品碼頭為我們業務發展的重要里程碑。濰坊液體品碼頭的營運及發展必定惠及本集團在未來的盈利及鞏固龍翔於中國液體石化行業的卓越地位。

龍翔於2019年12月31日擁有雄厚財務實力,總資產達13.399億港元(2018年:13.414億港元)及總權益達10.760億港元(2018年:11.039億港元)。於2019年12月31日,本集團持有手頭現金2.432億港元(2018年:1.949億港元),為持有淨現金狀況。穩健的財務狀況確保本集團的可持續發展。

BUSINESS OUTLOOK

Although the development of the US-Sino trade war and the outbreak of coronavirus disease (COVID-19) are becoming more uncertain, the Group is prudently optimistic about the prospects of the industry and layout of the business. Looking ahead, with the opening of Weifang Port to foreign vessels, the Group is granted the opportunity to explore new market through business expansion while ensuring the development of its core business. The Group plans to continue enhancing its business development in the coastal regions of China, particularly along the Yangtze River Delta and Bohai Bay regions, so as to further expand Dragon Crown's domestic and even international market.

As Weifang Liquid Terminal Phase I and II commenced operation, and the development of Phase III will further enhance the scale of the terminal in the future, the Group will be more capable to capture the market demand in North-eastern China and North-eastern Asia. The Group believes in the great business potential in the region and is confident that the Group can maintain its leading role in the new market with the help of Weifang Liquid Terminal. Together with the construction of Weifang Liquid Terminal Phase III, it will become the largest terminal of the Group, with total storage capacity of over 660,000 m³. Several potential customers are in negotiation for renting the tank capacity in Phase III already. In addition, the construction of different railways and transportation network around Weifang Liquid Terminal will further strengthen our advantage in developing a remarkable role in the industry.

With advanced operations and a highly experienced management team at the helm, Dragon Crown is set to consolidate its superior position as a storage and integrated terminal service provider in China. Despite all the upcoming challenges, the Group will remain committed to achieving better financial results and delivering greater value to its shareholders.

FINANCIAL PERFORMANCE REVIEW

Revenue

For the year ended 31 December 2019, the revenue of the Group decreased by 12.4% from HK\$262.5 million in 2018 to HK\$229.8 million. The decrease was mainly due to the decrease in revenue in respect of ethylene, methanol and acetic acid.

業務展望

儘管中美貿易戰的發展及新型冠狀病毒 (COVID-19) 的爆發變得更加不確定，但本集團對行業前景及業務佈局持審慎樂觀態度。展望未來，隨着濰坊港對外國船舶開放，本集團在確保維持其核心業務的同時，將透過業務擴張獲得機遇，開拓新市場。本集團計劃繼續提升其位於中國沿海地區的業務發展，尤其在長三角及渤海灣地區，以進一步擴張龍翔的國內市場乃至國際市場。

隨着濰坊液化品碼頭一期及二期開始營運，加上碼頭規模未來將伴隨第三期的發展進一步提升，本集團將更能夠捕捉中國東北及亞洲東北市場的機遇。本集團相信該地區擁有巨大業務潛力，並深信助力於濰坊液化品碼頭，本集團將能保持其在新市場的領先地位。隨着濰坊液化品碼頭三期的建設，其將成為本集團最大型的碼頭，存儲容量合計超過660,000立方米。一些潛在客戶已經在洽談租賃三期的儲罐容量。此外，濰坊液化品碼頭周邊不同鐵路及交通網絡的建設，將進一步增強我們於該行業發展顯著作用的優勢。

憑藉先進的營運及在資深管理團隊的領導下，龍翔將致力於鞏固其作為中國儲存及綜合碼頭服務供應商的卓越地位。儘管將要面臨各種挑戰，本集團將繼續全力以赴，實現更卓越的財務業績，為股東帶來更大回報。

財務表現回顧

收入

截至2019年12月31日止年度，本集團收入由2018年之2.625億港元減少12.4%至2.298億港元。該減少主要由於乙烯、甲醇與醋酸之收入減少所致。

Management Discussion and Analysis

管理層討論與分析

Gross profit

For the year ended 31 December 2019, the gross profit of the Group decreased by 21.3% from HK\$143.9 million in 2018 to HK\$113.2 million. The decrease was mainly due to the decrease in revenue as mentioned above. The gross profit ratio decreased by 5.5%, from 54.8% in 2018 to 49.3% for the year.

Other income

Other income decreased to HK\$16.5 million from HK\$20.0 million in 2018, which was mainly due to the absence of one-off government grants recorded in 2018.

Administrative expenses

Administrative expenses decreased by 9.3% from HK\$50.9 million in 2018 to HK\$46.1 million. The decrease was mainly due to the decrease in loss on foreign exchange difference.

Finance costs

Finance costs for the year increased to HK\$8.7 million from HK\$7.2 million in 2018. It was mainly attributable to the increase of interest rate and the Group has drawn down certain new bank loans during the year.

Share of profit and loss of an associate

The associate in Tianjin was going through the liquidation process since 2016 and the loss of HK\$0.4 million for the year (2018: HK\$0.4 million) was due to the administrative expenses in relation to the liquidation.

毛利

截至2019年12月31日止年度，本集團毛利由2018年之1.439億港元減少21.3%至1.132億港元。該減少主要由於上述的收入減少所致。毛利率從2018年的54.8%減少5.5%至今年的49.3%。

其他收入

其他收入由2018年之2,000萬港元減少至1,650萬港元，該減少主要由於缺少2018年的一次性政府補貼所致。

行政開支

行政開支由2018年之5,090萬港元減少9.3%至4,610萬港元。該減少主要歸因於匯兌差額虧損的減少。

融資成本

融資成本由2018年之720萬港元增加至年內之870萬港元，乃主要由於利率上升及年內本集團提取了若干新增銀行貸款。

應佔一間聯營公司之溢利及虧損

天津聯營公司自2016年起進行清算程序，年內虧損40萬港元(2018年：40萬港元)乃由於有關清算的行政開支所致。

Share of profits and losses of joint ventures

There was no significant change in the share of profits of the joint ventures in Ningbo compared with that of 2018.

The share of loss of the joint venture in Weifang increased for the year due to the increase in operating costs such as depreciation and energy costs.

Since the share of loss of the joint venture in Weifang outweighed the share of profits of the joint ventures in Ningbo, the Group recorded share of losses of its joint ventures for the year.

Tax expense

The tax expense for the year decreased to HK\$26.9 million from HK\$36.2 million in 2018. The decrease was due to the decrease in profit for the year.

Investment in Weifang Sime Darby Liquid Terminal Co., Ltd. ("WSDL")

The acquisition of 50% equity interest in WSDL at a consideration of RMB60.9 million was completed on 23 May 2016 and WSDL becomes a joint venture of the Group since then. Afterwards, the Group had injected capital of a total amount of RMB225.0 million into WSDL in proportion to its shareholding interest in WSDL up to 31 December 2019.

The Group had provided shareholder's loans to WSDL. As at 31 December 2019, WSDL was indebted to the Group in an aggregate amount of RMB143.1 million.

稅項開支

年內稅項開支由2018年之3,620萬港元減少至2,690萬港元。該減少乃由於年內溢利減少所致。

於濰坊森達美液化品碼頭有限公司 ("WSDL") 的投資

以代價6,090萬人民幣收購WSDL的50%股權已於2016年5月23日完成，WSDL自此成為本集團的合營企業。此後，截至2019年12月31日，本集團按其於WSDL的持股權益比例向WSDL注資共2.250億人民幣。

本集團已向WSDL提供股東貸款。於2019年12月31日，WSDL欠付本集團總額為1.431億人民幣。

USE OF NET PROCEEDS FROM LISTING

The Group has received approximately HK\$281.1 million net proceeds, after deducting underwriting fee and other related expenses, from listing of the Company's shares in 2011.

These net proceeds were applied up to 31 December 2019 in accordance with the proposed applications set out in the section headed "Future Plans and Use of Proceeds" in the Company's prospectus dated 30 May 2011 and the Company's announcements dated 6 February 2013 headed "Change of use of proceeds", dated 20 December 2017 headed "Change in use of proceeds from the global offering" and dated 22 December 2017 headed "Clarification announcement", as follows:

FOREIGN CURRENCY AND INTEREST RATE RISKS

The Group's cash and bank balances were primarily denominated in Renminbi and Hong Kong dollars. Its operating cash inflows and outflows were primarily denominated in Renminbi and Hong Kong dollars. During the year, the Group did not have any material foreign exchange exposure and had not used any financial instruments for hedging purpose.

All bank borrowings of the Group were denominated in Hong Kong dollars, the interest rates of these bank borrowings are calculated in HIBOR plus a particular percentage. The Group will closely monitor the interest rate movements and regularly review its banking facilities so as to mitigate the expected interest rate risk.

CONTINGENT LIABILITIES

As at 31 December 2019, the Group did not have any significant contingent liabilities.

EMPLOYEES AND REMUNERATION

As at 31 December 2019, the Group had a total of 339 full time employees (2018: 363). The Group provides competitive remuneration package to retain its employees including salaries, discretionary bonus, medical insurance, other allowance and benefits in kind as well as mandatory provident fund schemes for employees in Hong Kong and state-managed retirement benefit schemes for employees in the People's Republic of China ("PRC").

CORPORATE GOVERNANCE PRACTICES

The Group is committed to achieving high standards of corporate governance to safeguard the interests of shareholders, enhance corporate value, formulate its business strategies and policies, and enhance its transparency and accountability.

The Company has adopted the principles and code provisions of the Corporate Governance Code (the “CG Code”) contained in Appendix 14 of the Rules Governing the Listing of Securities on the Stock Exchange (the “Listing Rules”) as the basis of the Company’s corporate governance practices.

The Company has in place a corporate governance framework and has established a set of policies and procedures based on the CG Code. Such policies and procedures provide the infrastructure for enhancing the Board’s ability to implement governance and exercise proper oversight on business conduct and affairs of the Company.

In the opinion of the directors, throughout the year, the Company has complied with all the code provisions as set out in the CG Code, except for code provision A.2.1 which stipulates that the roles of chairman and chief executive should be separate and should not be performed by the same individual.

The Company regularly reviews its corporate governance practices to ensure compliance with the CG Code.

INDEPENDENT NON-EXECUTIVE DIRECTORS

During the year ended 31 December 2019, the Board at all times met the requirements of the Listing Rules relating to the appointment of at least three independent non-executive directors representing one-third of the Board with at least one of whom possessing appropriate professional qualifications or accounting or related financial management expertise.

The independent non-executive directors bring a wide range of business and financial expertise, experience and independent judgment to the Board. Through active participation at Board meetings, taking the lead in managing issues involving potential conflict of interests, all independent non-executive directors have made various contributions to the effective direction of the Company.

Mr. LAU Sik Yuen has served the Board for more than nine years. Notwithstanding his length of tenure, in view of his professionalism, extensive business experience and familiarity with the Company's affairs, the Board is of the opinion that he possesses the required character, integrity and experience to ensure his independence in order to objectively scrutinise the Company's performance.

The Company has received written annual confirmation from each independent non-executive director of his independence pursuant to the requirements of the Listing Rules. The Company considers all independent non-executive directors to be independent in accordance with the independence guidelines as set out in the Listing Rules.

APPOINTMENT AND RE-ELECTION OF DIRECTORS

The procedures and process of appointment, re-election and removal of directors are laid down in the Company's Articles of Association. The Nomination Committee is responsible for reviewing Board composition, monitoring the appointment of directors and assessing the independence of independent non-executive directors.

The independent non-executive directors of the Company are appointed for a specific term of one year, subject to renewal after the expiry of the then current term.

All the directors of the Company are subject to retirement by rotation and re-election at the annual general meetings. Under the Articles of Association of the Company, at each annual general meeting, one-third of the directors for the time being, or if their number is not three of a multiple of three, the number nearest to but not less than one-third shall retire from office by rotation provided that every director shall be subject to retirement by rotation at least once every three years. The Company's Articles of Association also provides that all directors appointed to fill a casual vacancy shall be subject to election by shareholders at the first general meeting after appointment. The retiring directors shall be eligible for re-election.

At the forthcoming annual general meeting of the Company, Ms. CHAN Wan Ming and Mr. LAU Sik Yuen shall retire by rotation, and Mr. HOU Xiaoming shall retire and being eligible, offer themselves for re-election pursuant to the Company's Articles of Association.

RESPONSIBILITIES, ACCOUNTABILITIES AND CONTRIBUTIONS OF THE BOARD AND MANAGEMENT

The Board should assume responsibility for leadership and control of the Company. The Board has delegated to the Chief Executive Officer, and through him, to the senior management the authority and responsibility for the day-to-day management and operation of the Group.

The Board directly, and indirectly through its committees, leads and provides direction to management by laying down strategies and overseeing their implementation, monitors the Group's operational and financial performance, and ensures that sound internal control and risk management systems are in place.

All directors have carried out their duties in good faith, in compliance with applicable laws and regulations and in the interests of the Company and its shareholders at all times.

DELEGATION OF MANAGEMENT FUNCTIONS

The Board reserves for its decision all major matters of the Company, including: approval and monitoring of all policy matters, overall strategies and budgets, internal control and risk management systems, material transactions (in particular those that may involve conflict of interests), financial information, appointment of directors and other significant financial and operational matters.

All directors have full and timely access to all relevant information as well as the advice and services of the Company Secretary, with a view to ensuring that Board procedures and all applicable laws and regulations are followed. Each director is normally able to seek independent professional advice in appropriate circumstances at the Company's expense, upon making request to the Board.

The day-to-day management, administration and operation of the Company are delegated to the Chief Executive Officer and the senior management. The delegated functions and responsibilities are periodically reviewed. Approval has to be obtained from the Board prior to any significant transactions entered into by the aforesaid officers.

INDUCTION AND CONTINUING PROFESSIONAL DEVELOPMENT OF DIRECTORS

Directors shall keep abreast of regulatory developments and changes in order to effectively perform their responsibilities and to ensure that their contribution to the Board remains informed and relevant.

Each newly appointed director receives formal and comprehensive induction on the first occasion of his/her appointment to ensure appropriate understanding of the business and operations of the Company and full awareness of director's responsibilities and obligations under the Listing Rules and relevant statutory requirements.

All directors are encouraged to participate in continuous professional development to develop and refresh their knowledge and skills. The Company regularly circulates training materials or briefings to all directors in respect of the updates on, among other things, the Listing Rules, the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong) or other useful guidelines, the Companies Ordinance and financial or accounting standards which may be of the interest to the directors and benefit for them to discharge their duties. Training session for directors will also be arranged where necessary.

In addition, the Company provides and circulates the directors with monthly and regular updates relating to the Group's business, financial position and business environment, which aims to ensure compliance and to enhance their awareness of good corporate governance practices.

All directors have provided to the Company with their training records on a regular basis, and such records have been maintained by the Company for accurate and comprehensive record keeping. During the year, all directors (Mr. NG Wai Man, Mr. CHONG Yat Chin, Ms. CHAN Wan Ming, Mr. LAU Sik Yuen, Mr. FENG Jianping, Mr. ZHU Wujun (resigned on 1 July 2019) and Mr. HOU Xiaoming (appointed on 1 July 2019)) have complied with the code provisions in relation to continuous professional development through attendance of seminars on corporate governance, regulatory development and other relevant topics.

董事入職及持續專業發展

董事應掌握監管發展及轉變的最新趨勢，以有效履行彼等的職責，並確保彼等對董事會作出知情及恰當的貢獻。

每位新委任的董事在其首次獲委任時均獲得正式及全面的入職啟導，以確保對本公司的業務及營運有適當瞭解，以及全面認識在上市規則及相關法定要求下的董事職責及責任。

本公司鼓勵所有董事參與持續專業發展，以發展及更新其知識及技能。本公司定期向全體董事傳閱符合董事利益及有助於彼等履行職責之培訓材料或簡報，內容有關（其中包括）上市規則、香港法例第571章證券及期貨條例或其他有用指引、公司條例及財務或會計準則之最新資料。如有需要亦會為董事安排培訓課程。

此外，本公司向董事提供及傳閱每月及定期更新有關本集團業務、財務狀況及業務環境的資料，目的是確保合規，並提升彼等對良好企業管治常規的意識。

所有董事均定期向本公司提供彼等的培訓記錄，該等記錄由本公司保存以確保存置準確及全面之記錄。年內，所有董事（吳惠民先生、莊日青先生、陳芸鳴女士、劉錫源先生、馮建平先生、朱武軍先生（於2019年7月1日辭任）及侯曉明先生（於2019年7月1日獲委任））透過出席有關企業管治、監管發展及其他相關主題的研討會，均已遵守關於持續專業發展的守則條文。

BOARD COMMITTEES

The Board has established three committees, namely, the Nomination Committee, Remuneration Committee and Audit Committee, for overseeing particular aspects of the Company's affairs. All Board committees of the Company are established with specific written terms of reference which deal clearly with their authority and duties. The terms of reference of the Board committees are posted on the Company's website and the Stock Exchange's website and are available to shareholders upon request.

The list of the chairman and members of each Board committee is set out under "Corporate Information" on page 175 of this annual report.

Board committees are provided with sufficient resources to discharge their duties and, upon reasonable request, are able to seek independent professional advice in appropriate circumstances at the Company's expense.

NOMINATION COMMITTEE

The Nomination Committee comprises four members, namely, Mr. LAU Sik Yuen (chairman), Mr. FENG Jianping, Mr. HOU Xiaoming and Mr. NG Wai Man, the majority of which are independent non-executive directors.

The terms of reference of the Nomination Committee are of no less exacting terms than those set out in the CG Code.

The principal duties of the Nomination Committee include reviewing the Board composition, developing and formulating relevant procedures for the nomination and appointment of directors, making recommendations to the Board on the appointment and succession planning of directors, and assessing the independence of independent non-executive directors.

In assessing the Board composition, the Nomination Committee would take into account various aspects as well as factors concerning Board diversity as set out in the Company's Board Diversity Policy. The Nomination Committee would discuss and agree on measurable objectives for achieving diversity on the Board, where necessary, and recommend them to the Board for adoption.

董事委員會

董事委員會獲提供充足資源以履行其職責，並可按合理要求於情況合適時徵求獨立專業意見，費用由本公司支付。

提名委員會

提名委員會包括四名成員，即劉錫源先生（主席）、馮建平先生、侯曉明先生及吳惠民先生，其中大部分為獨立非執行董事。

提名委員會之職權範圍並不寬鬆於該等載於企業管治守則之職權範圍。

提名委員會之主要職責包括檢討董事會之組成，構思與制訂董事提名及委任之相關程序，就董事委任及繼任計劃向董事會提供意見，並評估獨立非執行董事之獨立性。

於評估董事會組成時，提名委員會將考慮多方面因素，以及本公司董事會成員多元化政策所載關於董事會成員多元化的因素。提名委員會將討論及一致同意實現董事會多元化的可衡量目標，並於有需要時推薦予董事會以供採納。

In identifying and selecting suitable candidates for directorships, the Nomination Committee would consider the candidate's relevant criteria as set out in the Director Nomination Policy that are necessary to complement the corporate strategy and achieve Board diversity, where appropriate, before making recommendation to the Board.

The Nomination Committee met twice during the year under review to review the structure, size and composition of the Board and the independence of the independent non-executive directors, and to consider the qualifications of the retiring directors standing for election at the Annual General Meeting and to consider and recommend to the Board on the appointment of independent non-executive director. The Nomination Committee considered an appropriate balance of diversity perspectives of the Board is maintained.

REMUNERATION COMMITTEE

The Remuneration Committee comprises four members, namely, Mr. LAU Sik Yuen (chairman), Mr. FENG Jianping, Mr. HOU Xiaoming and Mr. NG Wai Man, the majority of which are independent non-executive directors.

The terms of reference of the Remuneration Committee are of no less exacting terms than those set out in the CG Code.

The primary objectives of the Remuneration Committee include making recommendations on and approving the remuneration policy and structure and remuneration packages of all directors and the senior management. The Remuneration Committee is also responsible for establishing transparent procedures for developing such remuneration policy and structure to ensure that no director or any of his/her associates will participate in deciding his/her own remuneration, which remuneration will be determined by reference to the performance of the individual and the Company as well as market practice and conditions.

The Remuneration Committee met once during the year under review to review and make recommendation to the Board on the remuneration policy and the remuneration packages of all directors and senior management.

AUDIT COMMITTEE

The Audit Committee comprises three independent non-executive directors, namely, Mr. LAU Sik Yuen (chairman), Mr. FENG Jianping and Mr. HOU Xiaoming, including one independent non-executive director with the appropriate professional qualifications. None of the members of the Audit Committee is a former partner of the Company's existing external auditor.

The terms of reference of the Audit Committee are of no less exacting terms than those set out in the CG Code.

The main duties of the Audit Committee include the following:

- To review the financial statements and reports and consider any significant or unusual items raised by the external auditor before submission to the Board
- To review the relationship with the external auditor by reference to the work performed by the auditor, its fees and terms of engagement, and make recommendations to the Board on the appointment, re-appointment and removal of external auditor
- To review the adequacy and effectiveness of the Company's financial reporting system, internal control systems and risk management system and associated procedures

The Audit Committee held two meetings during the year under review to review the interim and annual financial results and reports and significant issues on the financial reporting, operational and compliance controls, the effectiveness of the risk management and internal control systems and internal audit function, appointment of external auditor and engagement of non-audit services and relevant scope of works and, connected transactions and arrangements for employees to raise concerns about possible improprieties.

審核委員會

審核委員會之職權範圍並不寬鬆於該等載於企業管治守則之職權範圍。

審核委員會主要職責包括下列各項：

- 於提交董事會前，審閱財務報表及報告，並考慮外聘核數師提呈之任何重大或非經常項目
- 參考核數師履行之工作、委聘費用及條款，以審閱與外聘核數師之關係，並就委聘、重新委任及罷免外聘核數師向董事會提出建議
- 審閱本公司財務申報系統、內部監控系統及風險管理系統和相關程序是否足夠及有效

審核委員會於回顧年度內已舉行兩次會議以審閱中期及年度財務業績及報告以及有關重大事宜，當中涉及財務申報、運作及合規監控、風險管理及內部監控系統之成效，及內部審計職能、外聘核數師的委任及進行非審計服務和相關工作範圍，關連交易及僱員可就可能不當行為提出關注之安排。

The Audit Committee also met the external auditor twice without the presence of the executive directors.

The Group's accounting principles and practices and the audited consolidated financial statements for the year ended 31 December 2019 have been reviewed by the Audit Committee.

BOARD DIVERSITY POLICY

The Company has adopted a Board Diversity Policy which sets out the approach to achieve diversity of the Board and is available on the website of the Company. The Company recognizes and embraces the benefits of having a diverse Board and sees increasing diversity at the Board level as an essential element in maintaining the Company's competitive advantage.

Pursuant to the Board Diversity Policy, the Nomination Committee will review annually the structure, size and composition of the Board and where appropriate, make recommendations on changes to the Board to complement the Company's corporate strategy and to ensure that the Board maintains a balanced diverse profile. In relation to reviewing and assessing the Board composition, the Nomination Committee is committed to diversity at all levels and will consider a number of aspects, including but not limited to gender, age, cultural and educational background, professional qualifications, skills, knowledge and regional and industry experience.

The Company aims to maintain an appropriate balance of diversity perspectives that are relevant to the Company's business growth and is also committed to ensuring that recruitment and selection practices at all levels (from the Board downwards) are appropriately structured so that a diverse range of candidates are considered.

The Board will consider setting measurable objectives to implement the Board Diversity Policy and review such objectives from time to time to ensure their appropriateness and ascertain the progress made towards achieving those objectives.

At present, the Nomination Committee considered that the Board is sufficiently diverse and the Board has not set any measurable objectives.

董事會多元化政策

根據董事會多元化政策，提名委員會每年檢討董事會的架構、規模及組成，並在適當時向董事會作出有關任何變更的推薦意見，以配合本公司的企業策略並確保董事會維持均衡的多元化組合。在檢討及評估董事會組成時，提名委員會致力於在所有層面的多元化並將考慮多個方面，包括但不限於性別、年齡、文化及教育背景、專業資格、技能、知識及地區以及行業經驗。

本公司旨在維持有關本公司業務增長適當的多元性，並致力於確保董事會及公司其他各級員工之聘用和甄選辦法均按適當的架構程序進行，以便能招徠多元背景的人選。

董事會將考慮制定可計量目標以實行董事會成員多元化政策，並不時檢討該等目標，以確保其合適性及確定達致該等目標之進度。

提名委員會現時認為董事會之組成屬充分多元化，董事會沒有制定任何可計量目標。

The Nomination Committee will review the Board Diversity Policy, as appropriate, to ensure its effectiveness.

DIRECTOR NOMINATION POLICY

The Board has delegated its responsibilities and authority for selection and appointment of directors to the Nomination Committee of the Company.

The Company has adopted a Director Nomination Policy which sets out the selection criteria and process and the Board succession planning considerations in relation to nomination and appointment of directors of the Company and aims to ensure that the Board has a balance of skills, experience and diversity of perspectives appropriate to the Company and the continuity of the Board and appropriate leadership at Board level.

The Director Nomination Policy sets out the factors for assessing the suitability and the potential contribution to the Board of a proposed candidate, including but not limited to the following:

- Reputation for integrity
- Accomplishment and experience
- Qualifications
- Compliance with legal and regulatory requirements
- Commitment in respect of available time and relevant interest
- Independence
- Diversity in all its aspects, including but not limited to gender, age (18 years or above), cultural and educational background, ethnicity, professional experience, skills, knowledge and length of service

These factors are for reference only, and not meant to be exhaustive and decisive. The Nomination Committee has the discretion to nominate any person, as it considers appropriate.

The Director Nomination Policy also sets out the procedures for the selection and appointment of new directors and re-election of directors at general meetings. During the year ended 31 December 2019, the composition of the Board was changed with Mr. ZHU Wujun resigned as an independent non-executive director and Mr. HOU Xiaoming appointed as an independent non-executive director.

上述因素僅供參考，並非盡列所有因素，亦不具決定性作用。提名委員會可酌情決定提名其認為適當的任何人士。

董事提名政策亦載有於股東大會上甄選及委任新董事及重選董事之程序。於截至2019年12月31日止年度，董事會之組成有所變動，朱武軍先生已辭任獨立非執行董事而侯曉明先生獲委任為獨立非執行董事。

The Nomination Committee will review the Director Nomination Policy, as appropriate, to ensure its effectiveness.

年內，董事會已檢討本公司之企業管治政策及常規、董事及高級管理人員之培訓及持續專業發展、本公司在遵守法律法規規定、遵守標準守則及僱員書面指引以及遵守企業管治守則及企業管治報告披露之政策及常規。

董事及委員會成員出席記錄

各董事出席截至2019年12月31日止年度舉行的董事會及董事委員會會議以及本公司股東大會的出席記錄載列於下表：

Apart from regular Board meetings, the Chairman also held meetings with the independent non-executive directors without the presence of other directors during the year.

Independent non-executive directors have attended general meetings to gain and develop a balanced understanding of the view of shareholders.

Practices and Conduct of Board Meetings

Annual meeting schedules and draft agenda of each meeting are normally made available to directors in advance.

Notice of regular Board meetings is served to all directors at least 14 days before the meeting. For other Board meetings, reasonable notice is generally given.

Board papers together with all appropriate, complete and reliable information are sent to all directors at least 3 days before each Board meeting to keep directors apprised of the latest developments and financial position of the Company and to enable them to make informed decisions. The Board and each director also have separate and independent access to the senior management where necessary.

The secretary of the meeting is responsible for taking and keeping minutes of all Board meetings. Draft minutes are normally circulated to directors for comment within a reasonable time after each meeting and final versions are open for directors' inspection.

According to current Board practice, any material transaction, which involves a conflict of interests for a substantial shareholder or a director, will be considered and dealt with by the Board at a duly convened Board meeting. The Company's Articles of Association contain provisions requiring directors to abstain from voting and not to be counted in the quorum at meetings for approving transactions in which such directors or any of their associates have a material interest.

獨立非執行董事已出席股東大會以獲得並對股東意見有公正之了解。

董事會會議常規及操守

董事一般可事先取得週年大會會期及各會議議程初稿。

定期董事會會議通知於會議前最少14日向全體董事發出，其他董事會會議則一般會發出合理通知。

董事會文件連同所有完備之合適可靠資料將於各董事會會議前最少3日向全體董事發出，以令董事得知本公司最新發展及財務狀況，並確保彼等作出知情決定。於必要時，董事會及各董事亦可個別獨立接觸高級管理人員。

會議秘書負責作出及保存所有董事會會議之會議記錄。會議記錄初稿一般將於各會議後一段合理時間內分發予董事，而定稿將可供董事查閱。

根據現行董事會常規，任何涉及主要股東或董事利益衝突之重大交易將由董事會於正式召開之董事會會議上考慮及處理。本公司之組織章程細則亦載有條文，規定董事就批准該等董事或彼等任何聯繫人士擁有重大利益之交易於會議上放棄投票，且不計入會議法定人數。

RISK MANAGEMENT AND INTERNAL CONTROLS

The Board acknowledges its responsibility for the Group's risk management and internal control systems and reviewing their effectiveness to safeguard interests of shareholders, customers, employees and the Group's assets. Such systems are designed to manage rather than eliminate the risk of failure to achieve business objectives, and can only provide reasonable and not absolute assurance against material misstatement or loss.

The Board has the overall responsibility for evaluating and determining the nature and extent of the risks it is willing to take in achieving the Company's strategic objectives, and establishing and maintaining appropriate and effective risk management and internal control systems. The Audit Committee assists the Board in leading the management and overseeing their design, implementation and monitoring of the risk management and internal control systems.

The Group's risk management and internal control systems have been developed with the following principles, features and processes:

- (1) Identify significant risks in the Group's operation environment;
- (2) Evaluate the impacts of those risks on the Group's business and the likelihood of occurrence;
- (3) Determine the risk management strategies and internal control processes to prevent, avoid or mitigate the risks; and
- (4) Perform ongoing monitoring, review and revise the strategies and processes in case of any significant change of situation, ensuring effective communication to the Audit Committee and the Board on all findings and the effectiveness of the systems regularly.

The Internal Audit Department as well as the external professional firm engaged by the Company for providing the internal audit function are responsible for performing independent review of the adequacy and effectiveness of the risk management and internal control systems. The Internal Audit Department with the support of the external professional firm examined key issues in relation to the accounting practices and all material controls and provided its findings and recommendations for improvement to the Audit Committee.

風險管理及內部監控

董事會確認其有關本集團之風險管理及內部監控系統，以及檢討其保障股東權益、客戶、僱員及本公司資產之成效的責任。該等系統乃旨在管理而非消除未能達成業務目標之風險，而且只能就不會有重大失實陳述或損失作出合理而非絕對保證。

董事會有整體責任評估及釐定本集團為達成其策略目標所願承擔的風險性質及程度，並建立及維持本集團合適而有效的風險管理及內部監控系統。審核委員會協助董事會帶領管理層並監察彼等就風險管理及內部監控系統的設計、推行和監管。

本公司制訂的風險管理及內部監控系統之原則、特點及程序如下：

- (1) 識別本集團營運環境的主要風險；
- (2) 評核該等風險對本集團業務的影響及發生的可能性；
- (3) 確定風險管理策略及內部監控程序以防止、避免或緩解該等風險；及
- (4) 當有任何重大的情況轉變時，持續監察、檢討及修訂該等策略及程序，確保定期就所得結果及系統的成效與審核委員會及董事會有效地溝通。

內部審計部門以及本公司委聘的提供內部審計職能的外部專業公司負責就風險管理及內部監控系統的充分性和成效進行獨立審查。內部審計部門在外部專業公司的支持下審查有關會計常規及所有重大監控的主要事項，並向審核委員會提供其結論及改善建議。

The Board, as supported by the Audit Committee as well as the management report and the internal audit findings, reviewed the Group's risk management and internal control systems, including major financial, operational and compliance controls, as well as risk management functions, for the year ended 31 December 2019, and considered that such systems are effective and adequate. The annual review also covered the resources, staff qualifications and experiences, training programmes and budget of the Group's accounting, financial reporting and internal audit functions, which also considered to be adequate. In addition, the management has confirmed to the Board and the Audit Committee on the effectiveness of the risk management and internal control systems for the year ended 31 December 2019.

The Group regulates the handling and dissemination of inside information according to internal procedures and policy so as to ensure inside information remains confidential until the disclosure of such information is appropriately approved, and the dissemination of such information is efficiently and consistently made.

The Board assesses the likely impact of any unexpected and significant event that may impact the share price and/or trading volume and decides whether the relevant information is considered inside information and needs to be disclosed as soon as reasonably practicable pursuant to Rules 13.09 and 13.10 of the Listing Rules and the Inside Information Provisions under Part XIVA of the Securities and Futures Ordinance. The Group has strictly prohibited unauthorized use of confidential or inside information and has established and implemented procedures for responding to external enquiries about the Group's affairs, so that only the executive directors and company secretary are authorized to communicate with parties outside the Group.

截至2019年12月31日止年度，董事會在審核委員會、管理報告及內部審計結果的支持下，審閱風險管理及內部監控系統，包括主要財務、運作及合規監控及風險管理職能，並認為該等系統有效和充分。該年度審閱亦涵蓋資源、員工資歷及經驗、培訓計劃及本集團會計、財務報告的預算及內部審計職能，並視為充分。此外，截至2019年12月31日止年度，管理層已向董事會及審核委員會確認風險管理及內部監控系統的成效。

本集團根據內部程序及政策，對內幕消息的處理和發佈進行規範，以確保內幕消息在獲適當批准披露前一直保密，並確保能盡快及一致地發佈有關消息。

PRINCIPAL ACTIVITIES

The principal activity of the Company is investment holding. Details of the principal activities of the principal subsidiaries are set out in note 1 to the financial statements. There were no significant changes in the nature of the Group's principal activities during the year.

RESULTS AND DIVIDENDS

The Group's profit for the year ended 31 December 2019 and the Group's financial position at that date are set out in the financial statements on pages 64 to 67.

An interim dividend of HK1.5 cents (2018: HK2.0 cents) per share was paid on 27 September 2019.

The Company has adopted a Dividend Policy with effect from 20 December 2018. Subject to the relevant laws and the articles of association of the Company, the Company, through a general meeting, may declare dividends in any currency but no dividend shall be declared in excess of the amount recommended by the Board.

Dividends may be declared and paid out of profit, or from any reserve set aside from profits, share premium account or any other fund or account which can be authorised for this purpose in accordance with the Companies Law of the Cayman Islands and the articles of association of the Company.

The Company's ability to declare and pay dividends will depend on the availability of dividends received from its subsidiaries, including its subsidiaries in the PRC. For the purpose of declaration of dividend, the amount which the Company and its subsidiaries can legally distribute by way of dividend is reference to the profits as reflected in their PRC statutory financial statements prepared in accordance with PRC generally accepted accounting practices.

Subject to the availability of the Company's cash and distributable reserves, investment requirements, cashflows and working capital requirements and the approval of the shareholders of the Company, where dividend is being declared in any particular financial year, the total amount of payment shall be approximately 40% of any net distributable profits derived from ordinary activities during such given financial year.

The Board has recommended the payment of a final dividend of HK1.0 cent (2018: HK2.0 cents) per share for the year ended 31 December 2019 to shareholders whose names appear on the register of members of the Company at the close of business on Monday, 1 June 2020. The proposed final dividend is subject to the approval of the shareholders at the forthcoming annual general meeting.

BUSINESS REVIEW

A review of the business of the Group for the year and a discussion on the Group's future business development and the principal risks and uncertainties facing the Group are provided in the Management Discussion and Analysis on pages 13 to 20 which form part of the Directors' Report. An analysis of the Group's performance during the year using financial key performance indicators is provided in the Financial and Operating Highlights on page 2 which forms part of the Directors' Report but not part of the audited financial statements. No important event affecting the Group has occurred since the end of the financial year under review.

The Group is committed to supporting environmental sustainability. Being an integrated service provider that specialized in the handling and storage of liquid petrochemical products in the PRC, the Group is subject to various environmental laws and regulations set by the PRC national, provincial and municipal governments. These include regulations on air and noise pollutions and petrochemical storage.

Pursuant to the Deed, each of the Covenantors shall procure that their respective associates shall not directly or indirectly engage in any business in competition with the existing business activity of the Group. Relevant information on the Deed was disclosed in the Prospectus in the section headed “Relationship with Controlling Shareholders”.

The Company has received confirmations from the Covenantors of their compliance with the terms of the Deed. The Covenantors declared that they have fully complied with the Deed for the year ended 31 December 2019. The independent non-executive directors have reviewed on the confirmations from the Covenantors and concluded that the Deed has been complied with and has been effectively enforced.

(A) 2018 Ningbo Storage Agreement (Renewed)

On 28 December 2018, Ningbo Ningxiang and Ningbo FTZ Dragon Crown entered into the 2018 Ningbo Storage Agreement (Renewed), pursuant to which Ningbo Ningxiang agreed to provide Ningbo FTZ Dragon Crown with terminal and storage services at the Group's terminal in Ningbo. The term of the 2018 Ningbo Storage Agreement (Renewed) is for the period of three years from 1 January 2019 to 31 December 2021.

關連交易

本集團於年內進行以下非豁免持續關連交易。

(A) 2018年寧波儲存協議(經更新)

於2018年12月28日，寧波寧翔與寧波保稅區龍翔訂立2018年寧波儲存協議(經更新)，據此，寧波寧翔同意於本集團的寧波碼頭為寧波保稅區龍翔提供碼頭及儲存服務。2018年寧波儲存協議(經更新)由2019年1月1日至2021年12月31日止為期三年。

Ningbo FTZ Dragon Crown is a wholly-owned subsidiary of Dragon Crown Investments Limited which in turn is owned as to 98% by Mr. NG, a director and a controlling shareholder and as to 2% by Mr. CHONG, a director. It is principally engaged in trading of chemicals. According to the Listing Rules, Ningbo FTZ Dragon Crown is an associate of Mr. NG and thus a connected person. As Ningbo FTZ Dragon Crown is a connected person of the Company, the transactions contemplated under the 2018 Ningbo Storage Agreement (Renewed) constitute continuing connected transactions of the Company under Rule 14A.31 of the Listing Rules.

The fees for the services provided are principally determined by (i) the quantity of the liquid chemical products handled by Ningbo Ningxiang; and (ii) the period for the storage of the liquid chemical products at the terminal. The price will be negotiated and agreed between both parties with reference to the market price and the management will take into account the price range charged by other service providers for the same services within the port. This is to ensure that the terms offered by Ningbo FTZ Dragon Crown to Ningbo Ningxiang are no less favourable than those offered by other independent third parties in the ordinary course of business.

(B) Ningbo Port Loading, Discharging and Storage Agreement

On 22 January 2019, Ningbo Ningxiang and Ningbo Zhenhai entered into the Ningbo Port Loading, Discharging and Storage Agreement, pursuant to which Ningbo Zhenhai agreed to provide Ningbo Ningxiang with loading, discharging and storage services at the terminal in Ningbo. The term of the Ningbo Port Loading, Discharging and Storage Agreement is for the period from 22 January 2019 to 31 December 2019.

Ningbo Zhoushan Port Company Limited ("Ningbo Port") is a substantial shareholder of Ningbo Ningxiang and Ningbo Xinxiang, owning 40% equity interests in Ningbo Ningxiang and Ningbo Xinxiang. Each of Ningbo Ningxiang and Ningbo Xinxiang is deemed to be a subsidiary of the Company under the Listing Rules by virtue of being a subsidiary undertaking as defined in schedule 1 to the Companies Ordinance (Cap 622). Ningbo Port, being a substantial shareholder of subsidiaries of the Company, is considered as a connected person of the Company under the Listing Rules. Ningbo Zhenhai, being a branch company of Ningbo Port, is also considered as a connected person of the Company under the Listing Rules.

寧波保稅區龍翔為龍翔化工國際有限公司的全資附屬公司，而龍翔化工國際由董事兼控股股東吳先生擁有98%，及董事莊先生擁有2%。其主要從事化學品貿易。根據上市規則，寧波保稅區龍翔為吳先生的聯繫人士，因此為關連人士。由於寧波保稅區龍翔為本公司的關連人士，故2018年寧波儲存協議（經更新）項下擬進行的交易將構成本公司於上市規則第14A.31條下的持續關連交易。

提供服務的費用主要按照(i)寧波寧翔所處理液體化學品的數量；及(ii)在碼頭儲存液體化學品的期間釐定。價格將由雙方參考市價磋商及協議，且管理層將考慮其他服務供應商就港口內相同服務所收取的價格範圍。這是為了保證寧波保稅區龍翔提供予寧波寧翔的條款不遜於其他獨立第三方於日常業務過程中所提供的條款。

(B) 寧波港接卸及儲存協議

於2019年1月22日，寧波寧翔與寧波鎮海訂立寧波港接卸及儲存協議，據此，寧波鎮海同意在寧波碼頭為寧波寧翔提供接卸及儲存服務。寧波港接卸及儲存協議由2019年1月22日至2019年12月31日止。

寧波舟山港股份有限公司（「寧波港」）是寧波寧翔及寧波新翔的主要股東，擁有寧波寧翔及寧波新翔40%股權。寧波寧翔及寧波新翔各自為香港法例第622章公司條例附表1所界定的附屬企業，故根據上市規則被視為本公司的附屬公司。寧波港為本公司附屬公司的主要股東，根據上市規則被視為本公司的關連人士。寧波鎮海作為寧波港的分公司，根據上市規則亦被視為本公司的關連人士。

As Ningbo Zhenhai is a connected person of the Company, the transactions contemplated under the Ningbo Port Loading, Discharging and Storage Agreement constitute continuing connected transactions of the Company under Rule 14A.31 of the Listing Rules.

The fees payable by the Group to Ningbo Zhenhai for the services provided are principally determined by (i) the quantity of the liquid chemical products handled by Ningbo Zhenhai; and (ii) the period for the storage of the liquid chemical products at the terminal in Ningbo. The price will be negotiated and agreed between both parties with reference to the market price. The Group considered the following factors in order of priority before the determination of the fees payable by the Group to Ningbo Zhenhai under the Ningbo Port Loading, Discharging and Storage Agreement:

- i) Similar to Ningbo Zhenhai, Ningbo Ningxiang also provides liquid chemical terminal and storage services to its customers at the Group's terminal in Ningbo. Ningbo Ningxiang may purchase liquid chemical terminal and storage service from third party suppliers of liquid chemical terminal and storage services to meet the demand from its customers from time to time. The Group would ensure that the price payable by the Group to Ningbo Zhenhai under the Ningbo Port Loading, Discharging and Storage Agreement is more favorable than the price offered by Ningbo Ningxiang to its customers for the provision of liquid chemical terminal and storage services with an acceptable profit margin.
- ii) By obtaining quotations from not less than two Independent Third Parties suppliers of liquid chemical terminal and storage services at the terminals in Ningbo in the ordinary and usual course of business, the Group would ensure that the price payable by the Group to Ningbo Zhenhai under the Ningbo Port Loading, Discharging and Storage Agreement is no less favorable than the market prices.

由於寧波鎮海為本公司的關連人士，故寧波港接卸及儲存協議項下擬進行的交易將構成本公司於上市規則第14A.31條下的持續關連交易。

本集團就所獲服務應付寧波鎮海的費用主要按(i)寧波鎮海所處理液體化學品的數量；及(ii)在寧波碼頭儲存液體化學品的期間釐定。價格將由雙方參考市價磋商及協定。本集團於釐定寧波港接卸及儲存協議下應付寧波鎮海的費用前按先後次序考慮下列因素：

- i) 寧波寧翔於本集團的寧波碼頭為其客戶提供與寧波鎮海類似的液體化學品碼頭及儲存服務。寧波寧翔不時會向液體化學品碼頭及儲存服務的第三方供應商購買液體化學品碼頭及儲存服務，以滿足其客戶的需求。本集團將確保本集團根據寧波港接卸及儲存協議應付寧波鎮海的價格較寧波寧翔向其客戶提供的液體化學品碼頭及儲存服務之價格更為優惠，以享有可接受的利潤率。
- ii) 本集團透過按日常及一般業務過程從不少於兩個寧波碼頭液體化學品碼頭及儲存服務的獨立第三方供應商獲得報價，將確保本集團根據寧波港接卸及儲存協議應付寧波鎮海的價格不遜於市場價格。

Since the Group is under no obligation to enter into any actual transaction under the Ningbo Port Loading, Discharging and Storage Agreement unless it is satisfied that the price and terms of the proposed transactions after considering the above factors, the Directors believe that such procedures can ensure that the transactions contemplated by the Ningbo Port Loading, Discharging and Storage Agreement will be conducted on normal commercial terms (including the prices) or on terms no less favourable than those offered by Independent Third Parties.

The independent non-executive directors of the Company have, for the purpose of Rule 14A.55 of the Listing Rules, reviewed the continuing connected transactions set out above and have confirmed that these continuing connected transactions have been entered into by the Group (i) in the ordinary and usual course of its business; (ii) on normal commercial terms or better; and (iii) according to the agreement governing them on terms that are fair and reasonable and in the interests of the Company's shareholders as a whole.

Pursuant to Rule 14A.56 of the Listing Rules, the Company's auditor was engaged to report on the Group's continuing connected transactions in accordance with Hong Kong Standard on Assurance Engagements 3000 (Revised) "Assurance Engagements Other Than Audits or Reviews of Historical Financial Information" and with reference to Practice Note 740 "Auditor's Letter on Continuing Connected Transactions under the Hong Kong Listing Rules" issued by the Hong Kong Institute of Certified Public Accountants. The auditor has not qualified its report in respect of the continuing connected transactions disclosed above by the Group. A copy of the auditor's letter confirming the matters set out under Rule 14A.56 of the Listing Rules has been provided by the Company to the Stock Exchange.

由於本集團並無責任根據寧波港接卸及儲存協議進行任何實際交易，除非經考慮上述因素後本集團滿意擬進行交易的價格及條款，因此董事認為該等程序可確保寧波港接卸及儲存協議項下擬進行的交易將按一般商業條款（包括價格）或不遜於獨立第三方提供之條款進行。

就上市規則第14A.55條而言，本公司獨立非執行董事已審核上述所載的持續關連交易，並確認該等持續關聯交易已由本集團於下列情況中訂立 (i) 屬本集團的日常業務；(ii) 按一般商務條款或更佳條款進行；及(iii) 根據有關交易的協議進行，有關條款公平合理並且符合本公司股東的整體利益。

根據上市規則第14A.56條，本公司之核數師已獲聘依照香港會計師公會頒佈的《香港核證工作準則》第3000號（經修訂）「對過往財務資料進行審計或審閱以外的核證工作」及參照應用指引第740號「關於香港《上市規則》所述持續關連交易的核數師函件」報告本集團的持續關連交易。就本集團以上披露的持續關連交易，核數師於其報告內並未發出保留意見。確認上市規則第14A.56條所載事項之核數師函件副本已由本公司提交予聯交所。

OPINION

We have audited the consolidated financial statements of Dragon Crown Group Holdings Limited (the “Company”) and its subsidiaries (the “Group”) set out on pages 64 to 173, which comprise the consolidated statement of financial position as at 31 December 2019, and the consolidated statement of profit or loss, the consolidated statement of comprehensive income, the consolidated statement of changes in equity and the consolidated statement of cash flows for the year then ended, and notes to the consolidated financial statements, including a summary of significant accounting policies.

Basis of consolidation

The consolidated financial statements include the financial statements of the Company and its subsidiaries (collectively referred to as the “Group”) for the year ended 31 December 2019. A subsidiary is an entity (including a structured entity), directly or indirectly, controlled by the Company. Control is achieved when the Group is exposed, or has rights, to variable returns from its involvement with the investee and has the ability to affect those returns through its power over the investee (i.e., existing rights that give the Group the current ability to direct the relevant activities of the investee).

When the Company has, directly or indirectly, less than a majority of the voting or similar rights of an investee, the Group considers all relevant facts and circumstances in assessing whether it has power over an investee, including:

- (a) the contractual arrangement with the other vote holders of the investee;
- (b) rights arising from other contractual arrangements; and
- (c) the Group’s voting rights and potential voting rights.

The financial statements of the subsidiaries are prepared for the same reporting period as the Company, using consistent accounting policies. The results of subsidiaries are consolidated from the date on which the Group obtains control, and continue to be consolidated until the date that such control ceases.

All intra-group assets and liabilities, equity, income, expenses and cash flows relating to transactions between members of the Group are eliminated in full on consolidation.

The Group reassesses whether or not it controls an investee if facts and circumstances indicate that there are changes to one or more of the three elements of control described above. A change in the ownership interest of a subsidiary, without a loss of control, is accounted for as an equity transaction.

If the Group loses control over a subsidiary, it derecognises (i) the assets (including goodwill) and liabilities of the subsidiary, (ii) the carrying amount of any non-controlling interest and (iii) the cumulative translation differences recorded in equity; and recognises (i) the fair value of the consideration received, (ii) the fair value of any investment retained and (iii) any resulting surplus or deficit in profit or loss. The Group's share of components previously recognised in other comprehensive income is reclassified to profit or loss or retained profits, as appropriate, on the same basis as would be required if the Group had directly disposed of the related assets or liabilities.

The standard sets out the principles for the recognition, measurement, presentation and disclosure of leases and requires lessees to account for all leases under a single on-balance sheet model to recognise and measure right-of-use assets and lease liabilities, except for certain recognition exemptions. Lessor accounting under HKFRS 16 is substantially unchanged from HKAS 17. Lessors continue to classify leases as either operating or finance leases using similar principles as in HKAS 17. Therefore, HKFRS 16 did not have any financial impact on leases where the Group is the lessor.

The Group has adopted HKFRS 16 using the modified retrospective method with the date of initial application of 1 January 2019. Under this method, the standard has been applied retrospectively with the cumulative effect of initial adoption recognised as an adjustment to the opening balance of retained profits at 1 January 2019, and the comparative information for 2018 was not restated and continued to be reported under HKAS 17 and related interpretations.

New definition of a lease

Under HKFRS 16, a contract is, or contains, a lease if the contract conveys a right to control the use of an identified asset for a period of time in exchange for consideration. Control is conveyed where the customer has both the right to obtain substantially all of the economic benefits from use of the identified asset and the right to direct the use of the identified asset. The Group elected to use the transition practical expedient allowing the standard to be applied only to contracts that were previously identified as leases applying HKAS 17 and HK(IFRIC)-Int 4 at the date of initial application. Contracts that were not identified as leases under HKAS 17 and HK(IFRIC)-Int 4 were not reassessed. Amendments to HKFRS 3 clarify and provide additional guidance on the definition of a business. The amendments clarify that for an integrated set of activities and assets to be considered a business, it must include, at a minimum, an input and a substantive process that together significantly contribute to the ability to create output. A business can exist without including all of the inputs and processes needed to create outputs. The amendments remove the assessment of whether market participants are capable of acquiring the business and continue to produce outputs. Instead, the focus is on whether acquired inputs and acquired substantive processes together significantly contribute to the ability to create outputs. The amendments have also narrowed the definition of outputs to focus on goods or services provided to customers, investment income or other income from ordinary activities. Furthermore, the amendments provide guidance to assess whether an acquired process is substantive and introduce an optional fair value concentration test to permit a simplified assessment of whether an acquired set of activities and assets is not a business. The Group expects to adopt the amendments prospectively from 1 January 2020. Since the amendments apply prospectively to transactions or other events that occur on or after the date of first application, the Group will not be affected by these amendments on the date of transition.

香港財務報告準則第3號修訂對業務的定義澄清及提供額外指引。該修訂訂明一項完整活動及資產組合可視為一個業務，必須至少包括一項資源投入及一項實質過程，而兩者必須對創造產出的能力有重大貢獻。業務之存在毋須包括創造產出所需的所有資源投入及過程。該修訂移除對市場參與者是否有能力收購業務並能持續創造產出的評估，轉為重點關注所取得的資源投入及實質過程共同對形成產出的能力有否重大貢獻。該修訂亦已收窄產出的定義範圍，重點關注為客戶提供的商品或服務、投資收入或日常活動產生的其他收入。此外，該修訂亦提供有關評估所取得的過程是否重大的指引，並新增公平價值集中度測試選項，允許對所取得的一項活動和資產組合是否不屬於業務進行簡化評估。本集團預期自2020年1月1日起前瞻性採納該等修訂。由於該等修訂預期適用於首次應用日期或之後發生之交易或其他事件，故本集團於過渡日期將不受該等修訂影響。

Amendments to HKFRS 10 and HKAS 28 (2011) address an inconsistency between the requirements in HKFRS 10 and in HKAS 28 (2011) in dealing with the sale or contribution of assets between an investor and its associate or joint venture. The amendments require a full recognition of a gain or loss when the sale or contribution of assets between an investor and its associate or joint venture constitutes a business. For a transaction involving assets that do not constitute a business, a gain or loss resulting from the transaction is recognised in the investor's profit or loss only to the extent of the unrelated investor's interest in that associate or joint venture. The amendments are to be applied prospectively. The previous mandatory effective date of amendments to HKFRS 10 and HKAS 28 (2011) was removed by the HKICPA in January 2016 and a new mandatory effective date will be determined after the completion of a broader review of accounting for associates and joint ventures. However, the amendments are available for adoption now.

Amendments to HKAS 1 and HKAS 8 provide a new definition of material. The new definition states that information is material if omitting, misstating or obscuring it could reasonably be expected to influence decisions that the primary users of general purpose financial statements make on the basis of those financial statements. The amendments clarify that materiality will depend on the nature or magnitude of information. A misstatement of information is material if it could reasonably be expected to influence decisions made by the primary users. The Group expects to adopt the amendments prospectively from 1 January 2020. The amendments are not expected to have any significant impact on the Group's financial statements.

香港會計準則第1號及香港會計準則第8號修訂本為重大性提供了新的定義。新定義指出，如果可合理預計漏報、錯報或掩蓋某信息會影響通用目的財務報表的主要使用者，基於該等財務報表作出的決策，則該信息具有重大性。該修訂澄清，重大性將取決於信息的性質或規模。如果可合理預計對信息的錯報會對主要使用者的決策造成影響，則該錯報為重大錯報。本集團預期自2020年1月1日起前瞻性採納該等修訂。該等修訂預期不會對本集團的財務報表產生任何重大影響。

Business combinations and goodwill

Business combinations are accounted for using the acquisition method. The consideration transferred is measured at the acquisition date fair value which is the sum of the acquisition date fair values of assets transferred by the Group, liabilities assumed by the Group to the former owners of the acquiree and the equity interests issued by the Group in exchange for control of the acquiree. For each business combination, the Group elects whether to measure the non-controlling interests in the acquiree that are present ownership interests and entitle their holders to a proportionate share of net assets in the event of liquidation at fair value or at the proportionate share of the acquiree's identifiable net assets. All other components of non-controlling interests are measured at fair value. Acquisition-related costs are expensed as incurred.

When the Group acquires a business, it assesses the financial assets and liabilities assumed for appropriate classification and designation in accordance with the contractual terms, economic circumstances and pertinent conditions as at the acquisition date. This includes the separation of embedded derivatives in host contracts of the acquiree.

If the business combination is achieved in stages, the previously held equity interest is remeasured at its acquisition date fair value and any resulting gain or loss is recognised in profit or loss.

Any contingent consideration to be transferred by the acquirer is recognised at fair value at the acquisition date. Contingent consideration classified as an asset or liability is measured at fair value with changes in fair value recognised in profit or loss. Contingent consideration that is classified as equity is not remeasured and subsequent settlement is accounted for within equity.

業務合併及商譽

業務合併乃以收購法入賬。已轉讓代價按收購日期之公允值計量，該公允值為本集團所轉讓資產於收購日期之公允值、本集團向被收購方前擁有人承擔的負債及本集團為換取被收購方控制權所發行之股本權益之總和。於各業務合併中，本集團選擇是否以公允值或被收購方可識別資產淨值的應佔比例，計量於被收購方屬現時擁有人權益的非控股權益，並賦予擁有人權利，於清盤時按比例分佔實體的資產淨值。非控股權益之一切其他成分乃按公允值計量。收購相關成本於產生時列為開支。

當本集團收購一項業務時，會根據合約條款、於收購日期的經濟環境及相關條件，評估將承接的金融資產及負債，以作出適合的分類及標示，其中包括將被收購方主合約中的嵌入式衍生工具進行分離。

倘企業合併分階段進行，先前持有的股權按於收購日期的公允值重新計量，而所產生之任何收益或虧損於損益中確認。

由收購方將予轉讓的任何或然代價將於收購日期按公允值確認。分類為資產或負債的或然代價按公允值計量，相關公允值變動則於損益確認。被分類為權益的或然代價不會重新計量，且其後結算於權益內入賬。

Goodwill is initially measured at cost, being the excess of the aggregate of the consideration transferred, the amount recognised for non-controlling interests and any fair value of the Group's previously held equity interests in the acquiree over the identifiable net assets acquired and liabilities assumed. If the sum of this consideration and other items is lower than the fair value of the net assets acquired, the difference is, after reassessment, recognised in profit or loss as a gain on bargain purchase.

After initial recognition, goodwill is measured at cost less any accumulated impairment losses. Goodwill is tested for impairment annually or more frequently if events or changes in circumstances indicate that the carrying value may be impaired. The Group performs its annual impairment test of goodwill as at 31 December. For the purpose of impairment testing, goodwill acquired in a business combination is, from the acquisition date, allocated to each of the Group's cash-generating units, or groups of cash-generating units, that are expected to benefit from the synergies of the combination, irrespective of whether other assets or liabilities of the Group are assigned to those units or groups of units.

Impairment is determined by assessing the recoverable amount of the cash-generating unit (group of cash-generating units) to which the goodwill relates. Where the recoverable amount of the cash-generating unit (group of cash-generating units) is less than the carrying amount, an impairment loss is recognised. An impairment loss recognised for goodwill is not reversed in a subsequent period.

Where goodwill has been allocated to a cash-generating unit (or group of cash-generating units) and part of the operation within that unit is disposed of, the goodwill associated with the operation disposed of is included in the carrying amount of the operation when determining the gain or loss on the disposal. Goodwill disposed of in these circumstances is measured based on the relative value of the operation disposed of and the portion of the cash-generating unit retained.

商譽起初按成本計量，即已轉讓總代價、已確認非控股權益及本集團先前持有的被收購方股權的公允值總額，超逾所收購可識別資產淨值及所承擔負債的差額。如代價及其他項目的金額低於所收購資產淨值的公允值，於評估後其差額將於損益中確認為議價購買收益。

於初始確認後，商譽按成本減任何累計減值虧損計量。商譽須每年作減值測試，若有事件發生或情況改變顯示賬面值有可能減值時，則會更頻密地進行檢討。本集團於12月31日進行商譽之年度減值測試。為進行減值測試，無論本集團其他資產或負債是否已分配予該等單位或單位組別，因業務合併而購入的商譽自購入之日被分配至預期可從合併產生的協同效益中獲益的本集團各個現金產生單位或現金產生單位組別。

減值乃通過評估與商譽有關的現金產生單位(或現金產生單位組別)的可收回金額釐定。當現金產生單位(或現金產生單位組別)的可收回金額低於賬面金額時，減值虧損便予以確認。已就商譽確認的減值虧損不得於未來期間撥回。

Investments in associates and joint ventures

An associate is an entity in which the Group has a long term interest of generally not less than 20% of the equity voting rights and over which it is in a position to exercise significant influence. Significant influence is the power to participate in the financial and operating policy decisions of the investee, but is not control or joint control over those policies.

A joint venture is a type of joint arrangement whereby the parties that have joint control of the arrangement have rights to the net assets of the joint venture. Joint control is the contractually agreed sharing of control of an arrangement, which exists only when decisions about the relevant activities require the unanimous consent of the parties sharing control.

The Group's investments in associates and joint ventures are stated in the consolidated statement of financial position at the Group's share of net assets under the equity method of accounting, less any impairment losses. Adjustments are made to bring into any dissimilar accounting policies that may exist. The Group's share of the post-acquisition results and other comprehensive income of associates and joint ventures is included in the consolidated statement of profit or loss and consolidated other comprehensive income, respectively. In addition, when there has been a change recognised directly in the equity of the associate or joint venture, the Group recognises its share of any changes, when applicable, in the consolidated statement of changes in equity. Unrealised gains and losses resulting from transactions between the Group and its associates or joint ventures are eliminated to the extent of the Group's investments in the associates or joint ventures, except where unrealised losses provide evidence of an impairment of the assets transferred. Goodwill arising from the acquisition of associates or joint ventures is included as part of the Group's investments in associates or joint ventures.

於聯營公司及合營企業之投資

聯營公司為本集團於其中一般性持有股本投票權不少於20%的長期權益，並可對其行使重大影響力的實體。重大影響力乃有權參與投資對象之財務及經營政策決定而非控制或共同控制該等政策。

合營企業指一種共同安排，對安排擁有共同控制權之訂約方據此對合營企業之資產淨值擁有權利。共同控制指按照合約協定對一項安排所共有之控制，共同控制僅在有關活動要求享有控制權之訂約方作出一致同意之決定時存在。

本集團於聯營公司及合營企業的投資於本集團綜合財務狀況表內按權益會計法以本集團應佔資產淨值列賬，並扣減任何減值虧損。若會計政策有差異，則會調整一致。本集團應佔聯營公司及合營企業收購後的業績及其他全面收入分別於綜合損益表及綜合其他全面收益表內確認。此外，當已有變動直接確認於聯營公司或合營企業的權益時，本集團會將其分佔的任何變動於綜合權益變動表中確認(倘適用)。本集團與其聯營公司或合營企業之間交易所產生的未變現收益及虧損乃按本集團所佔聯營公司或合營企業的投資抵銷，惟未變現虧損證明已轉讓的資產出現減值除外。收購聯營公司或合營企業所產生的商譽將計入本集團於聯營公司或合營企業投資的一部分。

If an investment in an associate becomes an investment in a joint venture or vice versa, the retained interest is not remeasured. Instead, the investment continues to be accounted for under the equity method. In all other cases, upon loss of significant influence over the associate or joint control over the joint venture, the Group measures and recognises any retained investment at its fair value. Any difference between the carrying amount of the associate or joint venture upon loss of significant influence or joint control and the fair value of the retained investment and proceeds from disposal is recognised in profit or loss.

Impairment of non-financial assets

Where an indication of impairment exists, or when annual impairment testing for an asset is required (other than inventories, deferred tax assets and financial assets), the asset's recoverable amount is estimated. An asset's recoverable amount is the higher of the asset's or cash-generating unit's value in use and its fair value less costs of disposal, and is determined for an individual asset, unless the asset does not generate cash inflows that are largely independent of those from other assets or groups of assets, in which case the recoverable amount is determined for the cash-generating unit to which the asset belongs.

An impairment loss is recognised only if the carrying amount of an asset exceeds its recoverable amount. In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset. An impairment loss is charged to the statement of profit or loss in the period in which it arises in those expense categories consistent with the function of the impaired asset.

倘於聯營公司之投資變為於合營企業之投資或出現相反情況，則不會重新計量保留權益。取而代之，該投資繼續根據權益法入賬。在所有其他情況下，於失去對聯營公司的重大影響力或合營企業的共同控制後，本集團按公允值計量及確認任何保留投資。於失去重大影響力或共同控制後聯營公司或合營企業的賬面值與保留投資及來自出售所得款項的公允值之間的差額於損益確認。

非金融資產減值

倘有跡象顯示出現減值或須就資產進行年度減值測試(存貨、遞延稅項資產及金融資產除外)，則會估計資產的可收回數額。資產的可收回數額為資產或現金產生單位的使用價值以及公允值減出售成本(以較高者為準)，並就個別資產而確定，除非有關資產並無產生現金流入，且在頗大程度上獨立於其他資產或資產類別。在此情況下，可收回數額就資產所屬的現金產生單位而確定。

只有當資產的賬面值超出其可收回值時，減值虧損才予以確認。在評估使用價值時，估計未來現金流量乃按稅前折現率折現至彼等的現值，而稅前折現率乃反映現時市場就金錢時間價值及資產特定風險的評估。減值虧損將於其產生期間於損益表內與減值資產功能一致的開支類別中扣除。

An assessment is made at the end of each reporting period as to whether there is an indication that previously recognised impairment losses may no longer exist or may have decreased. If such an indication exists, the recoverable amount is estimated. A previously recognised impairment loss of an asset other than goodwill is reversed only if there has been a change in the estimates used to determine the recoverable amount of that asset, but not to an amount higher than the carrying amount that would have been determined (net of any depreciation/amortisation) had no impairment loss been recognised for the asset in prior years. A reversal of such an impairment loss is credited to the statement of profit or loss in the period in which it arises.

Property, plant and equipment and depreciation

Property, plant and equipment, other than construction in progress, are stated at cost less accumulated depreciation and any impairment losses. The cost of an item of property, plant and equipment comprises its purchase price and any directly attributable costs of bringing the asset to its working condition and location for its intended use.

Expenditure incurred after items of property, plant and equipment have been put into operation, such as repairs and maintenance, is normally charged to the statement of profit or loss in the period in which it is incurred. In situations where the recognition criteria are satisfied, the expenditure for a major inspection is capitalised in the carrying amount of the asset as a replacement. Where significant parts of property, plant and equipment are required to be replaced at intervals, the Group recognises such parts as individual assets with specific useful lives and depreciates them accordingly.

在每個報告期末會評估有否於任何過往已確認的資產減值虧損可能不再存在或可能減少的跡象。倘出現任何該等跡象，會估計可收回數額。只有當用以確定資產可收回值的估計出現更改時，才可將以往確認的資產(商譽除外)減值虧損撥回，但有關價值並不可高於假設過往年度並無就該資產確認任何減值虧損的情況下，該資產本來確定的賬面值(經扣除任何折舊／攤銷)。減值虧損撥回至其產生期間的損益表中。

物業、廠房及設備以及折舊

物業、廠房及設備(在建工程除外)乃按成本減累計折舊及任何減值虧損列賬。物業、廠房及設備項目的成本包括其購買價及任何使資產達至營運狀況及地點作擬定用途的直接應佔成本。

物業、廠房及設備項目投入運作後所產生維修保養等支出，一般於其產生期間自損益表扣除。倘達到確認條件，則重大檢查的開支會於資產賬面值中資本化作為替換。倘物業、廠房及設備的重大部分須定期替換，則本集團會將該等部分確認為有特定可使用年期的個別資產，並作出相應折舊。

Depreciation is calculated on the straight-line basis to write off the cost of each item of property, plant and equipment to its residual value over its estimated useful life. The principal annual rates used for this purpose are as follows:

Where parts of an item of property, plant and equipment have different useful lives, the cost of that item is allocated on a reasonable basis among the parts and each part is depreciated separately. Residual values, useful lives and the depreciation method are reviewed, and adjusted if appropriate, at least at each financial year end.

An item of property, plant and equipment including any significant part initially recognised is derecognised upon disposal or when no future economic benefits are expected from its use or disposal. Any gain or loss on disposal or retirement recognised in the statement of profit or loss in the year the asset is derecognised is the difference between the net sales proceeds and the carrying amount of the relevant asset.

Construction in progress represents the infrastructure of a terminal under construction, which is stated at cost less any impairment losses, and is not depreciated. Cost comprises the direct costs of construction and capitalised borrowing costs on related borrowed funds during the period of construction. Construction in progress is reclassified to the appropriate category of property, plant and equipment when completed and ready for use.

當一項物業、廠房及設備項目的其中部分擁有不同的可用年期，該部分的成本會以合理原則分攤並將各部分單獨計提折舊。剩餘價值、可用年期及折舊方法將至少於各財政年末複核及按需要作出調整。

物業、廠房及設備項目包括經首次確認的任何重要部分，乃於出售後或預期將來其用途或出售並無經濟利益時取消確認。於資產取消確認的年內，於損益表中確認的出售或報廢的任何收益或虧損乃出售所得款項淨額與相關資產賬面值之差額。

在建工程指興建中的碼頭基礎設施，乃按成本減任何減值虧損列賬，但不會計提折舊。成本包括建造期間的直接建設成本及有關借款資金的借款成本資本化。在建工程於完工且可供使用時將重新歸入物業、廠房及設備的適當類別。

The Group assesses at contract inception whether a contract is, or contains, a lease. A contract is, or contains, a lease if the contract conveys the right to control the use of an identified asset for a period of time in exchange for consideration.

Group as a lessee

The Group applies a single recognition and measurement approach for all leases, except for short-term leases and leases of low-value assets. The Group recognises lease liabilities to make lease payments and right-of-use assets representing the right to use the underlying assets.

At inception or on reassessment of a contract that contains a lease component, the Group allocates the consideration in the contract to each lease and non-lease component on the basis of their standard-alone prices. A practical expedient is available to a lessee, which the Group has adopted, not to separate non-lease components and to account for the lease and the associated non-lease components (e.g., property management services for leases of properties) as a single lease component.

The cost of right-of-use assets includes the amount of lease liabilities recognised, initial direct costs incurred, and lease payments made at or before the commencement date less any lease incentives received. Where applicable, the cost of a right-of-use asset also includes an estimate of costs to dismantle and remove the underlying asset or to restore the underlying asset or the site on which it is located. Right-of-use assets are depreciated on a straight-line basis over the shorter of the lease terms and the estimated useful lives of the assets as follows:

If ownership of the leased asset transfers to the Group by the end of the lease term or the cost reflects the exercise of a purchase option, depreciation is calculated using the estimated useful life of the asset.

(b) Lease liabilities

Lease liabilities are recognised at the commencement date of the lease at the present value of lease payments to be made over the lease term. The lease payments include fixed payments (including in-substance fixed payments) less any lease incentives receivable, variable lease payments that depend on an index or a rate, and amounts expected to be paid under residual value guarantees. The lease payments also include the exercise price of a purchase option reasonably certain to be exercised by the Group and payments of penalties for termination of a lease, if the lease term reflects the Group exercising the option to terminate. The variable lease payments that do not depend on an index or a rate are recognised as an expense in the period in which the event or condition that triggers the payment occurs.

In calculating the present value of lease payments, the Group uses its incremental borrowing rate at the lease commencement date because the interest rate implicit in the lease is not readily determinable. After the commencement date, the amount of lease liabilities is increased to reflect the accretion of interest and reduced for the lease payments made. In addition, the carrying amount of lease liabilities is remeasured if there is a modification, a change in the lease term, a change in lease payments (e.g., a change to future lease payments resulting from a change in an index or rate) or a change in assessment of an option to purchase the underlying asset.

(b) 租賃負債

租賃負債於租賃開始日期按租賃期內作出之租賃付款之現值確認。租賃付款包括固定付款(包括實質固定付款)，扣減任何應收租賃優惠款項、視乎某指數或利率而定之可變租賃付款及預期根據殘餘價值擔保支付之金額。租賃付款亦包括合理確定將由本集團行使之購買選擇權之行使價以及終止租賃之罰款付款(如租賃期反映本集團行使選擇權進行終止)。並非視乎某指數或利率而定之可變租賃付款於發生引發付款之事件或條件期間確認為開支。

(c) Short-term leases and leases of low-value assets

The Group applies the short-term lease recognition exemption to its short-term leases (that is those leases that have a lease term of 12 months or less from the commencement date and do not contain a purchase option). It also applies the recognition exemption for leases of low-value assets. When the Group enters into a lease in respect of a low-value asset, the Group decides whether to capitalise the lease on a lease-by-lease basis. Lease payments on short-term leases and leases of low-value assets are recognised as an expense on a straight-line basis over the lease term.

Group as a lessor

When the Group acts as a lessor, it classifies at lease inception (or when there is a lease modification) each of its leases as either an operating lease or a finance lease.

Leases in which the Group does not transfer substantially all the risks and rewards incidental to ownership of an asset are classified as operating leases. When a contract contains lease and non-lease components, the Group allocates the consideration in the contract to each component on a relative stand-alone selling price basis. Rental income is accounted for on a straight-line basis over the lease terms and is included in revenue in the statement of profit or loss due to its operating nature. Initial direct costs incurred in negotiating and arranging an operating lease are added to the carrying amount of the leased asset and recognised over the lease term on the same basis as rental income. Contingent rents are recognised as revenue in the period in which they are earned.

Leases that transfer substantially all the risks and rewards incidental to ownership of an underlying assets to the lessee are accounted for as finance leases.

本集團對其短期租賃(即該等於開始日期的租期為12個月或以下且不包含購買權的租賃)應用短期租賃確認豁免。其亦對低值資產應用確認豁免。當本集團就低價值資產訂立租賃時,本集團按個別租賃基準決定是否將租賃資本化。短期租賃及低值資產租賃的租賃款項按租期以直線法確認為開支。

本集團作為出租人

當本集團作為出租人時,於租賃開始時(或發生租賃變更時)將其每個租賃分類為經營租賃或融資租賃。

所有本集團並未轉讓資產所有權所附帶的絕大部分風險及回報的租賃歸類為經營租賃。倘合約包括租賃及非租賃部分,目標集團根據相對獨立的售價基準將合約代價分配予各部分。租金收入於租期內按直線法列賬並因其經營性質計入損益表之收入。於磋商及安排經營租賃時產生的初始直接成本乃計入租賃資產的賬面值,並於租期內按相同方法確認為租金收入。或然租金乃於所賺取的期間內確認為收益。

租賃中資產擁有權之絕大部分風險及回報,均轉嫁到承租人之租賃,均視作融資租賃。

Leases where substantially all the rewards and risks of ownership of assets remain with the lessor are accounted for as operating leases. Where the Group is the lessor, assets leased by the Group under operating leases are included in non-current assets, and rentals receivable under the operating leases are credited to the statement of profit or loss on the straight-line basis over the lease terms. Where the Group is the lessee, rentals payable under operating leases net of any incentives received from the lessor are charged to the statement of profit or loss on the straight-line basis over the lease terms.

Prepaid land lease payments under operating leases are initially stated at cost and subsequently recognised on the straight-line basis over the lease terms. When the lease payments cannot be allocated reliably between the land and buildings elements, the entire lease payments are included in the cost of the land and buildings as a finance lease in property, plant and equipment.

Investments and other financial assets

Initial recognition and measurement

Financial assets are classified, at initial recognition, as subsequently measured at amortised cost, fair value through other comprehensive income, and fair value through profit or loss.

The classification of financial assets at initial recognition depends on the financial asset's contractual cash flow characteristics and the Group's business model for managing them. With the exception of accounts receivable that do not contain a significant financing component or for which the Group has applied the practical expedient of not adjusting the effect of a significant financing component, the Group initially measures a financial asset at its fair value, plus in the case of a financial asset not at fair value through profit or loss, transaction costs. Accounts receivable that do not contain a significant financing component or for which the Group has applied the practical expedient are measured at the transaction price determined under HKFRS 15 in accordance with the policies set out for "Revenue recognition" below.

資產所有權的絕大部分回報及風險由出租人保留的租賃乃列為經營租賃。倘本集團是出租人，由本集團以經營租賃出租的資產會在非流動資產內列賬，而經營租賃的應收租金按租賃年期以直線法列入損益表內。倘本集團是承租人，經營租賃的應付租金扣除自出租人收取的任何優惠，按租賃年期以直線法列支於損益表。

經營租賃項下的預付土地租金初步按成本列賬，隨後按租期以直線法確認。當租金無法可靠地在土地及樓宇兩部分之間進行分配時，則全部租金作為物業、廠房及設備之融資租賃，計入土地及樓宇之成本中。

投資及其他金融資產

初步確認及計量

金融資產於初步確認時分類為其後按攤銷成本、按公允值計入其他全面收益及按公允值計入損益計量。

於初始確認時，金融資產分類取決於金融資產的合約現金流量特點及本集團管理該等金融資產的業務模式。除並無重大融資成分或本集團並未就此應用不調整重大融資成分影響實際權宜方法的應收款項外，本集團初步按其公允值加(倘並非按公允值計量且其變動計入損益的金融資產)交易成本計量金融資產。如下文「收入確認」所載政策，並無重大融資成分或本集團並未就此應用實際權宜方法的應收款項按香港財務報告準則第15號釐定的交易價格計量。

Initial recognition and measurement (continued)

In order for a financial asset to be classified and measured at amortised cost or fair value through other comprehensive income, it needs to give rise to cash flows that are solely payments of principal and interest (“SPPI”) on the principal amount outstanding. Financial assets with cash flows that are not SPPI are classified and measured at fair value through profit or loss, irrespective of the business model.

The Group’s business model for managing financial assets refers to how it manages its financial assets in order to generate cash flows. The business model determines whether cash flows will result from collecting contractual cash flows, selling the financial assets, or both. Financial assets classified and measured at amortised cost are held within a business model with the objective to hold financial assets in order to collect contractual cash flows, while financial assets classified and measured at fair value through other comprehensive income are held within a business model with the objective of both holding to collect contractual cash flows and selling. Financial assets which are not held within the aforementioned business models are classified and measured at fair value through profit or loss.

All regular way purchases and sales of financial assets are recognised on the trade date, that is, the date that the Group commits to purchase or sell the asset. Regular way purchases or sales are purchases or sales of financial assets that require delivery of assets within the period generally established by regulation or convention in the marketplace.

Subsequent measurement

The subsequent measurement of financial assets depends on their classification as follows:

Financial assets at amortised cost (debt instruments)

Financial assets at amortised cost are subsequently measured using the effective interest method and are subject to impairment. Gains and losses are recognised in the statement of profit or loss when the asset is derecognised, modified or impaired.

初步確認及計量(續)

為使金融資產按攤銷成本或按公允值計入其他全面收益進行分類及計量，需產生純粹為支付未償還本金及本金利息(「本金及利息支付」)的現金流量。現金流量不只是本金及利息支付之金融資產，其以公允價值計入損益進行分類及計量，不論其業務模式如何。

本集團管理金融資產的業務模式指其如何管理其金融資產以產生現金流量。業務模式確定現金流量是否來自收集合約現金流量、出售金融資產，或兩者兼有。以攤銷成本分類及計量的金融資產按業務模式持有，持有目的為收取合約現金流量，而以公允值計入其他全面收益分類及計量的金融資產按業務模式持有，持有目的為以收取合約現金流量及出售。不屬於上述業務模式的金融資產，則按公允值計入損益分類及計量。

金融資產的一般買賣於交易當日確認，即本集團承諾購買或出售該資產當日。一般買賣指須按市場規定或慣例於一般指定期間內交付資產的金融資產買賣。

後續計量

金融資產的後續計量按下列分類：

按攤銷成本計量的金融資產(債務工具)

按攤銷成本計量的金融資產其後使用實際利率法計量，並可能受減值影響。當資產終止確認、修訂或減值時，收益及虧損於損益表確認。

Derecognition of financial assets

A financial asset (or, where applicable, a part of a financial asset or part of a group of similar financial assets) is primarily derecognised (i.e., removed from the Group's consolidated statement of financial position) when:

- the rights to receive cash flows from the asset have expired; or
- the Group has transferred its rights to receive cash flows from the asset or has assumed an obligation to pay the received cash flows in full without material delay to a third party under a "pass-through" arrangement; and either (a) the Group has transferred substantially all the risks and rewards of the asset, or (b) the Group has neither transferred nor retained substantially all the risks and rewards of the asset, but has transferred control of the asset.

When the Group has transferred its rights to receive cash flows from an asset or has entered into a pass-through arrangement, it evaluates if, and to what extent, it has retained the risk and rewards of ownership of the asset. When it has neither transferred nor retained substantially all the risks and rewards of the asset nor transferred control of the asset, the Group continues to recognise the transferred asset to the extent of the Group's continuing involvement. In that case, the Group also recognises an associated liability. The transferred asset and the associated liability are measured on a basis that reflects the rights and obligations that the Group has retained.

Derecognition of financial assets (continued)

Continuing involvement that takes the form of a guarantee over the transferred asset is measured at the lower of the original carrying amount of the asset and the maximum amount of consideration that the Group could be required to repay.

Impairment of financial assets

The Group recognises an allowance for expected credit losses (“ECLs”) for all debt instruments not held at fair value through profit or loss. ECLs are based on the difference between the contractual cash flows due in accordance with the contract and all the cash flows that the Group expects to receive, discounted at an approximation of the original effective interest rate. The expected cash flows will include cash flows from the sale of collateral held or other credit enhancements that are integral to the contractual terms.

General approach

ECLs are recognised in two stages. For credit exposures for which there has not been a significant increase in credit risk since initial recognition, ECLs are provided for credit losses that result from default events that are possible within the next 12 months (a 12-month ECL). For those credit exposures for which there has been a significant increase in credit risk since initial recognition, a loss allowance is required for credit losses expected over the remaining life of the exposure, irrespective of the timing of the default (a lifetime ECL).

金融資產的減值

本集團確認對並非按公允值計入損益的所有債務工具預期信貸虧損(「預期信貸虧損」)的撥備。預期信貸虧損乃基於根據合約到期的合約現金流量與本集團預期收取的所有現金流量之間的差額而釐定，並以原實際利率的近似值貼現。預期現金流量將包括出售所持抵押的現金流量或組成合約條款的其他信貸提升措施。

一般方法

預期信貸虧損分兩個階段進行確認。就自初始確認起未有顯著增加的信貸風險而言，預期信貸虧損提供予由未來12個月內可能發生違約事件而導致的信貸虧損(12個月預期信貸虧損)。就自初始確認起經已顯著增加的信貸風險而言，不論何時發生違約，於餘下風險年期內的預期信貸虧損均須計提虧損撥備(全期預期信貸虧損)。

At each reporting date, the Group assesses whether the credit risk on a financial instrument has increased significantly since initial recognition. When making the assessment, the Group compares the risk of a default occurring on the financial instrument as at the reporting date with the risk of a default occurring on the financial instrument as at the date of initial recognition and considers reasonable and supportable information that is available without undue cost or effort, including historical and forward-looking information.

The Group considers a financial asset in default when contractual payments are 90 days past due. However, in certain cases, the Group may also consider a financial asset to be in default when internal or external information indicates that the Group is unlikely to receive the outstanding contractual amounts in full before taking into account any credit enhancements held by the Group. A financial asset is written off when there is no reasonable expectation of recovering the contractual cash flows.

Financial assets at amortised cost are subject to impairment under the general approach and they are classified within the following stages for measurement of ECLs except for accounts receivable and contract assets which apply the simplified approach as detailed below.

Simplified approach

For accounts receivable and contract assets that do not contain a significant financing component or when the Group applies the practical expedient of not adjusting the effect of a significant financing component, the Group applies the simplified approach in calculating ECLs. Under the simplified approach, the Group does not track changes in credit risk, but instead recognises a loss allowance based on lifetime ECLs at each reporting date. The Group has established a provision matrix that is based on its historical credit loss experience, adjusted for forward-looking factors specific to the debtors and the economic environment.

For accounts receivable that contain a significant financing component and lease receivables, the Group chooses as its accounting policy to adopt the simplified approach in calculating ECLs with policies as described above.

Financial liabilities

Initial recognition and measurement

Financial liabilities are classified, at initial recognition, as financial liabilities at fair value through profit or loss, loans and borrowings, payables or as derivatives designated as hedging instruments in an effective hedge, as appropriate.

All financial liabilities are recognised initially at fair value and, in the case of loans and borrowings and payables, net of directly attributable transaction costs.

Subsequent measurement

The subsequent measurement of financial liabilities depends on their classification as follows:

Financial liabilities at amortised cost (loans and borrowings)

After initial recognition, financial liabilities are subsequently measured at amortised cost, using the effective interest rate method unless the effect of discounting would be immaterial, in which case they are stated at cost. Gains and losses are recognised in the statement of profit or loss when the liabilities are derecognised as well as through the effective interest rate amortisation process.

Amortised cost is calculated by taking into account any discount or premium on acquisition and fees or costs that are an integral part of the effective interest rate. The effective interest rate amortisation is included in finance costs in the statement of profit or loss.

Derecognition of financial liabilities

A financial liability is derecognised when the obligation under the liability is discharged or cancelled, or expires.

When an existing financial liability is replaced by another from the same lender on substantially different terms, or the terms of an existing liability are substantially modified, such an exchange or modification is treated as a derecognition of the original liability and a recognition of a new liability, and the difference between the respective carrying amounts is recognised in the statement of profit or loss.

金融負債的後續計量根據如下分類：

於初步確認後，金融負債其後利用實際利率法按已攤銷成本計算，但若折現的影響不重要，則按成本列賬。當負債取消確認及於實際利率攤銷的過程中，相關損益於損益表確認。

計算攤銷成本時會計及收購的任何折扣或溢價，並包括屬於實際利率完整部分的費用或成本。實際利率攤銷計入損益表的融資成本內。

金融負債的取消確認

當相關負債的責任被解除或取消或屆滿時，金融負債將取消確認。

如現有金融負債由同一放債人以條款極為不同的負債所取代，或現有負債的條款作出重大修訂，此類替換或修訂將被視為取消確認原負債及確認新負債處理，有關賬面值的差額於損益表中確認。

Offsetting of financial instruments

Financial assets and financial liabilities are offset and the net amount is reported in the statement of financial position if there is a currently enforceable legal right to offset the recognised amounts and there is an intention to settle on a net basis, or to realise the assets and settle the liabilities simultaneously.

Cash and cash equivalents

For the purpose of the consolidated statement of cash flows, cash and cash equivalents comprise cash on hand and demand deposits, and short term highly liquid investments that are readily convertible into known amounts of cash, are subject to an insignificant risk of changes in value, and have a short maturity of generally within three months when acquired, less bank overdrafts which are repayable on demand and form an integral part of the Group's cash management.

For the purpose of the consolidated statement of financial position, cash and cash equivalents comprise cash on hand and at banks, including term deposits, and assets similar in nature to cash, which are not restricted as to use.

Inventories

Inventories represent consumables, tools and parts for use in the operation, and are stated at the lower of cost and net realisable value. Cost is determined on the first-in, first-out basis. Net realisable value is based on estimated selling prices less any estimated costs to be incurred to completion and disposal.

現金及現金等價物

就綜合現金流量表而言，現金及現金等價物包括手頭現金及活期存款，以及可隨時轉換為已知金額的現金、沒有涉及重大價值變動風險且一般自取得起計三個月內到期的短期高流通性投資，減須於要求時償還並構成本集團現金管理組成部分的銀行透支。

就綜合財務狀況表而言，現金及現金等價物包括不受使用限制的手頭現金及銀行現金(包括定期存款及與現金性質類似的資產)。

存貨

存貨指用於營運中使用的消耗品、工具及配件，並按成本與可變現淨值的較低者列賬。成本按先進先出基準釐定。可變現淨值乃根據估計售價減完成及出售產生的任何估計成本計算。

Income tax

Income tax comprises current and deferred tax. Income tax relating to items recognised outside profit or loss is recognised outside profit or loss, either in other comprehensive income or directly in equity.

Current tax assets and liabilities are measured at the amount expected to be recovered from or paid to the taxation authorities, based on tax rates (and tax laws) that have been enacted or substantively enacted by the end of the reporting period, taking into consideration interpretations and practices prevailing in the countries in which the Group operates.

Deferred tax is provided, using the liability method, on all temporary differences at the end of the reporting period between the tax bases of assets and liabilities and their carrying amounts for financial reporting purposes.

Deferred tax liabilities are recognised for all taxable temporary differences, except:

- when the deferred tax liability arises from the initial recognition of goodwill or an asset or liability in a transaction that is not a business combination and, at the time of the transaction, affects neither the accounting profit nor taxable profit or loss; and
- in respect of taxable temporary differences associated with investments in subsidiaries, associate and joint ventures, when the timing of the reversal of the temporary differences can be controlled and it is probable that the temporary differences will not reverse in the foreseeable future.

所得稅包括即期及遞延稅項。有關於損益以外確認的項目的所得稅於損益外確認為其他全面收入或直接確認為權益。

Deferred tax assets are recognised for all deductible temporary differences, and the carryforward of unused tax credits and any unused tax losses. Deferred tax assets are recognised, to the extent that it is probable that taxable profit will be available against which the deductible temporary differences, the carryforward of unused tax credits and unused tax losses can be utilised, except:

- when the deferred tax asset relating to the deductible temporary differences arises from the initial recognition of an asset or liability in a transaction that is not a business combination and, at the time of the transaction, affects neither the accounting profit nor taxable profit or loss; and

The carrying amount of deferred tax assets is reviewed at the end of each reporting period and reduced to the extent that it is no longer probable that sufficient taxable profit will be available to allow all or part of the deferred tax asset to be utilised. Unrecognised deferred tax assets are reassessed at the end of each reporting period and are recognised to the extent that it has become probable that sufficient taxable profit will be available to allow all or part of the deferred tax asset to be recovered.

Deferred tax assets and liabilities are measured at the tax rates that are expected to apply to the period when the asset is realised or the liability is settled, based on tax rates (and tax laws) that have been enacted or substantively enacted by the end of the reporting period.

Dividend income derived from the Company's subsidiaries, associate and joint ventures in Mainland China is subject to a withholding tax under the prevailing tax rules and regulations of the PRC.

Revenue from contracts with customers

Revenue from contracts with customers is recognised when control of goods or services is transferred to the customers at an amount that reflects the consideration to which the Group expects to be entitled in exchange for those goods or services.

When the consideration in a contract includes a variable amount, the amount of consideration is estimated to which the Group will be entitled in exchange for transferring the goods or services to the customer. The variable consideration is estimated at contract inception and constrained until it is highly probable that a significant revenue reversal in the amount of cumulative revenue recognised will not occur when the associated uncertainty with the variable consideration is subsequently resolved.

When the contract contains a financing component which provides the customer with a significant benefit of financing the transfer of goods or services to the customer for more than one year, revenue is measured at the present value of the amount receivable, discounted using the discount rate that would be reflected in a separate financing transaction between the Group and the customer at contract inception. When the contract contains a financing component which provides the Group a significant financial benefit for more than one year, revenue recognised under the contract includes the interest expense accreted on the contract liability under the effective interest method. For a contract where the period between the payment by the customer and the transfer of the promised goods or services is one year or less, the transaction price is not adjusted for the effects of a significant financing component, using the practical expedient in HKFRS 15.

Provision of terminal storage and handling services of liquid chemicals

Revenue from the provision of terminal storage and handling services of liquid chemicals is recognised (i) over the scheduled period on a straight-line basis over contract terms because the customer simultaneously receives and consumes the benefits provided by the Group, or (ii) over time, using an input method, because the input method recognises revenue based on the proportion of the throughput volume incurred relative to the service rendered by the Group.

Revenue from other sources

Rental income is recognised on a time proportion basis over the lease terms.

Other income

Interest income is recognised on an accrual basis using the effective interest method by applying the rate that exactly discounts the estimated future cash receipts over the expected life of the financial instrument or a shorter period, when appropriate, to the net carrying amount of the financial asset.

Dividend income is recognised when the shareholders' right to receive payment has been established, it is probable that the economic benefits associated with the dividend will flow to the Group and the amount of the dividend can be measured reliably.

Contract liabilities

A contract liability is recognised when a payment is received or a payment is due (whichever is earlier) from a customer before the Group transfers the related goods or services. Contract liabilities are recognised as revenue when the Group performs under the contract (i.e. transfers control of the related goods or services to the customer).

Government grants

Government grants are recognised at their fair value where there is reasonable assurance that the grant will be received and all attaching conditions will be complied with. When the grant relates to an expense item, it is recognised as income on a systematic basis over the periods that the costs, which it is intended to compensate, are expensed.

Employee benefits-pension schemes

The Group operates a defined contribution Mandatory Provident Fund retirement benefit scheme (the "MPF Scheme") under the Mandatory Provident Fund Schemes Ordinance for those employees who are eligible to participate in the MPF Scheme. Contributions are made based on a percentage of the employees' basic salaries and are charged to the statement of profit or loss as they become payable in accordance with the rules of the MPF Scheme. The assets of the MPF Scheme are held separately from those of the Group in an independently administered fund. The Group's employer contributions vest fully with the employees when contributed into the MPF Scheme.

The employees of the Group's subsidiary which operates in Mainland China are required to participate in a central pension scheme operated by the local municipal government. The subsidiary is required to contribute a certain percentage of its payroll costs to the central pension scheme. The contributions are charged to the statement of profit or loss as they become payable in accordance with the rules of the central pension scheme.

Foreign currencies

These financial statements are presented in Hong Kong dollars, which is the Company's functional currency. Each entity in the Group determines its own functional currency and items included in the financial statements of each entity are measured using that functional currency. Foreign currency transactions recorded by the entities in the Group are initially recorded using their respective functional currency rates prevailing at the dates of the transactions. Monetary assets and liabilities denominated in foreign currencies are translated at the functional currency rates of exchange ruling at the end of the reporting period. Differences arising on settlement or translation of monetary items are recognised in the statement of profit or loss.

Non-monetary items that are measured in terms of historical cost in a foreign currency are translated using the exchange rates at the dates of the initial transactions. Non-monetary items measured at fair value in a foreign currency are translated using the exchange rates at the date when the fair value was measured. The gain or loss arising on translation of a non-monetary item measured at fair value is treated in line with the recognition of the gain or loss on change in fair value of the item (i.e., translation difference on the item whose fair value gain or loss is recognised in other comprehensive income or profit or loss is also recognised in other comprehensive income or profit or loss, respectively).

In determining the exchange rate on initial recognition of the related asset, expense or income on the derecognition of a non-monetary asset or non-monetary liability relating to an advance consideration, the date of initial transaction is the date on which the Group initially recognises the non-monetary asset or non-monetary liability arising from the advance consideration. If there are multiple payments or receipts in advance, the Group determines the transaction date for each payment or receipt of the advance consideration.

Significant management judgements on the future tax treatment of certain transactions are required in determining income tax provisions. The Group carefully evaluates tax implications of transactions and tax provisions are set up accordingly. The tax treatment of such transactions is reconsidered periodically to take into account all changes in tax legislation.

Estimation uncertainty

The key assumptions concerning the future and other key sources of estimation uncertainty at the end of the reporting period, that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial period, are described below.

Impairment of non-financial assets

The Group assesses whether there are any indicators of impairment for all non-financial assets (including the right-of-use assets) at the end of each reporting period. Indefinite life intangible assets are tested for impairment annually and at other times when such an indicator exists. Other non-financial assets are tested for impairment when there are indicators that the carrying amounts may not be recoverable. An impairment exists when the carrying value of an asset or a cash-generating unit exceeds its recoverable amount, which is the higher of its fair value less costs of disposal and its value in use. The calculation of the fair value less costs of disposal is based on available data from binding sales transactions in an arm's length transaction of similar assets or observable market prices less incremental costs for disposal of the asset. When value in use calculations are undertaken, management must estimate the expected future cash flows from the asset or cash-generating unit and choose a suitable discount rate in order to calculate the present value of those cash flows.

The provision rates are based on days past due for groupings of various customer segments that have similar loss patterns (i.e., by customer type). The provision matrix is initially based on the Group's historical observed default rates. The Group will calibrate the matrix to adjust the historical credit loss experience with forward-looking information. At each reporting date, the historical observed default rates are updated and changes in the forward-looking estimates are analysed.

The assessment of the correlation among historical observed default rates, forecast economic conditions and ECLs is a significant estimate. The amount of ECLs is sensitive to changes in circumstances and forecast economic conditions. The Group's historical credit loss experience and forecast of economic conditions may also not be representative of a customer's actual default in the future. The information about the ECLs on the Group's accounts receivable is disclosed in note 21 to the financial statements.

Pursuant to the PRC Corporate Income Tax Law, a 5% to 10% withholding tax is levied on dividends declared to foreign investors from foreign investment enterprises established in Mainland China. The requirement is effective from 1 January 2008 and applies to earnings generated after 31 December 2007. A lower withholding tax rate may be applied if there is a tax treaty between Mainland China and the jurisdiction of the foreign investors. For the Group, the applicable rate is 5%. The Group is therefore liable to withholding taxes on dividends distributed by the subsidiary, associate and joint ventures established in Mainland China in respect of earnings generated from 1 January 2008.

The Group has tax losses arising in Hong Kong of HK\$162,957,000 (2018: HK\$140,228,000) that are available indefinitely for offsetting against future taxable profits of the companies in which the losses arose. Deferred tax assets have not been recognised in respect of these losses as they have arisen in subsidiaries that have been loss-making for some time and in the opinion of the directors of the Company, it is not considered probable that taxable profits will be available against which the tax losses can be utilised.

The Group's principal financial instruments comprise cash and cash equivalents and interest-bearing bank loans. The main purpose of these financial instruments is to finance the Group's operations. The Group has various other financial assets and liabilities such as accounts and bills receivables, deposits and other receivables, and other payables and accruals, which mainly arise directly from its operations.

The main risks arising from the Group's financial instruments are interest rate risk, credit risk and liquidity risk. The board of directors reviews and agrees policies for managing each of these risks and they are summarised below.

The Group mitigates the risk by monitoring closely the movements in interest rates and reviewing its banking facilities and borrowings regularly. The Group has not used any interest rate swap to hedge its exposure to interest rate risk.

The following table demonstrates the sensitivity to a reasonably possible change in the HIBOR, with all other variables held constant, of the Group's profit before tax (through the impact on floating rate bank borrowings).

The Group primarily provides services to recognised and creditworthy third parties. It is the Group's policy that advanced payments are generally required for new customers. In addition, receivable balances are monitored on an ongoing basis and the Group's exposure to bad debts is not significant. Since the Group primarily provides services to recognised and creditworthy third parties, there is normally no requirement for collateral. As at 31 December 2019, there was a concentration of credit risk as approximately 79.4% (2018: 63.3%) of the Group's accounts receivable were due from one debtor.
