- In the case of joint holders of a Share, any one of such joint holders may vote at the General Meeting or any adjournment thereof (as the case may be), either in person or by proxy, in respect of such Share as if he were solely entitled thereto. If more than one of such joint holders are present at the General Meeting or any adjournment thereof (as the case may be) whether in person or by proxy, that one of the said persons so present whose name stands first on the register of members in respect of the relevant Share will alone be entitled to vote in respect thereof.
