**UPDATE ON LITIGATION**

This announcement is made by CT Environmental Group Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) pursuant to Part XIVA of the Securities and Future Ordinance (Chapter 571 of the Laws of Hong Kong) and Rule 13.09 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited.

Reference is made to the announcements of the Company dated 27 June 2019, and the paragraph headed “Other Updates” in the Company’s quarterly announcements dated 28 June 2019, 2 October 2019, 31 December 2019 and 1 April 2020 (collectively the “**Relevant Announcements**”). Unless otherwise defined, capitalized terms used herein shall have the same meanings as those defined in the Relevant Announcements.

The Company wishes to update its shareholders and the public that Zhongshan Haitao informed the Company that on 14 April 2020, the First People’s Court of Zhongshan City, Guangdong Province (廣東省中山市第一人民法院) handed down its judgement against Zhongshan Haitao for committing environmental pollution offences and fined Zhongshan Haitao the sum of RMB500,000 (the “**Zhongshan Haitao Judgement**”). After reviewing the content of the Zhongshan Haitao Judgement with the PRC legal advisors, Zhongshan Haitao has decided not to appeal against the Zhongshan Haitao Judgement.

Further, the Company was informed by Guangzhou Liangang that on 29 April 2020, the People's Court of Nansha District, Guangzhou City, Guangdong Province (廣東省廣州市南沙區人民法院) issued its judgement against Guangzhou Liangang for committing environmental pollution offences and fined Guangzhou Liangang the sum of RMB300,000 (the "**Guangzhou Liangang Judgement**"). After reviewing the content of the Guangzhou Liangang Judgement with the PRC legal advisors, Guangzhou Liangang has decided to lodge an appeal against the Guangzhou Liangang Judgement. The Company will keep the shareholders of the Company and the public informed of any material progress of the appeal by way of further announcement(s) as and when appropriate.

## **CONTINUED SUSPENSION OF TRADING**

At the request of the Company, trading in the Shares on the Stock Exchange has been suspended with effect from 9:00 a.m. on 1 April 2019. Trading in the Shares will remain suspended until further notice.
