SUPPLEMENTAL ANNOUNCEMENT

This announcement is made by Sparkle Roll Group Limited (the “**Company**”, and together with its subsidiaries, the “**Group**”) pursuant to Rule 13.09 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”) and the Inside Information Provisions (as defined in the Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the laws of Hong Kong).

Reference is made to the announcement of the Company dated 19 May 2020 relating to its profit warning (the “**Announcement**”). Unless otherwise defined in this announcement, capitalised terms used in this announcement shall have the same meanings as they are defined in the Announcement.

The Board wishes to provide the Shareholders and the potential investors of the Company with further information that based on the preliminary assessment of the latest unaudited consolidated management accounts of the Group and the financial information currently available, the profit attributable to owners of the Company for the year ended 31 March 2020 is expected to decrease by approximately 75% as compared with that of approximately HK\$97 million for the year ended 31 March 2019.

Since the Group is still in the course of compiling its consolidated financial results for the year ended 31 March 2020, the information contained in this announcement is only a preliminary assessment made by the Board based merely on the information currently available, including the unaudited consolidated management accounts of the Group for the year ended 31 March 2020 which have not yet been audited by the Company's independent auditors. The actual financial results of the Group for the year ended 31 March 2020 may differ from what is disclosed in this announcement. The Company will announce its annual results for the year ended 31 March 2020 before the end of June 2020.

Shareholders and potential investors are advised to exercise caution when dealing in the securities of the Company.
