Poll results for Annual General Meeting held on 26 May 2020

At the Annual General Meeting (the “AGM”) of Chinese Estates Holdings Limited (the “Company”) held on 26 May 2020, a poll was demanded by the chairman of the meeting for voting on all the proposed resolutions as set out in the notice of the AGM dated 23 April 2020 (which was incorporated in the circular of the Company dated the same date (the “Circular”)).

As at the date of the AGM, a total of 1,907,619,079 shares of the Company were in issue and entitled the holders of which to attend and vote at the AGM. There was no restriction on shareholders to cast votes on the proposed resolutions at the AGM. No person has indicated in the Circular that he/she intends to abstain from voting on or vote against any of the resolutions at the AGM.
