PRECAUTIONARY MEASURES FOR THE AGM

In view of the ongoing COVID-19 epidemic and recent guidelines for prevention and control of its spread, the Company will implement the following precautionary measures at the AGM to protect the Shareholders, staff and other stakeholders who attend the AGM from the risk of infection:

- (i) compulsory body temperature checks will be conducted on every Shareholder, proxy and other attendee. Any person with a body temperature of 37 degrees Celsius or higher may be denied entry into the AGM venue or be required to leave the AGM venue;
- (ii) the Company will require all attendees to wear surgical face masks before they are permitted to attend, and during their attendance of the AGM at all times, and to maintain a safe distance between seats (please bring your own mask);
- (iii) no refreshment will be served at the AGM;
- (iv) no souvenirs will be distributed at the AGM; and
- (v) no guest will be allowed to enter the AGM venue if he/she is wearing quarantine wristband issued by the Government of Hong Kong.

Any person who does not comply with above requirements may be denied entry into the AGM venue or be required to leave the AGM venue. To the extent permitted under law, the Company reserves the right to deny entry into the AGM venue or require any person to leave the AGM venue in order to ensure the safety of other attendees at the AGM. In our case, denied entry to the AGM venue also means that person will not be allowed to attend the AGM.

In the interest of all stakeholders' health and safety and in accordance with recent guidelines for prevention and control of the spread of COVID-19, the Company reminds all Shareholders that physical attendance in person at the AGM is not necessary for the purpose of exercising voting rights. As an alternative, the Shareholders may complete the proxy forms and appoint the chairman of the AGM as their proxy to vote on the relevant resolutions at the AGM instead of attending the AGM in person.

The proxy forms were despatched to the Shareholders together with this circular, and can otherwise be downloaded from the websites of the Company at www.fw-fh.com or the Stock Exchange at www.hkexnews.hk. If you are not a registered Shareholder (i.e. if your Shares are held via banks, brokers, custodians or Hong Kong Securities Clearing Company Limited), you should consult directly with your banks, brokers or custodians (as the case may be) to assist you in the appointment of proxy.

1. INTRODUCTION

The purpose of this circular is to provide you with information in respect of the resolutions to be proposed at the AGM for the approval of (a) the granting to the Directors of the Issue Mandate; (b) the granting to the Directors of the Repurchase Mandate; (c) the extension of the Issue Mandate by adding to it the aggregate number of Shares repurchased under the Repurchase Mandate; (d) the re-election of the retiring Directors; (e) the re-appointment of auditors; (f) the refreshment of Share Option Scheme Mandate Limit; and (g) the proposed change of Company name.

LETTER FROM THE BOARD

2. GENERAL MANDATES TO ISSUE AND REPURCHASE SHARES

At the AGM, ordinary resolutions will be proposed to grant to the Directors the Issue Mandate and the Repurchase Mandate. Conditional upon the above resolutions being passed, a separate resolution will be proposed to extend the Issue Mandate by adding to it the aggregate number of Shares repurchased under the Repurchase Mandate. Details of these resolutions are contained in the AGM Notice.

As at the Latest Practicable Date, the issued share capital of the Company was 12,604,291,446 Shares. Assuming that there is no change in the issued share capital of the Company during the period between the Latest Practicable Date and the date of the AGM, the maximum number of Shares which may be issued pursuant to the Issue Mandate on the date of passing the resolution approving the Issue Mandate will be 2,520,858,289 Shares and the maximum number of Shares which may be repurchased pursuant to the Repurchase Mandate will be 1,260,429,144 Shares.

In accordance with the requirements of the Listing Rules, the Company is required to send to the Shareholders an explanatory statement containing all the information reasonably necessary to enable them to make an informed decision on whether to vote for or against the granting of the Repurchase Mandate. The explanatory statement as required by the Listing Rules in connection with the Repurchase Mandate is set out in Appendix I to this circular.

3. RE-ELECTION OF THE RETIRING DIRECTORS

The Board currently consists of twelve Directors, namely Mr. Wang Fei, Mr. Liang Jian, Mr. Yu Zhenzhong, Mr. Cai Linzhan, Mr. Lau Fai Lawrence, Mr. Siu Yun Fat, Mr. Yu Qingrui, Mr. Chen Pei, Mr. Siu Siu Ling, Robert, Mr. Tam Tak Wah, Mr. Wang Ning and Mr. Zheng Zongjia.

Pursuant to Article 108(A), Mr. Lau Fai Lawrence, Mr. Yu Qingrui, Mr. Siu Siu Ling, Robert and Mr. Zheng Zongjia shall retire by rotation at the AGM. Mr. Wang Ning was appointed as Director by the Board pursuant to Article 112, shall hold office until the forthcoming annual general meeting and shall then be eligible for re-election. All of the above five retiring Directors, being eligible, will offer themselves for re-election at the AGM.

Details of the retiring Directors proposed to be re-elected at the AGM are set out in Appendix II to this circular.

The Nomination Committee of the Company has reviewed the structure and composition of the Board in accordance with the Nomination Policy of the Company and the objective criteria (including but not limited to gender, age, cultural, educational background, professional experience, skills and know-how) with due regard for the benefits of diversity, as set out under the Board Diversity Policy of the Company.

The Nomination Committee has taken into account of the integrity, skills and experience of Mr. Siu, Mr. Wang and Mr. Zheng. Mr. Siu holds a bachelor's degree in laws from the University of London and a postgraduate certificate in laws from The University of Hong Kong. He also holds a Master of Laws from the University of Greenwich, United Kingdom. He has been admitted as a solicitor in Hong Kong since 1992 and has been admitted as a solicitor in England and Wales since 1993. His legal practice is mainly in the field of commercial and corporate finance. Mr. Siu also has extensive experience in corporate governance. During the year, Mr. Siu has provided valuable contributions to the Company. Mr. Wang has participated in national and provincial-level research projects in the PRC, business consulting projects, and the writing of high-quality academic journals. Mr. Wang has extensive research experience and unique perspectives in the fields of intelligent and new energy automobile industry policies, strategies, product positioning, and future mobile development and being a new member to the Board, enabling him to provide valuable perspective and contribution to the Board on matters relating to the robotic business development. Mr. Zheng has extensive experience in the field of real estate development in the People's Republic of China, enabling him to provide valuable perspective and contribution to the Board on matters relating to property investment business development. The Nomination Committee is of the view that Mr. Siu, Mr. Wang and Mr. Zheng have satisfied the criteria for independence set out in rule 3.13 of the Listing Rules and will be able to provide valuable, independent and objective view to the Company's affairs.

With the recommendation by the Nomination Committee, the Board recommended the retiring Directors, Mr. Lau Fai Lawrence, Mr. Yu Qingrui, Mr. Siu Siu Ling, Robert, Mr. Wang Ning and Mr. Zheng Zongjia to stand for re-election as Directors at the AGM. Each of the retiring Directors abstained from voting at the relevant Board meetings on respective propositions of their recommendations for re-election by the Shareholders.

4. RE-APPOINTMENT OF AUDITORS

Moore Stephens CPA Limited (“**Moore Stephens**”) will retire as the auditor of the Company at the AGM and, being eligible, offer themselves for re-appointment.

The Board proposed to re-appoint Moore Stephens as the auditor of the Company and to hold office until the conclusion of the next annual general meeting of the Company.

5. REFRESHMENT OF SHARE OPTION SCHEME MANDATE LIMIT

At the extraordinary general meeting of the Company held on 22 February 2012, the Company adopted a new Share Option Scheme. The Share Option Scheme became effective on 22 February 2012 and, unless otherwise cancelled or amended, will remain in force for 10 years from that date.

The Board proposes to seek the approval of the Shareholders to refresh the existing Share Option Scheme Mandate Limit. Under the existing Share Option Scheme Mandate Limit, the Directors were authorised to grant 1,248,029,144 Options to subscribe for up to 1,248,029,144 Shares, representing 10% of the issued share capital of the Company as at the date of the annual general meeting on 17 June 2019 at which the Share Option Scheme Mandate Limit was previously refreshed.

After refreshment of the Share Option Scheme Mandate Limit as approved by the Shareholders at last year's annual general meeting of the Company held on 17 June 2019 and up to the Latest Practicable Date, (i) 1,248,000,000 Options were granted, 124,000,000 Options were exercised and 640,000,000 Options were lapsed under the Share Option Scheme. As at the Latest Practicable Date, the Company may grant 29,144 Options under the Share Option Scheme Mandate Limit prior to its refreshment.

As at the Latest Practicable Date, the number of outstanding Options entitling the holders thereof to subscribe for Shares under the Share Option Scheme is 2,282,000,000.

In order to provide the Company with greater flexibility in granting Options to eligible persons (including but not limited to employees and Directors) of the Company under the Share Option Scheme as incentives or rewards for their contributions to the Company, the Board decided to seek the approval from the Shareholders to refresh the Share Option Scheme Mandate Limit at the AGM. The refreshment of the Share Option Scheme Mandate Limit is in line with the purpose of the Share Option Scheme. The Directors consider that such refreshment of the Share Option Scheme Mandate Limit is in the best interests of the Company and the Shareholders as a whole.

Based on 12,604,291,446 Shares in issue as the Latest Practicable Date and assuming no further Shares are repurchased and issued prior to the AGM, upon the approval of the refreshment of the Share Option Scheme Mandate Limit at the AGM, the Directors will, apart from the 2,282,000,000 options which have already been granted and are still outstanding, be authorised to exercise the powers of the Company to issue 1,260,429,144 Options to subscribe for a total of 1,260,429,144 Shares, representing 10% of the total number of Shares in issue as at the AGM. Assuming that the refreshment of the Share Option Scheme Mandate Limit is approved at the AGM and taking into account the following:

1. the additional 1,260,429,144 Shares subject to the Share Option Scheme Mandate Limit (as refreshed); and
2. the 2,282,000,000 Shares subject to the Options granted under the Share Option Scheme and yet to be exercised,

the number of the Shares that may be issued under the options to be granted under the Share Option Scheme Mandate Limit (as refreshed) and to be issued under the Options granted and outstanding will be in aggregate 3,542,429,144 Shares, representing approximately 28.10% of the Shares in issue as at the Latest Practicable Date and is within the 30% of Shares in issue from time to time as required under the Share Option Scheme.

The refreshment of the Share Option Scheme Mandate Limit of the Share Option Scheme is conditional upon:

1. the passing of an ordinary resolution at the AGM to approve the refreshment of the Share Option Scheme Mandate Limit by the Shareholders, to authorise the Directors to grant Options to subscribe for Shares under the Share Option Scheme and to allot and issue Shares pursuant to the exercise of any Options granted under the Share Option Scheme; and
2. the Listing Committee of the Stock Exchange granting the listing of, and permission to deal in, the new Shares to be issued pursuant to the exercise of any Options granted under the refreshed Share Option Scheme Mandate Limit.

Application will be made to the Stock Exchange by the Company for the approval of the listing of and permission to deal in the Shares to be issued upon the exercise of any Options that may be granted under the Share Option Scheme and any other schemes of the Company under the refreshed Share Option Scheme Mandate Limit.

An ordinary resolution will be proposed at the AGM to approve the refreshment of the Share Option Scheme Mandate Limit of the Share Option Scheme in the terms as set out in Resolution No. 5 of the notice of the AGM. In order that the Company could continue to grant Options to selected participants as incentives or rewards for their contributions to the Company, the Directors recommend the Shareholders to vote in favor of this resolution.

As disclosed in the above table, a total of 2,282,000,000 outstanding Options were granted to Directors, employees and consultants of the Group. The grant of the Options to the relevant grantees was in recognition of their contributions to the growth and development of the Group in the past and as an incentive for their continuing commitments and contributions to the Group in the future. The Directors who were the relevant grantees are executive Directors which play key role in setting up the Company's strategy. The employees and consultants also provided contributions to the Group by implementing the strategy and/or giving consultancy advices to the Group.

The Share Option Scheme was adopted to recognise and acknowledge the contributions of the eligible participants made to the Group and provide incentive to those eligible persons. The Share Option Scheme will provide the grantees with an opportunity to have a personal stake in the Company with the view to achieving the objectives of motivating the grantees to optimise their performance efficiency for the benefit of the Company, and to attract and retain or otherwise maintain on-going relationships with the grantees whose contributions are or will be beneficial to the growth and development of the Group.

The Directors consider that the refreshment of the Share Option Scheme Mandate Limit will allow the Company to have greater flexibility to provide incentives to the eligible participants of the Share Options Scheme by way of granting Options to them to strive for the future development and success of the Group. The Directors further consider that the refreshment of the Share Option Scheme Limit is in the interests of the Group and the Shareholders as a whole because it enables the Company to reward and motivate the eligible participants by way of granting Options under the Share Option Scheme.

6. PROPOSED CHANGE OF COMPANY NAME

Reference is made to the announcement of the Company dated 11 May 2020, pursuant to which the Board proposes to change the English name of the Company from “Future World Financial Holdings Limited” to “Future World Holdings Limited” and to adopt the Chinese name “未來世界控股有限公司” to replace its existing Chinese name “未來世界金融控股有限公司” (the “Change of Company Name”).

Conditions for the proposed Change of Company Name

The proposed Change of Company Name is conditional upon the following conditions having been satisfied:

- (i) the passing of a special resolution by the Shareholders approving the Change of Company Name at the AGM; and
- (ii) the Registrar of Companies in the Cayman Islands granting approval for the Change of Company Name.

The relevant filings with the Registrar of Companies in the Cayman Islands will be made after passing of the special resolution at the AGM. The proposed Change of Company Name will take effect from the date on which the Registrar of Companies in the Cayman Islands enters the new name on the register of companies and issues a certificate of incorporation on change of name.

The Company will then carry out all necessary filing procedures with the Companies Registry in Hong Kong.

Reasons for the proposed Change of Company Name

In order to enhance the long-term growth potential of the Group, the Company has formulated long-term business strategy to explore other business or investment opportunities and broaden its scope of business. The Board is of the view that a change of company name will help establish a fresh corporate image identity and better reflect the Group's future business plans and development. As such, the Board considers that the Change of Company Name is in the best interests of the Company and its Shareholders as a whole.

Effects of the proposed Change of Company Name

The proposed Change of Company Name will not affect any rights of the Shareholders or the Company's daily operations or its financial position. Once the Change of Company Name has become effective, any new share certificates of the Company issued thereafter will bear the new name of the Company. However, all the existing share certificates in issue bearing the present name of the Company will, after the proposed Change of Company Name has become effective, continue to be effective and as documents of title to the shares of the Company, will continue to be valid for trading, settlement, registration and delivery purposes. Accordingly, there will not be any arrangement for free exchange of the existing share certificates of the Company for new share certificates bearing the new name of the Company.

In addition, subject to the confirmation by the Stock Exchange, the stock short names of the Company for trading in the securities on the Stock Exchange will also be changed after the Change of Company Name becoming effective.

7. VOTING AT THE AGM

According to Rule 13.39(4) of the Listing Rules, any vote of the Shareholders at a general meeting must be taken by poll. Therefore, all the resolutions put to vote at the AGM will be taken by way of poll and an announcement will be made after the AGM.

To the best of the Directors' knowledge, information and belief having made all reasonable enquiry, no Shareholders have a material interest in the refreshment of the Share Option Scheme Mandate Limit and no Shareholders are required to abstain from voting for the resolutions for the refreshment of the Share Option Scheme Mandate Limit. The refreshment of the Share Option Scheme Mandate Limit will not confer benefits to the eligible persons since the grant of any Options shall comply with the relevant requirements of the Listing Rules and also the Share Option Scheme.

The following is an explanatory statement required by the Listing Rules to be sent to the Shareholders to enable them to make an informed decision on whether to vote for or against the ordinary resolution to be proposed at the AGM in relation to the granting of the Repurchase Mandate.

1. SHARE CAPITAL

As at the Latest Practicable Date, the issued share capital of the Company was 12,604,291,446 Shares. Subject to the passing of the ordinary resolution granting the Repurchase Mandate and on the basis that no further Shares are issued or repurchased from the Latest Practicable Date up to the date of the AGM, the Company would be allowed under the Repurchase Mandate to repurchase a maximum of 1,260,429,144 Shares, representing 10% of the issued Shares of the Company as at the date of the AGM.

2. SOURCE OF FUNDS

Repurchases of Shares by the Company must be made out of funds which are legally available for such purpose in accordance with the Articles, the Listing Rules and the applicable laws and regulations of the Cayman Islands. The Company shall not repurchase its own Shares on the Stock Exchange for a consideration other than cash or for settlement otherwise than in accordance with the trading rules of the Stock Exchange from time to time.

Subject to the above, any repurchase of the Shares by the Company may only be made out of profits of the Company or out of a fresh issue of Shares made for the purpose of the repurchase, or, subject to Cayman Islands Companies Law, out of capital, provided that on the day immediately following the date of repurchase of the Shares, the Company is able to pay its debts as they fall due in the ordinary course of business.

3. REASONS FOR REPURCHASES

The Directors believe that it is in the best interests of the Company and the Shareholders as a whole to seek a general authority from Shareholders to enable the Company to repurchase its Shares on the Stock Exchange. Such repurchases may, depending on the market conditions, and funding arrangements at the time, lead to an enhancement of the net asset value of the Company and/or earnings per Share and will only be made when the Directors believe that such a repurchase will benefit the Company and the Shareholders as a whole.

4. IMPACT OF REPURCHASES

There might be a material adverse impact on the working capital or gearing position of the Company (as compared with the position disclosed in the consolidated financial position of the Company as at 31 December 2019, being the date of the latest published audited financial statements of the Company) in the event that the Repurchase Mandate is exercised in full. Save as disclosed above, there is no other information relating to Mr. Lau which is required to be disclosed under rules 13.51(2)(h) to 13.51(2)(v) of the Listing Rules and there are no other matters that need to be brought to the attention of the Shareholders in respect of the re-election of Mr. Lau.

Mr. Yu Qingrui, *Executive Director*

Mr. Yu, aged 48, has been appointed as an Executive Director in September 2014. Mr. Yu specialises in property investment and trading business in the PRC. After graduating from high-school in 1989, Mr. Yu joined the shipping and trading business in the PRC. He was the general manager of a shipping company before he became a private investor in 2003. In 2011, Mr. Yu joined a marketing and management firm in Shanghai and served as their property investment manager.

Mr. Siu Siu Ling, Robert, *Independent Non-executive Director*
