完善的培訓體系 Sound Training System

朗詩希望將企業辦成一所「學校」。為員工提供滿足不同需求的、有針對性的培訓,包括職場新人的小白修鍊計劃、各方向專業培訓俱樂部、中高層的管理賦能。公司針對不同層級的後備人才,設置不同類型的特訓營,採取「共性培養+個性培養」的方式,透過課堂培訓、交流學習和在崗實踐等快速提升;透過產品專業力學習俱樂部、產品、工程、營銷、採購等專業學習俱樂部持續開展學習活動,邀請內外部優秀講師開展如經驗分享、行業交流、標桿專案參觀、案例研討等形式多樣的培訓。2019年,員工人均培訓時長為35小時。

Landsea hopes to build the enterprise into a "school," providing employees with targeted training that meets different needs, including programs for new recruits, professional training clubs for different purposes, and middle and senior management empowerment. Landsea sets up different types of special training camps to develop talents at different levels, adopts the "generality + personality cultivation" method, and rapidly improves capabilities through classroom training, exchange learning and on-the-job practice. It continues to carry out learning activities through product power learning clubs, product, engineering, marketing, procurement and other professional learning clubs, and invites excellent internal and external lecturers to conduct various trainings such as experience sharing, industry exchanges, benchmarking project visits, and case studies. In 2019, the average training hour per employee reached 35h.

By adopting a strategy of green product-differentiation for development, Landsea built the 1.0 high-comfort, low energy consumption green housing complex "Nanjing Landsea International Block" in 2004 and independently developed the new-generation "Free Ark" healthy housing design in 2019. 朗詩擁有成熟完善的產品研發體系，由 8 位博士及多位研發人員和綠色建築領域專家組成，涵蓋能源、暖通、綠建、建築、保健醫療、智慧化等多領域。2019 年，朗詩研發投入約 1.5 億元人民幣，用於覆蓋建築節能、高效設備、室內舒適、人體健康、生態環境等專項課題的研發，研發成果被廣泛運用於朗詩的綠色產品。

Landsea boasts a mature and complete product R&D system and has 8 doctors, many researchers and green building experts engaged in various sectors such as energy, heating and ventilation, green building, construction, health and medical care, and intelligence. In 2019, Landsea invested about RMB 150 million in the R&D of special projects like building energy conservation, efficient equipment, home comfort, physical health, and eco-environment, etc. for wide application in its green products.

朗詩自 2019 年度開始研發的全新一代產品自由方舟，是一個「更自由、智慧地營造健康、舒適、節能的室內人居環境」的產品。之所以叫「自由方舟」，是因為它在保證室內環境健康的基礎上，能給使用者提供更大的自由體驗。自由方舟採用集中能源和戶內系統相結合系統形式，作為朗詩劃時代的住宅產品，單個產品就擁有 100 餘項專利。它的推出是朗詩在「為人造房」的理念下，對人類居住的「自由」邊界的又一次探索和突破。

The new-generation Free Ark design, developed by Landsea in 2019, is dedicated to "creating a smarter and more flexible environment that offers a healthy, comfortable and energy-efficient living experience". It provides customers with greater freedom in addition to a healthy living environment, hence the name "Free Ark". The Free Ark combines a centralized energy supply with indoor systems, and each pioneering housing product has over 100 patents. The launching of Free Ark marks another attempt by Landsea to explore the boundaries of "free" residences and make breakthroughs in this area under the philosophy of "building home for people".

朗詩地產 2019 年首進華南，落子粵港澳大灣區，打造【中山朗詩德洲尚郡】項目。項目緊鄰國家 5A 級風景旅遊區孫中山故居，兼有「山、城、田、海」的自然風貌。作為朗詩首個新一代自由方舟健康住宅產品系，也是首個粵港澳項目，項目承擔著把朗詩「健康、舒適、節能、環保、智慧、人文」的綠色理念帶給大灣區的責任，因地制宜項目結合華南高溫高濕的氣候特點，搭載新一代自由方舟產品，為當地打造高舒適健康綠色人居。

Landsea property made its debut in South China in 2019 with its base in the Guangdong-Hong Kong-Macao Greater Bay Area (GBA), where the [Landsea Dezhou Shang County] project was launched. This project is adjacent to one of China's 5A tourist attractions – the Former Residence of Dr. Sun Yat-sen – and its location boasts a varied natural landscape of "mountains, cities, fields and ocean". As Landsea's first new-generation Free Ark healthy housing product series and also the first project based in GBA, it aims to bring the green concepts of "health, comfort, energy conservation, environmental protection, intelligence and human focus" to the GBA region. By adapting to local conditions such as high temperatures and humidity of South China, Landsea presents a new generation of Free Ark products, with the goal of creating a high-comfort, healthy and green living environment for local residents.





常州中建朗詩熙華雅園繼承朗詩地產綠色基因和成熟的綠建體系，引入綠建科技系統，從保溫、傳熱等多個維度全方位匠造控溫、控濕、控氧的綠色科技住宅，建築節能率達 70%，低於國家標準。全年室內溫度處於 18-26°C 之間，無需冷氣機暖氣的協助，實現「每一平米皆舒適」的居住體驗。

- 透過設計高熱工性能的圍護結構、節能及高氣密性門窗系統、可調節外遮陽系統以及全熱回收新風系統最大限度的降低建築本身的能耗
- 採用地源熱泵系統為各樓棟提供冷氣機冷熱水以及生活熱水

The Xihua Yayuan Property, co-developed by Landsea and the China State Construction Engineering Corporation (CSCEC), continues Landsea's green building tradition and benefits from its established green construction system. By systematically introducing green construction technologies, this real estate project concentrates on a wide variety of dimensions such as heat preservation and transmission to develop temperature-, humidity- and oxygen-controlled green residential properties. The energy-saving rate of its buildings reaches 70%, below the national standard. The indoor temperature is maintained between 18°C and 26°C all year around. No extra air conditioner required, it offers fantastic living experience with comfortable temperature within every square meter of the houses.

- Minimize the energy consumption of green buildings by designing their envelopes with great thermal performance, energy-efficient door-and-window system with high air-tightness, adjustable external sun-shading system and entire heat recovery fresh air supply system.
- Provide hot and chilled water for air conditioning system as well as hot water for life by means of the ground-source heat pump system (GSHPs).
- Adjust indoor temperature and humidity thus enhance comfort level by equipping the buildings with radiant ceiling system as well as replacement of fresh air system.
- Take into full consideration in real estate developing the need to save space, energy, water and materials as well as indoor environmental quality.
- Make specific plan for rainwater diversion, including leaving enough green ground, using permeable pavement, taking green rainwater, ecological measures and installing rainwater recycling system. With these measures, the total annual runoff control rate of the site reaches above 70%.
- Develop multidimensional green vegetation space to change the humidity of local environment.







因人制宜，在掌握項目基本規劃資訊後，對容積率、綠化率、建築密度、產品類型、產品受眾等作可行性研究，運用綠色技術和手段開展設計，最大限度實現人與自然的和諧相處。

The great integration of Landsea's real estate into local community starts with site selection. We will fully examine the local natural and social environment by measuring the location, surroundings, geological conditions, humanistic and climatic characteristics of planned sites.

Being well suited to people's needs is equally important to Landsea housing. After completing basic project planning, Landsea will conduct a feasibility analysis of the project's floor area ratio, green space ratio, building density, housing type, target customer, etc. Then we will design it to maximize the harmony between man and nature by means of green technologies.

Under the green design philosophy of deep integration into local community, the project has included green designs that adapt to local conditions and people's needs with regard to building layout, exterior wall materials, roof greening, sunroom, water planning, etc.

花園裡種房子的景觀規劃 Creative Landscape Planning Achieves the Effect of "Planting Houses in the Garden"



朗詩房為建築預留最合適的空間，在「花園裡種房子」。結合季節特徵選擇植被，營造「花開四季皆應景」的美麗健康環境，巧思搭配落葉與常綠植物，確保陽光充足，讓一年四季均有綠意，同時透過綠化淨化空氣、增加含氧量、阻擋粉塵。

Landsea housing tends to reserve a certain amount of suitable space for buildings to achieve the effect of "planting house in the garden". Different vegetation has been carefully chosen to match different seasons, creating a beautifully harmonious landscape decorated by "flowers suited for different seasons". Ingeniously-positioned deciduous trees and evergreen plants guarantee enough sunshine for the space and make it look refreshingly green all the year round. At the same time, green plants can help purify the air, increase oxygen level and block flowing dust.

微環境模擬分析 Micro-environment Simulation

朗詩房，在項目規劃前期，利用計算機模擬分析方法對社區風速、溫度、日照、陰影、噪聲等物理環境進行計算，對包括社區設施的佈局、建築朝向、排布、樓幢組合方式、高低錯落關係、景觀綠化佈置、植物高低選擇等進行分析和優化，在數十種不同的規劃方案中，選擇最優方案。

01 風環境 Wind Environment



良好的建築佈局為基礎，合理的落葉、常綠喬木布局，營造良好室外風場環境。冬季，室外活動場所基本無強烈吹風感；夏季，室外活動場所有氣流通過，帶走燥熱；春秋兩季，無靜風區、無渦流產生，保持室外活動場地的空氣清新。

Based on a sound building layout, Landsea real estate carefully plans the positions of deciduous trees and evergreen trees, creating a pleasant outdoor wind-flow system. In winter, residents won't feel strong gusts when walking outside in the community; in summer, air will flow through all outdoor areas, taking away scorching heat; in spring and autumn, an area free of wind or eddy will be formed above the property space, keeping air fresh in outdoor areas.



In the early stage of project planning, Landsea housing conducts computer-based simulation and analysis of the wind speed, temperature, sunlight exposure, shadow, noise, and other indicators of the physical environment and analyzes and optimizes the layout of community facilities, building orientation and layout, combination and height distribution of buildings, the green landscape design, selection of height of plants, etc. The best plan will be selected among tens of different plans.

02 溫度 Temperature

結合住區內熱島強度類比方法，優化設置喬灌木、景觀水體等元素，打造溫度適宜的生態社區。

By simulating the heat island effect within the estate, Landsea makes efforts to alleviate the effect by planting trees and shrubs and building landscape waters, so as to create an ecological residential area with a pleasant temperature.



04 陰影 Shadow

朗詩積極持續開展供應商審核與管理體系和制度的制定工作。對於供應商的入庫審核，朗詩建立專業網招平台，供應商通過註冊，並提交相關資質和業績檔，朗詩對供應商的營業資質、財務狀況及工程業績進行相關審核，通過天眼查等外部軟體，對供方的信用進行審核，判斷其是否存在重大違法失信記錄。對於存在違法失信的供應商，不與合作。

Landsea actively engages in the examination of suppliers and the formulation of management systems. A special online recruitment platform has been established to examine entries where suppliers can submit relevant qualification and performance documents after registration. Landsea then examines the suppliers' qualifications, financial positions and project performance, and assesses their credit through external tools such as TianYanCha to eliminate those with bad credit or records of violation of the law. Landsea will stop cooperating with suppliers with illegal or dishonest conduct.


招標檔案中納入環境合規要求 Environmental Compliance Written in the Request for Proposal

朗詩自 2016 年起，持續對供應鏈上游企業進行環境合規檢索，並將環境合規要求納入「招標文檔」。在「招標文檔」中要求投標企業在第三方環境資訊網站「蔚藍地圖」上提供企業的環境監管信息依據，並督促不合格企業改善。對於供應商環境違規情況，朗詩要求供應商到「蔚藍地圖」網站提交公開說明，並要求其採取及時整改措施。

朗詩已在「蔚藍地圖」資料庫中檢索了 197 家企業的環境監管記錄，其中，通過整改撤銷環境違規記錄的有 24 家，發佈公開說明的有 28 家，切實推動了相關企業逐步實現綠色生產。

Since 2016, Landsea has been assessing upstream suppliers' environmental compliance and included it as a requirement in the "Request for Proposal", which specifies that bidders should provide supporting documents for their environmental regulatory information on Blue Map, a third-party environmental information website. Meanwhile, it has also been urging unqualified enterprises to make rectifications. When found violating environmental regulations, suppliers are requested to submit public statements to Blue Map and take timely corrective measures.

Landsea has retrieved the environmental regulatory records of 197 companies, among which 24 revoked the violation records after rectification, and 28 published public statements, effectively pushing forward green production in these enterprises.

As a member of the Global Forest & Trade Network, Landsea stands by sustainable forest operations and responsible trade in forest products when it comes to legal procurement channels for wood products. In 2019, Landsea published its "Wood Products Procurement Commitment".

Wood Products Procurement Commitment

- 不採購轉基因木材;
- Do not purchase wood from forests of high protective value, such as the Amazon biodiversity conservation zone, the Xishuangbanna nature reserve, and other ecological reserves, except those certified by FSC;
- Do not purchase trees listed in the *Convention on International Trade in Endangered Species of Wild Fauna and Flora*, unless appropriate permits for sale issued from endangered species protection agencies can be provided by suppliers;
- Do not purchase wood from war zones or regions under forest/right disputes;
- Do not purchase wood produced on non-forest land converted from forest land;
- Do not purchase wood produced from artificial forests converted from natural forests;
- Do not purchase genetically modified wood.

為實現以上承諾,朗詩嚴格審核供應商木材來源,確保其源於合法途徑,要求供應商:

1. 提供木材原料記錄,該記錄至少包括:木材產地證明、運輸證、檢疫證、採伐證、海關證明和木材產品檢驗報告等內容。
2. 提供木材原料來源地的相關信息以及相關的合法性證明文件和相關記錄,保證採購的林產品可追溯到產地。
3. 提高已知源和合法源的比例,逐步消除不予採購源和未知源,並最終獲得 FSC 認證。

To fulfill the Commitment, Landsea strictly examines the sources of wood, making sure they are legally sourced, and requires the suppliers to:

1. Provide wood records including at least the following items: certificate of wood origins, transportation certificate, quarantine certificate, logging certificate, customs certificate, wood product inspection report, etc.
2. Provide wood origin information, legality proofs and other relevant records, making sure that all the wood products purchased are traceable.
3. Increase the proportion of wood from known and legal sources while gradually eliminating those from forbidden and unknown sources, as efforts to eventually earn an FSC certificate.



2.3 綠色施工

Green Construction

朗詩房,在施工建造過程中,關注環境、資源節約和生物多樣性等議題。在保證品質、安全的前提下,通過科學管理、技術進步、動態規範化管理,實現綠色施工,最大限度節約資源,減少對環境的負面影響。

During construction, issues like environmental protection, resource conservation and biodiversity are taken into consideration. With scientific management, technological advance and dynamic standardized management, Landsea carries out green construction, saving resources as much as possible and minimizing negative impact on the environment while guaranteeing quality and safety.

Resource Conservation and Emission Management

在項目施工建設過程中,朗詩制定節能措施、優化土地利用、實行用水計量、選用綠色材料以及控制施工現場的噪音、揚塵、有害氣體、固體廢棄物的排放等要求,有效做到節能、節地、節水、節約材料、資源利用以及環境保護。

During construction, Landsea formulates energy-saving measures, optimizes land use, implements water metering, selects green materials, and controls noise, dust, toxic air emission, solid wastes, and other emissions from construction activities. These will greatly save energy, land, water and construction materials, achieving effective resource utilization and environmental protection.

Practicing "safe development with life in the first place", Landsea housing has established the Landsea Green Properties Safety Management System, sorting out safety management conduct and standards for suppliers, with an emphasis on safety management and control measures during the construction process. Landsea housing works to improve the safety management of suppliers through methods such as education and awareness training, and continues to strengthen supervision and evaluation, effectively controlling and reducing on-site construction risks.

Taking into account environmental issues such as household health, air pollution, food safety and drinking water pollution, Landsea effectively integrates green decoration technologies into building space, business formats, usage scenarios, and green values to create **a healthy indoor environment**.



朗詩房，搭建了能源管理系統集中管控平台，並在朗詩地產總部設立調度中心，在實現遠端數位化監測的基礎上，我們更注重數據的積累與分析，在保證朗詩房冷氣系統穩定運行的同時，為節能降耗提供數據支撐。

Landsea housing has built a centralized management and control platform for energy management systems and set up a dispatch center at the company's headquarters. Based on remote digital monitoring, Landsea focuses on data accumulation and analysis so as to provide data support for energy conservation and consumption reduction, while ensuring the stable operation of the air conditioning system of Landsea housing.

可持續的售後社區維護服務 Sustainable After-sales Service for Community Maintenance

隨著霧霾情況日益加重以及朗詩系統的除霾技術的不斷進步。朗詩房，秉承負責任售後，為進一步提升業主居住品質，朗詩對配置集中置換新風系統的、已交付住宅樓棟進行免費升級改造，升級後系統的除霾能力將得到顯著提升，在霧霾較嚴重情況下，新風過濾效能可達 80% 以上。

While the smog issue becomes increasingly severe, Landsea has also been making progress on its smog removal technology. Being responsible for the after-sales service, Landsea offers free upgrade and renovation for sold houses with centralized replacement of fresh air systems, which greatly increase the houses' smog removal capacity. In some cases, the fresh air filtration efficiency can reach more than 80%.

For the Hangzhou Landsea Youth Residence, turf and trees were planted on wasteland, with a total turf area of about 300 square meters, neutralizing carbon emissions in the community.





Landsea is committed to the career development needs of employees. In 2019, Landsea renovated and upgraded the office building of the Real Estate Headquarters in China. By following the WELL design concept, Landsea adhered to the human-oriented design principle and created a "healthy, comfortable, energy-saving, environmentally friendly, intelligent and humanistic" green working environment for employees.

Advocate a Balanced Layout of Work and Life

[Leisure space] Add leisure spaces such as coffee bars and public houses, partitioned by walls, clear glass, cellular shades and green plants, creating a healthy, leisurely, relaxed and flexible working space.

提倡平等、合作、協同的 工位分佈和共享辦公

「工位分佈」將東、南向陽光充足、視線開闊、風景怡人的室內空間提供給開敞式員工辦公，將西、北向相對較差的環境提供給獨立管理層辦公室和會議室。共用辦公區域，採用了升降桌、摩擦平衡板、地球樹等辦公桌椅的組合，打破了對常規「正確的坐姿」和「舒適的坐姿」的認識，有效降低頸椎病、腰椎病等機率。

Promote Equal, Cooperative and Collaborative Desk Distribution and Shared Office

[Desk distribution] Create an open-office space facing the east and the south, with enough sunlight, wide views and pleasant interior scenes, and the less desirable environment facing the north and the west reserved for independent management offices and meeting rooms. In the shared office area, there are adjustable desks, frictional balance plates and earth trees in place to redefine the conventional "correct sitting posture" and "comfortable sitting posture", and effectively reduce the probability of cervical spondylosis and lumbar spondylosis among employees.



關心員工身心健康的 設計管理

「顏色搭配」地面採用低反射度深灰色地膠，頂面白色乳膠漆，牆面原木色和白色乳膠漆搭配，原木色辦公桌面、淺灰色織物隔斷、白色櫥櫃、黑色扶手椅和綠植等低色彩飽和度搭配，空間色彩統一純粹、安靜和諧。

「光照設計」盡量採用自然光滿足日常需求外，集中在有效桌面區域。使用 6,000K 色溫的白色柔光面光源，整體照度透過計算滿足 500Lux，且照明分佈按辦公區域、走道、休閒區等不同功能主次佈置，合理使用能耗。

「降噪管理」臨街面用來臨時辦公或輔助健身功能，將主要辦公區域進行退讓，同時結合不同部門功能職責特性進行動靜分區，並透過吸音棉、地膠、到頂隔斷等材料 and 手段減少物理噪音對辦公的干擾。

「能源管理」根據不同功能空間分區域進行能源管理，盡量使用自然資源並選擇裝修效果的極簡主義，在裝修材料選擇上選擇環保、綠色的部品部件，整體室內環境達到芬蘭 S1 標準。

「情緒管理」在辦公環境的企業 VI 設計上，強調不斷奮鬥、創新的文化價值觀貫穿整個辦公空間，辦公健身、休閒的一體化空間、簡單明快、統一的低飽和度色彩、動靜分區的聲場環境、明暗和諧、高效的光照設計提供了健康、積極的情緒管理氛圍。

Design and Management Fit for Employees' Physical and Mental Health


[Color matching] The space color is unified and pure, quiet and harmonious, with low color saturation matching: low-reflectivity dark gray flooring, white latex paint on the ceiling, wood color and white latex paint on the walls, wood color desktop, light gray fabric partitions, white file cabinets, black armchairs, and green plants.

[Lighting design] Use natural light as much as possible to meet daily needs, and focus lighting on the effective desktop area. Use the white soft light source with 6000K color temperature. The overall illuminance is calculated to meet 500Lux, and the lighting distribution is arranged according to different functions such as office areas, aisles and leisure areas for efficient energy use.

[Noise reduction management] Use the frontage for temporary office or auxiliary fitness functions, put the main office area behind, partition dynamic and static areas according to the functions of different departments, and filters out physical noise in the office through materials and measures such as sound-absorbing cotton, floor rubber, and ceiling partitions.

[Energy management] Carry out energy management according to different functional spaces in different areas, use natural resources as much as possible, choose the minimalism of the decoration effect, choose environmentally friendly and green parts and components in decoration materials, and make the overall indoor environment meet the Finnish S1 Standards.

[Emotion management] In the design of the corporate VI of the working environment, the cultural values emphasizing continuous striving and innovation run through the office space. The integrated space for working, fitness and leisure, simple, bright and unified low saturation color, dynamic and static sound field environment, and an efficient and harmonious lighting design between bright and dark provide a healthy and positive emotion management atmosphere.



資源節約的綠色辦公 Resource-conservative Green Office

宣導資源節能

積極傳播健康生活方式,提高員工環保意識。

- 宣導節電、節水、公司多處張貼小貼士,提醒員工從小事做起,提升節約能源意識。
- 宣導包裝循環利用、節約紙張,減少資源浪費。

2019 年,辦公環境績效:單位面積耗電量減低 5%,單位面積耗水量減低 14%,有害廢棄物總量降低 45%,無害廢棄物總量降低 21%。

電子化、無紙化辦公

採用線上審批流程,以電腦代替紙筆做會議記錄,鼓勵大家使用 e-message、email、微信進行線上的工作溝通。2019 年,公司累計完成線上審批流程 29 萬條,召開移動視訊會議 2,284 次,累計會議時長超過 21,000 小時。

相較 2018 年,2019 年的辦公環境文印紙使用量減少 6.9 噸,名片、筆記本、宣傳冊等其他辦公用品消耗量也減少了 0.1 噸。

Advocating resource conservation

Actively promote healthy lifestyles and raise employees' awareness of environmental protection.

- Advocate power and water saving and post several small signs in the office to remind employees of saving energy from small things.
- Advocate package recycling and paper saving to reduce resource wastes.
- Advocate green travel and encourage public transportation.
- Print business cards with environmentally friendly paper.

In 2019, in terms of environmental performance, the power consumption per unit reduced by 5% and the water consumption per unit reduced by 14% while the total harmful wastes reduced by 45% and the total harmless wastes reduced by 21% compared with that of 2018 respectively.

Electronic and paperless office

Adopt online approval process, use computer instead of paper and pen to take meeting notes, and encourage employees to use e-message, e-mail, WeChat for online work communication. In 2019, Landsea completed a total of 290,000 online approval processes, and held 2,284 mobile video conferences, with cumulative conference duration of over 21,000 hours.

In 2019, the consumption of printed paper in office reduced by 6.9 tons while that of other office paper such as business cards, notebooks and brochures reduced by 0.1 tons compared with that of 2018 respectively.

In response to the national policy of waste classification, Landsea carried out promotions initiatives such as knowledge popularization, online testing, WeChat public account promotion, and employee family activities.




3.4 持續推進公益事業

中國武漢自 2019 年 12 月爆發新冠肺炎疫情以來，朗詩始終密切關注疫情發展及防疫物資的供給。2020 年 1 月 30 日，朗詩通過中歐國際工商學院校友總會、上海復星公益基金會及北京春苗慈善基金會，捐贈人民幣 1,000 萬元¹，該筆款項將用於從海外購買緊缺醫療物資，支援疫區一線工作人員，保障醫護人員的切實防護。

Since the outbreak of COVID-19 in Wuhan, China, in December 2019, Landsea has been paying close attention to the development of the epidemic and the supply of epidemic prevention materials. On January 30, 2020, Landsea donated RMB 10 million through CEIBS Alumni, Fosun Foundation and Beijing Chunmiao Charity Foundation to purchase medical supplies in short supply from overseas to support front-line medical workers and ensure their effective protection.

一對一助學活動

自 2008 年起，朗詩組織開展「一對一幫扶」，旨在幫助貧困家庭的學生實現讀書夢，為偏遠地區教育尋找出路。該計劃從創立至 2019 年，收到愛心捐助逾百萬元。

支教活動

為了促進師資隊伍建設，調動希望小學教職員的工作熱情和工作積極性，朗詩公益基金會自 2018 年起特設立「助教金」，用於幫助朗詩五權希望小學教職員的家庭或個人生活較為貧困的教職員，以及鼓勵業績優秀的教職員。



From 2008 to 2011, Landsea provided disaster relief assistance for two "earthquake-free" elementary schools (Landsea Wuquan Hope Elementary School and Labu Landsea Hope Elementary School). Labu Landsea Hope Elementary School is the first school in Yushu to be rebuilt and used after the earthquake, which can withstand a magnitude 8 earthquake. Over the years, Landsea has continued to provide soft support:

One-to-one Help Plan

Since 2008, Landsea has initiated the "One-to-one Help Plan" to help students from poor families attend schools and seek solution to education in remote areas. From its launch through 2019, the program has received more than one million yuan of donations, and every one thousand yuan can support one student through one school year. Landsea has been fulfilling its commitment to education support ever since.

Teaching Assistance Activities

In order to promote the development of the teaching staff and to mobilize their enthusiasm and activeness, Landsea Foundation set up a teaching assistantship in 2018 to help poor families or individual faculty members of Landsea Wuquan Hope Elementary School, and to recognize outstanding faculty members.

綠色蓓蕾 Green Bud Action

2016 年 11 月，朗詩公益基金會發起「綠色蓓蕾抗霾幼稚園公益行」行動（以下簡稱「綠色蓓蕾行動」），為幼稚園提供的包含新風換氣、高效除霾、智慧監控、節能降耗、超低噪音五大功能的除霾方案，在高效改善室內空氣的同時，還配備了可視化的智慧集成控制面板，做到家長、老師對室內空氣質素的實時監控。

「綠色蓓蕾行動」已相繼落地北京、天津、上海、蘇州、南京、合肥、杭州、成都、武漢和保定 10 座城市，共計 12 家機構。目前，改造的幼稚園已投入正常使用。

In 2019, Landsea continued to follow up on the user experience after the kindergarten was put into use, and called for more industry peers to participate into the initiative.”

In November 2016, Landsea Foundation launched the Green Bud Anti-Haze Public Welfare Action at Kindergartens (hereinafter referred to as the Green Bud Action), which provided kindergartens with a haze removal solution with five key elements—fresh air ventilation, efficient haze removal, intelligent monitoring, energy saving and consumption reduction, and ultra-low noise. While improving indoor air efficiently, it is also equipped with a visual intelligent integrated control panel to enable parents and teachers to monitor indoor air quality in real time. The Green Bud Action has been successively launched at 12 institutions in 10 cities—Beijing, Tianjin, Shanghai, Suzhou, Nanjing, Hefei, Hangzhou, Chengdu, Wuhan and Baoding. At present, the transformed kindergarten has been put into use.



In compliance with the *Environmental, Social and Governance Reporting Guide* (hereinafter referred to as the "ESG Reporting Guide") by The Stock Exchange of Hong Kong Limited (hereinafter referred to as "SEHK") international standards and guidelines, and relevant laws and regulations of China's mainland, Landsea clarifies the definition, calculation methods and parameters of various ESG indicators, tailors each indicator to functional departments based on its organizational structure and rolls out the *Instruction Manual of the ESG Performance Management System and Indicators* to standardize the ESG indicator management.



公司重視持份者的識別與溝通，持份者包括公司的股東及投資者、員工、客戶、供應商、社區、行業、政府及監管機構等。2019 年，公司與持份者建立了常態化的溝通機制，深入了解各方關注重點與訴求，透過一系列的應對措施，將持份者關注的議題納入公司的運營和決策過程中，積極回應持份者的訴求和期望，同時提升公司的可持續發展能力。2019 年，公司邀請第三方專業機構開展各持份者問卷調研，共計回收 204 份持份者調研問卷。

Landsea values stakeholders identification and engagement. Its stakeholders include shareholders and investors, employees, customers, suppliers, communities, industries, governments and regulatory agencies. Landsea has established a standard communication mechanism with stakeholders, further learns about their concerns and requests, and actively responds to their expectations via incorporating key issues of concern into its daily operation and decision-making process. Doing so also help enhance the company's ability for sustainable development. In 2019, Landsea authorized a professional third-party institution to carry out a stakeholder surveys, and collected 204 questionnaires from stakeholders in total.



公司按照議題界定與篩選、問卷調研、實質性議題分析與評估的程式，依據香港聯合交易所有限公司《環境、社會及管治報告指引》和全球報告倡議組織《可持續發展報告標準》，結合朗詩地產的社會責任理念、戰略和業務重點，對標國內外同行業優秀報告，識別出 21 項對公司和持份者關注的重要環境、社會與管治議題。透過開展持份者調研與專家意見諮詢，從對業務影響和對持份者影響兩個方面，對實質性議題的重要性進行排序。

Based on the ESG Reporting Guides issued by The Stock Exchange of Hong Kong Limited (SEHK) and the *Guidelines of Sustainable Development Report* issued by the Global Reporting Initiative (GRI), combined with the company's CSR concept, strategy and business focus, as well as domestic and global peer benchmarking, Landsea identified 21 ESG material issues most relevant to the company and its stakeholders via the process of issue identification, engagement survey, and material issue assessment. By conducting stakeholder survey and consulting experts, Landsea prioritizes material issues against two dimensions: impact on its business and impact on its stakeholders.

As a green company committed to sustainable development, Landsea regards "building home for people" as its mission and incorporates the ESG concept into its strategy and daily operation. Landsea has also set up an ESG working group to carry out communication with stakeholders, ESG data collection and report preparation, and contribute to the sustainable development of the company by continuing improving its ESG management performance.

朗詩奉行嚴格的防貪污政策，嚴格遵守「**不行賄受賄、不做假賬、不偷稅漏稅、不欺騙客戶**」四不鐵律，並對任何違反四不鐵律的人員進行追責，必要時訴諸法律。

Four Rules

Landsea has strict policies to prevent corruption and strictly abides by the rules against **bribery, false accounts, tax evasion, and customer fraud**. Those who disobey these rules will be held accountable or taken to court when necessary.

Zero Tolerance Principle

Upholding the zero tolerance principle for corruption, Landsea will report corruptive behaviors proven to be valid to the police department without exception. People involved in corruptive behaviors will be announced in real name and published on Landsea Green Properties' official website and corporate WeChat account.

反腐敗制度流程

公司有完善的反腐敗制度流程，制定了《反腐敗條例》、《廉潔從業規範手冊》、《朗詩集團審計監察制度》等反腐敗相關制度流程。公司設立審計監察部作為處理貪腐事件的直接部門，設立有專門的反腐舉報管道，包括郵件、信箱、微信公眾號、電話、傳真等多種管道。

Anti-corruption System Process

Landsea has a complete anti-corruption system process and formulates relevant regulations like the *Anti-corruption Regulations*, the *Standard Guide of Honest Practice* and the *Audit and Supervision System of Landsea Group*. Landsea sets up the Auditing and Inspection Office which is in direct charge of corruption cases and has special reporting channels for corruption cases such as emails, mailboxes, WeChat official accounts, phones, faxes, etc.

朗詩美國參照《反海外腐敗法》及朗詩集團反腐相關制度，制訂了公司《商業行為與道德守則》，並要求所有高管、管理層和員工按標準執行。

With reference to the *Foreign Corrupt Practices Act* and relevant anti-corruption regulations of Landsea Group, Landsea Homes formulates the *Code of Business Conduct and Ethics* and requires all the executives, managers and employees to act in accordance with the regulation.

商業行為守則與道德規範：

The Code of Business Conduct and Ethics

Violations and consequences; U.S. anti-boycott laws, export controls, money laundering, conflicts of interest, record keeping, corporate opportunities, competition and fair trading, business entertainment and gifts, discrimination and harassment, health and safety, environment, confidentiality, protection and proper use of corporate assets, anti-bribery and anti-corruption, waivers, reporting illegal or unethical behaviors and political donations.

反腐敗措施

朗詩對腐敗始終堅持懲教結合的態度，在公司企業文化中對於員工行為準則進行了詳細的規定，並定期進行宣講和案例分享。員工簽訂《廉潔承諾書》承諾廉潔從業，與合作供應商簽訂《廉潔協定》，控制貪腐行為。審計監察部定期對各區域公司進行例行和專項審計，並聘請外部機構對公司內控進行審計，以彌補內部控制上面的漏洞，降低腐敗事件發生概率。

Anti-corruption Measures

Sticking to a method combining punishment with education, Landsea sets up detailed provisions on the codes of conduct for its staff and organizes regular lectures and case sharing sessions. Employees should sign the Letter of Commitment to Integrity to engage in honest practice, and sign the Integrity Agreement with partner suppliers to contain corruption. Audit Committee conducts regular and special audits of regional companies and hires external agencies to conduct internal audit, in order to identify and mitigate any potential risks in internal control, and reduce the likelihood of corruption.

2019 年，朗詩監察室對中國大陸各區域公司 2018 年 -2019 年採購管理進行了專項監察，提出監察意見並要求相關單位及時整改。先後完成了地產上海公司、武漢公司、南京公司採購管理專項監察，及時發現採購圍標、合同價格虛高、多計結算等事項並要求相應公司進行跟蹤整改，從源頭上控制腐敗事件發生。

In 2019, Landsea Supervision Office conducted a special inspection on the procurement management of regional companies in China's mainland from 2018 to 2019 and proposed opinions and required relevant departments to make rectifications. Landsea has successively completed the special supervision on the procurement management of Landsea Shanghai Company, Wuhan Company and Nanjing Company, identified such issues as surround-bidding in procurement, high contract price and multiple settlement, and required all parties concerned to make rectifications, so as to combat corruption at its source.

在公司 OA 上進行廉潔公告，並設立專門的廉潔帳戶，員工在公務或社交活動中，因為各種原因，曾經有或將來有收受禮金行為的，可將未能拒收的禮金存入廉政帳戶。員工應妥善保管匯款憑證備查，並作為拒收禮金的依據。禮品及有價證券按照禮品上交制度辦理。及時處理各類舉報，結合審計中發現的線索對違規行為進行專項調查及處理。

Landsea opened the Business Integrity Bulletin on the OA and established a specialized incorruptibility account. Employees who have had or may receive cash gifts in public or social activities for various reasons may deposit the cash into this account when they fail to decline such cash gifts. Employees should keep the remittance vouchers for future reference and use them as evidence for proving their rejection of cash gifts. Gifts and securities shall be handled according to the gift submitting system.

Landsea handled tip-offs in a timely manner, and conducted special investigations and handled violations by referring to indications uncovered in the audit.

2019 年度反腐敗情況披露

2019 年，朗詩共發生 1 宗貪腐案件完成判決，另有 1 宗案件處於公訴階段，共開展了 15 項專項監察，除移送司法機關外，另處理違規違紀事項 6 起，開除辭退違規人員 6 人，予以其他處罰 3 人。

Anti-corruption Disclosure in 2019

In 2019, Landsea reported one corruption case whose judgment has been made and another case was at the stage of public prosecution. A total of 15 special inspections were carried out. In addition to reporting to the judicial body, Landsea handled six cases of violation of regulations and disciplines, dismissed six staff and imposed penalties on three others.

知識產權維護 IPR Protection

朗詩嚴格遵守《商標法》、《專利法》、《著作權法》及《反不正當競爭法》等相關法律法規的規定，透過培訓、教育等方式開展知識產權宣傳普及工作。朗詩歷來重視自身知識產權的維護，不限於品牌、商標保護，在專利、版權和域名等眾多知識產權領域都有所涉及；不限於國內，在香港地區和北美等也有朗詩商標等知識產權佈局。截止到 2019 年底，朗詩共布局商標（包括申請中）545 件。

Landsea strictly abides by the *Trademark Law of the People's Republic of China*, the *Patent Law of the People's Republic of China*, the *Copyright Law of the People's Republic of China*, the *Law of the People's Republic of China Against Unfair Competition* and other relevant laws and regulations, and promote awareness of intellectual property (IP) right through training and education. Landsea has been attaching great importance to the maintenance of its own IP rights, including but not limited to the protection of brands, trademarks, patents, copyrights and domain names; expanding its layout from China to Hong Kong, North America and other areas. By the end of 2019, Landsea owned a total of **545** trademarks (including those under application).
