Determination of the Offer Price and Allocation of the Hong Kong Offer Shares

The Offer Price is expected to be fixed on or around Friday, 10 July 2020. Applicants are required to pay the maximum Offer Price of HK\$0.69 for each Hong Kong Offer Share together with 1% brokerage, 0.0027% SFC transaction levy and 0.005% Stock Exchange trading fee. If the Offer Price is not agreed between the Company and the Joint Global Coordinators (for themselves and on behalf of the Underwriters), the Share Offer will not proceed and will lapse immediately.
