REPURCHASE OF 13.0% SENIOR NOTES DUE 2020 (STOCK CODE: 5717)

Reference is made to the announcements of Jingrui Holdings Limited (the “**Company**”) dated 31 January 2019 in relation to the Company’s 13.0% senior notes due 2020 (the “**Notes**”).

On 8 July 2020, the Company, through private negotiations, purchased the Notes in an aggregate principal amount of US\$20,000,000, representing 13.33% of the aggregate principal amount of the Notes originally issued.

Upon cancellation, the aggregate principal amount of the Notes that remains outstanding is US\$130,000,000, representing 86.67% of the aggregate principal amount of the Notes originally issued.

The Company may or may not purchase further Notes in the future. Noteholders and potential investors should note that any purchase of Notes from time to time by the Company will be at the board of the Company’s sole and absolute discretion. There is no assurance of the timing, amount or price of any purchase of the notes or whether the Company will make any further purchase at all. Noteholders and potential investors should therefore exercise caution when dealing in any Notes.
