The extraordinary general meeting of the Company has been held on 2 July 2020 to approve the share consolidation which become effective on 6 July 2020.

As a result of the share consolidation:-

(1) the authorised share capital of the Company shall become HK\$10,000,000 divided into 312,500,000 consolidated shares of par value of HK\$0.032 each, of which 189,300,000 consolidated shares will be in issue

(2) the number of consolidated shares to be allotted and issued under the share option scheme and the exercise price of share options adjusted to 18,750,000 shares and HK\$0.90 per share.

(3) the number of consolidated shares to be allotted and issued under the share option scheme and the exercise price of share options adjusted to 18,930,000 shares and HK\$0.464 per share.
