- As at July 31, 2020, the Company completed the distribution of issue of A shares of the Company by way of conversion of capital reserve into share capital. Due to the approval by the State Administration of Foreign Exchange, as at July 31, 2020 the Company was handling the distribution of issue of H shares of the Company by way of conversion of capital reserve into share capital, which is expected to be completed on August 18, 2020.
