## **ANNOUNCEMENT POWER GENERATION FOR AUGUST 2020**

This announcement is made pursuant to Rule 13.09 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited and the Inside Information Provisions under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

The board of directors (the “**Board**”) of Huadian Fuxin Energy Corporation Limited (the “**Company**”) announces that, according to the preliminary statistics of the Company, the gross power generation of the Company for August 2020 amounted to 5,510,122.3 MWh, representing an increase of 26.9% over the corresponding period of 2019, of which, the wind power generation was 1,170,192.1 MWh, representing an increase of 8.9% over the corresponding period of 2019; the solar power generation was 160,694.0 MWh, representing an increase of 0.7% over the corresponding period of 2019; the hydropower generation was 330,137.0 MWh, representing a decrease of 69.8% over the corresponding period of 2019; the coal-fired power generation was 3,462,009.2 MWh, representing an increase of 109.6% over the corresponding period of 2019; the natural gas-fired (distributed) power generation was 372,392.7 MWh, representing an increase of 4.0% over the corresponding period of 2019; and the power generation of other clean energy was 14,697.4 MWh, representing an increase of 140.5% over the corresponding period of 2019.
