**ANNOUNCEMENT ON UNAUDITED OPERATING DATA
FOR THE THIRD QUARTER OF
THE THREE MONTHS ENDED 30 SEPTEMBER 2020 AND
THE NINE MONTHS ENDED 30 SEPTEMBER 2020**

This announcement is voluntarily made by Dynagreen Environmental Protection Group Co., Ltd.* (the “**Company**”, together with its subsidiaries, the “**Group**”).

The board of directors (the “**Board**”) of the Company is pleased to announce that the unaudited waste input volume, electricity generation volume and on-grid electricity volume of the Group amounted to 2,451,700 tons, 944,386,200 kWh and 776,533,700 kWh respectively in the third quarter of the three months ended 30 September 2020. For the nine months ended 30 September 2020, the unaudited waste input volume of the Group amounted to 6,431,000 tons, representing a year-on-year increase of 22.88%; the electricity generation volume was 2,335,941,900 kWh, representing a year-on-year increase of 39.66%; and the on-grid electricity volume was 1,915,703,400 kWh, representing a year-on-year increase of 39.04%.
