**WINDING UP BY THE COURT;
APPOINTMENT OF PROVISIONAL LIQUIDATOR
AND
SUSPENSION OF TRADING**

Reference is made to the announcements of Rentian Technology Holdings Limited (the “Company”) released on 22 March 2020, 1 April 2020, 8 June 2020, 19 June 2020, 17 July 2020, 3 August 2020, 9 September 2020 and 21 October 2020 in relation to the winding up petition presented against the Company.

WINDING UP ORDER AGAINST THE COMPANY

On 21 October 2020, the Company was ordered to be wound up by the High Court of Hong Kong in HCCW 63/2020 pursuant to the provisions of the Companies (Winding Up and Miscellaneous Provisions) Ordinance (Chapter 32, Laws of Hong Kong) and the Official Receiver by virtue of her office becomes the Provisional Liquidator of the Company.

SUSPENSION OF TRADING

In view of the above, trading in the Company’s shares on The Stock Exchange of Hong Kong Limited has been suspended with effect from 9:00 a.m. on 22 October 2020.

The Company will keep the public informed by making further announcements as and when appropriate.
