Unless you have indicated otherwise in this form of proxy, your proxy will abo be entitled to vote at his discretion on any resolution to be proposed properly at the H Share Class Meeting other than those referred to in the notice convening the H Share Class Meeting.
- 5. This form of proxy must be signed by you or your attorney duly authorised in writing. In case of a corporation, the same must be either under its common seal or signed by the director or duly authorised attorney(s). If the form of proxy is signed by an attorney of the shareholder, the power of attorney authorising that attorney to sign or other authorisation document must be notarised.
- 6. In case of joint holders of any share, any one of such joint holders may vote at the H Share Class Meeting, either personally or by proxy, in respect of such shares as if he/she is solely entitled thereto. However, if more than one of such joint holders are present at the H Share Class Meeting, personally or by proxy, the vote of the joint holder whose name stands first in the register of members and who tenders a vote, whether in person or by proxy, will be accepted to the exclusion of the votes of other joint holder(s).
- 7. In order to be valid, this form of proxy together with the power of attorney or other authorisation document (if any) must be deposited at the Company's H share registrar for holders of H Shares not less than 24 hours before the time fixed for holding the meeting or any adjournment thereof (as the case may be). Completion and return of a form of proxy will not preclude a shareholder from attending and voting in person at the meeting if he/she so wishes. The H share registrar of the Company is Tricor Investor Services Limited at Level 54, Hopewell Centre, No. 183 Queen's Road East, Hong Kong.
- 8. Shareholders or their proxies attending the H Share Class Meeting shall produce their identity documents.
