ADJOURNMENT OF EXTRAORDINARY GENERAL MEETING

Reference is made to the circular ("**Circular**") of Convoy Global Holdings Limited ("**Company**") and the notice of the EGM dated 18 October 2020, and the announcement on COVID-19 Precautionary Measures for the EGM dated 18 November 2020. Unless the context requires otherwise, terms used herein shall have the same meanings as defined in the Circular.

Reference is made to the extraordinary general meeting of the Company held on 26 November 2020 at 6:00 p.m. (the "EGM").

A quorum was present at the time appointed for the EGM and the EGM commenced at 6:00 p.m. As Mr. Johnny Chen was not in Hong Kong, the Directors present at the EGM nominated the Company's independent non-executive Director, Mr. Lam Kwok Cheong to preside as the chairman of the EGM ("**Mr. Lam**").

Soon after the EGM commenced, a proxy (the "**Disruptive Proxy**") of Mr. Kwok Hiu Kwan ("**Mr. Kwok**") interrupted the proceedings, claiming that Mr. Kwok controlled 51.2% of the voting rights of the Company and tried to wrest control of the EGM. The Disruptive Proxy physically approached the Directors' bench and also acted in a threatening and intimidating manner.

Mr. Lam repeatedly requested the Disruptive Proxy to cease interrupting the EGM and to allow the EGM to proceed, but the Disruptive Proxy refused to heed Mr. Lam's request. Following this, the meeting descended into a shouting session from proxies of Mr. Kwok who continued to attempt to wrest control of the EGM. As the EGM could not proceed in a safe and orderly manner, Mr. Lam adjourned the meeting.

Subsequent to the adjournment of the EGM, Mr. Lam has requested the Company to adjourn the meeting to a time and date before the end of January 2021.

The Company will make a further announcement regarding the adjourned meeting as soon as possible.

CONTINUED SUSPENSION OF TRADING

At the request of the Company, trading in the Company's shares on The Stock Exchange of Hong Kong Limited (the "**Stock Exchange**") was halted from 11:04 a.m. on 7 December 2017 (automatically converted to "being suspended" thereafter), and will remain suspended until further notice. The Company will keep the public informed of the latest developments by making further announcement(s) as and when appropriate.
