The Board of the Company hereby announces that, subject to acceptance of the Grantees, 2,400,000 Options to subscribe for the Shares were granted on 14 December 2020 under the Share Option Scheme.

The Board (the “**Board**”) of directors (the “**Director(s)**”) of Plover Bay Technologies Limited (the “**Company**”) hereby announces that subject to acceptance of the grantees (the “**Grantees**”), 2,400,000 share options (the “**Options**”) to subscribe for 2,400,000 ordinary shares of HK\$0.01 each in the Company (the “**Shares**”) were granted on 14 December 2020 (the “**Date of Grant**”), under the share option scheme conditionally adopted by the Company on 21 June 2016 and which became effective on 13 July 2016 (the “**Share Option Scheme**”).
