INTRODUCTION

Reference is made to the prospectus of National Investments Fund Limited (the “Company”) date Monday, 21 December 2020 in relation to the Rights Issue (the “Prospectus”). Terms defined in the Prospectus shall have the same meanings when used herein unless the context otherwise requires.

In accordance with the terms set out in the Prospectus accompanying this PAL, the Directors have provisionally allotted to you the Rights Shares on the basis of five (5) Rights Shares for every one (1) Existing Share held and registered in your name(s) on Friday, 18 December 2020 at a Subscription Price of HK\$0.035 per Rights Share. Your holding of Existing Shares as at Friday, 18 December 2020 is set out in Box A and the number of Rights Shares provisionally allotted to you is set out in Box B.

The Rights Shares, when allotted, issued and fully paid, will rank *pari passu* with the then Existing Shares in issue on the date of allotment of the Rights Shares in all respects. Holders of such Rights Shares will be entitled to receive all future dividends and distributions which are declared, made or paid on or after the date of allotment and issue of the Rights Shares.

The Prospectus and the related application forms have not been and will not be registered or filed under any applicable securities or equivalent legislation of any jurisdictions other than Hong Kong.

No action has been taken to permit the offering of the Rights Shares, or the distribution of the Prospectus or any of the related application forms, in any territory or jurisdiction outside Hong Kong.
