### Price Determination of the Global Offering

The Offer Price is expected to be fixed on or around Monday, 28 December 2020. If the Offer Price is not agreed between the Company, the Selling Shareholders and the Sole Global Coordinator (on behalf of the Underwriters) by Monday, 4 January 2021, the Global Offering will not proceed and will lapse.
