- establishing benefit entitlements of securities' holders of the Company, such as dividends, rights issues and bonus issues, etc.;

4. Retention of personal data

All requests for access to data or correction of data should be addressed to us, at our registered address disclosed in the section headed "Corporate Information" in the Prospectus or as notified from time to time, for the attention of the company secretary of the Company, or the Hong Kong Branch Share Registrar for the attention of the privacy compliance officer.
