ADDITIONAL RESUMPTION GUIDANCE

This announcement is made by Good Resources Holdings Limited (the “**Company**”) pursuant to Rule 13.09 of the Listing Rules and the Inside Information Provisions (as defined under the Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

Reference is made to the announcements of the Company dated (i) 24 September 2020 in relation to, among others, the Loan Transactions; (ii) 30 September 2020 in relation to, among others, the delay in publication of the 2020 Annual Results; and (iii) 28 October 2020 in relation to the resumption guidance set by the Stock Exchange for the Company (collectively, the “**Announcements**”). Unless otherwise defined, capitalised terms used herein shall have the same meanings as those defined in the Announcements.

ADDITIONAL RESUMPTION GUIDANCE

With reference to the announcement of the Company dated 28 October 2020, the Company received a letter from the Stock Exchange dated 23 October 2020 in which the Stock Exchange sets out the following resumption guidance for the Company (the “**Initial Resumption Guidance**”):

- (a) publish all outstanding financial results required under the Listing Rules and address any audit modifications;
- (b) conduct an appropriate independent forensic investigation into the Loan Transactions, announce the findings and take appropriate remedial actions; and
- (c) announce all material information for the Company’s shareholders and investors to appraise its position.

On 8 December 2020, the Company received a further letter from the Stock Exchange in which the Stock Exchange sets out the following additional resumption guidance for the Company (the “**Additional Resumption Guidance**”, together with the Initial Resumption Guidance, the “**Resumption Guidance**”):

(d) demonstrate the Company’s compliance with Rule 13.24 of the Listing Rules.

The Stock Exchange indicated that it may modify the Resumption Guidance that has been given and/or give further guidance if the Company’s situation changes.

CONTINUED SUSPENSION OF TRADING

At the request of the Company, trading in the shares of the Company on the Stock Exchange has been suspended with effect from 1:00 p.m. on 23 September 2020, and will remain suspended until the Company fulfills the Resumption Guidance.

Shareholders and potential investors of the Company are advised to exercise caution when dealing in the securities of the Company.
