**TENDER AWARDED FOR THE EQUIPMENT PROCUREMENT PROJECT OF  
LONGKOU BIG DATA CENTER BY JIANGSU INTELLITRANS,  
A WHOLLY OWNED SUBSIDIARY OF THE COMPANY**

This voluntary announcement is made by Nanjing Sample Technology Co., Ltd. (the “**Company**”).

The board of directors of the Company (the “**Board**”) is pleased to announce that on 15 December 2020, Jiangsu Intellitrans Company Ltd.\* (江蘇智運科技發展有限公司) (“**Jiangsu Intellitrans**”), a wholly-owned subsidiary of the Company, received the “Tender Award Notice” issued by Longkou City Longxin Big Data Co., Ltd.\* (龍口市龍芯大數據有限公司) which stated that Jiangsu Intellitrans successfully won the bidding for the equipment procurement project of Longkou Big Data Center in Yantai City, Shandong Province (the “**Project**”), with an amount of approximately RMB248 million. On 17 December 2020, a formal contract was signed for the Project.

**BACKGROUND OF THE PROJECT**

HUAWEI – Longkou Big Data Industrial Park\* (龍口大數據產業園) is located on the central axis of Longkou city, which is within the same proximity where the People’s Government, the People’s Park, and the Civil Activity Center\* (市民活動中心) of Longkou City are situated. With the superior geographical location, Longkou Big Data Industrial Park is divided into six major sectors: big data core industry, demonstration and exchanges, research and development office, platform services, intelligent manufacturing and park supporting facilities.

As of now, construction has been commenced at a core area covering an area of 100 acres, with an estimated total investment of RMB1.53 billion. Focusing on the establishment of HUAWEI (Longkou) Big Data Center\* (華為(龍口)大數據中心), it is committed to building Longkou city into a public cloud computing and big data service platform for Yantai, and a data backup center for Japan, Korea, national ministries and commissions, financial institutions and Bohai Economic Rim. Surrounding the Big Data Center, Longkou City Showroom\* (龍口城市展廳), a supporting facility will be built, it

includes Longkou Intelligent Operation Center\* (龍口智能運營中心), Emergency Command Center\* (應急指揮中心), Longkou City Image Exhibition Center \* (龍口城市形象展示中心) and HUAWEI Big Data Exhibition Center\* (華為大數據展示中心). An industrial building will be built to establish an innovation and entrepreneurship incubators, naming as HUAWEI Cloud (Longkou) Innovation Center\* (華為雲(龍口)創新中心). A dual innovation industry demonstration zone will be built to provide a support platform for HUAWEI's ecological partners and foreign big data enterprises.
