#### TRADING UPDATE POWER GENERATION FOR DECEMBER 2020

This announcement is made by CGN New Energy Holdings Co., Ltd. (the "Company") on a voluntary basis.

The board (the "Board") of directors (the "Directors") of the Company announces that, according to the preliminary statistics of the Company, the power generation of the Company and its subsidiaries (the "Group") on a consolidated basis amounted to 1,221.2 GWh for the month of December 2020, representing an increase of 4.5% compared with the corresponding period of 2019. In particular, power generation of PRC wind projects increased by 59.5%, power generation of PRC solar projects increased by 67.3%, power generation of PRC coal-fired, cogen and gas-fired projects decreased by 67.3%, power generation of PRC hydro projects decreased by 38.1% and power generation of Korea gas-fired projects decreased by 8.1%. For the twelve months ended 31 December 2020, the accumulated power generation of the Group amounted to 13,825.2 GWh, representing an increase of 2.1% compared with the corresponding period of 2019. In particular, power generation of PRC wind projects increased by 46.4%, power generation of PRC solar projects increased by 64.4%, power generation of PRC coal-fired, cogen and gas-fired projects decreased by 75.1%, power generation of PRC hydro projects decreased by 5.5% and power generation of Korea gas-fired projects decreased by 4.4%.

Since January 2020, one of the projects has temporarily stopped operations due to, among others, its restricted access to local water supply, which caused a year-on-year decrease in power generation in December 2020.
