According to the present PRC Corporate Income Tax Law and its relevant regulations, Jiangsu Chuangxin will be entitled to a preferential corporate income tax rate of 15% for 3 years from 1 January 2020 to 31 December 2022 upon receipt of the certificate of "High and New Technology Enterprise", instead of the statutory corporate income tax rate of 25% that Jiangsu Chuangxin paid for 2019, which would lead to the decrease of the Company's income tax expenses in 2020 over 2019.
