On 27 January 2021, the Company issued Convertible Bonds with principal amount of US\$125,000,000 at an interest rate of 2.25% per annum under general mandate to raise funds for repayment of existing borrowings, acquisitions and general corporate purposes. Based on the initial Conversion Price (subject to adjustments) of HK\$2.525 per Share and assuming full conversion of the Bonds, the Bonds will be convertible into approximately 383,881,188 New Shares (subject to adjustments). The Convertible Bonds will mature on the Fifth anniversary from the date of the issue on 27 January 2021.
