(1) According to the audited financial statements of the Company for the year ended 31 December 2016, the issued and fully paid share capital of the Company as at 31 December 2016 was stated to be 14,938,896,000 ordinary shares ("Original Share Capital").

For the purpose of the Company's financial statements for the financial years ended 31 December 2017, 2018 and 2019, a total of 7,160,300,000 ordinary shares (representing approximately 47.93% of the Original Share Capital) became null and void and/or invalid and/or rescinded, and such ordinary shares were recognised and stated as reserve (rather than share capital) as a matter of financial reporting in the financial statements for the financial years ended 31 December 2017, 2018 and 2019.
