If the Company does not receive the enclosed Reply Form duly completed and signed by you or does not receive a response indicating an objection from you by 16 April 2021, you will be deemed to have agreed to the Website Version instead of receiving printed copies of all future corporate communications, and to receive a written notification by post for the publication of the relevant corporate communications on the website of the Company.

You have the right at any time to change your elected means of receipt and choice of language of the corporate communications by providing reasonable prior notice in writing to the Company c/o the Hong Kong Share Registrar or by sending an e-mail to pagd.ecom@computershare.com.hk. If for any reason you have difficulty in receiving or gaining access to the Website Version of the corporate communications, the Company will, upon your request in writing or by e-mail, promptly send the printed version(s) of the corporate communications to you free of charge.

Please note that (a) the printed versions of the corporate communications in English and Chinese will be available from the Company and the Branch Share Registrar upon request, and (b) the Website Version of both English and Chinese of the corporate communications will be available on the website of the Company at www.pagd.net and on the HKExnews' website at www.hkexnews.hk.
