天能概況

天能動力國際有限公司(「天能動 力」或「公司」)及連同其附屬公司 (「集團」) 是中國新能源動力電池 行業的龍頭企業, 創始於 1986 年。 2007 年, 天能動力在香港聯合交易所 有限公司(「聯交所」)主板上市[證 券代碼 00819.HK]。經過三十多年的 發展, 現已成為以電動輕型車動力電 池為主, 集汽車起動啓停電池、儲能 電池、電動特種車動力電池、備用電 池等多品類電池的研發、生產、銷 售, 以及廢舊電池回收和可再生資源 循環利用、 綠色智造產業園建設、智 慧物流平台等為一體的新能源集團。

Enterprise Profile

Tianneng Power International Limited ("Tianneng Power" or the "Company"), together with its subsidiaries (the "Group"), is a leading company in the sector of motive batteries for new-energy vehicles in China, founded in 1986. In 2007, Tianneng Power was listed on the Main Board of The Stock Exchange of Hong Kong Limited (the "Stock Exchange") (Stock Code: 00819.HK). After more than 30 years of development, it has become a high-tech energy group focusing on the motive batteries for light electric vehicles and integrating the research and development (R&D), production and sale of various types of batteries (including start-stop batteries for automobiles, power storage batteries, motive batteries for special electric vehicles and standby batteries), the recycling of waste batteries and renewable energy, the construction of green and intelligent manufacturing industrial parks, and smart logistics platforms.

The Company was awarded the honorary title of "National Green Factory" by the Ministry of Industry and Information Technology of the People's Republic of China("China" or the "PRC"), and was selected as the Excellent Case of Chinese Private Enterprise Social Responsibility.

Products and Services

The core segments of the Group' s products and services include high-end eco-friendly batteries, new energy batteries and green new materials.

High-end Eco-Friendly Batteries

The high-end eco-friendly batteries are a series of sealed, maintenance-free lead-acid batteries created by Tianneng relying on R&D and technological innovation. They are environmentally friendly battery products with high stability, high cost performance and excellent recyclability. Their application fields cover electric light vehicles, electric special vehicles, starting and stopping of cars, energy storage and backup, etc.

New Energy Batteries

The Company's new energy batteries are mainly lithium-ion batteries, and also involve the production and R&D of next-generation battery products such as fuel cells. The application fields of lithium-ion batteries are mainly divided into two categories: power applications and non-power applications. Among them, power applications include electric light vehicles, electric passenger cars, and electric commercial vehicles, whereas the non-power applications include consumer electronics and energy storage.

Renewable New Materials

Tianneng actively fulfills the producer's extended obligation to recycle metals, plastics, residual acids and other substances in used batteries.

In 2020, in the face of the complex and severe macro situation, industry trends, and the impact of the COVID-19 epidemic, the Group adhered to the keynote of "seeking improvement in stabilization", coordinated the prevention and control of the epidemic and production and operation, and vigorously implemented the development strategy of "intelligence, platform and globalization" to continuously maintain high-quality and steady development.

In 2020, the total assets of the Group reached RMB 23.2 billion , with an increase of 21.3% over the previous year; the profit attributable to shareholders was RMB 2.48 billion, with an increase of 47.3% over the previous year.

During the year, the Group has actively responded to the ever-changing external situation and market environment, overcomed the challenges posed by the epidemic, seized opportunities and optimized strategies, which further enhanced our pattern of high-quality development. The Group places priority on the health and safety of its employees with improving its competitiveness in the industry as its core focus, consolidates the achievements of epidemic prevention and control, and pays close attention to its business objectives. In addition, the Group is committed to the R&D and the use of new technologies, new processes and new materials to fulfill the needs of different markets and customers, and thus its operating performance has improved gradually. The Group ranks 15th among the top 500 global new energy enterprises, 147th among the top 500 Chinese enterprises, 16th among the top 500 Chinese private manufacturing enterprises, and first among the top 10 enterprises in the Chinese light industry battery industry.

Carry Out Epidemic Prevention and Control

On 28 January, 2020, Tianneng established an epidemic prevention and control leading group in good time. During the epidemic, Chairman Zhang Tianren arranged deployment in person, organizing more than 20 special meetings, formulating more than 50 prevention and control mechanisms and over 160 prevention and control measures, and arranging more than 1,800 quarantine rooms to lay a solid foundation for resumption of work and production.

In the face of the Covid-19 epidemic, the Group acted solidly and swiftly, focusing on the prevention and control of the epidemic on the one hand, and resuming work and production on the other hand, highlighting its corporate accountability in the fight against the epidemic.

A total of 15 vehicles were sent to Yunnan, Henan, Guizhou and other places to pick up 500 workers from other provinces to return to work, making positive contributions to "stabilizing employment".

Tianneng' s production bases have successively established upstream and downstream enterprise docking working groups to activate a large number of "market entities" driven by leading enterprises to ensure the smooth flow of the industry chain. Relevant subsidiaries also went to supporting enterprises to provide guidance on epidemic prevention, assisted in obtaining 11 certificates of work resumption and more than 200 logistics passes, which was like clicking the "shortcut" of work resumption in the industry chain.

Since 2005, the Group has gone out of Zhejiang Province and has successively opened factories in Henan Province, Jiangsu Province, Anhui Province, Guizhou Province and other provinces to stabilise employment and solve problems in life for tens of thousands of people through poverty alleviation driven by employment, consumption and donation.

"輸血""造血" 有機融合

在產業扶貧過程中, 天能集團牢牢 抓住增強貧困地區自身造血能力這 一關鍵, 積極創新扶貧模式, 通過 "公司+貧困戶" "保底+分紅" 的利益聯結方式共建扶貧產業園, 建立產業發展與脫貧攻堅的長效持 久的脫貧機制, 實現 "輸血"扶貧 和 "造血"扶貧有機融合, 為產業 扶貧賦予持續發展的新動能。

特別是 2016 年以來, 天能積極回應 東西部扶貧協作的號召, 到國家級貧 困縣——貴州省黔東南州台江縣投資 興業,通過產業拉動、利益聯結、就 業增收、結對攻堅等創新舉措, 打造 具有天能特色的"扶貧套餐"。

黔東南州台江縣是中國脫貧攻堅的主 戰場,全縣總人口16.9萬人,其中苗 族人口占全縣總人口的98%,有"天 下苗族第一縣"之稱,由於群山阻 隔、基礎條件落後、群眾受教育程度 低等原因,長期處於貧困和落後狀 態,過去村民經濟收入主要來自傳統 農業和外出勞務打工,二、三產業十 分脆弱,脫貧攻堅任務極其繁重。

2019 年 4 月,天能集團在台江的新項 目正式開工投產,吸納了 15 個少數民 族、近千名台江籍員工在"家門口" 就業。

Potent Combination of "Giving" and "Empowering"

In the process of industrial poverty alleviation, the Group firmly grasped the key to enhancing the money-making capability of poverty-stricken areas, actively innovated poverty alleviation models, jointly built poverty alleviation industrial parks through the benefit linkage of "company + poor households" and "guarantee + dividends", and established a long-term and lasting poverty alleviation mechanism for industrial development and poverty alleviation, realizing the potent combination of "giving" and "empowering" in poverty alleviation, and giving new impetus to the sustainable development of industrial poverty alleviation.

Especially since 2016, Tianneng has actively responded to the call for poverty alleviation cooperation between east China and west China, and invested in the state-level poverty-stricken county - Taijiang County, Qiandongnan Prefecture, Guizhou Province. Through innovative measures such as industry stimulus, interest linkage, employment to increase income and pairing to tackle problems, we have created a "poverty alleviation package" with Tianneng characteristics.

Taijiang County in Qiandongnan Prefecture is the main battlefield for China's poverty alleviation. The county has a total population of 169,000, of which the Miao population accounts for 98%. It is known as the "No. 1 Miao County in the World". Due to the isolated geographic conditions, poor basic conditions and low education of the people, the county has been in a state of poverty and backwardness for a long time. In the past, the villagers' economic income mainly came from traditional agriculture and migrant labor. The secondary and tertiary industries were very fragile in the county and the task of poverty alleviation was extremely arduous.

In April 2019, the Group's new project in Taijiang County officially started and was put into production, attracting 15 ethnic minorities and nearly 1,000 Taijiang local employees to find employment near their "home".

2020 年 5 月 9 日, 余杭天能扶貧產 業園項目簽約儀式在台江舉行, 貴州 台江經濟開發區經濟發展有限責任公 司、天能融資租賃 (天津) 有限公 司、天能集團貴州能源科技有限公司 三方簽訂合作協定, 共同創新 "政府 + 龍頭企業 + 貧困村 + 貧困戶" 的扶 貧模式。

這種扶貧模式對缺乏工業支撐的深度 貧困村和失能、 弱能貧困農戶具有非 常強的扶貧針對性, 既把貧困戶的收 入和勞動掛鉤, 又保證了產業項目最 大程度地惠及每一個貧困群眾, 讓沒 有勞動能力的人也能獲得保障。

該項目就近吸納有勞動能力的 500 名 貧困村民就業, 人均月收入 3500 元 以上, 讓貧困戶月月既有保底的工資 性收入,也能按股權年年獲得分紅。



Explore a New Model of Poverty Alleviation based on Interest Linkage

On 9 May, 2020, the signing ceremony of the Yuhang Tianneng County Poverty Alleviation Industrial Park project was held in Taijiang County. Guizhou Taijiang Economic Development Zone Economic Development Co., Ltd., Tianneng Finance Leases (Tianjin) Co., Ltd.. and Tianneng Group Guizhou Energy Technology Co., Ltd. signed a cooperation agreement to jointly innovate the poverty alleviation model of "government + leading enterprises + poor villages + poor households".

This poverty alleviation model is specially targeted to deeply impoverished villages lacking industrial support, as well as the disabled and impoverished rural households. It not only links the income of poor households with labor, but also ensures that industrial projects benefit every impoverished person to the greatest extent, so that those who are unable to work can also be secured.

The project helped 500 impoverished villagers with working capacity nearby to obtain employment, with a per capita monthly income of more than RMB 3,500, so that poor households could have guaranteed wage income each month and also receive annual dividends based on their equity.

2019 年 1 月到 2020 年 5 月, 天能集 團貴州台江公司累計投入約 10 萬元消 費扶貧資金,對周邊村民種植大米、西 瓜、蘑菇、枇杷,養殖的雞肉、牛肉等 農副產品進行保價收購,解決當地貧困 農民的農副產品滯銷難題。

2020 年 3 月 3 日, 貴州省人民政府 發出公告, 正式批准台江縣退出國家 級貧困縣序列。天能為台江縣的脫貧 工作,作出了應有的貢獻。 With benefit-linkage development to assist industrial projects, the Group is also actively carrying out consumption-driven poverty alleviation work.

From January 2019 to May 2020, Tianneng Group Taijiang Company in Guizhou Province invested about RMB 100,000 in the consumption-driven poverty alleviation funds to purchase agricultural and sideline products such as rice, watermelon, mushrooms, loquat and farmed chicken and beef grown and raised by the surrounding villagers, solving the problem of unsalable agricultural and sideline products of local poor farmers.

On 3 March, 2020, the People's Government of Guizhou Province issued an announcement officially approving Taijiang County to withdraw from the list of state-level poverty-stricken counties. Tianneng has made due contributions to the poverty alleviation work in Taijiang County.

Governance Structure

The Group always regards "managing enterprises in accordance with the law and operating in good faith" as the code of conduct, follows the guidelines of the Rules Governing the Listing of Securities on the Stock Exchange (the "Listing Rules"), and builds a corporate governance platform through rules and regulations, internal management, risk prevention and control, and timely, comprehensive and public information disclosure.

Decisions on major issues of the Group are made by the Board. The Board consists of eight directors, three of whom are independent non-executive directors. Directors perform their duties faithfully and diligently, whose main duties include reviewing and approving corporate strategies, reviewing internal controls and operational compliance. The Group convenes meetings of the Board on a regular basis, and all directors can express their opinions on management and other matters at the meetings.

There are three special committees under the Board: the Audit Committee, the Nomination Committee and the Remuneration Committee. The main duties of the Audit Committee are to review the Group's financial reporting procedures and internal control systems, and to advise the Board on the appointment, renewal and dismissal of the Company's independent external auditors and related terms of remuneration and appointment. The Nomination Committee is responsible for identifying qualified Board members and advising the Board on related issues such as the appointment or renewal of directors when needed. The main responsibility of the Remuneration Committee is to advise the Board on the Company's policies related to the remuneration of directors and senior management.

The results of external audit are reported directly to the Board by the firm' s staff, which not only strengthens the internal risk management of the enterprise, but also effectively avoids the occurrence of violations of laws and regulations.

Regardless of the region in which the Group operates its business, we strictly abide by all laws and regulations regarding anti-corruption and bribery. The Group has formulated strict anti-corruption policies and prevents and manages possible conflicts of interest and bribery through training or patrol.

On the basis of summing up previous anti-corruption work experience, the Group strengthened relevant trainings in combination with cases, and announced reporting channels (hotline, email, WeChat public account, etc.) to encourage and protect personnel who report and expose behaviors that harm the Company' s interests, and to resolutely crack down on corruption and fraud, so that the lawful rights and interests of the enterprise and shareholders are strongly protected to ensure the healthy development of the enterprise.

Security and Environmental **Protection System**

In 2020, the Group normalized risk management and control, comprehensively boosted in-depth safety construction, which further ensured the good momentum of high-guality development. The relevant measures included: establishing a three-level inspection mechanism of "Second-level company self-inspection and self-correction + business department supervision and inspection + group supervision and control", launching an internal control risk system, integration of safety and environmental information, construction of a safety and environmental system process system, organization of hierarchical risk management and control and hidden danger investigation and management, through the compilation of risk maps in key areas, precise management of production sites, and special trainings and education activities for liaison officers. We have realized self-pressurization, fundamentally eliminating hidden dangers of accidents, and vigorously improving the intrinsic safety of the Group.

Over the past year, the Group has consolidated the foundation for environmental protection and security. We strengthened the safety bottom line awareness and environmental protection red line thinking, integrated internal high-quality resources, and further consolidated the foundation of environmental protection and security compliance with policy analysis, mechanism optimization, management empowerment, supervision and inspection, etc. as effective means.

At the same time, the Group initiated the construction of an internal risk control system to drive contract management and seal management upgrades with digitalization, further reducing operating risks. The hours of work, remuneration for overtime, statutory holidays, paid leave and related benefits are in accordance with the stipulations in local labor laws. The labor union organizes congress of workers each year to discuss big issues related to workers' rights and interests.

Salary and Welfare

The Group adheres to a people-oriented approach and provides employees with competitive remuneration and benefits. In 2020, the Group formulated and improved the organizational performance and individual performance appraisal management systems, gradually implemented comprehensive performance management and remuneration distribution mechanism reforms, comprehensively built a differentiated remuneration incentive system, further optimized short-term, mid- and long-term incentive programs, and innovated project follow-up investment mechanisms. These measures have maximized the employees' new passion for rooting in Tianneng, serving Tianneng and contributing to Tianneng, which provides a strong driving force for the Group' s reform and development.

While providing a safe and healthy working environment for all employees, the Group also provides a series of benefits for employees to stimulate employees' work enthusiasm.

Adhering to the people-oriented principle, we established and improved the occupational health and safety management system, improved staff' s working environment and safety conditions on and on, and passed various certifications. Besides, we also conduct employees' occupational health monitoring each year, establish employee health records, and actively carry out emergency drills, safety knowledge trainings, firefighting skills contests, safety publicity and other activities.

Our staff members participated in safety trainings 67,000 times in total and in skills trainings 1,100 times in total throughout the year.

Protection of Customers

The Group adheres to customer-centric orientation, continuously improves its product system, marketing system, and service system, and constantly improves its product quality, technical research and development strength and service level. Adhering to the

"customer-centric" service concept, we implemented the "Five Heart Service Satisfaction Project" of being sincere, considerate, careful, patient and reassuring, actively promoted and built customer relationships, and strengthened customer relationship management. By changing from passive service to active service, we conduct two customer satisfaction surveys and net promoter score (NPS) surveys every year to fully understand customer needs, and strive to meet and exceed customer needs and expectations, gain customer loyalty, and become the object to be followed and surpassed in the industry.

The Group has more than 3,000 resellers across the country, and has formed an extended service network based in Zhejiang Province and radiating across the country. We carried out cooperation based on the principle of mutual benefit and win-win, and has established complete service management standards, processes, and systems. At the same time, more than 700 full-time after-sales personnel are employed to provide technical support and product training services for the service network across the country. The training is conducted at least once a week, covering more than 30 people each time.

In order to effectively protect the corporate brand image and consumer rights, Tianneng established a brand rights protection office, formulated counterfeit battery feedback, combat and control mechanisms and preventive measures, opened a protection hotline and established reward and punishment regulations, and arranged full-time personnel for safeguarding rights and fighting counterfeits to investigate, obtain evidence and trace sources of counterfeit Tianneng battery products in the market, and cooperated with the Administration for Industry and Commerce, public security and other law enforcement agencies to harshly punish and resolutely crack down on fraud and sales.

The Group sets up the Department of Projects and Intellectual Property, and it is totally responsible for jobs related to projects application and intellectual property management, which effectively guarantees the core competitiveness of the Group. In 2020, more than 300 projects have applied for approval and honorary titles. We have successively gained the approval for the Industrial Internet Innovation and Development Engineering Bidding Project by the Ministry of Industry and Information Technology (MIIT), the approval for the Public Service Platform Project of Industrial Technology Foundation by MIIT, the China Patent Award, etc. In addition, the Group' s "High Performance Lead Carbon Battery Industrialization Demonstration Project" won the 6th China Industry Award, and its subsidiaries were awarded the honorary titles of National Technological Innovation Demonstration Enterprise and the second batch of National Industrial Product Green Design Demonstration Enterprise, etc.

Green Intelligent Manufacturing

As a leading company in the new energy battery industry, the Group has actively promoted green smart manufacturing demonstrations for many years. From introducing the comprehensive green design concept from the product research and development side, to the supply chain side with full-process smart models as support, and to the full implementation of green smart manufacturing factory at the manufacturing side, we strive to build a demonstration model of new energy intelligent manufacturing, and replicate and promote it to all bases of the Group. The "Intelligent Management and Control Technology Development Project for Customized High-end Battery Mass Manufacturing Processes" led and undertaken by the Group was approved by the Ministry of Science and Technology as a key R&D program in 2020, promoting China' s high-end battery manufacturing and Tianneng' s contribution to the implementation of China' s manufacturing empowering strategy.

At the same time, in the creation of the green system, in 2020, 2 more enterprises were included in the national green factory group, and 3 more enterprises were included in the national green supply chain management demonstration enterprise group. Accumulatively, the Group has been selected for more than 30 national green manufacturing lists and won the first national "green product" certification in the industry. There are accumulatively 3 industrial product green design demonstration enterprises rated by the Ministry of Industry and Information Technology of the PRC, and related technologies have been selected and included in the Green Technology Promotion Catalog (2020) jointly issued by the National Development and Reform Commission, the Ministry of Science and Technology, the Ministry of Industry and Information Technology, and the Ministry of Natural Resources. Two subsidiaries were awarded the title of "Zhejiang Smart Factory".

The Group also further accelerated the practice of industrial interconnection, explored the creation of a green smart manufacturing industry chain, ecosystem,

and a shared platform for new energy smart manufacturing, and realized the interconnection of internal and external resources and remote product services. Tianneng Industrial Interconnection Innovation Platform won the national project approval of key field and specific scenario industrial Internet platform application, and was selected as the one of the "Top Ten Industrial Internet Cases in Zhejiang Province".

循環再生

近年來, 隨著鉛蓄電池在電動自行 車、 汽車和儲能等領域的大規模應 用, 鉛蓄電池和再生鉛行業快速發 展。國家有關部門修訂、 出臺了一系 列的政策措施、 法律法規, 2020 年 《中華人民共和國固體廢物污染環境 防治法》的頒佈和實施, 進一步規範 和完善了廢舊電池回收體系。

從全產業鏈來看, 目前鉛蓄電池污染 防治的重點在非法收集、處理環節, 針對這一突出問題, 天能集團積極回 應國家提出的生產者責任延伸制, 在 浙江省長興縣、河南省濮陽市、江蘇 省沭陽縣、安徽太和建設了廢鉛蓄電 池循環再生企業。通過在全國各地的 終端門店, 將廢舊電池分散回收、集 中處置、無害化再生利用, 形成了閉 環式的循環經濟生態圈。

在位於湖州的天能集團循環經濟產業 園中, 通過採用國際上最先進的生產 工藝和設備, 廢舊電池金屬回收率可 達 99% 以上, 塑膠回收率達 99%, 殘酸回收率達 100%。

2020年,集團進一步加快大循環事業 的全國佈局。目前集團已在 15 個省 取得了回收試點資質,全國最大的廢 舊電池 "回收雲 "平臺已經上線運行, 全面構建了循環經濟發展新格局。同 時,鋰電回收按期投產,實現生產、 回收閉環,並成為中國工信部鋰電再 生利用的白名單企業。

Recycling and Regeneration

In recent years, along with the large-scale application of lead-acid battery in the fields of electric bicycles, automobiles and storage energy, the lead-acid battery and recycled lead industries have developed rapidly. Relevant state departments have revised and introduced a series of policy and measures, laws and regulations. The promulgation and implementation of the Law of the PRC on the Prevention and Control of Environmental Pollution by Solid Waste in 2020 has further standardized and completed the recycling the system of waste lead-acid battery.

From the perspective of the entire industry chain, the current focus of the prevention and control of lead-acid battery pollution is illegal collection and processing. In response to this outstanding problem, the Group actively responds to the extended producer responsibility system proposed by the state. It has established waste lead battery recycling enterprises in Changxing County, Zhejiang Province, Puyang City, Henan Province, Shuyang County, Jiangsu Province, and Taihe, Anhui Province. Waste batteries are recycled, centralized, and harmlessly recycled at terminal stores across the country, forming an endless cycle of circular economy ecosystem.

In the Tianneng Group Circular Economy Industrial Park located in Huzhou, through the use of the most advanced production technology and equipment in the world, the metal recovery rate of waste batteries can reach over 99%, the plastic recovery rate is 99%, and the residual acid recovery rate is 100%.

In 2020, the Group further accelerated the national layout of the large-scale recycling business. At present, the Group has obtained the qualification for recycling pilot projects in 15 provinces, and the country' s largest waste battery "recycling cloud" platform has been put into operation, and a new pattern of circular economy development has been fully established. At the same time, lithium battery recycling was put into operation on schedule, achieving an endless cycle of production and recycling, and the Group has become a whitelisted company for lithium battery recycling of the Ministry of Industry and Information Technology of the PRC. 天能重視水資源保護, 積極推行水資 源循環利用, 採用先進的中水回用技 術, 將工業廢水進行自動化沉澱後處 理, 經過反復滲透凈化, 再循環利 用。經過處理的工業水達到國家二級 城市用水標準, 可以用來澆花養魚, 真正做到了變廢為寶, 實現了經濟效 益、社會效益、環境效益相統一。

It adopts the advanced reclaimed water reuse technology to automate the post-treatment of industrial wastewater after precipitation, repeated osmosis and purification, and then recycling. The treated industrial water meets the national secondary municipal water standard and can be used for watering flowers and fish farming, truly turning waste into treasure and realizing the unification of economic, social and environmental benefits.

節能減排

天能循環經濟產業園通過採用全球最 先進全自動機械破碎、 水力分選工藝 和純氧低溫轉爐連續熔煉再生技術. 相比于傳統的原生鉛生產方式, 節能 減排效益明顯。每生產一噸再生鉛, 可實現節約標煤 60%, 節水 50%, 減 少固體廢棄物 60%, 減少二氧化硫 66%。

天能還在光伏、儲能及智慧微網領域取 得了實質性進展。其中分散式光伏電站 專案成功並網發電, 可實現年發電量 約 252 萬度, 節約標準煤約 881 噸, 減少二氧化碳排放約 2438m³, 減少二 氧化硫排放約 73.375 噸: 商業化智慧 微網鉛炭儲能電站 150KW/1.6MWh 專 案, 保證使用者電力增容 120KW, 降 低對電網的功率衝擊, 降低了當地的電 網故障率;1MW/8MWh 智慧微網鉛炭/ 鋰電儲能電站專案也正在有序推進中。

目前, 天能已建成非洲光伏儲能離網項 目、甘比亞總統別墅光儲系統、智慧微 網鉛炭電池儲能電站等多個專案。在中 央電視臺《朝聞天下》報導的浙江省首 批在建的4個電網側儲能電站專案中, 天能參與了兩個專案——長興 10 千伏 雉城儲能電站項目以及衢州灰坪鄉大 麥源儲能電站專案。其中, "10 千伏 雉城儲能電站專案 " 也是全國首座電 網側儲能電站。

Energy Conservation and Emission Reduction

Tianneng Circular Economy Industrial Park adopts the world's most advanced fully automatic mechanical crushing, hydraulic separation process and continuous smelting and regeneration technology of pure oxygen low temperature converter. Compared with the traditional primary lead production method, the energy saving and emission reduction benefits are obvious. Every ton of recycled lead produced can save 60% of standard coal, 50% of water, 60% of solid waste, and 66% of sulfur dioxide.

Tianneng has also made substantial progress in the fields of photovoltaics, energy storage and smart micro-grids. Among them, the distributed photovoltaic power station project has been successfully connected to the grid for power generation, which can achieve an annual power generation of about 2.52 million kWh, saving about 881 tons of standard coal, reducing carbon dioxide emissions by about 2438m³, and reducing sulfur dioxide emissions by about 73.375 tons; the commercial intelligent micro-grid lead-carbon energy storage 150KW/1.6MWh power station project ensures that the user's power capacity can be increased by 120KW, reducing the power impact on the grid, and the local grid failure rate; the 1MW/8MWh smart micro-grid lead-carbon/lithium energy storage power station project is also progressing in an orderly manner.

At present, Tianneng has built a number of projects such as the off-grid photovoltaic energy storage project in Africa, the solar storage system of the Presidential Villa in Gambia, and the intelligent micro-grid lead-carbon battery energy storage power station. In the first batch of 4 grid-side energy storage power station projects under construction in Zhejiang Province reported by CCTV' s "Morning News", Tianneng participated in two projects, namely, Changxing 10kVZhicheng Energy Storage Power Station Project and Quzhou Huiping Village Damaiyuan Energy Storage Power Station Project. Among them, the "10kV Zhicheng Energy Storage Power Station Project" is also the country' s first grid-side energy storage power station.

污染防治

天能積極打造環境友好型企業,把綠 色生態理念貫穿到產品設計至處置全 生命週期,通過產品設計生態化、生 產工藝清潔化、裝備製造智慧化、資 源利用循環化等創新舉措,實現了電 池從設計、生產、使用到回收等各個 環節的污染防治。

本集團還制定了嚴謹的突發環境事件 應急預案,包括應急指揮部、應急物 資配置以及應急演練計畫,每年定期 開展突發環境事件應急演練,對預案 每三年進行更新並向當地生態環境主 管部門備案。

此外, 天能始終宣導企業與環境和 諧發展, 將環境保護作為企業發展 的底線, 除對園區設置環境防護距 離以及防護綠地外, 還定期對園區 周邊環境開展大氣、水體以及土壤 等監測活動, 通過引入先進的監測 設備與培養專業技術團隊, 實現了 污染物因數人工日常監測、線上24 小時監測。

Pollution Prevention and Governance

Tianneng actively builds an environmentally-friendly enterprise, and embeds the concept of green ecology throughout the entire life cycle of its products from design to disposal. Through innovative measures such as ecological product design, clean production process, intelligent equipment manufacturing, and recycling of resources, it has realized battery pollution prevention and control in every link from design, production, use to recycling.

The Group has also formulated a rigorous emergency response plan for environmental emergencies, including emergency headquarters, emergency material allocation, and emergency drill plans. It regularly conducts emergency drills for environmental emergencies every year, updates the plan every three years, and reports to the local competent department of ecological environment for record.

In addition, Tianneng always advocates the harmonious development of enterprises and the environment, and regards environmental protection as the bottom line of enterprise development. In addition to setting environmental protection distances and green buffers in the park, Tianneng also regularly conducts atmospheric, water and soil monitoring activities on the surrounding environment of the park. The introduction of advanced monitoring equipment and the training of a professional technical team have realized the manual daily monitoring of pollutant factors and online 24-hour monitoring. 天能嚴格執行污染物排放限值標準, 全面構建污染物自行監測、 協力廠商 委託監測及政府部門監督相結合的全 方位污染物防控體系, 保障治理設施 長期穩定運行, 實現廢水、廢氣污染 物達標排放。對可利用的污染物和廢 棄物採取科學管理措施, 變廢為寶, 進行資源再利用, 既減少了對環境的 污染,也提升了資源利用率。

Tianneng strictly implements pollutant discharge limit standards, and comprehensively builds an all-round pollutant prevention and control system that combines pollutant self-monitoring, third-party entrusted monitoring and government supervision to ensure the long-term stable operation of treatment facilities, and achieve up-to-standard discharge of wastewater and exhaust pollutants. We also take scientific management measures for exploitable pollutants and wastes, turning waste into treasure, and reusing resources, which not only reduces environmental pollution, but also improves resource utilization rate.

Tianneng regularly releases pollutant monitoring data and evaluation reports of the factory area to the public through relevant government information release platforms, and prepares corporate environmental reports on an annual basis. In the past three years, through continuous improvement of the pollutant management system, Tianneng has achieved zero probability of environmental pollution accidents.

Tianneng observes the industry and sector development rules, the Environmental Occupational Health and Safety Management System (EHS), adheres to energy conservation and emission reduction, solidly promotes pollution prevention, and strives to eliminate the "three wastes" in the technological process. In addition, Tianneng has established a professional management team to effectively ensure the smooth development of ecological environment construction and safe production. For example, Tianneng has formulated a series of environmental and safety management systems such as Tianneng Group Environmental Protection Management System, Tianneng Group Safety Management System and Tianneng Group Occupational Prevention Management System, and entrusts gualified units to conduct impact assessment and safety assessment on the production environment to ensure green production.
