Pursuant to the ordinary resolution passed at the special general meeting of the Company held on 26 February 2021, the share consolidation of every five (5) issued and unissued shares of the Company (the "Shares") of par value of HK\$0.1 each in the share capital of the Company into one (1) consolidated share of par value of HK\$0.5 each (the "Share Consolidation") became effective on 2 March 2021.

As a result of the Share Consolidation had become effective on 2 March 2021, adjustments were made to the exercise price of and the number of Shares entitled to be allotted and issued upon full exercise of subscription rights attaching to the outstanding share options.
