**PROPOSED RE-ELECTION OF RETIRING DIRECTORS

NOTICE OF ANNUAL GENERAL MEETING**

1. INTRODUCTION

The purpose of this circular is to provide the Shareholders with information in respect of certain resolutions to be proposed at the Annual General Meeting to be held on 18 May 2021.

LETTER FROM THE BOARD

2. PROPOSED RE-ELECTION OF RETIRING DIRECTORS

According to Article 87 of the Articles of Association (“**Article 87**”), at each annual general meeting one-third of the Directors for the time being (or, if their number is not a multiple of three (3), the number nearest to but not less than one-third) shall retire from office by rotation provided that every Director shall be subject to retirement at least once every three years. The Directors to retire by rotation shall include (so far as necessary to ascertain the number of Directors to retire by rotation) any Director who wishes to retire and not to offer himself for re-election. Any further Directors so to retire shall be those of the other Directors subject to retirement by rotation who have been longest in office since their last re-election or appointment and as between persons who became or were last re-elected Directors on the same day those to retire shall (unless they otherwise agree among themselves) be determined by lot.

Accordingly, Mr. Yang, Tou-Hsiung, Mr. Yang, Kun-Chou, Mr. Chou, Szu-Cheng and Mr. Chao, Pei-Hong will retire from office by rotation in accordance with Article 87. All such directors being eligible, will offer themselves for re-election at the Annual General Meeting.

Mr. Chao, Pei-Hong who has been serving the Company as independent non-executive Director for more than 9 years, has confirmed his independence with reference to the factors set out in Rule 3.13 of the Listing Rules. The Company considers that Mr. Chao, Pei-Hong is still independent in accordance with the independence guidelines set out in the Listing Rules and will continue to bring valuable business experience, knowledge and professionalism to the Board for its efficient and effective functioning.

Details of the retiring Directors are set out in Appendix I to this circular.

3. PROPOSED GRANTING OF GENERAL MANDATE TO REPURCHASE SHARES

At the annual general meeting of the Company held on 19 May 2020, a general mandate was granted to the Directors to repurchase Shares. Such mandate will lapse at the conclusion of the Annual General Meeting. In order to give the Company the flexibility to repurchase Shares if and when appropriate, an ordinary resolution will be proposed at the Annual General Meeting to approve the granting of the Share Buy-back Mandate to the Directors to repurchase Shares on the Stock Exchange of not exceeding 10% of the total number of issued Shares as at the date of passing of the proposed ordinary resolution contained in item 5 of the notice of the Annual General Meeting as set out on pages 19 to 23 of this circular (i.e. up to 152,274,200 Shares based on 1,522,742,000 Shares in issue as at the Latest Practicable Date and on the basis that no further Shares are issued or repurchased before the Annual General Meeting). The Directors wish to state that they have no immediate plan to repurchase any Shares pursuant to the Share Buy-back Mandate.

An explanatory statement required by the Listing Rules to provide the Shareholders with requisite information reasonably necessary for them to make an informed decision on whether to vote for or against the granting of the Share Buy-back Mandate is set out in Appendix II to this circular.

4. PROPOSED GRANTING OF GENERAL MANDATE TO ISSUE SHARES

At the annual general meeting of the Company held on 19 May 2020, a general mandate was granted to the Directors to issue Shares. Such mandate will lapse at the conclusion of the Annual General Meeting. In order to give the Company the flexibility to issue Shares if and when appropriate, an ordinary resolution will be proposed at the Annual General Meeting to approve the granting of the Issuance Mandate to the Directors to allot, issue or deal with additional Shares of not exceeding 20% of the total number of issued Shares as at the date of passing of the proposed ordinary resolution contained in item 6 of the notice of the Annual General Meeting as set out on pages 19 to 23 of this circular (i.e. up to 304,548,400 Shares based on 1,522,742,000 Shares in issue as at the Latest Practicable Date and on the basis that no further Shares are issued or repurchased before the Annual General Meeting). An ordinary resolution to extend the Issuance Mandate by adding such number of Shares repurchased by the Company pursuant to the Share Buy-back Mandate will also be proposed at the Annual General Meeting.

The Directors wish to state that they have no immediate plan to issue any new Shares pursuant to the Issuance Mandate.

5. CLOSURE OF REGISTER OF MEMBERS

To be eligible to attend and vote at the Annual General Meeting

The register of members of the Company will be closed from Wednesday, 12 May 2021 to Tuesday, 18 May 2021, (both days inclusive), during such period no transfer of shares will be registered. In order to be eligible to attend and vote at the Annual General Meeting, unregistered holders of shares of the Company should ensure all transfer forms accompanied by the relevant share certificates must be lodged with the Company's branch share registrar, Tricor Tengis Limited, 54/F, Hopewell Centre, 183 Queen's Road East, Hong Kong, for registration not later than 4:30 p.m. on Tuesday, 11 May 2021.

To qualify for the proposed final dividend

In order to ascertain the entitlement to the proposed final dividend, the register of members of the Company will be closed from Tuesday, 25 May 2021 to Thursday, 27 May 2021, (both days inclusive), during such period no transfer of shares will be registered. In order to be eligible to receive the proposed final dividend, unregistered holders of shares of the Company should ensure all transfer forms accompanied by the relevant share certificates must be lodged with the Company's branch share registrar, Tricor Tengis Limited, 54/F, Hopewell Centre, 183 Queen's Road East, Hong Kong, for registration not later than 4:30 p.m. on Monday, 24 May 2021.

6. ANNUAL GENERAL MEETING AND PROXY ARRANGEMENT

The notice of the Annual General Meeting is set out on pages 19 to 23 of this circular.

Pursuant to the Listing Rules, any vote of Shareholders at a general meeting must be taken by poll except where the chairman decides to allow a resolution relating to a procedural or administrative matter to be voted on by a show of hands. An announcement on the poll results will be published by the Company after the Annual General Meeting in the manner prescribed under the Listing Rules.

A form of proxy for use at the Annual General Meeting is enclosed with this circular and such form of proxy is also published on the websites of Hong Kong Exchanges and Clearing Limited (www.hkexnews.hk) and the Company (www.vedaninternational.com). To be valid, the form of proxy must be completed and signed in accordance with the instructions printed thereon and deposited, together with the power of attorney or other authority (if any) under which it is signed or a certified copy of that power of attorney or authority at Company's branch share registrar in Hong Kong, Tricor Tengis Limited, at Level 54, Hopewell Centre, 183 Queen's Road East, Hong Kong as soon as possible but in any event not less than 48 hours before the time appointed for holding the Annual General Meeting (i.e. not later than 3:00 p.m. on Sunday, 16 May 2021) or any adjournment thereof. Completion and delivery of the form of proxy will not preclude you from attending and voting at the Annual General Meeting if you so wish. In such event, the form of proxy previously submitted will be deemed to be revoked.

7. RECOMMENDATION

The Directors consider that the proposed re-election of retiring Directors and granting of the Share Buy-back Mandate and the Issuance Mandate are in the best interests of the Company and the Shareholders. Accordingly, the Directors recommend the Shareholders to vote in favour of the relevant resolutions to be proposed at the Annual General Meeting.

The following are details of the Directors who will retire and being eligible, offer themselves for re-election at the Annual General Meeting.

- (1) **Mr. Yang, Tou-Hsiung**, 78, the Chairman and an Executive Director of the Company, as well as the Chairman of the Nomination Committee, has been a director of the Company since 2002. Mr. Yang, Tou-Hsiung graduated from Taichung Min Der Commercial Vocational High School. Mr. Yang, Tou-Hsiung has approximately 58 years' working experience in the MSG industry and is one of the founders of the Taiwan Vedan Group. Mr. Yang, Tou-Hsiung is responsible for formulating our overall corporate strategy. Mr. Yang, Tou-Hsiung is also an executive director of Taiwan Amino Acid Manufacturers Association.

Mr. Yang, Tou-Hsiung is a director of Vedan Vietnam, Taiwan Vedan, Billion Power and King International. Mr. Yang, Tou-Hsiung indirectly holds approximately 19.77 per cent. interest in Taiwan Vedan. Mr. Yang, Tou-Hsiung is also a director and a shareholder of King International, a company which is beneficially owned by Mr. Yang, Tou-Hsiung as to 65 per cent.

King International, Billion Power and Taiwan Vedan, together with various other parties, are the controlling shareholders of the Company.

Mr. Yang, Tou-Hsiung is a member of the Yang Family. Mr. Yang, Tou-Hsiung is the elder brother of Mr. Yang, Cheng and the cousin of Mr. Yang, Kun-Hsiang, Mr. Yang, Chen-Wen and Mr. Yang, Kun-Chou. Mr. Yang, Cheng, Mr. Yang, Kun-Hsiang, Mr. Yang, Chen-Wen and Mr. Yang, Kun-Chou are Executive Directors.

Mr. Yang, Tou-Hsiung has entered into a service agreement with the Company for a term of three years commencing on 27 June 2003 and thereafter shall continue from year to year until terminated by the giving of not less than three months' prior notice in writing thereof by either party to the other. In accordance with the service agreement, Mr. Yang, Tou-Hsiung is entitled to an annual remuneration of US\$342,000. After each completed year of service, the remuneration payable to Mr. Yang, Tou-Hsiung may, subject to the discretion of the Directors, be increased by not more than 15 per cent. He is also eligible to a discretionary bonus as the Board may determine, the amount of which is computed based on audited combined/consolidated profit after taxation and minority interests (and after the payment of such bonus) but before extraordinary items for the relevant year of the Company ("**Adjusted Profit**") and the specified percentage applicable to each level of the Adjusted Profit. Mr. Yang, Tou-Hsiung is also entitled to reimbursement of traveling expenses in the sum of US\$4,000 per quarter of each year of service. Mr. Yang, Tou-Hsiung was entitled to director's emoluments of US\$859,000 for the year ended 31 December 2020. The emoluments of Mr. Yang, Tou-Hsiung have been determined by the Company with reference to his qualification and experience, responsibilities undertaken, contribution to the Group, and the prevailing market level of remuneration for executives of similar position.

Pursuant to Part XV of the SFO, as at the Latest Practicable Date, Mr. Yang, Tou-Hsiung was deemed to be interested in 169,730,196 Shares held by King International by reason that he was entitled to exercise or control the exercise of more than one-third of the voting power of King International.

Mr. Yang, Tou-Hsiung has not been and is not involved in any of the matters required to be disclosed pursuant to any of the requirements of the provisions under Rules 13.51(2)(h) to 13.51(2)(v) of the Listing Rules.

Save as disclosed above, Mr. Yang, Tou-Hsiung (i) has not held any directorship in public companies the securities of which are listed on any securities exchange in Hong Kong or overseas in the past three years; (ii) does not have any relationship with any Director, senior management or any substantial or controlling shareholders of the Company; and (iii) as at the Latest Practicable Date, did not have any interest (within the meaning of Part XV of the SFO) in any securities of the Company. There is no other matter which needs to be brought to the attention of the Shareholders in relation to the proposed re-election of Mr. Yang, Tou-Hsiung as an Executive Director.

- (2) **Mr. Yang, Kun-Chou**, aged 61, an executive Director, joined the Group in 1984 and has approximately 39 years' working experience in the food, beverage and consumer products industry and extensive experience in marketing of products and business development. Mr. Yang, Kun-Chou is responsible for assisting with the go-to market strategy, sales and operations for the Group in China and Vietnam. Mr. Yang, Kun-Chou graduated from Tamsui Oxford College, Taiwan in 1982. Mr. Yang, Kun-Chou is a director and the Vice President of the consumer products department of Taiwan Vedan and is also a director of Vedan Vietnam, Shanghai Vedan and Xiamen Vedan. Mr. Yang, Kun-Chou also holds directorship in Ve Wong Corporation (a company listed on the Taiwan Stock Exchange Corporation) since 28 June 2006. Mr. Yang, Kun-Chou is a member of the Yang Family. He is the younger brother of Mr. Yang, Kun-Hsiang and the cousin of Mr. Yang, Tou-Hsiung, Mr. Yang, Cheng and Mr. Yang, Chen-Wen. Mr. Yang, Tou-Hsiung, Mr. Yang, Cheng, Mr. Yang, Kun-Hsiang and Mr. Yang, Chen-Wen are executive Directors.

There is a service agreement entered into between Mr. Yang, Kun-Chou and the Company. According to the service agreement, Mr. Yang Kun-Chou has been appointed for a fixed period of three years commencing on 8 March 2021. Mr. Yang Kun-Chou's remuneration has been determined by reference to his duties and responsibilities in the Company, the Company's performance and current market situation. Mr. Yang, Kun-Chou will also be entitled to a discretionary bonus as the Board may determine, the amount of which is computed based on audited combined/consolidated profit after taxation and minority interests (and after the payment of such bonus) but before extraordinary items for the relevant year ("**Adjusted Profit**") of the Company and the specified percentage applicable to each level of the Adjusted Profit. Mr. Yang, Kun-Chou is also entitled to reimbursement of traveling expenses in the sum of US\$4,000 per quarter of each year of service. The remuneration, including salary, travelling expenses and discretionary bonus, payable to Mr. Yang, Kun-Chou during the year ended 31 December 2020 amounted to approximately US\$546,000.

Mr Yang, Kun-Chou has not been and is not involved in any of the matters required to be disclosed pursuant to any of the requirements of the provisions under Rules 13.51(2)(h) to 13.51(2)(v) of the Listing Rules.

Save as disclosed above, as at the Latest Practicable Date, Mr. Yang, Kun-Chou (i) did not hold any directorship in public companies the securities of which are listed on any securities exchange in Hong Kong or overseas in the past three years; (ii) did not have any relationship with any Director, senior management or substantial or controlling shareholder of the Company; and (iii) did not have any interest in the Shares within the meaning of Part XV of the SFO. There is no other matter which needs to be brought to the attention of the Shareholders in relation to the proposed re-election of Mr. Yang, Kun-Chou as an executive Director of the Company.

- (3) **Mr. Chou, Szu-Cheng**, 60, a non-executive Director of the Company, has been a director of the Company since 2006. Mr. Chou is the Supervisor of Taiwan Vedan and an independent non-executive director of Shih-Kuen Plastics Co., Ltd. (a publicly-traded company on the Taiwan Stock Exchange Corporation). Mr. Chou was the founder member of Legalway Law Firm, the director and legal consultant of Wincome Incorporation and a supervisor of Shih-Kuen Plastics Co., Ltd. (a publicly-traded company on the Taiwan Stock Exchange Corporation). He has over 21 years of experience in the legal industry. Mr. Chou obtained his Bachelor of Law degree from Soochow University, Master of Law degree from East China University of Political Science and Law and Doctorate of Law degree from Peking University.

Mr. Chou has entered into a service agreement with the Company for a fixed period of three years commencing from 1 April 2021 and is subject to retirement by rotation and eligible for re-election pursuant to the Articles of Association. Mr. Chou and the Company may, upon or before the expiration of the original term or any renewed term (as the case may be) thereof, agree in writing to extend the term of the service agreement for another year. If the Company and Mr. Chou do not agree to extend, the service agreement shall lapse upon the expiration of the original term or any renewed term (as the case may be) of the service agreement. During the renewed term, Mr. Chou's appointment may be terminated by the giving of one month's notice in writing by either party to the other. In accordance with the service agreement, Mr. Chou is entitled to an aggregate fee of US\$16,000 per year as reimbursement of the travelling expenses, or such higher amount as the Board may from time to time determine in its absolute discretion; and such other fees or other remuneration in respect of any special services agreed by the parties to be rendered by Mr. Chou as the parties may from time to time agree. Mr. Chou was entitled to an annual director's fee of approximately of US\$16,000 for the year ended 31 December 2020, being reimbursement of traveling expenses as a member of the Board which is determined with reference to his duties and responsibilities with the Company, the Company's current standards for emoluments and the market conditions.

Mr. Chou has not been and is not involved in any of the matters required to be disclosed pursuant to any of the requirements of the provisions under Rules 13.51(2)(h) to 13.51(2)(v) of the Listing Rules.

Save as disclosed above, Mr. Chou (i) has not held any directorship in public companies the securities of which are listed on any securities exchange in Hong Kong or overseas in the past three years; (ii) does not have any relationship with any Director, senior management or any substantial or controlling shareholders of the Company; and (iii) as at the Latest Practicable Date, did not have any interest (within the meaning of Part XV of the SFO) in any securities of the Company. There is no other matter which needs to be brought to the attention of the Shareholders in relation to the proposed re-election of Mr. Chou as a non-executive Director.

- (4) **Mr. Chao, Pei-Hong**, aged 59, an independent non-executive Director and chairman of the audit committee and a member of each of the nomination committee and remuneration committee of the Company, has been a director of the Company since 2002. Mr. Chao, Pei-Hong obtained a bachelor degree in law in 1984 and a master degree in law from Soochow University, Taiwan in 1986 and a master degree in law from the University of Houston in 1992. Mr. Chao, Pei-Hong is an executive partner of Jurist Law Offices, a law firm in Taiwan. Mr. Chao is also a director of Hua Yu Lien Development Co., Ltd (a company listed on the Taiwan Stock Exchange Corporation, formerly known as Fui Industrial Co., Ltd. and was renamed on 19 June 2013) and the independent non-executive director of Force-MOS Technology Co., Ltd (an emerging-stock company on the Taiwan Stock Exchange Corporation). Mr. Chao, Pei-Hong has approximately 31 years' experience in his practice.

Mr. Chao, Pei-Hong has entered into a service agreement with the Company for a term of one year commencing on 27 June 2003 and thereafter shall continue from year to year until terminated by the giving of one month's notice in writing thereof by either party to the other. He has therefore served the Board for more than nine years. In accordance with the service agreement, Mr. Chao, Pei-Hong is entitled to reimbursement of traveling expenses in the sum of US\$4,000 per quarter of each year of service. Mr. Chao, Pei-Hong was entitled to director's emoluments of approximately of US\$18,000 for the year ended 31 December 2020. The reimbursement amount of the traveling expenses payable to Mr. Chao, Pei-Hong is determined by reference to the estimated amount of traveling expenses to be incurred by Mr. Chao, Pei-Hong in each quarter of each year of service. Other than the reimbursement of travelling expenses, Mr. Chao Pei-Hung is not entitled to any other payment or discretionary bonus.

Mr. Chao, Pei-Hong has served as an independent non-executive Director for more than 9 years. The Company has continued to receive written confirmation from him annually on his independence in accordance with Rule 3.13 of the Listing Rules. The Board has considered that Mr. Chao continues to be independent and will continue to bring valuable business experience, knowledge and professionalism to the Board for its efficient and effective functioning.

Mr. Chao, Pei-Hong has not been and is not involved in any of the matters required to be disclosed pursuant to any of the requirements of the provisions under Rules 13.51(2)(h) to 13.51(2)(v) of the Listing Rules.

As at the Latest Practicable Date, save as disclosed, Mr. Chao, Pei-Hong had not been a director in any other listed company in Hong Kong or overseas in the past three years and did not have any relationship with any Director or any senior management or substantial or controlling shareholder of the Company. Pursuant to Part XV of the SFO, Mr. Chao, Pei-Hong was interested in 500,000 Shares as at the Latest Practicable Date. There is no other matter which needs to be brought to the attention of the Shareholders in relation to the proposed re-election of Mr. Chao, Pei-Hong as an independent non-executive Director of the Company.

The following is an explanatory statement required by the Listing Rules to provide the Shareholders with requisite information reasonably necessary for them to make an informed decision on whether to vote for or against the ordinary resolution to be proposed at the Annual General Meeting in relation to the granting of the Share Buy-back Mandate.

1. SHARE CAPITAL

As at the Latest Practicable Date, the issued share capital of the Company comprised 1,522,742,000 Shares.

Subject to the passing of the ordinary resolution set out in item 5 of the notice of the Annual General Meeting in respect of the granting of the Share Buy-back Mandate and on the basis that no further Shares are issued or repurchased before the Annual General Meeting, i.e. being 1,522,742,000 Shares, the Directors would be authorized under the Share Buy-back Mandate to repurchase, during the period in which the Share Buy-back Mandate remains in force, a total of 152,274,200 Shares, representing 10% of the total number of Shares in issue as at the date of the Annual General Meeting.

2. REASONS FOR SHARE BUY-BACK

The Directors believe that the granting of the Share Buy-back Mandate is in the best interests of the Company and the Shareholders.

Shares buy-back may, depending on the market conditions and funding arrangements at the time, lead to an enhancement of the net asset value per Share and/or earnings per Share and will only be made when the Directors believe that such a buy-back will benefit the Company and the Shareholders.

3. FUNDING OF SHARE BUY-BACK

The Company may only apply funds legally available for share buy-back in accordance with its Memorandum and Articles of Association, the laws of Cayman Islands and/or any other applicable laws, as the case may be.

There might be a material adverse impact on the working capital or gearing position of the Company (as compared with the position disclosed in the audited accounts contained in the annual report of the Company for the year ended 31 December 2020) in the event that the Share Buy-back Mandate was to be carried out in full at any time during the proposed buy-back period. However, the Directors do not intend to exercise the Share Buy-back Mandate to such extent as would, in the circumstances, have a material adverse effect on the working capital requirements of the Company or the gearing levels which in the opinion of the Directors are from time to time appropriate for the Company.

6. GENERAL

To the best of their knowledge and having made all reasonable enquiries, none of the Directors nor any of their respective close associates (as defined in the Listing Rules) have any present intention to sell any Shares to the Company in the event that the granting of the Share Buy-back Mandate is approved by the Shareholders.

The Company has not been notified by any core connected persons (as defined in the Listing Rules) of the Company that they have a present intention to sell any Shares to the Company, or that they have undertaken not to sell any Shares held by them to the Company in the event that the granting of the Share Buy-back Mandate is approved by the Shareholders.

- (a) Billion Power, Concord Worldwide, High Capital, King International, Mr. Yang, Tou-Hsiung, Mr. Yang, Cheng, Mr. Yang, Kun-Chou, Mr. Yang, Kun-Hsiang, Mr. Yang, Yung-Huang, Mr. Yang, Yung-Jen, Mr. Yang, Chen-Wen, Mr. Yang, Tung, Mr. Yang, Wen-Hu, Ms. Yang, Wen-Yin, Ms. Yang, Shu-Hui, Ms. Yang, Shu-Mei and Taiwan Vedan, the controlling shareholders of the Company as defined in the Listing Rules, were interested in 936,408,000 Shares representing approximately 61.49% of the total issued share capital of the Company. In the event that the Directors exercise the proposed Share Buy-back Mandate in full, the aggregate shareholding of such controlling shareholders would be increased to approximately 68.33% of the issued share capital of the Company.

The Directors are not aware of any consequences which may give rise to an obligation to make a mandatory offer under Rule 26 of the Takeovers Code. The Directors do not consider such increase would reduce the issued share capital in the public to less than 25% (or the relevant prescribed minimum percentage required by the Stock Exchange). In the event that the Directors exercise the proposed Share Buy-back Mandate in full, the shareholding of Billion Power would be increased to approximately 37.37% of the issued share capital of the Company.

The Directors consider that such increase in shareholding would give rise to an obligation to make a mandatory offer under Rule 26 of the Takeovers Code. The Directors do not consider such increase would reduce the issued share capital in the public to less than 25% (or the relevant prescribed minimum percentage required by the Stock Exchange). The Directors do not propose to exercise the Share Buy-back Mandate to such an extent as would, in the circumstances, give rise to an obligation to make a mandatory offer in accordance with Rule 26 of the Takeovers Code and/or result in the aggregate number of Shares held by the public shareholders falling below the prescribed minimum percentage required by the Stock Exchange.
