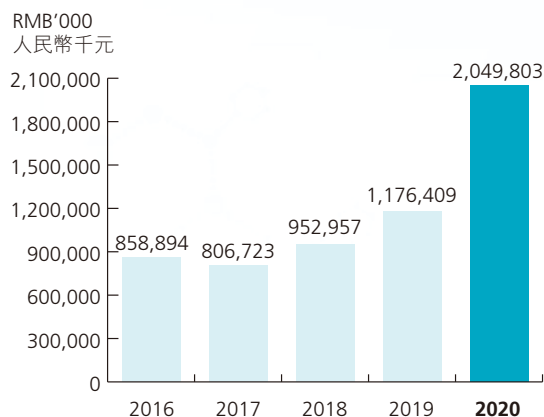
# Financial Highlights

## 財務摘要

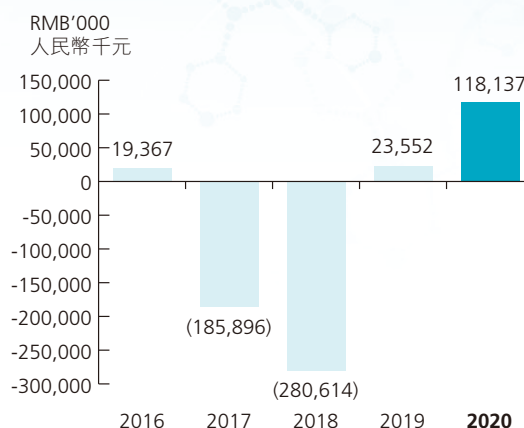
- Revenue of the Group increased by 74.2% or RMB873.4 million to RMB2,049.8 million for the Reporting Period (2019: RMB1,176.4 million), among which revenue from sales of Human Albumin Solution increased by approximately RMB1,040.8 million, mainly benefited from the increase in sales volume.
- Gross profit of the Group increased by RMB54.0 million to RMB273.8 million for the Reporting Period (2019: RMB219.8 million), while gross profit margin decreased from 18.7% in 2019 to 13.4% for the Reporting Period. The increase in gross profit was in line with the increase of the revenue.
- Net profit of the Group increased by 400.4% to RMB118.1 million for the Reporting Period (2019: RMB23.6 million), primarily due to the increase in gross profit of the Group and the large decrease in selling and distribution expenses, administrative expenses and financial cost.
- During the Reporting Period, net profit attributable to owners of the Company amounted to RMB118.1 million (2019: net profit RMB23.6 million), representing an increase in net profit by RMB94.5 million.
- Basic and diluted earnings per share for the year ended 31 December 2020 amounted to RMB0.070 (2019: RMB0.014).
- The Board resolved not to declare any final dividend for the Reporting Period (2019: Nil).
- 報告期內，本集團收益增長74.2%或人民幣873.4百萬元至人民幣2,049.8百萬元(2019年：人民幣1,176.4百萬元)，其中人血白蛋白注射液銷售收益增長約人民幣1,040.8百萬元，主要得益於銷售量的增長。
- 報告期內，本集團毛利增加人民幣54.0百萬元至人民幣273.8百萬元(2019年：人民幣219.8百萬元)，毛利率則由2019年的18.7%減少至報告期內的13.4%，毛利的增加與收益的增加保持一致。
- 於報告期內，本集團純利增加400.4%至人民幣118.1百萬元(2019年：人民幣23.6百萬元)，主要是由於本集團的毛利增加以及銷售及經銷開支、行政開支和財務成本大幅減少所致。
- 報告期內，本公司擁有人應佔純利為人民幣118.1百萬元(2019年：純利人民幣23.6百萬元)，純利增加人民幣94.5百萬元。
- 截至2020年12月31日止年度，每股基本及攤薄盈利為人民幣0.070元(2019年：人民幣0.014元)。
- 董事會決議不就報告期宣派任何末期股息(2019年：無)。

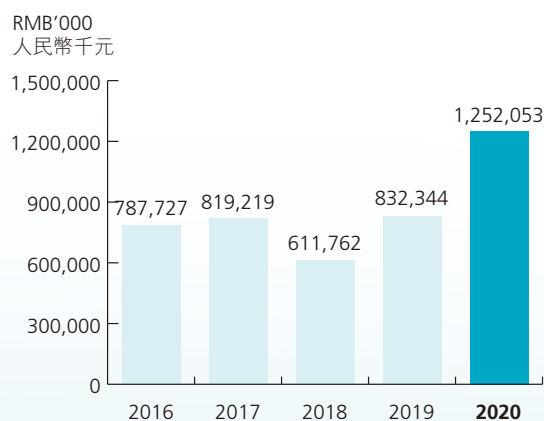

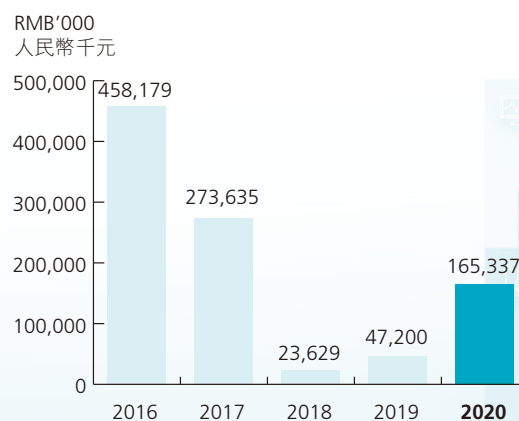

# Chairman's Statement

## 主席報告

### Dear Shareholders,

On behalf of the Board, I would like to express my gratitude to the Shareholders for their attention and support to the Group, and present the report of the Group for the Reporting Period.

Affected by the COVID-19 epidemic in 2020, the pharmaceutical industry has met new opportunities and challenges. Due to the epidemic, the pharmaceutical industry continues to be sought after by the investment boom, and the demand for related pharmaceutical products has also been enlarged. In 2020, medical industry has also ushered in a new round of upsurge in China. At the same time, the epidemic has also raised people's awareness of their own health, which has increased the demand for medicine to a certain extent, and the growth rate of the entire pharmaceutical industry has continued to be higher than that of domestic GDP.

During the Reporting Period, the human albumin batch release amounted throughout the year was 58.9 million vials, an increase of 10.2% compared to last year, in which the imported human albumin was 37.7 million vials and accounted for 64.0%, an increase of 17.1% compared to last year, and the domestic production was 21.2 million vials and accounted for 36.0%, almost the same as the last year. Mainly due to the epidemic, the working hours of the plasma station at the beginning of the year were delayed, which led to a decrease in the amount of plasma collection and affected the batches of domestic albumin issued in the subsequent quarters. Due to the increase in demand for pharmaceutical products caused by the epidemic, the volume of imported human albumin continued to increase.

On the basis of the "Two-Invoice System" policy, the Company further adjusted and optimized the sales channels for products to enter the terminal market compared with last year. In the past year, our product marketing network has covered large-scale hospitals in major cities across the country, and has also penetrated into hospitals in cities and second- and third-tier cities cooperated with various distributors and promoters. In the history of the development of blood products, market and policy changes have had a greater impact on the entire industry in the short term, but after the sales channels adjustment and Integration in the previous two years, the Group enlarged the business scale and improved its profitability.

### 尊敬的各位股東：

本人謹代表董事會對各位股東對本集團的關注與支持表示衷心感謝，並在此呈報本集團於報告期之報告。

2020年受到新冠疫情的影響，醫藥行業迎來了新的機遇和挑戰。由於疫情的緣故，醫藥行業持續受到投資熱潮的追捧，相關醫藥產品的需求也被放大。在2020年裏，中國的醫療行業也迎來了新一輪的熱潮。同時，這次疫情也增加了人們對於自己的健康意識，使得醫藥需求在一定程度的上升，整個醫藥行業的增速持續保持著高於國內GDP的增速。

報告期內，人血白蛋白全年批發量為58.9百萬瓶，較去年增長了10.2%，其中進口人血白蛋白37.7百萬瓶佔比64.0%，相較去年增加17.1%，國產21.2百萬瓶佔比36.0%，和去年大致相同。主要由於疫情原因，造成採漿站年初上班時間的推遲，從而導致採漿量的降低，影響了後續季度國產白蛋白的批發量。由於疫情導致的醫藥產品需求的增加，進口人血白蛋白的採購量持續增加。

在「兩票制」政策的基礎上，本公司較去年進一步調整和優化了產品進入終端市場的銷售渠道。在過去的一年裏，我司產品的營銷網絡在覆蓋了全國主要城市的大型醫院基礎上，同時還在各經銷商和推廣商的協作下進一步滲透到了地市及二、三線城市的醫院。在血液製品的發展歷史中，市場變化和政策的變化在短期內對於整個行業都有較大的衝擊，但是集團經過過去兩年的銷售渠道調整和整合，實現了業務規模和盈利能力的提升。

Throughout the Reporting Period, revenue of Human Albumin Solution stood at RMB1,889.0 million, representing an increase of approximately 122.7% or RMB1,040.8 million as compared to 2019. The gross profit of Human Albumin Solution realized RMB227.7 million, representing an increase of approximately 202.8% or RMB152.5 million as compared to 2019.

With the smooth expansion of production capacity of human albumin suppliers, the Group's continuous reduction of inventory and the enhancement of its sales and distribution capabilities, the purchase volume in 2020 has significantly increased. During the Reporting Period, Sinco distributed a total of about 7.1 million vials of human albumin solution, a significant year-on-year increase of 135.0%. At the same time, on the premise that market demand has picked up and terminal prices have stabilized, the supply price of the Group's human albumin products has also remained stable throughout the year. In 2021, the Group will further expand its market share in accordance with market conditions on the basis of the smooth establishment of sales channels and a substantial rebound in sales volume to further increase sales scale.

With the completion of reshaping the Group's business model and bettering its independent sales network, the Group managed to gradually bring down the cost of channel development and sales expense and significantly improve the overall profitability. As of 31 December 2020, the Group recorded a net profit of approximately RMB118.1 million. The successful transformation of the business system has laid a good foundation for the Group's operations in 2021.

於整個報告期內，人血白蛋白注射液收益為人民幣1,889.0百萬元，相比2019年增長約人民幣1,040.8百萬元，增幅約122.7%。人血白蛋白注射液毛利共計人民幣227.7百萬元，相較2019年增長約202.8%或人民幣152.5百萬元。

在人血白蛋白供應商順利擴張產能，本集團持續消化庫存以及提升自身銷售配送能力的背景下，2020年度的採購量顯著提升。報告期內興科蓉共計分銷人血白蛋白注射液約7.1百萬瓶，同比大幅增長135.0%。同時，在市場需求回暖以及終端價格趨穩的前提下，本集團人血白蛋白產品的供應價格也在全年保持穩定。在2021年，本集團也將在銷售渠道得以順利構建和銷售量大幅回升的基礎上，進一步根據市場情況擴大市場份額，以進一步提升銷售規模。

隨著本集團業務模式重構完成以及自主銷售網絡的逐步完善，本集團在渠道建設和銷售費用上的投入逐漸減少，綜合盈利能力大幅提升。截至2020年12月31日，本集團錄得純利約人民幣118.1百萬元。業務體系的成功轉型為本集團在2021年的運營奠定了良好的基礎。



During the year of the outbreak of the COVID-19 epidemic, the Group continued to promote the adjustment of sales policies and further optimization measures, and continued to penetrate and develop new terminal hospitals. With the stable development of terminal market, the Company's adaptability to policy adjustments and market changes in the pharmaceutical industry has been greatly increased. While actively building the internal system of the Group, it is also developing the management and training of talents. Through this series of measures, the sales team of the Company's products has been continuously improved. The Company will also continue to strengthen the construction of internal control and risk management systems, pay close attention to corporate social responsibility, and put corporate social responsibility into practice under group control. Based on the good cooperation with Octapharma and according to Octapharma's forecast and production plan, the supply of human albumin products to the Chinese market will continuously be increased in 2021. It is believed that the Group's sales performance in 2021 will create a new high in benefits of the stable and continuous cooperation between the Group and its suppliers.

Last but not least, on behalf of the Board, I would like to thank our Shareholders, customers and partners for their trust and support during the Group's difficult time, and all the employees of the Group for their hard work and contribution. The Group will seize the market opportunities brought by the upgrade and transformation of the pharmaceutical industry and continuously improve its competitiveness, in an effort to maximize value for the Shareholders, customers and other stakeholders.

### FINANCIAL REVIEW

#### Revenue

The Group recorded revenue of RMB2,049.8 million for the Reporting Period, representing an increase of RMB873.4 million, or 74.2% as compared to RMB1,176.4 million in 2019, which could be further analysed as follows:

- Throughout the Reporting Period, revenue of human albumin solution stood at RMB1,889.0 million, representing an increase of approximately 122.7% or RMB1,040.8 million as compared with 2019. Such increase in revenue was caused by the increase in the supply volume and the sales volume of human albumin.
- During the Reporting Period, revenue from sales of antibiotics decreased by RMB165.2 million as compared with 2019. The decrease was mainly caused by the outbreak of the coronavirus COVID-19 in the beginning of the year 2020 which caused the drop in the number of hospital inpatients as a result the usage of antibiotics decreased correspondingly, and with the implementation of the drug volume-based purchasing policy the sale volume in some provinces declined.

- 於報告期內，人血白蛋白注射液收益為人民幣1,889.0百萬元，相比2019年上升約122.7%或人民幣1,040.8百萬元。收益增加主要源於人血白蛋白供應量和銷售量提升所致。
- 於報告期內，來自於抗生素的銷售收益較2019年減少人民幣165.2百萬元。減少主要是因為2020年初新型冠狀病毒COVID-19的爆發使醫院裏的病人減少，因而抗生素的用量相應減少，以及藥品帶量採購政策的實施導致部分省份的銷售量大降。

### Cost of sales

The Group recorded cost of sales of RMB1,776.0 million for the Reporting Period, representing an increase of RMB819.4 million, or 85.7% as compared with RMB956.6 million in 2019, which was generally in line with the increase in sales.

### Gross profit and gross profit margin

During the Reporting Period, the Group recorded gross profit of RMB273.8 million, representing an increase of RMB54.0 million as compared with RMB219.8 million in 2019, in which the gross profit of the human albumin increased by RMB152.5 million and was partially offset by the decrease of the gross profit of the antibiotics by RMB98.5 million. The gross profit margin decreased from 18.7% in 2019 to 13.4% for the Reporting Period. The decrease in gross profit margin was mainly due to the large increase of sales of human albumin which in generally has lower profit margin than the antibiotics.

### Other income and gains

During the Reporting Period, other income and gains of the Group amounted to RMB13.7 million, representing a decrease of RMB1.4 million as compared with 2019, which was mainly caused by the decrease of delivery service income.

### Selling and distribution expenses

During the Reporting Period, the Group's selling and distribution expenses amounted to approximately RMB89.8 million, representing a decrease of RMB24.7 million as compared with the 2019. The decrease was mainly due to the decrease of marketing promotion expenses which was in line with the decrease in sales of the antibiotics.

### Administrative expenses

During the Reporting Period, the Group recorded administrative expenses of RMB40.6 million, which was similar to that of the 2019. The administrative expenses mainly included staff cost of RMB8.9 million, intermediary service fees of RMB9.2 million, tax charges of RMB5.0 million, depreciation and amortization cost of RMB6.7 million and other miscellaneous expenses.

### Other expenses

During the Reporting Period, the Group recorded other expenses of RMB12.7 million, representing an increase of RMB2.4 million as compared with the 2019, which was mainly due to the increase in foreign exchange loss.

### 銷售成本

本集團於報告期內錄得銷售成本人民幣1,776.0百萬元，較2019年的人民幣956.6百萬元增加人民幣819.4百萬元，增幅85.7%，總體與銷售收入的增加相符。

### 毛利及毛利率

於報告期內，本集團錄得毛利人民幣273.8百萬元，較2019年的人民幣219.8百萬元增加人民幣54.0百萬元，其中人血白蛋白毛利增加人民幣152.5百萬元，以及部分被抗生素毛利減少人民幣98.5百萬元所抵銷。報告期內毛利率則由2019年的18.7%減少至13.4%。毛利率減少主要是因為人血白蛋白銷售的大幅增加，而人血白蛋白毛利率總體上低於抗生素的毛利率。

### 其他收入及收益

於報告期內，本集團的其他收入及收益為人民幣13.7百萬元，較2019年減少人民幣1.4百萬元，其主要是由於運輸配送服務收入減少所致。

### 銷售及經銷開支

於報告期內，本集團銷售及經銷開支約人民幣89.8百萬元，較2019年減少人民幣24.7百萬元。減少主要是由於市場推廣費用減少，與抗生素銷售減少相符。

### 行政開支

於報告期內，本集團錄得行政開支人民幣40.6百萬元，與2019年相若。行政開支主要包括員工成本人民幣8.9百萬元、中介服務費人民幣9.2百萬元、稅費人民幣5.0百萬元、折舊與攤銷成本人民幣6.7百萬元和其他各項費用。

### 其他開支

於報告期內，本集團錄得其他開支人民幣12.7百萬元，較2019年增加人民幣2.4百萬元，主要由於外匯匯兌損失增加。

### Finance costs

During the Reporting Period, the Group recorded finance costs of RMB8.8 million, representing a decrease of RMB11.2 million as compared with 2019, which was mainly due to the repayment of the other interest-bearing loans by the Group in January 2020 and accordingly the relevant interest expense decreased.

### Income tax expense

During the Reporting Period, the income tax expenses decreased by RMB1.6 million or 8.2% to RMB17.8 million as compared with 2019. The decrease was mainly due to utilisation of tax losses from previous periods.

### Profit for the Reporting Period

As a result of the foregoing, the Group recorded the net profit of RMB118.1 million, which increased by RMB94.5 million as compared with RMB23.6 million in 2019.

### Inventories

Inventory balances amounted to RMB242.6 million as of 31 December 2020 (31 December 2019: RMB259.3 million), representing a decrease of RMB16.7 million as compared with the year-end balance of 2019. Such decrease was due to the decrease in the inventory balance of human albumin solution.

Due to the decrease of the inventory and adjustment of sales channels, the Group's average inventory turnover days decreased by 38 days from 90 days in 2019 to 52 days for the Reporting Period.

### 財務成本

於報告期內，本集團錄得財務成本人民幣8.8百萬元，較2019年減少人民幣11.2百萬元，主要由於本集團在2020年1月份償還了其他計息貸款，因此對應的利息支出減少。

### 所得稅開支

於報告期內，所得稅開支為人民幣17.8百萬元，較2019年減少人民幣1.6百萬元或8.2%。該減少主要是因為動用過往期間的稅項虧損。

### 報告期內溢利

由於前述原因，本集團錄得純利人民幣118.1百萬元，較2019年的人民幣23.6百萬元增加人民幣94.5百萬元。

### 存貨

截至2020年12月31日，存貨餘額為人民幣242.6百萬元(2019年12月31日：人民幣259.3百萬元)，較2019年的年結日餘額減少人民幣16.7百萬元。該減少主要是由於人血白蛋白注射液庫存餘額減少。

由於存貨的減少及銷售渠道的調整，本集團於報告期內的平均存貨週轉天數為52天，較2019年的90天減少38天。

### Trade and bills receivables

The balance of trade receivables amounted to RMB578.7 million as of 31 December 2020 (31 December 2019: RMB26.0 million). The main reason for the increase of RMB552.7 million as compared with the year-end balance of 2019 was that most of trade receivables were covered by letter of credit issued by the customers and not yet past due which led to an increase in the balance of trade receivables.

The balance of bills receivables as of 31 December 2020 was nil (31 December 2019: RMB4.7 million).

### Prepayments, other receivables and other assets

As of 31 December 2020, the current portion of prepayments, other receivables and other asset amounted to RMB40.7 million (31 December 2019: RMB109.2 million), representing a decrease of RMB68.5 million as compared with the year-end balance of 2019. The decrease was mainly caused by the drop of prepayment of deposits for issuance of letter of credit by RMB42.6 million and valued-added tax recoverable by RMB20.8 million.

### Trade payables

As of 31 December 2020, trade payables amounted to RMB700.3 million (31 December 2019: RMB300.5 million), representing an increase of RMB399.8 million as compared with the year-end balance of 2019, which was caused by the increase of payables for the purchase of Human Albumin Solution.

### Other payables and accruals

As of 31 December 2020, other payables and accruals amounted to RMB161.9 million (31 December 2019: RMB116.9 million), representing an increase of RMB45.0 million as compared with the year-end balance of 2019. The increase was mainly due to the increase of payables in relation to the import agent contract by RMB54.7 million. The increase was partially offset by the decrease of (i) the payables in relation to marketing, promotion and consulting services by RMB12.7 million; and (ii) the interest payable on other interest-bearing loans by RMB23.2 million.

### 貿易應收款項及應收票據

截至2020年12月31日，貿易應收款項餘額為人民幣578.7百萬元(2019年12月31日：人民幣26.0百萬元)，較2019年的年結日餘額增加人民幣552.7百萬元，主要是由於大部分貿易應收款項是由客戶開立且尚未逾期的信用證擔保支付，使貿易應收款項餘額增加。

截至2020年12月31日，應收票據餘額為零(2019年12月31日：人民幣4.7百萬元)。

### 預付款項、其他應收款項及其他資產

截至2020年12月31日，預付款項、其他應收款項及其他資產的即期部分為人民幣40.7百萬元(2019年12月31日：人民幣109.2百萬元)，較2019年的年結日餘額減少人民幣68.5百萬元。該減少主要由於開立信用證的按金預付款項減少人民幣42.6百萬元及可收回增值稅進項稅額減少人民幣20.8百萬元。

### 貿易應付款項

截至2020年12月31日，貿易應付款項為人民幣700.3百萬元(2019年12月31日：人民幣300.5百萬元)，較2019年的年結日餘額增加人民幣399.8百萬元，其由於應付人血白蛋白注射液採購款增加所致。

### 其他應付款項及應計款項

截至2020年12月31日，其他應付款項及應計款項為人民幣161.9百萬元(2019年12月31日：人民幣116.9百萬元)，較2019年的年結日餘額增加人民幣45.0百萬元。該增幅主要是由於與進口代理合約相關的應付款項增加人民幣54.7百萬元。該增幅部分由(i)與營銷、推廣及諮詢服務相關的應付款項減少人民幣12.7百萬元；及(ii)其他計息貸款的應付利息減少人民幣23.2百萬元所抵銷。

### Other payables and accruals (non-current portion)

As of 31 December 2020, non-current portion of other payables amounted to RMB93.4 million (31 December 2019: RMB130.1 million), representing a decrease of RMB36.7 million as compared with the year-end balance of 2019. The decrease was mainly due to the decrease of payables in relation to the import agent contracts by RMB130.1 million which was partially offset by the increase in payables in relation to the long-term deposits received from distributors.

### Borrowings

As of 31 December 2020, the Group has borrowings of RMB81.0 million in total, with details set out below:

## 1) Net cash from/(used in) operating activities

During the Reporting Period, the Group's net cash inflow from operating activities amounted to approximately RMB137.3 million (for the year 2019: net cash outflow of RMB9.5 million), which was mainly due to the increase in cash from sales and increase in deposits receivable from distributors during the Reporting Period as compared with the corresponding period of prior year.

## 2) Net cash from/(used in) investing activities

During the Reporting Period, the Group's net cash outflow from investing activities amounted to approximately RMB46.8 million (for the year 2019: net cash outflow of RMB2.5 million), which was mainly due to the significant capital expenditure on the addition of leasehold land.

## 3) Net cash from/(used in) financing activities

During the Reporting Period, the Group's net cash outflow from financing activities amounted to approximately RMB169.9 million (for the year 2019: net cash inflow of RMB156.4 million), which mainly include (i) repayment of the interest-bearing bank and other borrowings of RMB226.3 million; (ii) payment of interests of RMB6.8 million and (iii) net payment of other payables and accruals of RMB98.6 million in relation to import agency contracts. The cash outflow was partially offset by (i) net proceeds from bank and other loans of RMB120.3 million and (ii) proceeds from deposits of issuance of letters of credit of RMB42.6 million.

The Group seeks to maintain strict control over its outstanding receivables and the senior management of the Company reviews and assesses the creditworthiness of the Group's existing customers on an ongoing basis. To manage liquidity risk, the Group monitors its exposure to a shortage of funds by considering the maturity of both its financial liabilities and financial assets and projected cash flows from operations. Cash and cash equivalents of the Group is mainly denominated in RMB.

### Foreign currency risk

Most of the Group's assets and liabilities are denominated in RMB, except for certain items below:

## BUSINESS REVIEW

With extensive experience in the distribution of pharmaceutical imports, the Group provides comprehensive MPCM services for small and medium-sized overseas pharmaceutical manufacturers. Meanwhile, the Group is the only MPCM services provider for imported blood products in the PRC, leveraging our quality product portfolio that focuses on blood products and nationwide marketing and promotion network. The Group's existing product portfolio encompasses many quality products produced by small and medium-sized overseas pharmaceutical manufacturers, covering multiple therapeutic areas such as anti-infective drugs, and blood products. Included in such products are blood products which are in short supply in the Chinese market and prescription drugs which can meet the high demand for high-quality drugs with excellent clinical results among medical institutions and patients.

### 業務回顧

本集團擁有進口醫藥分銷的豐富經驗，為海外中小型藥商提供綜合營銷、推廣及渠道管理服務。同時，本集團憑藉以血液製品為核心的優質產品組合和覆蓋全中國的營銷及推廣網絡，是中國進口血液製品唯一的營銷、推廣及渠道管理服務供應商。本集團現有產品組合包括由海外中小型製藥商生產的優質產品，涵蓋抗感染藥物和血液製品等多個治療領域。該等產品既包括在中國市場上供不應求的血液製品，亦包括可滿足醫療機構、患者對於臨床效果卓越、品質優異的藥品的強烈需求的處方藥品。

## 1. Core Products

### *Human Albumin Solution*

Dating back to the early 1940s, blood products have undergone decades of fast development. Such products have grown from Human Albumin at the very beginning to the current 20-plus categories in three series, encompassing such sub-categories as Human Albumin, immune globulin and blood coagulation factors. Given the approval granted to new indications and an improved rate of diagnosis, the Plasma Protein Therapeutics Association (PPTA) predicts that the market demand for blood products will retain a high-speed growth around the globe. In these two years, as many new plasma collection stations have been put into service, the amount of plasma collection increases every year and production capacity of domestic manufacturers has also increased rapidly. As the largest sales category in the market of blood products in the PRC, Human Albumin is the only kind of blood product allowed to be imported at present, and its lot release of imported and domestic categories maintains a rapid growth every year. In 2020, the annual batch release amounted to 58.9 million vials (2019: 53.4 million vials), among which the percentages of imported and domestic categories were 64.0% and 36.0% respectively. Manufactured by Octapharma, a global leading manufacturer of blood products, and included as a Category B product in the National Reimbursement Drug List (NRDL), the Human Albumin Solution operated by the Group is used to remedy the shock caused by hypovolemia, remove edema and poisonous substances, and treat neonatal hyperbilirubinemia. Based on the batch release of the Human Albumin Solution in the PRC in 2020, the market share of the Human Albumin Solution manufactured by Octapharma was approximately 15.4%.

## 2. Marketing Network Development

The Group provides its marketing service through its internal teams and their cooperation with third-party promoters. Hence, one of the Group's key development strategies is to continuously expand the marketing network and enhance distributor and promoter management. During the Reporting Period, the Group took "Flexible, Professional and Efficient" as its objective, and strove to develop its marketing team in respect of the ability of quickly responding to market environment changes and executing operational plans with high efficiency. Furthermore, the Group sorted out its human resources in each division. The marketing team had its structure streamlined and its performance management further refined, with optimized allocation of sales resources that are invested in each product, there by achieving higher efficiency of business operation.

## 1. 核心產品

### 人血白蛋白注射液

血液製品起源於20世紀40年代初，經過幾十年的快速發展，該產品品種已由最初的人血白蛋白發展到現在的人血白蛋白、免疫球蛋白和凝血因子類等3大系列20多個品種。隨著新的適應症的獲批和診治率的提高，國際血漿蛋白治療協會(PPTA)預計全球血液製品市場需求仍將保持較高的增長速度。近兩年，隨著國內新批採漿站的投入使用，每年的採漿量得到了增長，國內生產廠家的產能也得到快速提升。人血白蛋白作為中國血液製品市場中最大的銷售品種，也是目前唯一可以允許進口的血液製品，其每年進口和國產品種的批發發量都保持了快速的增長，2020年全年的批發發量為58.9百萬瓶(2019年：53.4百萬瓶)，其中進口和國產的佔比分別為64.0%和36.0%。本集團經營的人血白蛋白注射液是由全球血液製品巨頭之一的奧克特法瑪公司生產，用於治療因血容量降低引起的休克、消除水腫和有毒物質、新生兒高膽紅素血症等，是國家醫保目錄乙類產品。以2020年中國人血白蛋白注射液批發發量統計，奧克特法瑪人血白蛋白注射液市場佔有率約為15.4%。

## 2. 營銷推廣網絡發展

本集團的營銷推廣服務通過內部團隊及與第三方推廣服務商合作而展開。因此，不斷拓展營銷推廣網絡，並持續強化對經銷商及推廣服務商的管理是本集團的重點發展戰略之一。於報告期內，本集團以「靈活應變」和「專業高效」為目標，著力打造營銷推廣隊伍快速應對市場環境變化以及高效執行運營方案兩方面的能力，對各部門進行人才盤點，精簡營銷推廣隊伍組織架構。此外，本集團進一步細化營銷團隊績效管理，優化對各產品投入的銷售資源分配，從而提升營銷推廣隊伍業務運營效率。

At the same time, the implementation of “Two-Invoice System” took place at a faster pace in each province. To positively respond to such implementation, the existing structure of distributor network was comprehensively sorted out. Based on sufficient communication with its distributors, the Group has further extended its sales channels to end markets through the collaboration between its internal sales team and local distributors. Previously, promoters were allocated by region. Now, the promoters are matched with each hospital of the region concerned, which enables the Group’s sales network to reach the end market directly. Besides, the coverage of the network has also been extended from large top Class-III hospitals to provincial, municipal and county hospitals, to keep improving market penetration, thereby establishing a precise management system that each hospital will have its respective promoters.

In addition, the Group has further improved the direct participation of its internal marketing team in product marketing activities. In this regard, approaches include regularly training third-party promoters on product knowledge, hosting or taking part in medical or pharmaceutical conferences, symposiums and product seminars to directly partake in the academic promotion activities of products, and extend the opinion leadership network for the main therapeutic areas of products. All the approaches serve to ensure accurate and timely delivery of product information to doctors. In addition to product promotion, the Group has taken the initiative to invite third party promoters from across the country to discuss and interpret the major impact of national policies, to increase the added value and attraction of the Group’s training.

### 3. Cold Chain Storage Facility

Considering the future demand for business expansion and the significant demand for pharmaceutical cold chains in the storage and delivery of blood products and bio-products, the Group has constructed a cold chain storage facility in Shuangliu District, Chengdu, Sichuan Province. The Group has completed the first phase of its cold chain storage facility (15,000 square meters), which can satisfy the Group’s storage demand and provide better control for the quality and safety of the blood products in our product portfolio. Additionally, we will be able to provide third parties with high quality pharmaceutical cold-chain storage services upon completing the second-phase construction (which includes 25,000 square meters of cold chain storage and 47,000 square meters of research and development base), which will be a new business unit of the Group.

Save as mentioned above, the Group did not hold any material investments, and there was no material acquisition or disposal of its subsidiaries, associates or joint ventures during the Reporting Period.

與此同時，本集團積極應對在各省加速落地的「兩票制」，全面梳理現有經銷商網絡結構，在與經銷商進行充分交流的基礎上，採取內部銷售隊伍和與各地經銷商合作的方式，本集團進一步推動銷售渠道向終端市場延伸，由先前按照區域劃分轉型到按照各個區域內的醫院劃分對應的推廣服務商，使本集團的銷售網絡直達終端市場，同時從大型的三級甲等醫院逐漸往下覆蓋到省地市以及縣一級醫院，不斷加深市場滲透率，以達到建立每家醫院均有對應推廣服務商的精細化管理體系。

另外，本集團進一步強化內部營銷團隊對產品市場推廣活動的直接參與，包括定期向第三方推廣服務商提供產品知識培訓，通過籌辦或參與醫療或醫藥會議、座談會及產品研討會等方式直接參與產品的學術推廣活動，拓展產品主要治療領域的意見領袖網絡等，以保證產品信息準確及時地傳達予醫生。除了產品推介外，本集團還主動邀請全國第三方推廣服務商一同探討解讀國家政策的重大影響，提高本集團培訓的附加值及吸引力。

### 3. 冷鏈倉儲設施

考慮到本集團今後業務擴展需求以及關於血液製品和生物製品在倉儲及運輸環節對於醫藥冷鏈的巨大需求，本集團在四川省成都市雙流區建設了冷鏈倉儲設施。已完工的第一期冷鏈倉儲設施(15,000平方米)可滿足本集團自身的倉儲需求，能夠更好地控制產品組合中血液製品的質量與安全，待第二期建設(包括25,000平方米的冷鏈倉儲及47,000平方米的研發基地)竣工時可向第三方提供高質量的醫藥冷鏈倉儲服務，形成本集團新的業務單元。

除上文所述者外，本集團並無持有任何重大投資，於報告期內亦無其附屬公司、聯營公司或合營公司的重大收購或出售。

#### 4. Research and Development

The Group has entered into a collaboration agreement with the China Academy of Chinese Medical Sciences to develop “Sinco I”, a new realgar-based chemical medicine for treating acute promyelocytic leukemia. The collaboration aims for the upstream extension of the Group’s business and the future provision of a new medicine for patients in the therapeutic area. The Group is currently making efforts in designing and building a pilot plant for pilot experiments. During the Reporting Period, the Group incurred RMB0.8 million as the research and development expenses for developing Sinco I.

#### FUTURE AND OUTLOOK

In 2021, the 2019 novel coronavirus (“COVID-19”) epidemic may continue to affect the global economic situation. Under the influence of the epidemic, the amount of plasma collection in 2020 will be reduced, and according to the delay of blood products, the number of batches issued in 2021 will also be reduced accordingly. It is expected that in early 2021, there will be a short supply of albumin. In the short term, the price of albumin will continue to rise. In addition, the current domestic order of diagnosis and treatment is also gradually recovering, and the demand for albumin in the market in 2021 is expected to show a recovery growth. If supply fails to keep up with demand, it will also push up the price of albumin in the market. In the long run, current demand for albumin is far less than that of developed countries compared with China. Therefore, the market has huge potential. Under the influence of the population base, the demand will continue to increase in the future.

#### 4. 研發

本集團與中國中醫科學院訂立合作協議開發「Sinco I」，是以雄黃為原料的用於治療急性早幼粒細胞白血病的新型化學藥物，以期將本集團業務向上游延伸的同時，未來將該治療領域的新藥提供給患者。目前，本集團正在設計和建設中試車間以開展中試試驗。於報告期內，本集團產生開發Sinco I的研發費用為人民幣0.8百萬元。

#### 未來展望

2021年，新型冠狀病毒(「新冠」)疫情可能會持續影響著全球的經濟局勢。在疫情影響下，2020年的採漿量因此減少，而根據血液製品的延遲性，2021年的批簽發量也會隨之減少。預計在2021年初，將會出現白蛋白的供貨緊張，短期內，白蛋白的價格也會持續升高。此外，國內目前診療秩序也在陸續的恢復，2021年的白蛋白市場需求量預計也會出現恢復性的增長。若出現供給跟不上需求的情況，也會推動白蛋白市場價格上行。從長期來看，中國目前對於白蛋白的需求量遠不如發達國家，因此市場方面具備巨大潛力，在人口基數的影響下，需求量在未來也會持續增加。

Under the influence of the epidemic in 2021, people's medical awareness and needs will also increase with the emergence of the COVID-19 epidemic. Due to the clinical necessity for albumin and there is no corresponding substitute product in the short term, it is expected that the demand for albumin will increase in the future. After the implementation of the "two-invoice system" policy in China, sales channels have become flatter, and manufacturers can directly cooperate with end customers. While actively conducting academic promotion activities, the manufacturers' business ideas are also having fundamental changes, the original price-oriented thinking is transformed into a focus on academic promotion and actively improving brand influence. In recent years, products represented by human albumin have ushered in a rapid recovery. Under the existing sales team and model system, the Group will continue with its corporate sales team and development strategies in optimizing the marketing network and the product portfolio, and maintaining the business of blood products and antibiotics as a core therapeutic area. By concentrating its advantageous resources, the Group spares no effort in reaching a speedy completion of the adjustment on sales pattern under the new policies for stabilizing its business. In respect of expanding its marketing network, the Group will strengthen the control over its sales team, improve its incentive mechanism, continuously promote presence in the downstream of marketing network channels, and extend it to the end market by establishing multi-mode cooperation with hospitals and pharmacies, all in a bid to contribute higher profit to the Group, develop core marketing capabilities and build a quality terminal promotion network to accommodate more products.

Apart from the above, the Group will continue to enhance the development of its internal control system and risk management, pay much attention to and fulfill its corporate social responsibilities throughout the Group's governance. The Group will offer its staff a great platform for career development, and keep working to create a greater value for the Shareholders.

## EMPLOYEE AND REMUNERATION POLICY

As of 31 December 2020, the Group had a total of 107 employees. For the Reporting Period, the total staff costs of the Group were RMB11.7 million (2019: RMB12.5 million).

The Group's employee remuneration policy is determined by factors such as remuneration in respect of the local market, the overall remuneration standard in the industry, the inflation level, corporate operating efficiency and employee performance. The Group conducts performance appraisals once every year for its employees, the results of which are applied in annual salary reviews and promotional assessments. The Group's employees are considered for annual bonuses according to certain performance criteria and appraisals results. Social insurance contributions are made by the Group for its PRC employees in accordance with the relevant PRC regulations.

於2021年，在疫情影響下，人們的醫療意識和需求也隨著新冠疫情的出現而增加。由於白蛋白在臨床上的必要性，而且在短期內並無相應的替代產品，預計未來對於白蛋白的需求也會有增無減。在國內實行「兩票制」後，銷售渠道更加扁平化，廠家可以直接與終端客戶進行合作，在積極進行學術推廣活動的同時，廠家的經營思路也進行著根本性的改變，由原本的價格為導向的思路轉化為重點以學術推廣和積極提高品牌影響力。近幾年，以人血白蛋白為代表的產品迎來快速復蘇。本集團將在現有的銷售團隊和銷售模式體系下，繼續秉持優化營銷推廣網絡和產品組合的企業銷售團隊及發展戰略，以血液製品和抗生素為業務發展的核心治療領域，集中優勢資源，不遺餘力地快速完成對在新政策下的銷售模式調整，穩定本集團的業務發展。在擴大營銷推廣網絡上，本集團將加強對營銷團隊的管控，完善激勵制度，不斷推進營銷推廣網絡下游渠道，並通過開發與醫院及藥房的多模式合作方式向終端市場延伸，為本集團提升利潤貢獻，打造核心營銷能力和建立優質的終端推廣網絡以容納更多產品。

除上述者外，本集團將繼續加強建設企業內部控制體系及風險管理，亦高度關注及履行企業社會責任，並在集團管治中貫徹執行。本集團將為員工提供理想的職業發展平台，為股東創造價值而不懈努力。

## 僱員及薪酬政策

截至2020年12月31日，本集團共有107名僱員。報告期內，本集團的員工成本總計人民幣11.7百萬元（2019年：人民幣12.5百萬元）。

本集團僱員薪酬政策乃根據有關當地市場的薪酬、行業的整體薪酬標準、通脹水平、企業運營效率及僱員表現等因素而確定。本集團每年為僱員作一次表現評核，年度薪金檢討及晉升評估時會考慮有關評核結果。本集團僱員根據若干績效條件及評核結果考慮其年度花紅。本集團根據相關中國法規為其中國僱員作出社會保險供款。

The Group also provides continuous learning and training programs to its employees to enhance their skills and knowledge, so as to maintain their competitiveness and improve customer service quality. The Group did not experience any major difficulties in recruitment, nor did it experience any material loss in manpower or suffer from any material labor dispute during the Reporting Period.

In addition, the Group adopted a share option scheme to recognize the contribution by certain employees of the Group, and to provide them with incentives in order to retain them for their continuing support in the operation and development of the Group.

### PRIOR YEAR ADJUSTMENTS

Prior year adjustments have been made by the Company due to correction of prior period errors (the “**Errors**”).

In July 2020, Ernst & Young was appointed as the auditor of the Company for the year ended 31 December 2020. The Errors were identified when Ernst & Young performed audit procedures on the opening balances according to Hong Kong Standard on Auditing 510 “Initial Audit Engagements – Opening Balances” during the review on interim condensed financial information for the six months ended 30 June 2020. In August 2020, Ernst & Young, drew the Company’s attention to the prior year adjustments to correct the Errors resulting from accounting estimates and judgment perspective. Upon discussion among the Audit Committee of the Company and the Board, and having been satisfied that the prior year adjustments have been properly made, the Company disclosed and restated the corrected financial figures under the prior year adjustments in its interim results announcement for the six months ended 30 June 2020 and annual results announcement for the year ended 31 December 2020, which were published on 28 August 2020 and 31 March 2021, respectively.

To enable the Company’s shareholders and potential investors to make an informed decision when dealing in the Company’s security, the Company further includes the prior year adjustment in this report.

Details of which are set out in note 2.4 to the consolidated financial statements of the Group in this report. In addition, the Company sets out below the underlying causes of the Errors, and the basis of which the prior year adjustments under each of note 2.4(a), (b) and (c) to the consolidated financial statements of the Group were made.

本集團亦為僱員提供持續學習及培訓計劃，以提升彼等的技能及知識，藉此維持彼等的競爭力並提高客戶服務的質量。本集團於報告期內在招聘方面並無遇到任何重大困難，亦無出現任何嚴重人員流失或任何重大勞資糾紛。

此外，本公司採納購股權計劃以肯定本集團若干僱員的貢獻，及向彼等提供獎勵，以挽留彼等繼續協助本集團的營運及發展。

### 去年調整

本公司因更正前期錯誤（「**錯誤**」）而作出去年調整。

於2020年7月，安永會計師事務所獲委任為本公司截至2020年12月31日止年度的核數師。安永會計師事務所審閱截至2020年6月30日止六個月的中期簡明財務資料時，根據香港審計準則第510號「初步審核委聘－期初結餘」就期初結餘執行審核程序過程中識別錯誤。於2020年8月，安永會計師事務所提請本公司注意為更正會計估計及判斷角度所導致的錯誤而作出的去年調整。經本公司審核委員會及董事會討論，且信納已適當作出去年調整後，本公司分別於2020年8月28日及2021年3月31日刊發的截至2020年6月30日止六個月的中期業績公告及截至2020年12月31日止年度的年度業績公告中，披露及重列根據去年調整更正後的財務數據。

為使本公司股東及潛在投資者於買賣本公司證券時作出知情決定，本公司於本報告中進一步載入去年調整。

有關詳情載於本報告內本集團綜合財務報表附註2.4。此外，本公司於下文載列錯誤的相關原因以及作出本集團綜合財務報表附註2.4(a)、(b)及(c)項下去年調整的依據。



### 1. Errors under Note 2.4(a) and Basis of Adjustments

The Group's overseas pharmaceuticals supplier requires that pharmaceuticals be shipped after payment is received or letter of credit is issued. Due to the monetary tightening in Mainland China since the fourth quarter of 2018, the Group was unable to obtain sufficient credit facilities from banks for the issuance of letters of credit. Since January 2019, the Group has entered into pharmaceuticals import agency agreements with six state-owned import agents which have been provided with more bank credit facilities.

The specific transaction process is:

- (1) Hong Kong subsidiary of the Group ("**Hong Kong Subsidiary**") enters into a purchase and sale agreement with an overseas pharmaceuticals supplier ("**Overseas Supplier**") for the purchase of pharmaceuticals; the respective import agents enter into a purchase and sales agreement with Hong Kong Subsidiary to purchase the same batch of pharmaceuticals from Hong Kong Subsidiary; one of the subsidiaries in PRC ("**onshore subsidiary**") of the Group then enters into a purchase and sale agreement with the import agent to purchase such pharmaceuticals from the import agent and pay for the services fees;
- (2) After the above series of agreements are entered into, the import agent will issue a letter of credit to Hong Kong Subsidiary, based upon which, Hong Kong Subsidiary will deliver the letter of credit to its bank which would then issue a letter of credit to Overseas Supplier;

The above transaction process (1) and (2) do not have any impact on the Group's consolidated financial statements.

### 1. 附註2.4(a)項下錯誤及調整依據

本集團的海外藥品供應商要求於收取付款或開立信用證後方運出藥品。由於2018年第四季度以來中國內地貨幣收縮，本集團未能自銀行獲取足夠信貸融資開立信用證。自2019年1月起，本集團與獲提供更多銀行信貸融資的六名國有進口代理訂立藥品進口代理協議。

具體交易過程為：

- (1) 本集團香港附屬公司(「**香港附屬公司**」)與一名海外藥品供應商(「**海外供應商**」)訂立買賣協議以購買藥品；有關進口代理與香港附屬公司訂立買賣協議，自香港附屬公司購買同一批藥品；之後本集團其中一間中國附屬公司(「**境內附屬公司**」)與進口代理訂立買賣協議，自該進口代理購買有關藥品，並支付服務費；
- (2) 於訂立上述一系列協議後，進口代理將向香港附屬公司開立信用證，據此，香港附屬公司將信用證交付予其銀行，而該銀行則向海外供應商開立信用證；

上述第(1)及(2)項交易過程對本集團綜合財務報表並無任何影響。

- (3) After receiving the letter of credit issued by Hong Kong Subsidiary, Overseas Supplier will ship the pharmaceuticals to an import agent designated by the Group. After completing customs clearance and obtaining satisfactory inspection report, the imported pharmaceuticals will be pledged in the warehouse of the import agent to secure the letter of credit issued by the import agent. Based on the series of agreements set out in above transaction process (1), after the obtaining of a satisfactory inspection report on the pharmaceuticals, the control of the imported pharmaceuticals have been transferred to the Group's onshore subsidiary. However, the pharmaceuticals are pledged at the imported agent's warehouse to secure of the letter of credit issued by the import agent.

In respect of the Group's consolidated financial statements, after the occurrence of transaction process (3), the Group recognizes the inventory (temporarily pledged at the import agent and already disclosed as restricted assets in the Group's consolidated financial statements), as well as trade payables (payable to the Overseas Supplier) and other payables (agent services fee) to the import agent.

- (4) the Group's onshore subsidiary needs to pay the import agent certain deposits including the service fee for the letter of credit, and such deposits can be used to deduct the other payables mentioned in transaction process (5) to the import agent in future;

In respect of the Group's consolidated financial statements, after the occurrence of transaction process (4), the Group first derecognises the other payables (agent services fee payable to the import agent) recognized in transaction process (3) and records the remaining balances as other receivables (receivable from the import agent).

- (3) 於收到香港附屬公司開立的信用證後，海外供應商將藥品運至本集團指定的進口代理。於完成清關及取得令人信納的檢驗報告後，進口藥品將抵押在進口代理的倉庫，以取得進口代理開具的信用證。根據上述第(1)項交易過程所載的一系列協議，就藥品取得令人信納的檢驗報告後，進口藥品的控制權轉移至本集團境內附屬公司。然而，藥品抵押在進口代理的倉庫以取得進口代理開具的信用證。

就本集團綜合財務報表而言，於發生第(3)項交易過程後，本集團確認存貨(臨時抵押予進口代理及已於本集團綜合財務報表中披露為受限制資產)以及貿易應付款項(應付海外供應商)及應付進口代理的其他應付款項(代理服務費)。

- (4) 本集團的境內附屬公司須向進口代理支付若干按金(包括信用證服務費)，而該等按金日後可用於扣減第(5)項交易過程所述的其他應付款項；

就本集團綜合財務報表而言，於發生第(4)項交易過程後，本集團首先終止確認第(3)項交易過程中所確認的其他應付款項(應付進口代理的代理服務費)，並將剩餘結餘入賬為其他應收款項(應收進口代理款項)。

- (5) The Group derecognizes the liabilities (trade payables) to the Overseas Supplier upon the maturity of the letter of credit and correspondingly recognizes the other payables with the same amount to the import agent at the meantime. The imported pharmaceuticals are released to the Group's onshore subsidiary once the other payables (including the agent service fee recognised in transaction process (3)) are settled.

However, Crowe was of the view that, when the Overseas Supplier receives the letter of credit, the Group shall derecognize the trade payables to the Overseas Supplier. As of 31 December 2019, although the payment to the Overseas Supplier had been not settled as the letter of credit was outstanding then, Crowe suggested the Group derecognize trade payables to Overseas Supplier and recognize other payables to the import agent by offsetting the deposits mentioned in transaction process (4).

The Group find that, as at 31 December 2019, the Group has outstanding letters of credit not yet settled with overseas suppliers amounting to RMB154,308,000; and the Group made a payment of RMB67,565,000 to import agents as deposits for outstanding letter of credit for the release of pledged pharmaceutical products.

According to IFRS 9 3.3.1, "an entity shall remove a financial liability (or a part of a financial liability) from its statement of financial position when, and only when, it is extinguished – ie when the obligation specified in the contract is discharged or cancelled or expires."

- (5) 本集團於信用證到期後終止確認有關海外供應商的負債(貿易應付款項)，同時相應確認應付進口代理的等額其他應付款項。一旦結清其他應付款項(包括於第(3)項交易過程中所確認的代理服務費)，進口藥品將發放予本集團境內附屬公司。

然而，國富浩華認為，當海外供應商收到信用證時，本集團應終止確認應付海外供應商的貿易應付款項。截至2019年12月31日，儘管由於當時信用證未償付，支付予海外供應商的款項尚未結清，國富浩華建議本集團透過抵銷第(4)項交易過程所述的按金，終止確認應付海外供應商的貿易應付款項及確認應付進口代理的其他應付款項。

本集團發現，於2019年12月31日，本集團有尚未與海外供應商結算的未償付信用證人民幣154,308,000元；及本集團向進口代理支付人民幣67,565,000元作為未償付信用證的按金，以解除藥品抵押。

根據國際財務報告準則第9 3.3.1條，「實體應於且僅於金融負債消失—即合約訂明的責任獲解除或取消或屆滿時，自其財務狀況表中移除金融負債(或金融負債的一部分)。」

According to IAS 32 paragraph 42, “a financial asset and a financial liability shall be offset and the net amount presented in the statement of financial position when, and only when, and entity: (a) currently has a legally enforceable right to set off the recognised amounts; and (b) intends either to settle on a net basis, or to realise the asset and settle the liability simultaneously.

In accounting for a transfer of a financial asset that does not qualify for derecognition, the entity shall not offset the transferred asset and the associated liability.”

Therefore, the Group incorrectly reclassified trade payables to other payables amounting to RMB86,743,000 and offset trade payables against other receivables of RMB67,565,000 as at 31 December 2019, which led to an understatement of prepayments, other receivables and other assets of RMB67,565,000, an understatement of trade payable of RMB154,308,000 and an overstatement of other payables of RMB86,743,000.

Accordingly, below adjustments were made:

根據國際會計準則第32號第42段：「當且僅當實體：(a)目前有可強制執行法定權利抵銷已確認金額；及(b)有意按淨額基準結算或同時變現資產及清償負債時，金融資產與金融負債可相互抵銷，淨額於財務狀況表呈列。

將一項不合資格終止確認的金融資產轉移入賬時，實體不得抵銷已轉移資產與相關負債。」

因此，本集團不可撤銷地將貿易應付款項重新分類為其他應付款項人民幣86,743,000元，並將於2019年12月31日的貿易應付款項與其他應收款項人民幣67,565,000元相互抵銷，從而導致預付款項、其他應收款項及其他資產少報人民幣67,565,000元、貿易應付款項少報人民幣154,308,000元及其他應付款項多報人民幣86,743,000元。

因此，已作出下列調整：

## 2. Errors under Note 2.4(b) and Basis of Adjustments

Since the second half of 2019, Overseas Supplier started to lower the price and no longer bear the transportation expenditure. According to International Accounting Standard 2 paragraph 10 “the cost of inventories shall comprise all costs of purchase, costs of conversion and other costs incurred in bringing the inventories to their present location and condition.”. Transportation expenditure is the necessary cost incurred in bringing the pharmaceuticals to their present location and condition, and should be recorded as inventory costs and charged to cost of sales along the sales of the inventories. As at 31 December 2019, the relevant imported pharmaceuticals have not been fully sold. However, the Group charged all the relevant transportation expenditure incurred into profit or loss during the year ended 31 December 2019, which led to an overstatement of the cost of sales of RMB3,811,000 and an understatement of the inventories of RMB3,811,000. As a result, an accounting error was identified for the year ended 31 December 2019.

In addition, as at 31 December 2019, antibiotics of RMB4,492,000 was not recognized by the Group although the customs clearance of those pharmaceuticals had been obtained. According to the agreement entered into with the supplier, upon the obtaining of imported customs clearance, the control of antibiotics pharmaceuticals are transferred to the Group. Therefore, an accounting error was identified, which led to an overstatement of prepayments of RMB4,492,000 and an understatement of inventories of RMB4,492,000.

## 3. Errors under Note 2.4(c) and Basis of Adjustments

The total payment in advance was RMB6,907,000 as of 31 December 2019, among which, payment in advance of RMB3,157,000 for realgar bio leaching techniques was recorded in the financial statements of Chengdu Sinco Pharmaceutical Technology Co., Ltd. (成都興科蓉醫藥技術有限責任公司) and payment in advance of RMB3,750,000 for high-purity realgar extraction techniques was recorded in the financial statements of Sichuan Sinco Pharmaceuticals Co., Ltd. (四川興科蓉藥業有限責任公司). Management only considered the impairment of the payment in advance of Sichuan Sinco Pharmaceuticals Co., Ltd. Crowe identified the error but did not propose an adjustment as it was immaterial to the financial statements for the year ended 31 December 2019 in its opinion.

## 2. 附註2.4(b)項下錯誤及調整依據

自2019年下半年起，海外供應商開始調低價格，且不再承擔運輸支出。根據國際會計準則第2號第10段，「存貨成本應包括所有購買成本、轉化成本及令存貨達至當前地點及狀況所產生的其他成本。」運輸支出為令藥品達至當前地點及狀況所產生的必要成本，應計入存貨成本及隨著存貨銷售而自銷售成本中扣除。於2019年12月31日，相關進口藥品並未悉數售出。然而，本集團於截至2019年12月31日止年度的損益中扣除所產生的所有相關運輸支出，導致銷售成本多報人民幣3,811,000元及存貨少報人民幣3,811,000元。因此，就截至2019年12月31日止年度識別出會計錯誤。

此外，於2019年12月31日，儘管已取得有關藥品的清關憑證，本集團並無確認人民幣4,492,000元的抗生素。根據與供應商訂立的協議，於取得進口清關憑證後，抗生素藥品控制權已轉移至本集團。因此識別出會計錯誤，導致預付款項多報人民幣4,492,000元及存貨少報人民幣4,492,000元。

## 3. 附註2.4(c)項下錯誤及調整依據

截至2019年12月31日墊款總額人民幣6,907,000元中，有關雄黃生物浸出技術的墊款人民幣3,157,000元計入成都興科蓉醫藥技術有限責任公司的財務報表，有關高純度雄黃萃取技術的墊款人民幣3,750,000元則計入四川興科蓉藥業有限責任公司的財務報表。管理層僅考慮四川興科蓉藥業有限責任公司的墊款減值。國富浩華識別出該錯誤，但由於其認為該錯誤對截至2019年12月31日止年度的財務報表並不重大，故並無建議調整。

## RISK MANAGEMENT

The principal risks and uncertainties identified by the Group which may have material and adverse impact on our performance or operation are summarized below. There may be other principal risks and uncertainties in addition to those set out below which are not known to the Group or which may not be material now but could turn out to be material in the future.

- Failure to maintain relationships with existing suppliers – The Group currently sources all the products in portfolio from limited suppliers, either directly or indirectly through their sales agents.
- Exchange rate fluctuation – The Group's purchase of products from the overseas suppliers is denominated in US\$, and certain items of bank balances, other receivables, bank borrowings and bonds are denominated in US\$ and HK\$.
- Decrease in gross profits due to increase in cost and competition.
- Experience prolonged delays or significant disruptions to the supply of the products.

The Group believes that risk management is essential to the Group's efficient and effective operation. The Group's management assists the Board in evaluating material risk exposure existing in the Group's business, and participates in formulating appropriate risk management and internal control measures, and to ensure such measures are properly implemented in daily operational management.

## RELATIONSHIP WITH KEY STAKEHOLDERS

Human resources is one of the most important assets of the Group. The Group strives to motivate its employees by providing them with a clear career path as well as comprehensive and professional training courses. In addition, the Group also offers competitive remuneration packages to its employees, including basic salary, certain benefits and other performance based incentives.

The Group purchases imported pharmaceutical products from overseas suppliers, either directly or indirectly through their sales agents, and generate revenue by on-selling them to hospitals and pharmacies through distributors and deliverers. Our suppliers or their sales agents have granted us the rights to market, promote and manage sales channels for their products in China. The Group maintains a stable and long-term relationship with its suppliers by providing them access to the growing Chinese market with steady sales growth.

## 風險管理

以下概述本集團所識別的主要風險及不明朗因素，該等風險及不明朗因素可能會對我們的表現或營運造成重大不利影響。除下文所示者外，可能還有其他本集團未知或現時可能並不重大但於未來可變為重大的主要風險及不明朗因素。

- 未能與現有供應商維持關係—本集團現時向數目有限的供應商直接或透過銷售代理間接採購所有產品組合。
- 匯率波動—本集團向海外供應商購買的產品以美元計值，且若干銀行結餘、其他應收款項、銀行借款及債券項目均以美元及港元計值。
- 成本增加及競爭加劇導致毛利減少。
- 產品供應遭遇長時間延誤或重大中斷。

本集團相信，風險管理對本集團的運營效率及效益十分重要。本集團的管理層協助董事會評估本集團業務所面對的重大風險，並參與制定合適的風險管理及內部控制措施，以及確保在日常營運管理中妥善實施有關措施。

## 與主要利益相關者的關係

人力資源作為本集團的重要資產之一，本集團致力於以清晰的職業發展路徑以及完善專業的培訓課程激勵僱員。此外，本集團亦為僱員提供具有市場競爭力的薪酬待遇，包括基本薪金、若干福利及其他績效獎勵。

本集團從海外供應商直接或透過銷售代理間接採購進口藥品，然後通過經銷商及配送商轉售予醫院和藥房產生收益。供應商或其銷售代理授予我們在中國營銷、推廣產品及管理銷售渠道權利。本集團與供應商維持穩定長遠關係，讓供應商可以進入不斷增長的中國市場，獲得穩定的銷售增長。

The Group sells pharmaceutical products to distributors, who on-sell the products to hospitals and pharmacies either directly or indirectly through their sub-distributors. The Group maintains stable and long-term relationship with its distributors by providing them guidance, training and support to carry out more targeted field marketing and promotion activities.

### ENVIRONMENTAL POLICIES AND PERFORMANCE

The Group is primarily engaged in MPCM for imported pharmaceutical products, a line of business that does not have material impact on the environment. The key environmental impact from the Group's operation is related to electricity, water and paper consumption. The Group is fully aware of the importance of sustainable environmental development, and has implemented the following measures to encourage environmental protection and energy conservation:

- Promoting paperless office
- Encouraging low-carbon commuting
- Ensuring reasonable energy consumption

During the Reporting Period, we did not incur any material cost of compliance with relevant environmental laws and regulations

### COMPLIANCE WITH LAWS AND REGULATIONS

The Group's business and operations are subject to related laws and regulations of the Cayman Islands, the British Virgin Islands, Hong Kong and the PRC. During the Reporting Period, we have complied with all related laws and regulations of the Cayman Islands, the British Virgin Islands, Hong Kong and the PRC, which would have significant impact on the Group.

本集團將藥品售予經銷商，再由其直接或經其分經銷商間接售予醫院和藥房。本集團與經銷商維持穩定長遠關係，為經銷商提供指引、培訓和支持，以在目標領域開展更多營銷及推廣活動。

### 環境政策及表現

本集團主要從事進口藥品營銷、推廣及渠道管理，該業務線不會嚴重影響環境。本集團營運所造成的重要環境影響與電、水及紙張消耗有關。本集團深明環境可持續發展的重要性，並已實施以下措施，以推動環保及節能：

- 推行無紙化辦公
- 鼓勵低碳出行
- 確保合理利用能源

於報告期內，我們並無因遵守相關環境法律及法規而產生任何重大支出。

### 遵守法律法規

本集團的業務及營運須遵守開曼群島、英屬維爾京群島、香港及中國相關法律及法規。於報告期內，我們一直遵守對本集團有重大影響的開曼群島、英屬維爾京群島、香港及中國所有相關法律及法規。

# Directors and Senior Managements

## 董事及高級管理層

### Executive Directors

**Mr. Huang Xiangbin (黃祥彬) (“Mr. Huang”)**, aged 55, founder of the Group, has been the Chairman and executive Director of our Group since April 2011. He is also the Co-Chief Executive Officer of the Company and is mainly responsible for overall strategic planning and operation management. Mr. Huang has served as the director of Risun, the controlling shareholder of the Company, and all the subsidiaries of the Company except for Chengdu Sinco Pharmaceutical Technology Co., Ltd., Chengdu Hengsheng Ziguang Pharmaceutical Technology Co., Ltd., Sichuan Sinco Biological Technology Co., Ltd., Qingdao Ruichi Pharmaceuticals Co., Ltd., Sinco Shanghai Trading Co., Ltd. and Chengdu Sinco Pharmaceuticals Co., Ltd.. Prior to joining the Group, Mr. Huang was the director and chairman of Vast Surplus since November 2004 up until now, mainly responsible for strategic planning and operation of Vast Surplus. After Vast Surplus transferred its exclusive distribution rights to service Taurilite, TAD and Esafosfina to Hong Kong Prosperous Group Holding Limited in March 2015, it has no other business operations. Since then, Mr. Huang has been devoting a majority of his time to the Group’s business. In addition, Mr. Huang was also a founder, chief executive officer and director of Chengdu Ruixin Biopharmaceutical Technology Co., Ltd (“Ruixin”) from February 2004 to April 2011. The principal business of Ruixin was consultation in the pharmaceutical products, providing marketing and promotion services as well as assisting in obtaining regulatory approvals and registrations for pharmaceutical products. However, the pharmaceutical products serviced by Ruixin were mainly traditional Chinese medicine extracts, which are different from those of the pharmaceutical products serviced by the Group. Ruixin was not engaged in any business which competed or was likely to compete, either directly or indirectly, with the Group’s business. Furthermore, Ruixin was jointly owned as to 50% by Mr. Huang and 50% by Mr. Chen Xiangui (an independent third party who is not considered a connected person or associate of a connected person of the Company under the Listing Rules (“Independent Third Party”)) and was never a member of the Group which was readily disposable for corporate reorganization solely based on Mr. Huang’s decision. Eventually, as the management of Ruixin began to focus on the business development of the Group since Mr. Huang incorporated Sichuan Sinco Pharmaceuticals in 2011, Ruixin did not have any business or operations, which subsequently led to the passing of the shareholders’ resolutions on 22 September 2015 to voluntarily dissolve Ruixin.

Mr. Huang worked in the Drug Inspection Institute of Guangyuan (廣元市藥品檢驗所) from July 1988 to July 2004 as a pharmacist in charge of drug quality research as well as collection and delivery of drug safety information.

### 執行董事

**黃祥彬先生(「黃先生」)**，55歲，本集團創始人，自2011年4月起一直為本集團主席兼執行董事。彼亦為本公司的聯席行政總裁，主要負責整體戰略規劃及經營管理。黃先生亦擔任本公司控股股東Risun的董事，以及除成都興科蓉醫藥技術有限責任公司、成都恒盛紫光醫藥技術有限責任公司、四川興科蓉生物科技有限公司、青島瑞馳藥業有限公司、興科蓉(上海)貿易有限公司及成都興科蓉醫藥有限公司以外本公司所有附屬公司的董事。加入本集團前，黃先生自2004年11月至今擔任鵬盈董事兼主席，主要負責鵬盈的戰略規劃及運營。鵬盈於2015年3月將其滔羅特、泰特及愛賽福的獨家經銷權轉讓予香港恒盛集團控股有限公司後無其他業務運營。自此，黃先生將其大部分時間投入到本集團業務中。此外，黃先生自2004年2月至2011年4月，亦一直為成都瑞欣生物醫藥技術有限公司(「瑞欣」)的創始人、行政總裁兼董事。瑞欣的主要業務是藥品諮詢，提供營銷及推廣服務，和協助獲取監管批文及進行藥品註冊。然而，瑞欣提供的藥品主要為傳統中藥精華類，不同於本集團提供的藥品種類。瑞欣並無從事與本集團業務直接或間接競爭或可能競爭的任何業務。此外，瑞欣分別由黃先生及陳賢貴先生(根據上市規則並不被視為本公司關連人士或關連人士之聯繫人的獨立第三方(「獨立第三方」))共同擁有50%及50%權益，不曾為本集團成員公司，故不可因公司重組而由黃先生全權決定將其出售。最終，由於黃先生於2011年註冊成立四川興科蓉藥業以來，瑞欣管理層開始注重本集團業務發展，而瑞欣本身並無任何業務或營運，隨後導致瑞欣股東於2015年9月22日通過股東決議案，自願解散瑞欣。

黃先生自1988年7月至2004年7月擔任廣元市藥品檢驗所的藥劑師，負責藥品質量研究、藥品安全信息收集和報送。



Mr. Huang had been a director of Beijing Guangtong Shidai Medical Consulting Company Limited (北京廣通時代醫藥投資顧問有限公司) (“Beijing Guangtong”), a limited liability company established in the PRC in 2003, since its establishment up until 2004. Prior to the revocation of its business license, Beijing Guangtong was owned as to 50%, 40% and 10% by Mr. Huang, Mr. You Fei and Mr. You Hao respectively. Both Mr. You Fei and Mr. You Hao are Independent Third Parties. Mr. Huang confirmed that at the time of the revocation of the business license of Beijing Guangtong, he was not involved in the daily operation of Beijing Guangtong as he was focusing on the development of Ruixin’s business. To the best of Mr. Huang’s knowledge, Beijing Guangtong had ceased attending annual inspection (年檢) as it had no business operation, resulting in its business license being revoked subsequently on 26 November 2004. Mr. Huang confirmed that there is no wrongful act on his part leading to the revocation and he is not aware of any actual or potential claim that has been or will be made against him as a result of the revocation.

Mr. Huang obtained a master’s degree in EMBA from Shanghai Jiao Tong University (上海交通大學) in December 2008 and graduated from the MBA programme of Renmin University (中國人民大學) in August 2002. He also obtained a bachelor’s degree in botanical resources (野生植物資源) from Jilin Agriculture University (吉林農業大學) in July 1988. Mr. Huang has been studying in the Université Paris – Dauphine under the Executive Doctorate in Business Administration (EDBA) program since December 2013.

黃先生自北京廣通時代醫藥投資顧問有限公司(「北京廣通」)(一家於2003年在中國成立的有限公司)成立之時起至2004年為該公司董事。北京廣通被撤銷營業執照前，由黃先生、游飛先生及游浩先生分別持有其50%、40%及10%的股權。游飛先生及游浩先生均為獨立第三方。黃先生確認當北京廣通被撤銷營業執照時，彼因專注瑞欣業務發展而無參與北京廣通日常營運。就黃先生所深知，由於北京廣通並無業務營運，故不再參加年檢，因而於2004年11月26日被撤銷營業執照。黃先生確認本身並無不當行為導致該執照遭撤銷，據其所知本身亦無因執照遭撤銷而曾引致或將引致任何實際或潛在申索。

黃先生於2008年12月獲得上海交通大學高級管理人員工商管理碩士學位，並於2002年8月自中國人民大學獲得工商管理碩士課程結業證書。彼亦於1988年7月獲吉林農業大學頒發野生植物資源學士學位，並自2013年12月起攻讀巴黎第九大學高級工商管理博士學位。

### Independent non-executive Directors

**Mr. Lau Ying Kit (劉英傑) (“Mr. Lau”)**, aged 47, is an independent non-executive Director with effect from 8 November 2018. Mr. Lau is currently an independent non-executive director of Kingdom Holdings Limited (Stock Code: 528), China Wood Optimization (Holding) Limited (Stock Code: 1885) and United Strength Power Holdings Limited (Stock Code: 2337). Besides, from May 2012 to October 2020, Mr. Lau served as an independent non-executive director of Xiezhong International Holdings Limited (Stock Code: 3663). Mr. Lau is a fellow member of the Hong Kong Institute of Certified Public Accountants and holds a master’s degree in finance from the City University of Hong Kong. He was extensive experience in financial and accounting in China and Hong Kong.

**Mr. Wang Qing (汪晴) (“Mr. Wang”)**, aged 56, was appointed as an independent non-executive Director with effect from 1 February 2016, mainly responsible for supervising and providing independent judgment to the Board. Mr. Wang worked at Dalian University of Technology (大連理工大學) from April 2003 up until now. Mr. Wang served as an associate professor when he first joined Dalian University of Technology and was later promoted to professor in November 2010 and he was responsible for research and development (“R&D”) and teaching. Mr. Wang is currently the director of the Department of Pharmacy in the School of Pharmaceutical Sciences and Technology at Dalian University of Technology. From July 1986 to September 1997, Mr. Wang worked as a pharmacist supervisor at Liaoning Provincial Medical Company Limited (遼寧省藥材有限責任公司), where he was responsible for drugs inspection and evaluation and participated in research and technical renovation.

Mr. Wang obtained his Ph.D. in treatment therapy system at Kyushu Institute of Technology (九州島工業大學) in Japan in March 2003 and a master’s degree in treatment therapy system at Kyushu Institute of Technology in March 2000. Mr. Wang obtained his bachelor’s degree in medicinal plants at Jilin Agricultural University (吉林農業大學) in July 1986.

汪晴先生(「汪先生」)，56歲，獲委任為獨立非執行董事，自2016年2月1日起生效，主要負責監督董事會並為其提供獨立意見。汪先生自2003年4月至今任職於大連理工大學，最初擔任副教授，隨後於2010年11月晉升為教授，負責研究及開發(「研發」)及教學。目前汪先生擔任大連理工大學製藥科學與技術學院藥學系主任。自1986年7月至1997年9月，汪先生擔任遼寧省藥材有限責任公司的藥劑師監督員，負責藥品監督與評估，並參與研究及技術創新。

汪先生於2003年3月獲得日本九州島工業大學治療系統學博士學位，於2000年3月獲得九州島工業大學治療系統學碩士學位。汪先生於1986年7月獲得吉林農業大學藥用植物學學士學位。

**Mr. Liu Wenfang (劉文芳) (“Mr. Liu”)**, aged 83, was appointed as an independent non-executive Director with effect from 1 February 2016, mainly responsible for supervising and providing independent judgment to the Board. Prior to joining our Group, from July 2017 to present, he serves as a senior technical consultant in Shanxi Kangbao Biological Product Co., Ltd (山西康寶生物製品股份有限公司). From July 2017 to September 2020, Mr. Liu served as a senior technical consultant in China Biologic Products Inc. (泰邦生物製品有限公司), a company listed on NASDAQ (stock code: CBPO). From February 2011 to June 2017, he serves as an independent director of China Biologic Products Inc. From 2007 to 2011, Mr. Liu worked as a chief consultant at Sichuan Yuanda Shuyang Pharmaceuticals Co., Ltd (四川遠大蜀陽藥業股份有限公司) where he was responsible for research and promoting new theories and applications in the medical field. From 2000 to 2007, he served as the chief engineer and director of Hualan Biological Engineering Inc. (華蘭生物工程股份有限公司) where he was responsible for supervising the manufacturing process and quality management. From May 1998 to May 1999, Mr. Liu served as the chief engineer of Guiyang Qianfeng Bio Manufacture Company (貴陽黔峰生物製品有限責任公司) where he was responsible for research and developing new products. From 1978 to 1988, Mr. Liu worked in the Institute of Blood Transfusion, Chinese Academy of Medical Sciences (中國醫學科學院輸血研究所) and was engaged in the segregation and purification of blood and protein and research, development and quality analysis of blood products.

Mr. Liu obtained a bachelor’s degree majoring in biochemistry from the Shenyang Institute of Applied Ecology, Chinese Academy of Sciences (中國科學院瀋陽應用生態研究所) (formerly known as the Institute of Forestry and Soil Sciences) in August 1963.

**Mr. Bai Zhizhong (白志中) (“Mr. Bai”)**, aged 63, was appointed as an independent non-executive Director with effect from 1 September 2020, mainly responsible for supervising and providing independent judgment to the Board. Mr. Bai has over 30 years of experience in the finance industry. Mr. Bai served as the chairman of Bank of China Investment Management Company Limited from January 2015 to June 2017. He worked with the Bank of China from July 1995 to January 2015, where he had previously served as the president of the Guangdong province branch, the Sichuan province branch, the Ningxia Hui Autonomous Region branch and the Guangxi Zhuang Autonomous Region branch of Bank of China, and he served as the head of comprehensive planning division of Bank of China, Shanxi Province branch.

Mr. Bai obtained a master degree in business administration from Shanghai Jiao Tong University, the PRC in 2007, and he was qualified as a senior economist of Bank of China Assessment Committee of Qualifications in Economic Professional Positions (中國銀行經濟專業技術職務資格評審委員會) in December 1994.

白先生於2007年取得中國上海交通大學工商管理碩士學位, 並於1994年12月獲中國銀行經濟專業技術職務資格評審委員會認可為高級經濟師。

Mr. Jin has over 19 years of experience in the pharmaceutical industry. Before joining the Group, Mr. Jin worked with Guangzhou Pharmaceuticals Co., Ltd. (廣州醫藥股份有限公司) from August 2001 to January 2014, and last served as the director of the marketing department responsible for product promotion and management. Mr. Jin obtained a bachelor’s degree in management in June 2001 and obtained a bachelor’s degree in science in June 2000 from Sun Yat-sen University, the PRC.

**Mr. Li Yifan (李一帆) (“Mr. Li”)**, aged 41, joined our Group in February 2015 and was appointed as the Chief Financial Officer of the Company in June 2015, mainly responsible for the overall financial strategic planning, internal control system management, and investment and financing management of the Group. Mr. Li is also the director of Sichuan Sinco Pharmaceuticals Co., Ltd.. Mr. Li has over 10 years of experience in accounting and financial management. Before joining the Group, Mr. Li worked for China Ploymetallic Mining Limited, a company listed on the HKSE (stock code: 2133) from March 2011 to January 2015, and last served as the deputy chief financial officer responsible for financial accounting and management. From February 2005 to February 2011, Mr. Li successively served as an auditor of the Shenzhen Branch and a senior auditor of the Chengdu branch of Ernst & Young Hua Ming LLP. Mr. Li obtained a Master of Science in Finance degree from the University of Stirling in January 2005 and graduated from Southwestern University of Finance and Economics (西南財經大學) in July 2002 with a bachelor’s degree in management. Mr. Li has been a Chinese Certified Public Accounting since January 2012.

**Mr. Zhang Tao (“Mr. Zhang”)**, aged 36, joined our Group in November 2013 and was appointed as the general manager of Sichuan Sinco Pharmaceuticals Co., Ltd. in November 2020, mainly responsible for its overall operation and management. Mr. Zhang was as the director of president office and deputy general manager of Sichuan Sinco Pharmaceuticals Co., Ltd., respectively. Mr. Zhang is also the director of Chengdu Sinco Pharmaceutical Technology Co., Ltd, Sichuan Sinco Biological Technology Co., Ltd and Chengdu Hengsheng Ziguang Pharmaceutical Technology Co., Ltd.. Mr. Zhang has over 10 years of experience in the pharmaceutical industry. Prior to joining the Group, Mr. Zhang worked for Chengdu Huide Pharmaceutical Co., Ltd. (成都慧德醫藥科技有限公司) from July 2010 to July 2012 as the project manager of R&D department and product registration manager, respectively. ### Principal Activities

The principal activity of the Company is investment holding and the Group is principally engaged in the provision of comprehensive marketing, promotion and channel management service for imported pharmaceutical products and medical devices in China. The analysis of the revenue of the principal activities of the Group during the Reporting Period is set out in note 4 to the consolidated financial statements.

### Business Review and Results

A review of the business of the Group during the Reporting Period is provided in “Chairman’s Statement” and “Management Discussion and Analysis” on pages 6 to 30. An analysis of the Group’s performance during the Reporting Period using financial key performance indicators is provided in the Financial Highlights on pages 4 to 5 of this annual report.

### Final Dividends

The Directors do not recommend a final dividend for the Reporting Period.

None of the Directors or any of their close associates or any Shareholders (which, to the best knowledge of the Directors, own more than 5% of the Company's issued share capital) had any interest in the Group's five largest customers and suppliers.

## Share Option Scheme

Pursuant to a resolution passed by the Shareholders, the Company had adopted the Share Option Scheme which became effective on 10 March 2016 (the "Listing Date").

### 1. Purpose

The purpose of the Share Option Scheme is to provide an incentive or reward for Eligible Participants (defined below) for their contribution or potential contribution to the Company and/or any of its subsidiaries.

### 2. Eligible participants

The Board may subject to and in accordance with the provisions of the Share Option Scheme and the Listing Rules, at its discretion grant options to any full-time or part-time employees, including executives, senior management of officers (including executive, non-executive and independent non-executive directors) of the Company, its subsidiaries or any entity in which the Group holds any equity interest, and to any company wholly owned by one or more persons belonging to any of the above classes of participants who, in the absolute discretion of the Board has contributed or will contribute to the Group (collectively, the "Eligible Participants").

### 3. Life of the Share Option Scheme

The Share Option Scheme shall be valid and effective for a period of ten years from 1 February 2016, after which time no further option will be granted.

### 4. Total number of Shares available for issue

The maximum number of Shares which may be issued upon exercise of all options to be granted under the Share Scheme shall not, in aggregate, exceed 160,000,000, representing 9.46% of the issued share capital of the Company as at the date of this report.

### 5. Maximum entitlement of each participant

Unless approved by Shareholders, the total number of Shares issued and to be issued upon exercise of options granted to any participant (including exercised and outstanding options) under the Share Option Scheme in any 12-month period up to the date of grant shall not exceed 1% of the total shares in issue.

### 1. 目的

因行使根據購股權計劃所授全部購股權而可能發行的最高股份數目，合共不得超過160,000,000股股份，佔本公司於本報告日期已發行股份的9.46%。

### 5. 每位參與者可享有的最高股份數目

除非經股東批准，於截至授出日期的任何12個月期間內因行使根據購股權計劃已授予任何參與者的購股權（包括已行使及尚未行使的購股權）而已發行及將發行的股份總數，不得超過已發行股份總數的1%。



## 6. Offer period and amount payable for options

An option may be accepted by an Eligible Participant within 15 days from the date of the offer of grant of the option. A nominal consideration of HK\$1.00 is payable upon acceptance of the grant of option.

## 7. Minimum period for which an option must be held before it can be exercised

The period during which an option must be held before it can be exercised in accordance with the terms of the Share Option Scheme shall be one year after the date on which the option is granted. The Board may in its absolute discretion impose further restrictions on the exercise of the option.

## 8. Period within which the Share must be taken up

Subject to the discretion of the Board who may impose restrictions on the exercise of the option, any option may be exercised one year after the date on which the options is granted and shall expire on the earlier of the last day of (i) a six year period from the date of such grant and (ii) the expiration of the Share Option Scheme.

## 9. Basis of determining the subscription price

The price per Share at which a Grantee may subscribe for Shares upon exercise of an option (the "Exercise Price") shall be a price determined by the Board but in any event shall be at least the highest of:

- (i) The closing price of the Shares as stated in the HKSE's daily quotations sheets on the date on which the option is granted;
- (ii) The average closing price of the Shares as stated in the HKSE's daily quotations sheets for the five business days immediately preceding the date of grant of that option; and
- (iii) The nominal value of the Shares.

## 6. 發售期及購股權應付金額

## 7. 可行使購股權前必須持有的最短期限

## Independent Auditors

Crowe (HK) CPA Limited (“Crowe”) resigned as auditor of the Company after taking into account various factors, including the professional risk associated with the audit, the level of audit fees and the availability of its internal resources in light of its current work flows. After considering the facts and circumstances, the Audit Committee, having been delegated to power to oversee the effectiveness of the external auditor, was of the view that it would be in the best interest of the Company and the Shareholders as a whole to replace Crowe with another sizeable accounting firm.

The Company had received a letter from Crowe confirming that there are no matters in connection with its resignation that needs to be brought to the attention of the Shareholders or the creditors of the Company.

Ernst & Young was appointed as auditor of the Company to fill the causal vacancy following the resignation of Crowe with effect from 20 July 2020 and hold office until the conclusion of the next annual general meeting of the Company.

Ernst & Young shall retire in the forthcoming AGM and, being eligible will offer themselves for re-appointment. A resolution for the re-appointment of Ernst & Young as auditor of the Company will be proposed at the forthcoming AGM.

## Environmental, Social and Governance

As a responsible corporation, the Company is committed to maintaining the highest environmental and social standards to ensure sustainable development of its businesses. The Company has complied with all relevant laws and regulations in relation to its business including health and safety, workplace conduct, employment and the environment.

# Corporate Governance Report

## 企業管治報告

### Corporate Governance Practices

The Group is committed to maintaining high standards of corporate governance to safeguard the interests of the Shareholders and to enhance corporate value and accountability. The Company has adopted the Corporate Governance Code (the “CG Code”) as set out in Appendix 14 to the Listing Rules as its own code of corporate governance. For the year ended 31 December 2020, the Company has complied with all applicable code provisions under the CG Code except for the deviation from code provision A.2.1 as mentioned in the paragraph headed “Chairman and Chief Executive Officer” of this report. The key corporate governance principles and practices of the Company are outlined later in this report. The Company will continue to review and monitor its corporate governance practices to ensure compliance with the CG Code.

### The Board Responsibilities

The Board is responsible for the overall leadership of the Group, oversees the Group’s strategic decisions and monitors business and performance. The Board has delegated the authority and responsibility for day-to-day management and operation of the Group to the senior management of the Group. To oversee particular aspects of the Company’s affairs, the Board has established four Board committees including the Audit Committee, the Remuneration Committee, the nomination committee (the “Nomination Committee”) and the internal control and corporate governance committee (the “ICCG Committee”) (together, the “Board Committees”). The Board has delegated to the Board Committees responsibilities as set out in their respective terms of reference.

All Directors have carried out duties in good faith and in compliance with applicable laws and regulations, and have acted in the interests of the Company and the Shareholders at all times.

The Company has arranged appropriate liability insurance in respect of legal action against the Directors. The insurance coverage will be reviewed on an annual basis.

### 企業管治常規

During the Reporting Period, the Company has been in compliance with the requirements under rules 3.10(1) and 3.10(2) of the Listing Rules relating to the appointment of at least three independent non-executive Directors with at least one independent non-executive Director possessing appropriate professional qualifications or accounting or related financial management expertise.

The Company has also complied with rule 3.10A of the Listing Rules relating to the appointment of independent non-executive Directors representing at least one-third of the Board.

The Company believes that the diversity of Board members will be immensely beneficial for the enhancement of the Company's performance. Therefore, the Company has adopted a Board diversity policy (the “Board Diversity Policy”) to ensure that the Company will, when determining the composition of the Board, consider Board diversity in terms of, among other things, age, cultural and educational background, professional experience, skills and knowledge. The Board Diversity Policy sets out the approach towards achieving diversity on the Board. Pursuant to the Board Diversity Policy, all Board appointments will be based on merits, and candidates will be considered against objective criteria, having due regard for the benefits of diversity of the Board.

Save as disclosed in the Directors' biographies set out in the section headed "Directors and Senior Management" in this annual report, none of the Directors has any personal relationship (including financial, business, family or other material or relevant relationship) with any other Director and chief executive.

All Directors, including independent non-executive Directors, have brought a wide spectrum of valuable business experience, knowledge and professionalism to the Board for its efficient and effective functioning. Independent non-executive Directors are invited to serve on the Audit Committee, the Remuneration Committee, the Nomination Committee and the Internal Control and Corporate Governance Committee.

As regards the CG Code provision requiring directors to disclose the number and nature of offices held in public companies or organisations and other significant commitments as well as the identity and the time involved to the issuer, Directors have agreed to disclose their commitments and any subsequent change to the Company in a timely manner.

### Dividend Policy

The Group adopted a dividend policy (the "Dividend Policy") on 21 December 2018. A summary of this policy is disclosed as below.

The Dividend Policy is to consider the payment of dividends, to allow shareholders of the Company to participate in the Company's profits whilst retaining adequate reserves for the Group's future growth.

- general economic conditions, business cycle of the Group's business and other internal or external factors that may have an impact on the business or financial performance and position of the Company; and
- other factors that the Board deems relevant.

The payment of dividend is also subject to any restrictions under the Companies Law of the Cayman Islands and the Articles of Association of the Company. The Board will continually review the Dividend Policy from time to time and there can be no assurance that dividends will be paid in any particular amount for any given period.

### Induction and Continuous Professional Development

Each newly appointed Director is provided with necessary induction and information to ensure that he/she has a proper understanding of the Company's operations and businesses as well as his/her responsibilities under relevant statutes, laws, rules and regulations. The Company also arranges regular seminars to provide Directors with updates on latest development and changes in the Listing Rules and other relevant legal and regulatory requirements from time to time. The Directors are also provided with regular updates on the Company's performance, position and prospects to enable the Board as a whole and each Director to discharge their duties.

Directors are encouraged to participate in continuous professional development to develop and refresh their knowledge and skills. The company secretary of the Company has from time to time updated and provided written training materials relating to the roles, functions and duties of a Director.

### Chairman and Chief Executive Officer

Under code provision A.2.1 of the CG Code, the roles of chairman and chief executive officer should be separate and performed by different individuals.

Under the organization structure of the Company, Mr. Huang was the Chairman of the Board and the co-chief executive officer of the Company ("CO-CEO"). With Mr. Huang's extensive experience in the pharmaceutical industry, the Board considered that vesting the roles of chairman and co-chief executive officer in the same person is beneficial to the business prospects and management of the Group. The check and balance of power and authority is ensured by the operation of the senior management and the Board, which comprises experienced and high calibre individuals. Accordingly, the Board believes that this arrangement will not impact on the balance of power and authorizations between the Board and the management of the Company.

### 主席及行政總裁

根據企業管治守則條文第A.2.1條，主席及行政總裁的角色應予以區分及由不同人士擔任。

根據本公司的組織架構，黃先生為董事會主席兼本公司聯席行政總裁（「聯席行政總裁」）。憑藉黃先生於醫藥行業的豐富經驗，董事會認為由同一人兼任主席及聯席行政總裁職位，有利於本集團的業務前景及管理。在由富有經驗及卓越才幹的人士組成的高級管理層與董事會運作下，可確保權力與權限之間有所制衡。因此，董事會相信，該安排不會影響董事會與本公司管理層之間的權力與權限互相制衡。



## Appointment and Re-election of Directors

Each of the executive Directors has signed a service contract with the Company for a term of three years commencing from their respective date of appointment subject to termination as provided in the service contract.

Each of the independent non-executive Directors has signed an appointment letter with the Company for a term of three years commencing from their respective date of appointment.

The appointments of executive Directors and independent non-executive Directors are subject to the provisions of retirement and rotation of Directors under the Articles of Association and the applicable Listing Rules.

None of the Directors has a service contract which is not determinable by the Group within one year without payment of compensation (other than statutory compensation).

The procedures and process of appointment, re-election and removal of Directors are set out in the Articles of Association. The Nomination Committee is responsible for reviewing the Board composition and making recommendations to the Board on the appointment or re-election of Directors and succession planning for Directors.

In accordance with the Articles of Association, one-third of the Directors for the time being (or, if their number is not three or a multiple of three, then the number nearest to, but not less than, one-third) shall retire from office by rotation and shall be eligible for re-election and re-appointment provided that every Director (including those appointed for a specific term) shall be subject to retirement by rotation at least once every three years at every AGM and any new Director appointed to fill a causal vacancy or as an addition to the Board shall submit himself/herself for re-election by Shareholders at the next general meeting after appointment.

The procedures and process of appointment, re-election and removal of Directors are set out in the Articles of Association. The Nomination Committee is responsible for reviewing the Board composition and making recommendations to the Board on the appointment or re-election of Directors and succession planning for Directors.

## Board Meetings

The Company intends to hold Board meetings regularly, at least four times a year, and at approximately quarterly intervals. Notices of not less than fourteen days will be given for all regular Board meetings to provide all Directors with an opportunity to attend and include matters in the agenda for a regular meeting.

For other Board and Board Committee meetings, reasonable notice is generally given. The agenda and accompanying board papers are dispatched to the Directors or Board Committee members at least three days before the meetings to ensure that they have sufficient time to review the papers and are adequately prepared for the meetings. When Directors or Board Committee members are unable to attend a meeting, they will be advised of the matters to be discussed and given an opportunity to make their views known to the Chairman prior to the meeting. Minutes of meetings are kept by the joint company secretary with copies circulated to all Directors for information and records.

Minutes of the Board meetings and Board Committee meetings are recorded in sufficient detail about the matters considered by the Board and the Board Committees and the decisions reached, including any concerns raised by the Directors. Draft minutes of each Board meeting and Board Committee meeting are/will be sent to the Directors for comments within a reasonable time after the date on which the meeting is held. Minutes of the Board meetings are open for inspection by Directors.

### Model Code for Securities Transactions

### Delegation by the Board

The Board reserves for its decision all major matters of the Company, including: approval and monitoring of all policy matters, overall strategies and budgets, internal control and risk management systems, material transactions (in particular those that may involve conflict of interests), financial information, appointment of Directors and other significant financial and operational matters. Directors could have recourse to seek independent professional advice in performing their duties at the Company’s expense and are encouraged to access and to consult with the Company’s senior management independently.

The daily management, administration and operation of the Group are delegated to the senior management. The delegated functions and responsibilities are periodically reviewed by the Board. Approval has to be obtained from the Board prior to any significant transactions entered into by the management.

The Board recognizes that corporate governance should be the collective responsibility of the Directors and delegated the corporate governance duties to the Internal Control and Corporate Governance Committee which includes, without limitation:

- (a) to develop and review the Company's policies and practices on corporate governance and make recommendations to the Board;
- (b) to review and monitor the training and continuous professional development of the Directors and senior management of the Company;
- (c) to review and monitor the Company's policies and practices on compliance with legal and regulatory requirements;
- (d) to develop, review and monitor the code of conduct and compliance manual (if any) applicable to employees and Directors of the Company;
- (e) to review the Company's compliance with the code and disclosure in the corporate governance report of the Company (the "Corporate Governance Report"); and
- (f) to oversee the Company's risk management and internal control systems on an on-going basis and ensure that a review of the effectiveness of the risk management and internal control systems of the Company and its subsidiaries has been conducted at least annually and report to Shareholders that it has done so in its Corporate Governance Report. The review shall cover all material controls, including financial, operational and compliance controls.

## Nomination Policy

### 1. Objective

- 1.1 The Nomination Committee shall review the structure, size and composition (including the skills, knowledge and experience) of the Board at least annually and make recommendations on any proposed changes to the Board to complement the Company's corporate strategy.
- 1.2 The Nomination Committee shall nominate suitable candidates to the Board for it to consider and make recommendations to Shareholders for election as Director at general meetings or appoint him/her to fill casual vacancies.
- 1.3 The nomination policy of the Company (the "**Nomination Policy**") helps the Nomination Committee and the Board to ensure that the Board has a balance of skills, experience and diversity of perspectives appropriate to the requirements of the Group's business.

### 2. Selection Criteria

- 2.1 The factors listed below would be used as reference by the Nomination Committee in assessing the suitability of a proposed candidate:
  - (1) Reputation for integrity;
  - (2) Commitment in respect of available time and relevant interest; and
  - (3) Diversity of the Board in all its aspects, including but not limited to gender, age (18 years or above), cultural and educational background, ethnicity, professional experience, skills, knowledge and length of service.

These factors are for reference only, and are not meant to be exhaustive and decisive. The Nomination Committee has the discretion to nominate any person, as it considers appropriate.

### 3. Nomination Procedures

#### 3.1 Appointment of Directors

- (1) The Nomination Committee identifies individual(s) suitably qualified to become Board members, having due regard to the Nomination Policy and the Board Diversity Policy, and assesses the independence of the proposed independent non-executive Director(s) as appropriate.
- (2) The Nomination Committee makes recommendation(s) to the Board.
- (3) The Board considers the individual(s) recommended by the Nomination Committee, having due regard to the Nomination Policy and the Board Diversity Policy.
- (4) The Board confirms the appointment of the individual(s) as Director(s) or recommends the individual(s) to stand for election at a general meeting. Individual(s) appointed by the Board either to fill a casual vacancy or as an addition to the Board will be subject to re-election by Shareholders at the next following general meeting, in accordance with the Article of Association.
- (5) The Shareholders approve the election of individual(s), who stand(s) for election at general meeting, as Director(s).

#### 3.2 Re-appointment of Directors

- (1) The Nomination Committee considers each retiring Director, having due regard to the Nomination Policy and the Board Diversity Policy, and assesses the independence of each retiring independent non-executive Director.
- (2) The Nomination Committee makes recommendation(s) to the Board.
- (3) The Board considers each retiring Director recommended by the Nomination Committee, having due regard to the Nomination Policy and the Board Diversity Policy.

### 3. 提名程序

#### 3.1 委任董事

- (1) 提名委員會經審慎考慮提名政策及董事會多元化政策後，物色合資格成為董事會成員的人士，並評估擬提名的獨立非執行董事的獨立性（視適用情況而定）。
- (2) 提名委員會向董事會提出推薦建議。
- (3) 董事會經審慎考慮提名政策及董事會多元化政策後，考慮提名委員會推薦的人士。
- (4) 董事會確認委任有關人士為董事或推薦其於股東大會上參選。根據組織章程細則，獲董事會委任以填補臨時空缺的人士或獲董事會委任加入董事會成員的人士亦須於下屆股東大會上經股東重選。
- (5) 股東批准在股東大會上參選的人士選舉為董事。

#### 3.2 重新委任董事

- (1) 提名委員會經審慎考慮提名政策及董事會多元化政策後，考慮各退任董事，並評估每名退任獨立非執行董事的獨立性。
- (2) 提名委員會向董事會提出推薦建議。
- (3) 董事會經審慎考慮提名政策及董事會多元化政策後，考慮提名委員會推薦的各退任董事。

(4) The Board recommends the retiring Directors to stand for re-election at the annual general meeting in accordance with the Articles of Association.

(5) The Shareholders approve the re-election of Directors at the annual general meeting.

3.3 The Board shall have the ultimate responsibility for all matters relating to the selection and appointment of Directors.

#### 4. Review of the Nomination Policy

4.1 The Nomination Committee will review the Nomination Policy, as appropriate, to ensure the effectiveness of the Nomination Policy. The Nomination Committee will discuss any revisions that may be required, and recommend any such revisions to the Board for consideration and approval.

The management has provided to the Board such explanation and information as are necessary to enable the Board to carry out an informed assessment of the Company's financial statements, which are put to the Board for approval. The Company provides all members of the Board with monthly updates on Company's performance, positions and prospects.

The Directors were not aware of any material uncertainties relating to events or conditions which may cast significant doubt upon the Group's ability to continue as a going concern.

### Risk Management and Internal Control

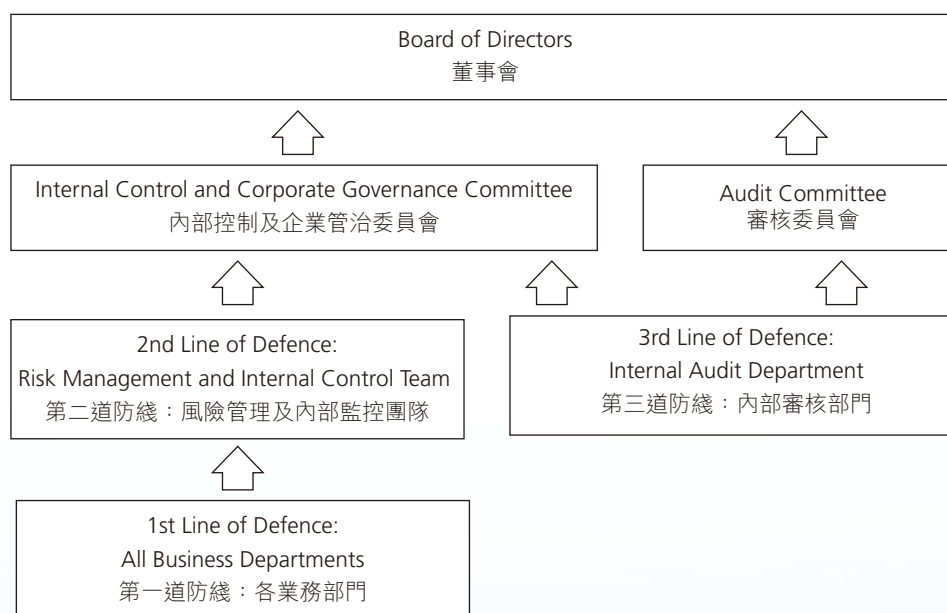
The Board acknowledges that it is the responsibility of the Board for maintaining an adequate risk management and internal control systems to safeguard Shareholder investments and Company assets and reviewing the effectiveness of such system on an annual basis.

The Group's internal audit department plays a major role in monitoring the internal governance of the Company. The major tasks of the internal audit department are reviewing the financial condition and internal control of the Company and conducting comprehensive audits of all branches and subsidiaries of the Company on a regular basis.

The Board has conducted a review of the effectiveness of the risk management and internal control systems of the Group and considered the risk management and internal control system to be effective and adequate.

### Main Characteristics of the Risk Management and Internal Control Systems

The Group's risk management framework is structured in the following "Three Lines of Defense" model as a guide:

### 風險管理和內部控制

董事會明白其有責任設立恰當的風險管理和內部控制體系，以保障股東的投資及本公司的資產，並且每年檢討該體系的效用。

本集團的內部審核部門在監察本公司內部管治方面擔任重要角色。內部審核部門的主要職責是檢討本公司的財務狀況及內部控制，並且定期全面審核本公司所有分支機構及附屬公司。

董事會已檢討本集團風險管理和內部控制體系的效用，認為該風險管理和內部控制體系有效並且足夠。

### 風險管理及內部控制系統的主要特點

本集團的風險管理框架以下圖列示的「三道防綫」模式作為指引：

The Board acknowledges its responsibility of overseeing the Group's risk management and internal control systems and reviewing their effectiveness at least annually through the Internal Control and Corporate Governance Committee (the "ICCG Committee") and the Audit Committee. Such review encompasses all major control aspects, including finance, operation and compliance. Such risk management and internal control systems can only provide reasonable but not absolute assurance against material misstatement or loss, as they are designed to manage, rather than eliminate the risk of failure to achieve business objectives.

The Board has completed its annual review of the internal control and risk management systems of the Company for the year ended 31 December 2020, with all the above major control aspects covered. The Board has considered the operation of risk management and internal control systems to be generally adequate and effective, with no significant areas brought to its attention during the year.

The ICCG Committee and the Audit Committee assist the Board to fulfill its responsibilities of risk management and internal control, ensuring adequate resources, staff qualifications and experience, staff training courses and related budgets for the Group in executing its accounting, internal audit and financial reporting functions. The committees also considers the important investigation results concerning the matters of risk management and internal control, reports to and raise suggestions to the Board.

### 1st Line of Defense

By preparing a risk list with risk control responsibility allocated to departments, the Group is able to deliver risk management across all the business departments. These departments continuously review and assess the risks that may have a potential impact on corporate operation, and effectively execute the process control for business according to the respective functions and departmental regulations, all in a bid to raise the efficiency in risk management.

### 2nd Line of Defense

Composed of nominated department managers and senior management, the Risk Management and Internal Control Team organizes business departments to identify, assess and manage the risks that may have a potential impact on corporate operation, and ensures the implementation of proper measures and internal control regulations to address major risks. In the meantime, the Team monitors risks and takes measures to reduce the risks in daily operation, provides timely response to and follow up of the investigation results of internal control from the Internal Audit Department, and confirms to the Board as to the effectiveness of such risk management and internal control systems.

董事會確認其有責任監察本集團風險管理及內部控制系統，並透過內部控制及企業管治委員會（「內部控制及企業管治委員會」）及審核委員會至少每年審閱一次其成效，有關審閱涵蓋所有重要的控制方面，包括財務控制、運作控制及合規控制。有關風險管理及內部控制系統只能對防範重大失實陳述或損失作出合理而非絕對的保證，原因為其旨在管理而非消除未能達致業務目標的風險。

董事會已就截至2020年12月31日止年度完成對本公司內部控制及風險管理系統的年度審閱，涵蓋上述所有重要的控制方面。董事會認為風險管理及內部控制系統運作整體上充足且有效，於本年度並無重大範疇值得關注。

內部控制及企業管治委員會及審核委員會協助董事會執行其風險管理及內部控制的職責，確保本集團在履行會計、內部審核及財務申報職能方面有足夠的資源、員工資歷與經驗、員工培訓課程以及有關預算。委員會亦考慮有關風險管理及內部控制事宜的重要調查結果，並向董事會呈報及作出建議。

### 第一道防綫

通過建立落實風險控制責任部門的風險清單，本集團將風險管理貫穿至各業務部門。該等部門持續地審閱及評估可能對企業經營構成潛在影響的風險，並按照各自職能分工及部門各項規章制度有效執行業務層面的流程控制，以加強風險管理效率。

### 第二道防綫

風險管理及內部控制團隊由獲提名的部門經理及高級管理層組成，負責組織業務部門識別、評估及管理可能對企業經營構成潛在影響的風險，確保就主要風險落實恰當的應對措施及內部控制規定。同時，團隊監察風險並採取措施降低日常營運風險，針對內部審核部門提出的內部控制調查結果作出及時的回應及跟進，以及向董事會提供有關風險管理及內部控制系統是否有效的確認。

### 3rd Line of Defense

The Internal Audit Department executes the actual review procedure, to collect the evidence on the adequacy and effectiveness of the Group's risk management and internal control systems, and report the review results to the ICCG Committee. In addition, the Department raises suggestions to the Board and the management, to address major institutional inadequacies or any control loopholes spotted.

External auditors further complement the third line of defense in respect of the major risk and control issues on financial reporting procedures that are spotted during the review process. For instance and illustrative purposes, Ernst & Young has assisted the Company in correcting the Errors and disclosing the prior year adjustments set out in notes 2.4(a), (b) and (c) to the consolidated financial statements of the Group in this report.

### Procedures Applied to Accessing, Managing and Rectifying the Errors

The Board and the Audit Committee have performed the following procedures in reviewing and approving the prior year adjustments (in chronological order):

1. Upon the receipt of management's report on the Errors and prior year adjustments, the Audit Committee discussed with Ernst & Young on the causes of the Errors and the basis of which the prior year adjustments ought to be made;
2. Upon discussion and agreement with Ernst & Young, the Audit Committee submitted to the Board the prior year adjustments together with the details and findings; and
3. The Board, upon reviewing and considering the Audit Committee's report and careful consideration of the matter, approved the prior year adjustments and the disclosure of same.

### Measures taken/ to be taken by the Company

The Company has, at all relevant times up to the date hereof, an accounting and financial reporting policy (the "Policy") in place and been strictly adhering to the same for the financial year ended 31 December 2019 up to the date hereof. The Company has reviewed and updated the Policy annually, and as needed and necessary where there are changes to the accounting standards and policies as well as changes in circumstances arising from significant events. In this regard, the Company is of the view that the Policy is sufficient for maintaining proper internal control within the Company.

### 第三道防綫

內部審核部門負責執行實際的審閱程序，以收集本集團風險管理及內部控制系統是否足夠及有效的證據，並向內部控制及企業管治委員會呈報審閱結果。此外，該部門向董事會及管理層作出建議，以改善制度的重大不足之處或所發現的任何監控缺失。

外聘核數師就在審閱過程中發現的財務報告程序方面的重大風險及控制問題，進一步補充第三道防綫。舉例而言，安永會計師事務所已協助本公司更正錯誤及披露本報告內本集團綜合財務報表附註2.4(a)、(b)及(c)所載的去年調整。

### 用於評估、管理及糾正錯誤的程序

董事會及審核委員會於審閱及批准去年調整時已執行下列程序(按順序)：

1. 於收到管理層有關錯誤的報告及去年調整後，審核委員會與安永會計師事務所討論錯誤的原因及須作出去年調整的依據；
2. 與安永會計師事務所討論並達成一致後，審核委員會向董事會提交去年調整，連同詳情及發現；及
3. 董事會於審閱及考慮審核委員會的報告並就有關事宜仔細考慮後，批准去年調整並予以披露。

### 本公司已採取／將採取的措施

本公司於直至本報告日期止的有關期間一直設有會計及財務報告政策(「政策」)，並於截至2019年12月31日止財政年度直至本報告日期嚴格遵守。本公司每年及於有必要時(倘會計準則及有關政策發生變動以及重大事件導致情況有變)審閱及更新政策。就此而言，本公司認為政策足以維持本公司適當的內部控制。

The Company shall continue to adhere to and ensure a strict implementation of the Policy, by arranging its accounting and finance personnel to attend training regularly to keep abreast of the Policy and the relevant accounting and regulatory changes.

In addition, when handling complicated transactions, the Company will consult with its auditor for opinion, and report and discuss the matters with the Audit Committee, in order to prevent similar error occurring in the future.

### Explanations of why the Errors were Made

Regarding the accounting error under note 2.4(a), in the opinion of the Company's predecessor auditor, Crowe, the liabilities (trade payables) to Overseas Supplier shall be derecognised by the Group when Overseas Supplier received the letter of credit, and at the meantime, other payables to the import agent should be recognized by the Group; while the Group consider that, the liabilities (trade payables) to Overseas Supplier shall be derecognized when the payment to Overseas Supplier was settled upon the maturity of letter of credit and the corresponding amount shall be recognized as other payables to the import agent.

Regarding the accounting errors under note 2.4(b) and note 2.4(c), the Group and Crowe considered that amounts were immaterial to the financial statements for year ended 31 December 2019. Therefore, adjustments were not proposed by the Crowe.

### Communication with Crowe in resolving the Errors

Crowe was notified of the prior year adjustments on 24 August 2020 and suggested that they have different opinions on the prior year adjustments under note 2.4(a) as they considered the liabilities (trade payables) to Overseas Supplier should be derecognized when Overseas Supplier received the letters of credit. Regarding the prior year adjustments under note 2.4(b) and note 2.4(c), Crowe advised that those audit differences were immaterial to the financial statements and did not propose adjustments for the year ended 31 December 2019 as they set planning materiality based on the revenue when auditing the consolidated financial statements of the Group for year ended 31 December 2019.

此外，當處理複雜交易時，本公司將諮詢核數師意見，並向審核委員會報告及討論有關事宜，從而防止日後出現類似錯誤。

### 對造成錯誤原因的解釋

就附註2.4(a)項下會計錯誤而言，本公司前任核數師國富浩華認為，本集團應於海外供應商收到信用證後終止確認有關海外供應商的負債(貿易應付款項)，同時本集團應確認應付進口代理的其他應付款項；而本集團認為有關海外供應商的負債(貿易應付款項)應於信用證到期後結清支付予海外供應商款項時終止確認，而相應金額應確認為應付進口代理的其他應付款項。

就附註2.4(b)及2.4(c)項下會計錯誤而言，本集團及國富浩華認為，該金額就截至2019年12月31日止年度的財務報表而言並不重大。因此國富浩華並無建議作出調整。

### 就解決錯誤與國富浩華溝通

國富浩華於2020年8月24日獲告知去年調整，並表示其就附註2.4(a)項下的去年調整有不同意見，其認為有關海外供應商的負債(貿易應付款項)不應於海外供應商收到信用證時終止確認。就附註2.4(b)及2.4(c)項下的去年調整而言，國富浩華告知該等審核差異對財務報表而言並不重大，乃由於其於審核本集團截至2019年12月31日止年度的綜合財務報表時根據收益制定規劃重大性，故並無建議就截至2019年12月31日止年度作出調整。

### Procedures Applied to Identifying, Assessing and Managing Major Risks

- Determining the scope: preparing uniform risk terms and risk assessment standards for the Group
- Risk identification: identifying the risks that may have a potential impact on corporate operation
- Risk assessment: considering risks in respect of the degree of importance of their impact on business and their occurrence, and assessing the risks identified
- Risk management: establishing risk management policies and internal control procedures, to avert or reduce risks
- Risk monitoring and reporting: continuously monitoring relevant risks, ensuring proper procedures of internal control, and regularly reporting to the management and the Board on the results of risk monitoring

### Function of Internal Audit

The Group's Internal Audit Department plays a major role in monitoring the internal governance of the Company. The Department's main responsibilities are to review the financial conditions and internal control of the Company and all its subsidiaries, communicate with department managers and senior management on the identified problems, non-compliance issues and inadequacies, and jointly prepare rectification and improvement solutions. The Department also follows such rectification results, and reports to the ICCG Committee and the Audit Committee.

### Information Disclosure System

The Group has formulated its information disclosure system, to ensure the identification and confidentiality of potential inside information until it is disclosed according to the Listing Rules in a consistent and timely manner. The procedures for publishing and processing inside information include:

- Business department managers as the people in charge of information reporting;
- Senior management as the people in charge of the information confidentiality of their respective business segments;
- The Board as the party in charge of information disclosure; and

### 內部審核職能

本集團的內部審核部門在監察本公司內部管治方面擔任重要角色。該部門的主要職責是審閱本公司及所有附屬公司的財務狀況及內部控制，就發現的問題、違規事項及不足之處與各部門經理及高級管理層溝通，共同確立整改及完善方案。該部門亦跟進整改結果，向內部控制及企業管治委員會以及審核委員會呈報。

### 信息披露制度

本集團訂有信息披露制度，確保能識別潛在內幕消息並加以保密，直至按照上市規則作出一致且適時的披露為止。發佈及處理內幕消息的程序包括：

- 業務部門經理作為信息報告負責人；
- 高級管理層作為分管業務板塊信息保密責任人；
- 董事會作為信息披露責任人；及



- The Investor Relations Department and the Board Secretary as the parties responsible for managing information disclosure, the reporting, audit and disclosure of information which needs public announcement, and archiving and keeping such information disclosure documents and announcements.

### Auditor's Remuneration

The remuneration for the audit services provided by the Auditor to the Group during the year ended 31 December 2020 was approximately RMB3,100,000. There is no remuneration paid to the Auditor in respect of non-audit services.

### Company Secretary

Ms. Peng Yunlu (“**Ms. Peng**”), one of our joint company secretaries of the Company, is responsible for advising the Board on corporate governance matters and ensuring that the Board policies and procedures, as well as the applicable laws, rules and regulations are followed.

In order to uphold good corporate governance and ensure compliance with the Listing Rules and applicable Hong Kong laws, the Company also engages Mr. Li Kin Wai (“**Mr. Li**”), manager of Corporate Services of Tricor Services Limited, as another joint company secretary to assist Ms. Peng to discharge her duties as company secretary of the Company. The primary corporate contact person at the Company is Ms. Peng, one of the joint company secretaries of the Company.

For the year ended 31 December 2020, Ms. Peng and Mr. Li have undertaken not less than 15 hours of relevant professional training respectively in compliance with rule 3.29 of the Listing Rules.

On 22 January 2021, Ms. Li Ching Yi (“**Ms. Li**”) resigned as the joint company secretary of the Company. Immediately after the resignation of Ms. Li, Ms. Wong was appointed as the joint company secretary of the Company with effect from 22 January 2021. On 31 March 2021, Ms. Wong resigned as the joint company secretary of the Company. Immediately after the resignation of Ms. Wong, Mr. Li was appointed as the joint company secretary of the Company with effect from 31 March 2021.

### Communication with Shareholders and Investor Relations

The Company considers that effective communication with the Shareholders is essential for enhancing investor relations and understanding of the Group's business, performance and strategies. The Company also recognizes the importance of timely and non-selective disclosure of information, which will enable Shareholders and investors to make the informed investment decisions.

報告期內，彭雲璐女士（「**彭女士**」）是本公司其中一位聯席公司秘書，負責為董事會提供有關企業管治事宜的意見，及確保符合董事會的政策及程序及適用的法例、規則及條例。

為維持良好的企業管治及確保遵守上市規則與適用的香港法例，本公司亦聘請卓佳專業商務有限公司的經理李健威先生（「**李先生**」）擔任另一位聯席公司秘書，以協助彭女士履行本公司的公司秘書職務。本公司的主要公司聯絡人為彭女士，即本公司其中一位聯席公司秘書。

截至2020年12月31日止年度，彭女士及李先生各自已遵守上市規則第3.29條的規定，接受不少於15小時的相關專業培訓。

於2021年1月22日，李菁怡女士（「**李女士**」）辭任本公司聯席公司秘書。緊隨李女士辭任後，黃女士獲委任為本公司聯席公司秘書，自2021年1月22日生效。於2021年3月31日，黃女士辭任本公司聯席公司秘書，緊隨黃女士辭任後，李先生獲委任為本公司聯席公司秘書，自2021年3月31日生效。

### 與股東溝通及投資者關係

本公司認為，與股東有效溝通對加強投資者關係及讓投資者瞭解本集團業務、表現及策略十分重要。本公司亦明白及時全面披露資訊以便股東及投資者作出知情投資決定的重要性。

The AGM provides opportunity for the Shareholders to communicate directly with the Directors. The Chairman of the Company and the chairmen of the Board Committees will attend the AGM to answer Shareholders' questions. The Auditor will also attend the AGM to answer questions about the conduct of the audit, the preparation and content of the independent auditor's report, the accounting policies and auditor independence.

To promote effective communication, the Company adopts a shareholders' communication policy which aims at establishing a two-way relationship and communication between the Company and the Shareholders and maintains a website of the Company at [www.sinco-pharm.com](http://www.sinco-pharm.com), where up-to-date information on the Company's business operations and developments, financial information, corporate governance practices and other information are available for public access.

### Shareholders' Rights

To safeguard Shareholders' interests and rights, a separate resolution will be proposed for each issue at general meetings, including the election of individual Directors.

All resolutions put forward at general meetings will be voted by poll pursuant to the Listing Rules and poll results will be posted on the websites of the Company and the HKSE in a timely manner after each general meeting.

### Convening of extraordinary general meeting and putting forward proposals

Shareholders may put forward proposals for consideration at a general meeting of the Company according to the Articles of Association. Any one or more members holding as at date of deposit of the requisition not less than one-tenth of the paid-up capital of the Company carrying the right of voting at general meetings of the Company shall at all times have the right, by written requisition to the Board or any one of the joint company secretaries of the Company, to require an extraordinary general meeting of the Company to be called by the Board for the transaction of any business specified in such requisition; and such meeting shall be held within two months after the deposit of such requisition. If within 21 days of such deposit the Board fails to proceed to convene such meeting the requisitionist(s) himself (themselves) may do so in the same manner, and all reasonable expenses incurred by the requisitionist(s) as a result of the failure of the Board shall be reimbursed to the requisitionist(s) by the Company.

As regards proposing a person for election as a Director, the procedures are available on the website of the Company.

### 股東權利

在股東大會上提呈的所有決議案將根據上市規則以投票方式表決，而投票結果將在各股東大會結束後適時在本公司及香港聯交所網站公佈。

### 召開股東特別大會及提呈議案

### Opinion

We have audited the consolidated financial statements of Sinco Pharmaceuticals Holdings Limited (the "Company") and its subsidiaries (the "Group") set out on pages 81 to 181, which comprise the consolidated statement of financial position as at 31 December 2020, and the consolidated statement of profit or loss and other comprehensive income, the consolidated statement of changes in equity and the consolidated statement of cash flows for the year then ended, and notes to the consolidated financial statements, including a summary of significant accounting policies.

In our opinion, the consolidated financial statements give a true and fair view of the consolidated financial position of the Group as at 31 December 2020, and of its consolidated financial performance and its consolidated cash flows for the year then ended in accordance with International Financial Reporting Standards ("IFRSs") issued by the International Accounting Standards Board ("IASB") and have been properly prepared in compliance with the disclosure requirements of the Hong Kong Companies Ordinance.

### Basis for opinion

We conducted our audit in accordance with Hong Kong Standards on Auditing ("HKSA") issued by the Hong Kong Institute of Certified Public Accountants ("HKICPA"). Our responsibilities under those standards are further described in the Auditor's responsibilities for the audit of the consolidated financial statements section of our report. We are independent of the Group in accordance with the HKICPA's Code of Ethics for Professional Accountants (the "Code"), and we have fulfilled our other ethical responsibilities in accordance with the Code. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

### Key audit matters

Key audit matters are those matters that, in our professional judgement, were of most significance in our audit of the consolidated financial statements of the current period. These matters were addressed in the context of our audit of the consolidated financial statements as a whole, and in forming our opinion thereon, and we do not provide a separate opinion on these matters. For each matter below, our description of how our audit addressed the matter is provided in that context.

The Group recognises revenue when the amount can be reliably estimated, it is probable that future economic benefits will flow to the entity and when the control of the goods is transferred to the buyer. For the year ended 31 December 2020, the Group recognised revenue of RMB2,050 million. Some terms of sales arrangements with customers including the timing of transfer of control of goods, delivery specifications, generate complexity and judgment in determining sales revenues and revenue cut-off. The risk is, therefore, that revenue is not recognised in the correct period or that revenue and associated profit is misstated.

The Group's disclosures about revenue is included in notes 2.5, 3 and 4 to the consolidated financial statements.

- reviewing sales contracts and supplementary agreements to check the relevant key terms of revenue recognition;
- performing analytical procedures by comparing the unit selling price, the sales volumes and gross margin to that in prior years by products and by month;
- obtaining confirmation from key customers and reviewing the reconciliation of any material difference by check to related documents; and
- performing the cut-off test for revenue recognised before and subsequent to the balance sheet date so as to check whether revenue is accounted in the appropriate period.

### 1 Corporate and Group Information

Sinco Pharmaceuticals Holdings Limited (the “Company”) is a limited liability company incorporated in the Cayman Islands on 16 March 2015. The registered office address of the Company is P.O. Box 309, Ugland House, Grand Cayman, KY1-1104, Cayman Islands. The Company’s principal place of business in Hong Kong is Room 2403, Wing On Centre, 111 Connaught Road Central, Hong Kong with effect from 20 November 2020.

During the year, the Company and its subsidiaries (collectively referred to as the “Group”) were principally engaged in marketing, promotion and channel management services for improved human plasma-based pharmaceuticals, antibiotics and other pharmaceuticals focused on therapeutic areas and complementary to human plasma-based products and other fast-growing categories in Mainland China. There were no significant changes in the nature of the Group’s principal activities during the year.

In the opinion of directors of the Company (the “Directors”), Risun Investments Limited (“Risun”), a company incorporated in the British Virgin Islands (“BVI”), is the parent and the ultimate holding company of the Company.

## 2.1 Basis of Preparation

These financial statements have been prepared in accordance with International Financial Reporting Standards (“IFRSs”), which comprise standards and interpretations approved by the International Accounting Standards Board (the “IASB”), and International Accounting Standards (“IASs”) and Standing Interpretations Committee Interpretations approved by the International Accounting Standards Committee that remain in effect, and the disclosure requirements of the Hong Kong Companies Ordinance. They have been prepared under the historical cost convention, except for certain wealth management products which have been measured at fair value. These financial statements are presented in Renminbi (“RMB”) and all values are rounded to the nearest thousand except when otherwise indicated.

### Basis of consolidation

The consolidated financial statements include the financial statements of the Company and its subsidiaries for the year ended 31 December 2020. A subsidiary is an entity, directly or indirectly, controlled by the Company. Control is achieved when the Group is exposed, or has rights, to variable returns from its involvement with the investee and has the ability to affect those returns through its power over the investee (i.e., existing rights that give the Group the current ability to direct the relevant activities of the investee).

When the Company has, directly or indirectly, less than a majority of the voting or similar rights of an investee, the Group considers all relevant facts and circumstances in assessing whether it has power over an investee, including:

- (a) the contractual arrangement with the other vote holders of the investee;
- (b) rights arising from other contractual arrangements; and
- (c) the Group’s voting rights and potential voting rights.

## 2.1 編製基準

### 綜合基準

綜合財務報表包括本公司及其附屬公司截至2020年12月31日止年度的財務報表。附屬公司指本公司直接或間接控制的實體。當本集團通過參與投資對象的相關活動而承擔可變回報的風險或有權享有可變回報, 並有能力運用對投資對象的權力(即賦予本集團現有有能力以主導投資對象相關活動的既存權利)影響該等回報時, 即取得控制權。

倘本公司直接或間接擁有少於投資對象大部分的投票或類似權利, 則本集團於評估其是否擁有對投資對象的權力時會考慮所有相關事實和情況, 包括:

- (a) 與投資對象其他投票持有人的合約安排;
- (b) 其他合約安排所產生的權利; 及
- (c) 本集團的投票權及潛在投票權。

### Basis of consolidation (Continued)

The financial statements of the subsidiaries are prepared for the same reporting period as the Company, using consistent accounting policies. The results of subsidiaries are consolidated from the date on which the Group obtains control, and continue to be consolidated until the date that such control ceases.

Profit or loss and each component of other comprehensive income are attributed to the owners of the parent of the Group and to the non-controlling interests, even if this results in the non-controlling interests having a deficit balance. All intra-group assets and liabilities, equity, income, expenses and cash flows relating to transactions between members of the Group are eliminated in full on consolidation.

The Group reassesses whether or not it controls an investee if facts and circumstances indicate that there are changes to one or more of the three elements of control described above. A change in the ownership interest of a subsidiary, without a loss of control, is accounted for as an equity transaction.

If the Group loses control over a subsidiary, it derecognises (i) the assets (including goodwill) and liabilities of the subsidiary, (ii) the carrying amount of any non-controlling interests and (iii) the cumulative translation differences recorded in equity; and recognises (i) the fair value of the consideration received, (ii) the fair value of any investment retained, and (iii) any resulting surplus or deficit in profit or loss. The Group's share of components previously recognised in other comprehensive income is reclassified to profit or loss or retained profits, as appropriate, on the same basis as would be required if the Group had directly disposed of the related assets or liabilities.

附屬公司的財務報表按與本公司相同的報告期編製，並採用貫徹一致的會計政策。附屬公司的業績自本集團取得控制權當日起綜合計算，並持續至該控制權終止之日為止。

即使會導致非控股權益產生虧絀結餘，損益及其他全面收益的各個組成部分仍歸屬於本集團母公司擁有人及非控股權益。與本集團成員公司交易有關的所有集團內公司間資產及負債、股權、收入、開支及現金流量均於綜合時悉數對銷。

倘事實及情況反映上述三項控制權因素的其中一項或多項有所變動，則本集團會重估是否仍然控制投資對象。並無失去控制權的附屬公司所有權益變動會入賬為股本交易。

- (a) *2018年財務報告概念框架*(「概念框架」)載列一套完整財務報告概念及準則設定，並為制訂貫徹一致的會計政策的財務報表編製者提供指引以及協助各方瞭解及詮釋準則。概念框架包括計量及報告財務表現的新章節、資產及負債終止確認的新指引，以及最新資產及負債界定及確認標準。其亦釐清監管、審慎及計量不確定性於財務報告的作用。概念框架並非準則，且其載述的概念概不凌駕任何準則內的概念或規定。概念框架對本集團的財務狀況及表現並無任何重大影響。

- (b) Amendments to IFRS 3 clarify and provide additional guidance on the definition of a business. The amendments clarify that for an integrated set of activities and assets to be considered a business, it must include, at a minimum, an input and a substantive process that together significantly contribute to the ability to create output. A business can exist without including all of the inputs and processes needed to create outputs. The amendments remove the assessment of whether market participants are capable of acquiring the business and continue to produce outputs. Instead, the focus is on whether acquired inputs and acquired substantive processes together significantly contribute to the ability to create outputs. The amendments have also narrowed the definition of outputs to focus on goods or services provided to customers, investment income or other income from ordinary activities. Furthermore, the amendments provide guidance to assess whether an acquired process is substantive and introduce an optional fair value concentration test to permit a simplified assessment of whether an acquired set of activities and assets is not a business. The Group has applied the amendments prospectively to transactions or other events that occurred on or after 1 January 2020. The amendments did not have any impact on the financial position and performance of the Group.
- (c) Amendments to IFRS 9, IAS 39 and IFRS 7 address issues affecting financial reporting in the period before the replacement of an existing interest rate benchmark with an alternative risk-free rate ("RFR"). The amendments provide temporary reliefs which enable hedge accounting to continue during the period of uncertainty before the introduction of the alternative RFR. In addition, the amendments require companies to provide additional information to investors about their hedging relationships which are directly affected by these uncertainties. The amendments did not have any impact on the financial position and performance of the Group as the Group does not have any interest rate hedge relationships.

- (c) 國際財務報告準則第9號、國際會計準則第39號及國際財務報告準則第7號(修訂本)旨在解決以其他無風險利率(「無風險利率」)取代現有利率基準前的期間對影響申報的事宜。修訂本提供暫時性寬免，可在引入其他無風險利率前的不確定期間內繼續進行對沖會計處理。此外，修訂本規定公司須向投資者提供有關直接受該等不確定因素影響的對沖關係的額外資料。由於本集團並無任何利率對沖關係，故修訂本對本集團的財務狀況及表現並無任何影響。

- (d) Amendment to IFRS 16 provides a practical expedient for lessees to elect not to apply lease modification accounting for rent concessions arising as a direct consequence of the covid-19 pandemic. The practical expedient applies only to rent concessions occurring as a direct consequence of the covid-19 pandemic and only if (i) the change in lease payments results in revised consideration for the lease that is substantially the same as, or less than, the consideration for the lease immediately preceding the change; (ii) any reduction in lease payments affects only payments originally due on or before 30 June 2021; and (iii) there is no substantive change to other terms and conditions of the lease. The amendment is effective for annual periods beginning on or after 1 June 2020 with earlier application permitted and shall be applied retrospectively. The amendments did not have any impact on the financial position and performance of the Group.
- (e) Amendments to IAS 1 and IAS 8 provide a new definition of material. The new definition states that information is material if omitting, misstating or obscuring it could reasonably be expected to influence decisions that the primary users of general purpose financial statements make on the basis of those financial statements. The amendments clarify that materiality will depend on the nature or magnitude of information, or both. The amendments did not have any impact on the financial position and performance of the Group.

Further information about those IFRSs that are expected to be applicable to the Group is described below.

Amendments to IFRS 3 are intended to replace a reference to the previous *Framework for the Preparation and Presentation of Financial Statements* with a reference to the *Conceptual Framework for Financial Reporting* issued in March 2018 without significantly changing its requirements. The amendments also add to IFRS 3 an exception to its recognition principle for an entity to refer to the Conceptual Framework to determine what constitutes an asset or a liability. The exception specifies that, for liabilities and contingent liabilities that would be within the scope of IAS 37 or IFRIC 21 if they were incurred separately rather than assumed in a business combination, an entity applying IFRS 3 should refer to IAS 37 or IFRIC 21 respectively instead of the Conceptual Framework. Furthermore, the amendments clarify that contingent assets do not qualify for recognition at the acquisition date. The Group expects to adopt the amendments prospectively from 1 January 2022. Since the amendments apply prospectively to business combination for which the acquisition date is on or after the date of first application, the Group will not be affected by these amendments on the date of transition.

有關預期適用於本集團的國際財務報告準則的進一步資料概述如下。

國際財務報告準則第3號(修訂本)旨在引用2018年3月頒佈的*財務報告概念框架*，以取代引用先前的*財務報表編製及呈列框架*，而不會大幅更改其規定。修訂本亦對國際財務報告準則第3號增加其確認原則的例外情況，以供實體引用概念框架以釐定構成資產或負債的內容。該例外情況規定，就國際會計準則第37號或國際財務報告詮釋委員會第21號範圍內的負債及或然負債而言，倘該等負債及或然負債單獨產生而非於業務合併中承擔，則應用國際財務報告準則第3號的實體應分別參閱國際會計準則第37號或國際財務報告詮釋委員會第21號，而非概念框架。此外，修訂本釐清或然資產不合資格於收購日期確認。本集團預期自2022年1月1日起提前採納該等修訂本。由於修訂本將提前應用於收購日期為首次應用日期或之後的業務合併，故本集團於過渡日期將不會受修訂本影響。

Amendments to IFRS 9, IAS 39, IFRS 7, IFRS 4 and IFRS 16 address issues not dealt with in the previous amendments which affect financial reporting when an existing interest benchmark is replaced with an alternative RFR. The Phase 2 amendments provide a practical expedient to allow the effective interest rate to be updated without adjusting the carrying amount when accounting for changes in the basis for determining the contractual cash flows of financial assets and liabilities, if the change is a direct consequence of the interest benchmark reform and the new basis for determining the contractual cash flows is economically equivalent to the previous basis immediately preceding the change. In addition, the amendments permit changes required by the interest rate benchmark reform to be made to hedge designations and hedge documentation without the hedging relationship being discontinued. Any gains or losses that could arise on transition are dealt with through the normal requirements of IFRS 9 to measure and recognise hedge ineffectiveness. The amendments also provide a temporary relief to entities from having to meet the separately identifiable requirement when an RFR is designated as a risk component. The relief allows an entity, upon designation of the hedge, to assume that the separately identifiable requirement is met, provided the entity reasonably expects the RFR risk component to become separately identifiable within the next 24 months. Furthermore, the amendments require an entity to disclose additional information to enable users of financial statements to understand the effect of interest rate benchmark reform on an entity's financial instruments and risk management strategy. The amendments are effective for annual periods beginning on or after 1 January 2021 and shall be applied retrospectively, but entities are not required to restate the comparative information.

The Group had certain interest-bearing bank loans denominated in RMB based on the China Loan Prime Rate as at 31 December 2020. If the interest rates of these borrowings are replaced by RFRs in a future period, the Group will apply this practical expedient upon the modification of these borrowings when the "economically equivalent" criterion is met and expects that no significant modification gain or loss will arise as a result of applying the amendments to these changes.

國際財務報告準則第9號、國際會計準則第39號、國際財務報告準則第7號、國際財務報告準則第4號及國際財務報告準則第16號(修訂本)解決了先前修訂本中未處理有關在現有利率基準被其他無風險利率取代時影響財務報告的問題。第2階段修訂本提供實際可行權宜方法，允許在對釐定金融資產及負債的合約現金流量的基準變動進行會計處理時，在不調整賬面值的情況下更新實際利率(倘有關變動為利率基準改革的直接後果，且釐定合約現金流量的新基準經濟上相當於緊接變動前的先前基準)。此外，修訂本允許在對沖關係並無終止的情況下，進行利率基準改革規定對對沖指定項目及對沖文件作出的變動。於過渡時可能產生的任何收益或虧損透過國際財務報告準則第9號的一般規定處理，以計量及確認對沖無效性。修訂本亦為實體提供臨時寬免，不用於無風險利率被指定為風險部分時符合獨立可識別規定。該寬免允許實體於指定對沖後假設符合獨立可識別規定，前提是實體合理預期無風險利率風險部分將於未來24個月內獨立可識別。此外，修訂本規定實體披露額外資料，以使財務報表使用者瞭解利率基準改革對實體金融工具及風險管理策略的影響。修訂本於2021年1月1日或之後開始的年度期間生效，並須追溯應用，惟實體毋須重列比較資料。

於2020年12月31日，本集團有若干按中國貸款市場報價利率以人民幣計值的計息銀行貸款。倘該等借款的利率於未來期間被無風險利率取代，則本集團將於符合「經濟等值」標準時經修改該等借款後應用此項實際可行權宜方法，並預期將不會因對有關變動應用修訂本而產生重大修改收益或虧損。

Amendments to IFRS 10 and IAS 28 address inconsistency between the requirements in IFRS 10 and in IAS 28 in dealing with the sale or contribution of assets between an investor and its associate or joint venture. The amendments require a full recognition of a gain or loss when the sale or contribution of assets between an investor and its associate or joint venture constitutes a business. For a transaction involving assets that do not constitute a business, a gain or loss resulting from the transaction is recognised in the investor's profit or loss only to the extent of the unrelated investor's interest in that associate or joint venture. The amendments are to be applied prospectively. The previous mandatory effective date of amendments to IFRS 10 and IAS 28 was removed by the IASB in December 2015 and a new mandatory effective date will be determined after the completion of a broader review of accounting for associates and joint ventures. However, the amendments are available for adoption now.

Amendments to IAS 1 clarify the requirements for classifying liabilities as current or non-current. The amendments specify that if an entity's right to defer settlement of a liability is subject to the entity complying with specified conditions, the entity has a right to defer settlement of the liability at the end of the reporting period if it complies with those conditions at that date. Classification of a liability is unaffected by the likelihood that the entity will exercise its right to defer settlement of the liability. The amendments also clarify the situations that are considered a settlement of a liability. The amendments are effective for annual periods beginning on or after 1 January 2023 and shall be applied retrospectively. Earlier application is permitted. The amendments are not expected to have any significant impact on the Group's financial statements.

國際會計準則第1號(修訂本)釐清將負債分類為流動或非流動的規定。修訂本訂明，倘實體遞延償還負債的權利須待實體符合特定條件，而實體於報告期結束日符合該等條件，則其於該日有權遞延償還負債。負債的分類不受實體將行使其權利遞延清償負債的可能性所影響。修訂本亦釐清被視為清償負債的情況。修訂本於2023年1月1日或之後開始的年度期間生效，並須追溯應用，亦可提早應用。預期修訂本對本集團的財務報表並無任何重大影響。

Amendments to IAS 16 prohibit an entity from deducting from the cost of an item of property, plant and equipment any proceeds from selling items produced while bringing that asset to the location and condition necessary for it to be capable of operating in the manner intended by management. Instead, an entity recognises the proceeds from selling any such items, and the cost of those items, in profit or loss. The amendments are effective for annual periods beginning on or after 1 January 2022 and shall be applied retrospectively only to items of property, plant and equipment made available for use on or after the beginning of the earliest period presented in the financial statements in which the entity first applies the amendments. Earlier application is permitted. The amendments are not expected to have any significant impact on the Group's financial statements.

Amendments to IAS 37 clarify that for the purpose of assessing whether a contract is onerous under IAS 37, the cost of fulfilling the contract comprises the costs that relate directly to the contract. Costs that relate directly to a contract include both the incremental costs of fulfilling that contract (e.g., direct labour and materials) and an allocation of other costs that relate directly to fulfilling that contract (e.g., an allocation of the depreciation charge for an item of property, plant and equipment used in fulfilling the contract as well as contract management and supervision costs). General and administrative costs do not relate directly to a contract and are excluded unless they are explicitly chargeable to the counterparty under the contract. The amendments are effective for annual periods beginning on or after 1 January 2022 and shall be applied to contracts for which an entity has not yet fulfilled all its obligations at the beginning of the annual reporting period in which it first applies the amendments. Earlier application is permitted. Any cumulative effect of initially applying the amendments shall be recognised as an adjustment to the opening equity at the date of initial application without restating the comparative information. The amendments are not expected to have any significant impact on the Group's financial statements.

國際會計準則第37號(修訂本)澄清，就根據國際會計準則第37號評估合約是否屬虧損性而言，履行合約的成本包括與合約直接相關的成本。與合約直接相關的成本包括履行該合約的增量成本(如直接勞工及材料)及與履行該合約直接相關的其他成本分配(如分配履行合約所用物業、廠房及設備項目的折舊費用以及合約管理及監督成本)。一般及行政成本與合約並無直接關係，除非根據合約可明確向對手方收取，否則不予計入。修訂本於2022年1月1日或之後開始的年度期間生效，並適用於實體於其首次應用修訂本的年度報告期初尚未履行其所有責任的合約，亦可提早應用。首次應用修訂本的任何累計影響須於首次應用日期確認為對期初權益的調整，而毋須重列比較資料。預期修訂本對本集團的財務報表並無任何重大影響。

*Annual improvements to IFRS Standards 2018-2020* sets out amendments to IFRS 1, IFRS 9, Illustrative Examples accompanying IFRS 16, and IAS 41. Details of the amendments that are expected to be applicable to the Group are as follows:

- IFRS 9 *Financial Instruments*: clarifies the fees that an entity includes when assessing whether the terms of a new or modified financial liability are substantially different from the terms of the original financial liability. These fees include only those paid or received between the borrower and the lender, including fees paid or received by either the borrower or lender on the other's behalf. An entity applies the amendment to financial liabilities that are modified or exchanged on or after the beginning of the annual reporting period in which the entity first applies the amendment. The amendment is effective for annual periods beginning on or after 1 January 2022. Earlier application is permitted. The amendment is not expected to have a significant impact on the Group's financial statements.
- IFRS 16 *Leases*: removes the illustration of payments from the lessor relating to leasehold improvements in Illustrative Example 13 accompanying IFRS 16. This removes potential confusion regarding the treatment of lease incentives when applying IFRS 16.

- (a) During the year ended 31 December 2019, the Group commenced to engage certain import agents to deal with the Group's import of pharmaceuticals, including import services and issuance of letters of credit to the Group for its endorsement to overseas suppliers. The relevant imported pharmaceuticals covered by the letters of credit are pledged to the import agents as security. The pledge of pharmaceuticals can be released when the Group makes full payment to the import agents. Upon the settlement of letters of credit issued by import agents, the Group reclassifies the settled amounts from trade payables to other payables due to import agents. As at 31 December 2019, the Group had outstanding letters of credit not yet settled with overseas suppliers amounting to RMB154,308,000; and the Group made a payment of RMB67,565,000 to import agents as deposits for outstanding letters of credit for the release of pledged pharmaceuticals. The Group incorrectly reclassified trade payables to other payables amounting to RMB86,743,000 and offset trade payables against other receivables of RMB67,565,000 as at 31 December 2019. In addition, the Group incorrectly classified the cash flows arising from the transactions with import agents as operating activities instead of the financing activities.

Therefore, the effect of correcting the above errors has resulted in:

- (i) an increase in prepayments, other receivables and other assets of RMB67,565,000;
- (ii) an increase in trade payable of RMB154,308,000;
- (iii) a decrease in other payables of RMB86,743,000, of which RMB65,855,000 are classified under non-current liabilities; and
- (iv) a decrease in net cash flows from operating activities of RMB125,707,000 and an increase in net cash flows from financing activities of RMB125,707,000.

## 2.4 更正前期錯誤(續)

- (a) 截至2019年12月31日止年度，本集團開始僱用若干進口代理為本集團處理藥品進口，包括進口服務及向本集團開立信用證供其向海外供應商背書。信用證涵蓋的相關進口藥品抵押予該等進口代理作為保證。本集團向該等進口代理作全數付款時，可解除藥品抵押。待該等進口代理結算信用證後，本集團將貿易應付款項重新分類為應付該等進口代理的其他應付款項。於2019年12月31日，本集團尚未與海外供應商結算的未償還信用證金額為人民幣154,308,000元；而本集團向該等進口代理支付人民幣67,565,000元作為餘下未償還信用證的按金，以解除所抵押藥品。於2019年12月31日，本集團誤將貿易應付款項重新分類至其他應付款項，金額為人民幣86,743,000元，並將貿易應付款項與其他應收款項抵銷，金額為人民幣67,565,000元。此外，本集團誤將與進口代理交易產生的現金流量分類至經營活動而非融資活動。

- (b) As at 31 December 2019, the Group charged transportation costs attributable to unsold inventories to profit or loss amounting to RMB3,811,000. In addition, there was a purchase cut-off error of inventories, which led to an overstatement of prepayment amounting to RMB4,492,000 as at 31 December 2019.

Therefore, the effect of correcting the above errors has resulted in:

- (i) an increase in inventories of RMB8,303,000;
  - (ii) a decrease in prepayments, other receivables and other assets of RMB4,492,000; and
  - (iii) a decrease in cost of sales, and a corresponding increase in reserves, of RMB3,811,000.
- (c) As at 31 December 2019, there was a payment in advance in respect of rights for the use of certain technical knowhow with a gross balance before impairment amounting to RMB6,907,000. According to the Group's impairment test made on the payment in advance as at 31 December 2019, a full impairment loss should be required, but only RMB3,750,000 was recognised in profit or loss for the year ended 31 December 2019.

Therefore, the effect of correcting the above error would result in an increase in other expense for the year ended 31 December 2019 and a decrease in reserves as at 31 December 2019, of RMB3,157,000 with a corresponding decrease in "Payments in advance" as at 31 December 2019.

  - (ii) 預付款項、其他應收款項及其他資產減少人民幣4,492,000元；及
  - (iii) 銷售成本減少人民幣3,811,000元，令儲備相應增加。
- (c) 於2019年12月31日，就若干專業技術使用權的預先支付款項於扣除減值前的總結餘為人民幣6,907,000元。根據本集團就於2019年12月31日的預先支付款項進行的減值測試，應有全額減值虧損，但只有人民幣3,750,000元於截至2019年12月31日止年度的損益確認。

### Fair value measurement

The Group measures its certain wealth management products at fair value at the end of each reporting period. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The fair value measurement is based on the presumption that the transaction to sell the asset or transfer the liability takes place either in the principal market for the asset or liability, or in the absence of a principal market, in the most advantageous market for the asset or liability. The principal or the most advantageous market must be accessible by the Group. The fair value of an asset or a liability is measured using the assumptions that market participants would use when pricing the asset or liability, assuming that market participants act in their economic best interest.

A fair value measurement of a non-financial asset takes into account a market participant's ability to generate economic benefits by using the asset in its highest and best use or by selling it to another market participant that would use the asset in its highest and best use.

The Group uses valuation techniques that are appropriate in the circumstances and for which sufficient data are available to measure fair value, maximising the use of relevant observable inputs and minimising the use of unobservable inputs.

### 公平值計量

本集團於各報告期末按公平值計量其若干理財產品。公平值為市場參與者於計量日期在有序交易中出售資產時收取或轉讓負債時支付的價格。公平值計量乃基於假設出售資產或轉讓負債的交易於資產或負債的主要市場中進行，倘無主要市場，則於資產或負債的最有利市場進行。主要或最有利市場必須為本集團可進入的市場。資產或負債的公平值採用對資產或負債定價時市場參與者採用的假設計量，並假設市場參與者以彼等最佳經濟利益行事。

非金融資產的公平值計量計及市場參與者透過使用資產的最高及最佳使用價值，或透過將其出售予另一名將使用資產的最高及最佳使用價值的市場參與者而產生經濟利益的能力。

本集團採用有關情況下屬適當且有足夠數據的估值技術計量公平值，盡量使用有關可觀察輸入數據及盡量避免使用不可觀察輸入數據。

### Fair value measurement (Continued)

All assets and liabilities for which fair value is measured or disclosed in the financial statements are categorised within the fair value hierarchy, described as follows, based on the lowest level input that is significant to the fair value measurement as a whole:

- Level 1 – based on quoted prices (unadjusted) in active markets for identical assets or liabilities
- Level 2 – based on valuation techniques for which the lowest level input that is significant to the fair value measurement is observable, either directly or indirectly
- Level 3 – based on valuation techniques for which the lowest level input that is significant to the fair value measurement is unobservable

For assets and liabilities that are recognised in the financial statements on a recurring basis, the Group determines whether transfers have occurred between levels in the hierarchy by reassessing categorisation (based on the lowest level input that is significant to the fair value measurement as a whole) at the end of each reporting period.

### Impairment of non-financial assets

Where an indication of impairment exists, or when annual impairment testing for an asset is required (other than inventories, deferred tax assets, financial assets, and investment properties), the asset's recoverable amount is estimated. An asset's recoverable amount is the higher of the asset's or cash-generating unit's value in use and its fair value less costs of disposal, and is determined for an individual asset, unless the asset does not generate cash inflows that are largely independent of those from other assets or groups of assets, in which case the recoverable amount is determined for the cash-generating unit to which the asset belongs.

An impairment loss is recognised only if the carrying amount of an asset exceeds its recoverable amount. In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset. An impairment loss is charged to profit or loss in the period in which it arises in those expense categories consistent with the function of the impaired asset.

An assessment is made at the end of each reporting period as to whether there is an indication that previously recognised impairment losses may no longer exist or may have decreased. If such an indication exists, the recoverable amount is estimated. A previously recognised impairment loss of an asset other than goodwill is reversed only if there has been a change in the estimates used to determine the recoverable amount of that asset, but not to an amount higher than the carrying amount that would have been determined (net of any depreciation/amortisation) had no impairment loss been recognised for the asset in prior years. A reversal of such an impairment loss is credited to profit or loss in the period in which it arises.

### 非金融資產減值

倘資產存在減值跡象，或須對資產進行年度減值測試(不包括存貨、遞延稅項資產、金融資產及投資物業)，則會估計資產的可收回金額。資產的可收回金額按資產或現金產生單位的使用價值與其公平值減出售成本兩者的較高者計算，並就個別資產釐定，除非有關資產並不產生很大程度上獨立於其他資產或資產組別的現金流入，在此情況下，則就有關資產所屬的現金產生單位釐定可收回金額。

僅當資產的賬面值超過其可收回金額時，方會確認減值虧損。評估使用價值時，使用稅前貼現率將估計未來現金流量貼現至其現值，而該貼現率反映市場當時所評估的貨幣時間價值及該資產的特定風險。減值虧損在其產生期間於與減值資產功能一致的開支分類內自損益扣除。

於各報告期末均會評估是否有任何跡象顯示過往確認的減值虧損可能不復存在或有所減少。如有任何該等跡象，則估計可收回金額。先前就資產(不包括商譽)確認的減值虧損，僅於用以釐定該資產可收回金額的估計有變時予以撥回，但撥回金額不得高於假設過往年度並無就該資產確認減值虧損而應釐定的賬面值(扣除任何折舊/攤銷)。減值虧損的撥回在其產生期間計入損益。

### Property, plant and equipment and depreciation

Property, plant and equipment, other than construction in progress, are stated at cost less accumulated depreciation and any impairment losses. The cost of an item of property, plant and equipment comprises its purchase price and any directly attributable costs of bringing the asset to its working condition and location for its intended use.

Expenditure incurred after items of property, plant and equipment have been put into operation, such as repairs and maintenance, is normally charged to profit or loss in the period in which it is incurred. In situations where the recognition criteria are satisfied, the expenditure for a major inspection is capitalised in the carrying amount of the asset as a replacement. Where significant parts of property, plant and equipment are required to be replaced at intervals, the Group recognises such parts as individual assets with specific useful lives and depreciates them accordingly.

Depreciation is calculated on the straight-line basis to write off the cost of each item of property, plant and equipment to its residual value over its estimated useful life. The estimated useful lives of items of property, plant and equipment are as follows:

物業、廠房及設備(在建工程除外)乃按成本減累計折舊及任何減值虧損入賬。物業、廠房及設備項目的成本包括購買價及使資產達到擬定用途運作狀態及地點的任何直接應計成本。

物業、廠房及設備項目投入運作後產生的維修及保養等開支，通常於產生期間自損益扣除。於符合確認標準的情況下，大型檢測開支於資產賬面值中資本化為重置成本。倘物業、廠房及設備的主要部分須定期替換，則本集團將該等部分確認為獨立資產，並設定特定的可使用年期及相應計提折舊。

Where parts of an item of property, plant and equipment have different useful lives, the cost of that item is allocated on a reasonable basis among the parts and each part is depreciated separately. Residual values, useful lives and the depreciation method are reviewed, and adjusted if appropriate, at least at each financial year end.

An item of property, plant and equipment including any significant part initially recognised is derecognised upon disposal or when no future economic benefits are expected from its use or disposal. Any gain or loss on disposal or retirement recognised in profit or loss in the year the asset is derecognised is the difference between the net sales proceeds and the carrying amount of the relevant asset.

Construction in progress represents items of property, plant and equipment under construction, which are stated at cost less any impairment losses and are not depreciated. Cost comprises the direct costs of construction and capitalised borrowing costs on related borrowed funds during the period of construction. Construction in progress is reclassified to the appropriate category of property, plant and equipment when completed and ready for use.

### Investment properties

Investment properties are interests in buildings held to earn rental income and/or for capital appreciation, rather than for use in the production or supply of goods or services or for administrative purposes; or for sale in the ordinary course of business. Such properties are measured initially at cost, including transaction costs.

Any gain or losses on the retirement or disposal of an investment property are recognised in profit or loss in the year of the retirement or disposal.

初始確認的物業、廠房及設備項目(包括任何重大部分)於出售後或預期使用或出售不會產生未來經濟利益時終止確認。於資產終止確認年度在損益確認的任何出售或報廢盈虧為有關資產的出售所得款項淨額與賬面值的差額。

在建工程指在建物業、廠房及設備項目，按成本減任何減值虧損列賬而不計提折舊。成本包括建設期間的直接建設成本及相關借款的已資本化借款成本。在建工程於完成並可使用時重新分類至適當的物業、廠房及設備類別。

### 投資物業

投資物業為持有作賺取租金收入及/或資本增值而非用於生產或供應商品或服務或作行政用途，或持作於日常業務過程中出售的物業權益。該等物業初步按成本(包括交易成本)計量。

### Intangible assets (other than goodwill)

Intangible assets acquired separately are measured on initial recognition at cost. The cost of intangible assets acquired in a business combination is the fair value at the date of acquisition. The useful lives of intangible assets are assessed to be either finite or indefinite. Intangible assets with finite lives are subsequently amortised over the useful economic life and assessed for impairment whenever there is an indication that the intangible asset may be impaired. The amortisation period and the amortisation method for an intangible asset with a finite useful life are reviewed at least at each financial year end.

Intangible assets are stated at cost less any impairment losses and are amortised on the straight-line basis over their estimated useful lives. The principal estimated useful life of intangible assets is as follows:

#### Research and development costs

All research costs are charged to profit or loss as incurred.

Expenditure incurred on projects to develop new products is capitalised and deferred only when the Group can demonstrate the technical feasibility of completing the intangible asset so that it will be available for use or sale, its intention to complete and its ability to use or sell the asset, how the asset will generate future economic benefits, the availability of resources to complete the project and the ability to measure reliably the expenditure during the development. Product development expenditure which does not meet these criteria is expensed when incurred.

Deferred development costs are stated at cost less any impairment losses and are amortised using the straight-line basis over the commercial lives of the underlying products not exceeding five to seven years, commencing from the date when the products are put into commercial production.

### Leases

The Group assesses at contract inception whether a contract is, or contains, a lease. A contract is, or contains, a lease if the contract conveys the right to control the use of an identified asset for a period of time in exchange for consideration.

#### *Group as a lessee*

The Group applies a single recognition and measurement approach for all leases, except for short-term leases and leases of low-value assets. The Group recognises lease liabilities to make lease payments and right-of-use assets representing the right to use the underlying assets.

#### (a) *Right-of-use assets*

Right-of-use assets are recognised at the commencement date of the lease (that is the date the underlying asset is available for use). Right-of-use assets are measured at cost, less any accumulated depreciation and any impairment losses, and adjusted for any remeasurement of lease liabilities. The cost of right-of-use assets includes the amount of lease liabilities recognised, initial direct costs incurred, and lease payments made at or before the commencement date less any lease incentives received. Right-of-use assets are depreciated on a straight-line basis over the shorter of the lease terms and the estimated useful lives of the assets as follows:

If ownership of the leased asset transfers to the Group by the end of the lease term or the cost reflects the exercise of a purchase option, depreciation is calculated using the estimated useful life of the asset.

### 租賃

本集團於合約開始時評估合約是否屬於或包含租賃。倘合約為換取代價而給予在一段時間內使用已識別資產的控制權，則該合約屬於租賃或包含租賃。

#### *本集團作為承租人*

本集團就所有租賃應用單一確認及計量方法，惟短期租賃及低價值資產租賃除外。本集團確認作出租賃付款的租賃負債，以及代表相關資產使用權的使用權資產。

#### (a) *使用權資產*

使用權資產於租賃開始日期(即相關資產可供使用的日期)確認。使用權資產按成本減任何累計折舊及任何減值虧損計量，並根據租賃負債的任何重新計量作出調整。使用權資產的成本包括已確認的租賃負債金額、產生的初始直接成本，以及於開始日期當日或之前支付的租賃付款減所收取的任何租賃優惠。使用權資產於資產的租期或估計可使用年期(以較短者為準)按直線法予以折舊如下：

辦公室物業及倉庫	2至5年
租賃土地	50年

倘租賃資產的擁有權於租期結束時轉讓予本集團或成本反映行使購買選擇權，則折舊按資產的估計可使用年期計算。

#### (b) Lease liabilities

Lease liabilities are recognised at the commencement date of the lease at the present value of lease payments to be made over the lease term. The lease payments include fixed payments (including in-substance fixed payments) less any lease incentives receivable, variable lease payments that depend on an index or a rate, and amounts expected to be paid under residual value guarantees. The lease payments also include the exercise price of a purchase option reasonably certain to be exercised by the Group and payments of penalties for terminating a lease, if the lease term reflects the Group exercising the option to terminate the lease. The variable lease payments that do not depend on an index or a rate are recognised as an expense in the period on which the event or condition that triggers the payment occurs.

In calculating the present value of lease payments, the Group uses the incremental borrowing rate at the lease commencement date because the interest rate implicit in the lease is not readily determinable. After the commencement date, the amount of lease liabilities is increased to reflect the accretion of interest and reduced for the lease payments made. In addition, the carrying amount of lease liabilities is remeasured if there is a modification, a change in the lease term, a change in lease payments (e.g., a change to future lease payments resulting from a change in an index or rate) or a change in assessment of an option to purchase the underlying asset.

The Group elected to present the lease liabilities separately in the consolidated statement of financial position.

本集團作為承租人(續)

#### (b) 租賃負債

租賃負債按租期內將支付的租賃付款現值於租賃開始日期確認。租賃付款包括定額付款(包含實質定額款項)減任何應收租賃優惠、取決於指數或利率的可變租賃付款以及預期根據剩餘價值擔保支付的金額。租賃付款亦包括本集團合理確定行使的購買選擇權的行使價,並在租期反映本集團行使終止租賃選擇權的情況下包括有關終止租賃的罰款。並非取決於指數或利率的可變租賃付款在出現觸發付款的事件或情況的期間內確認為開支。

於計算租賃付款的現值時,由於租賃隱含利率不易釐定,本集團使用租賃開始日期的增量借款利率計算。於開始日期後,租賃負債金額的增加反映利息的增長,並會因支付租賃付款而減少。此外,倘出現修訂、租期有所變更、租賃付款有所變更(例如因指數或利率變動導致未來租賃付款有所變更)或購買相關資產的選擇權的評估出現變動,租賃負債的賬面值將會重新計量。

本集團選擇於綜合財務狀況表中獨立呈列租賃負債。

##### (c) Short-term leases and leases of low-value assets

The Group applies the short-term lease recognition exemption to its short-term leases of machinery and equipment (that is those leases that have a lease term of 12 months or less from the commencement date and do not contain a purchase option). It also applies the recognition exemption for leases of low-value assets to leases of office equipment that is considered to be of low value. Lease payments on short-term leases and leases of low-value assets are recognised as an expense on a straight-line basis over the lease term.

#### Group as a lessor

When the Group acts as a lessor, it classifies at lease inception (or when there is a lease modification) each of its leases as either an operating lease or a finance lease.

Leases in which the Group does not transfer substantially all the risks and rewards incidental to ownership of an asset are classified as operating leases. When a contract contains lease and non-lease components, the Group allocates the consideration in the contract to each component on a relative stand-alone selling price basis. Rental income is accounted for on a straight-line basis over the lease terms and is included in other income in profit or loss due to its operating nature. Initial direct costs incurred in negotiating and arranging an operating lease are added to the carrying amount of the leased asset and recognised over the lease term on the same basis as rental income. Contingent rents are recognised as other income in the period in which they are earned.

Leases that transfer substantially all the risks and rewards incidental to ownership of an underlying asset to the leases are accounted for as finance leases.

#### 本集團作為承租人(續)

##### (c) 短期租賃及低價值資產租賃

本集團對機器及設備的短期租賃(即租期為自開始日期起計12個月或以下及不包含購買選擇權的租賃)應用短期租賃確認豁免。其亦將低價值資產租賃確認豁免應用於被視為低價值的辦公室設備。短期租賃及低價值資產租賃的租賃付款於租期按直線法確認為開支。

#### 本集團作為出租人

倘本集團為出租人，則於租賃開始時(或倘發生租賃修改時)將其各項租賃分類為經營租賃或融資租賃。

租賃如未有獲本集團轉讓資產所有權所附帶的絕大部分風險及回報，分類為經營租賃。倘合約包括租賃及非租賃部分，本集團按相對獨立的售價基準將合約代價分配至各部分。由於其經營性質，租金收入於租期內按直線法入賬並計入損益內的其他收入。於磋商及安排經營租賃時產生的初始直接成本計入租賃資產的賬面值，並於租期內按與租金收入相同的基準確認。或然租金於所賺取的期間內確認為其他收入。

租賃如獲轉讓相關資產所有權所附帶的絕大部分風險及回報予承租人，作為融資租賃入賬。

### Investments and other financial assets

#### Initial recognition and measurement

Financial assets are classified, at initial recognition, as subsequently measured at amortised cost.

The classification of financial assets at initial recognition depends on the financial asset's contractual cash flow characteristics and the Group's business model for managing them. With the exception of trade receivables that do not contain a significant financing component or for which the Group has applied the practical expedient of not adjusting the effect of a significant financing component, the Group initially measures a financial asset at its fair value plus in the case of a financial asset not at fair value through profit or loss, transaction costs. Trade receivables that do not contain a significant financing component or for which the Group has applied the practical expedient are measured at the transaction price determined under IFRS 15 in accordance with the policies set out for "Revenue recognition" below.

In order for a financial asset to be classified and measured at amortised cost or fair value through other comprehensive income, it needs to give rise to cash flows that are solely payments of principal and interest ("SPPI") on the principal amount outstanding. Financial assets with cash flows that are not SPPI are classified and measured at fair value through profit or loss, irrespective of the business model.

The Group's business model for managing financial assets refers to how it manages its financial assets in order to generate cash flows. The business model determines whether cash flows will result from collecting contractual cash flows, selling the financial assets, or both. Financial assets classified and measured at amortised cost are held within a business model with the objective to hold financial assets in order to collect contractual cash flows, while financial assets classified and measured at fair value through other comprehensive income are held within a business model with the objective of both holding to collect contractual cash flows and selling. Financial assets which are not held within the aforementioned business models are classified and measured at fair value through profit or loss.

### 投資及其他金融資產

#### 初始確認及計量

於初始確認時，金融資產劃分為隨後按攤銷成本計量。

金融資產於初步確認時的分類視乎金融資產合約現金流量的特徵及本集團管理該等資產的業務模式。除並無重大融資成分或本集團並未就此應用不調整重大融資成分影響的實際可行權宜方法的貿易應收款項外，本集團初步按其公平值加(倘並非按公平值計入損益的金融資產)交易成本計量金融資產。如下文「收益確認」所載政策，並無重大融資成分或本集團並未就此應用實際可行權宜方法的貿易應收款項按國際財務報告準則第15號釐定的交易價格計量。

為使金融資產分類為按攤銷成本或按公平值計入其他全面收益並按此計量，需產生僅為支付本金及未償還本金利息(「僅為支付本金及利息」)的現金流量。現金流量並非僅為支付本金及利息的金融資產分類為按公平值計入損益並按此計量，而不論業務模式。

本集團管理金融資產的業務模式指為產生現金流量管理金融資產的方式。業務模式釐定現金流量會否來自收取合約現金流量、出售金融資產或以上兩者。分類為按攤銷成本計量的金融資產於旨在持有金融資產以收取合約現金流量的業務模式中持有，而分類為按公平值計入其他全面收益計量的金融資產則於旨在持有以收取合約現金流量及出售的業務模式中持有。並非於上述業務模式中持有的金融資產分類為按公平值計入損益計量。

#### Initial recognition and measurement (Continued)

All regular way purchases and sales of financial assets are recognised on the trade date, that is, the date that the Group commits to purchase or sell the asset. Regular way purchases or sales are purchases or sales of financial assets that require delivery of assets within the period generally established by regulation or convention in the marketplace.

#### Subsequent measurement

The subsequent measurement of financial assets depends on their classification as follows:

#### Financial assets at amortised cost (debt instruments)

Financial assets at amortised cost are subsequently measured using the effective interest method and are subject to impairment. Gains and losses are recognised in profit or loss when the asset is derecognised, modified or impaired.

### Derecognition of financial assets

A financial asset (or, where applicable, a part of a financial asset or part of a group of similar financial assets) is primarily derecognised (i.e., removed from the Group's consolidated statement of financial position) when:

- the rights to receive cash flows from the asset have expired; or
- the Group has transferred its rights to receive cash flows from the asset or has assumed an obligation to pay the received cash flows in full without material delay to a third party under "pass-through" arrangement; and either (a) the Group has transferred substantially all the risks and rewards of the asset, or (b) the Group has neither transferred nor retained substantially all the risks and rewards of the asset, but has transferred control of the asset.

### 投資及其他金融資產(續)

#### 初始確認及計量(續)

所有常規方式買賣的金融資產於交易日(即本集團承諾買賣該資產之日)確認。常規方式買賣乃指須通常於法規或市場慣例約定的時間內交付資產的金融資產買賣。

#### 後續計量

金融資產的後續計量依據其分類分別如下：

#### 按攤銷成本計量的金融資產(債務工具)

按攤銷成本列賬的金融資產隨後使用實際利率法計量，並可予減值。收益及虧損於資產終止確認、修改或減值時於損益中確認。

### 終止確認金融資產

金融資產(或(倘適用)金融資產的其中部分或一組類似金融資產的其中部分)主要在下列情況下終止確認(即從本集團綜合財務狀況表中刪除)：

- 自資產收取現金流量的權利已屆滿；或
- 本集團已轉移自資產收取現金流量的權利，或已根據「轉付」安排承擔在無重大延誤的情況下將全數所得現金流量支付予第三方的責任；及(a)本集團已轉移資產的絕大部分風險及報酬，或(b)本集團並無轉移或保留資產的絕大部分風險及報酬，惟已轉移資產的控制權。

### Derecognition of financial assets (Continued)

When the Group has transferred its rights to receive cash flows from an asset or has entered into a pass-through arrangement, it evaluates if, and to what extent, it has retained the risk and rewards of ownership of the asset. When it has neither transferred nor retained substantially all the risks and rewards of the asset nor transferred control of the asset, the Group continues to recognise the transferred asset to the extent of the Group's continuing involvement. In that case, the Group also recognises an associated liability. The transferred asset and the associated liability are measured on a basis that reflects the rights and obligations that the Group has retained.

Continuing involvement that takes the form of a guarantee over the transferred asset is measured at the lower of the original carrying amount of the asset and the maximum amount of consideration that the Group could be required to repay.

### Impairment of financial assets

The Group recognises an allowance for expected credit losses ("ECLs") for all debt instruments not held at fair value through profit or loss. ECLs are based on the difference between the contractual cash flows due in accordance with the contract and all the cash flows that the Group expects to receive, discounted at an approximation of the original effective interest rate. The expected cash flows will include cash flows from the sale of collateral held or other credit enhancements that are integral to the contractual terms.

### 終止確認金融資產(續)

倘本集團已轉移自資產收取現金流量的權利，或已訂立轉付安排，將評估其是否保留該項資產的擁有權風險及報酬以及保留的程度。倘本集團並無轉移或保留資產的絕大部分風險及報酬，亦無轉移資產的控制權，則本集團在繼續參與的情況下繼續確認已轉移資產。在該情況下，本集團亦確認相關負債。已轉移資產及相關負債乃按反映本集團已保留權利及責任的基準計量。

就已轉移資產作出保證的持續參與，乃以該項資產的原賬面值與本集團或須償還的代價金額上限的較低者計量。

### 金融資產減值

本集團就所有並非按公平值計入損益持有的債務工具確認預期信貸虧損(「預期信貸虧損」)撥備。預期信貸虧損乃以根據合約應付的合約現金流量與本集團預期收取的所有現金流量之間的差額為基準，按與原有實際利率相近者貼現。預期現金流量將包括來自銷售所持有抵押品或屬合約條款不可或缺部分的其他信用增級的現金流量。

### Impairment of financial assets (Continued)

#### General approach

ECLs are recognised in two stages. For credit exposures for which there has not been a significant increase in credit risk since initial recognition, ECLs are provided for credit losses that result from default events that are possible within the next 12 months (a 12-month ECL). For those credit exposures for which there has been a significant increase in credit risk since initial recognition, a loss allowance is required for credit losses expected over the remaining life of the exposure, irrespective of the timing of the default (a lifetime ECL).

At each reporting date, the Group assesses whether the credit risk on a financial instrument has increased significantly since initial recognition. When making the assessment, the Group compares the risk of a default occurring on the financial instrument as at the reporting date with the risk of a default occurring on the financial instrument as at the date of initial recognition and considers reasonable and supportable information that is available without undue cost or effort, including historical and forward-looking information.

The Group considers a financial asset in default when contractual payments are 90 days past due. However, in certain cases, the Group may also consider a financial asset to be in default when internal or external information indicates that the Group is unlikely to receive the outstanding contractual amounts in full before taking into account any credit enhancements held by the Group. A financial asset is written off when there is no reasonable expectation of recovering the contractual cash flows.

### 金融資產減值(續)

#### 一般方法

預期信貸虧損於兩個階段進行確認。對於自初步確認後並無顯著增加的信貸風險，預期信貸虧損就可能於未來12個月內(12個月預期信貸虧損)出現的違約事件計提撥備。對於自初步確認後有顯著增加的信貸風險，須就信貸虧損風險預期的剩餘年期計提虧損撥備，不論違約事件於何時發生(存續期預期信貸虧損)。

於各報告日期，本集團對自初始確認後金融工具的信貸風險是否顯著增加進行評估。在評估時，本集團將於報告日期金融工具發生之違約風險與初始確認日金融工具發生之違約風險進行比較，本集團會考慮合理且可支持的資料，包括無需付出不必要的成本或努力而可得之歷史及前瞻性資料。

本集團將合約付款逾期90日的金融資產視作違約。然而，於若干情況下，當內部或外部資料顯示本集團不可能在本集團採取任何信貸提升安排前悉數收回未償還合約金額時，本集團亦可能認為該金融資產違約。倘並無收回合約現金流量的合理預期，則撤銷有關金融資產。

### Impairment of financial assets (Continued)

#### General approach (Continued)

Financial assets at amortised cost are subject to impairment under the general approach and they are classified within the following stages for measurement of ECLs except for trade receivables which apply the simplified approach as detailed below.

- Stage 1 – Financial instruments for which credit risk has not increased significantly since initial recognition and for which the loss allowance is measured at an amount equal to 12-month ECLs
- Stage 2 – Financial instruments for which credit risk has increased significantly since initial recognition but that are not credit-impaired financial assets and for which the loss allowance is measured at an amount equal to lifetime ECLs
- Stage 3 – Financial assets that are credit-impaired at the reporting date (but that are not purchased or originated credit-impaired) and for which the loss allowance is measured at an amount equal to lifetime ECLs

#### Simplified approach

For trade receivables that do not contain a significant financing component or when the Group applies the practical expedient of not adjusting the effect of a significant financing component, the Group applies the simplified approach in calculating ECLs. Under the simplified approach, the Group does not track changes in credit risk, but instead recognises a loss allowance based on lifetime ECLs at each reporting date. The Group has established a provision matrix that is based on its historical credit loss experience, adjusted for forward-looking factors specific to the debtors and the economic environment.

For trade receivables that contain a significant financing component, the Group chooses as its accounting policy to adopt the simplified approach in calculating ECLs with policies as described above.

### 金融資產減值(續)

#### 一般方法(續)

按攤銷成本計量的金融資產，在一般方法下可能會發生減值，且除採用簡化方法的貿易應收款項(以下詳述)外，它們在以下階段分類用於預期信貸虧損計量。

- 第一階段 – 金融工具自初始確認以來信貸風險並無顯著增加，且其虧損撥備按相當於12個月預期信貸虧損的金額計量
- 第二階段 – 金融工具自初始確認以來信貸風險顯著增加但並非出現信貸減值的金融資產，且其虧損撥備按相當於存續期預期信貸虧損的金額計量
- 第三階段 – 於報告日期出現信貸減值的金融資產(惟收購或產生時並未出現信貸減值)，其虧損撥備按相當於存續期預期信貸虧損的金額計量

#### 簡化方法

對於不包含重大融資成分的貿易應收款項，或本集團採用實際可行權宜方法，不會就重大融資成分的影響調整時，本集團採用簡化方法進行預期信貸虧損計量。根據簡化方法，本集團不會追蹤信貸風險的變化，而是於各報告日期根據存續期預期信貸虧損確認虧損撥備。本集團已根據其歷史信貸虧損經驗建立撥備矩陣，並根據債務人及經濟環境的前瞻性因素作出調整。

就包含重大融資成分的貿易應收款項而言，本集團會計政策選擇採用簡化方法根據上述政策進行預期信貸虧損計量。

### Financial liabilities

#### *Initial recognition and measurement*

Financial liabilities are classified, at initial recognition, as loans and borrowings and payables.

All financial liabilities are recognised initially at fair value and, in the case of loans and borrowings and payables, net of directly attributable transaction costs.

The Group's financial liabilities include trade payables, other payables and accruals, amounts due to related parties and interest-bearing bank and other borrowings.

#### *Subsequent measurement*

The subsequent measurement of financial liabilities depends on their classification as follows:

#### *Financial liabilities at amortised cost (loans and borrowings)*

After initial recognition, interest-bearing bank and other borrowings are subsequently measured at amortised cost, using the effective interest rate method unless the effect of discounting would be immaterial, in which case they are stated at cost. Gains and losses are recognised in profit or loss when the liabilities are derecognised as well as through the effective interest rate amortisation process.

Amortised cost is calculated by taking into account any discount or premium on acquisition and fees or costs that are an integral part of the effective interest rate. The effective interest rate amortisation is included in finance costs in profit or loss.

### 金融負債

#### *初始確認及計量*

於初始確認時，金融負債分類為貸款及借款以及應付款項。

所有金融負債初始按公平值確認及，如屬貸款及借款以及應付款項則扣除直接應佔交易成本。

本集團的金融負債包括貿易應付款項、其他應付款項及應計款項、應付關連方款項以及計息銀行及其他借款。

#### *後續計量*

金融負債的後續計量視乎以下分類：

#### *按攤銷成本計量的金融負債(貸款及借款)*

於初始確認後，計息銀行及其他借款採用實際利率法按攤銷成本計量，惟貼現影響並不重大，則按成本列賬。收益及虧損於負債終止確認時及按照實際利率攤銷過程中於損益確認。

計算攤銷成本時計及收購所產生的任何折讓或溢價，並包括組成實際利率一部分的費用或成本。實際利率攤銷計入損益的財務成本內。

### Derecognition of financial liabilities

A financial liability is derecognised when the obligation under the liability is discharged or cancelled, or expires.

When an existing financial liability is replaced by another from the same lender or substantially different terms, or the terms an existing liability are subsequently modified, such an exchange or modification is treated as a derecognition of the original liability and recognition of a new liability, and the difference between the respective carrying amounts is recognised in profit or loss.

### Offsetting of financial instruments

Financial assets and financial liabilities are offset and the net amount is reported in the statement of financial position if there is currently enforceable legal right to offset the recognised amounts and there is an intention to settle on a net basis, or to realise the assets and settle the liabilities simultaneously.

### Inventories

Inventories are stated at the lower of cost and net realisable value. Cost is determined on the weighted average method. Net realisable value is based on estimated selling prices less any estimated costs to be incurred to completion and disposal.

### Cash and cash equivalents

For the purpose of the consolidated statement of cash flows, cash and cash equivalents comprise cash on hand and demand deposits, and short term highly liquid investments that are readily convertible into known amounts of cash, are subject to an insignificant risk of changes in value, and have a short maturity of generally within three months when acquired.

For the purpose of the consolidated statement of financial position, cash and cash equivalents comprise cash on hand and at banks.

### 終止確認金融負債

金融負債於負債的責任已獲解除或註銷或屆滿時終止確認。

當現有金融負債被同一貸款人或大致上條款相異的另一項負債取代時，或現有負債的條款出現重大修改時，有關替換或修改被視為終止確認原有負債及確認一項新負債，而各賬面值的差額於損益確認。

### 抵銷金融工具

倘現時存在可執行合法權利抵銷已確認金額，且有意以淨額結算，或同時變現資產及清償負債，則金融資產及金融負債將予抵銷，且淨金額於財務狀況表呈報。

### 存貨

存貨按成本及可變現淨值兩者的較低者列賬。成本按加權平均法釐定。可變現淨值乃基於估計售價減完成及出售所產生的任何估計成本計算。

### 現金及現金等價物

就綜合現金流量表而言，現金及現金等價物包括手頭現金及活期存款，以及可隨時兌換為已知金額現金及所涉價值變動風險不高，且一般自取得起計三個月內到期的短期高流動性投資。

就綜合財務狀況表而言，現金及現金等價物包括手頭及銀行現金。

## 2.5 Summary of Significant Accounting Policies (Continued)

### Provisions

A provision is recognised when a present obligation (legal or constructive) has arisen as a result of a past event and it is probable that a future outflow of resources will be required to settle the obligation, provided that a reliable estimate can be made of the amount of the obligation.

When the effect of discounting is material, the amount recognised for a provision is the present value at the end of the reporting period of the future expenditures expected to be required to settle the obligation. The increase in the discounted present value amount arising from the passage of time is included in “finance costs” in profit or loss.

### Income tax

Income tax comprises current and deferred tax. Income tax relating to items recognised outside profit or loss is recognised outside profit or loss, either in other comprehensive income or directly in equity.

Current tax assets and liabilities are measured at the amount expected to be recovered from or paid to the taxation authorities, based on tax rates (and tax laws) that have been enacted or substantively enacted by the end of the reporting period, taking into consideration interpretations and practices prevailing in the countries in which the Group operates.

Deferred tax is provided, using the liability method, on all temporary differences at the end of the reporting period between the tax bases of assets and liabilities and their carrying amounts for financial reporting purposes.

### 撥備

當過往事件導致目前須承擔責任(法定或推定)，且日後可能需有資源流出以償付有關責任，則會確認撥備，惟該項責任的數額須能夠可靠地估計。

當貼現影響重大時，確認的撥備數額為預期日後用作償付有關責任所需支出於報告期末的現值。當貼現現值隨時間流逝而有所增加，有關增幅會計入損益的「財務成本」內。

### 所得稅

所得稅包括即期及遞延稅項。與於損益外確認的項目有關的所得稅於損益外確認，即於其他全面收益或直接於權益確認。

即期稅項資產及負債按預期可自稅務機關收回或向其支付的金額計量，採用於報告期末已制定或實質已制定的稅率(及稅法)，計及本集團經營所在國家的現行詮釋及慣例。

遞延稅項使用負債法就於報告期末資產及負債的計稅基礎與其作財務匯報用途的賬面值之間的所有暫時差額計提撥備。

### Income tax (Continued)

Deferred tax liabilities are recognised for all taxable temporary differences, except:

- when the deferred tax liability arises from the initial recognition of goodwill or an asset or liability in a transaction that is not a business combination and, at the time of the transaction, affects neither the accounting profit nor taxable profit or loss; and
- in respect of taxable temporary differences associated with investments in subsidiaries, when the timing of the reversal of the temporary differences can be controlled and it is probable that the temporary differences will not reverse in the foreseeable future.

Deferred tax assets are recognised for all deductible temporary differences, and the carryforward of unused tax credits and any unused tax losses. Deferred tax assets are recognised to the extent that it is probable that taxable profit will be available against which the deductible temporary differences, and the carryforward of unused tax credits and unused tax losses can be utilised, except:

- when the deferred tax asset relating to the deductible temporary differences arises from the initial recognition of an asset or liability in a transaction that is not a business combination and, at the time of the transaction, affects neither the accounting profit nor taxable profit or loss; and
- in respect of deductible temporary differences associated with investments in subsidiaries, deferred tax assets are only recognised to the extent that it is probable that the temporary differences will reverse in the foreseeable future and taxable profit will be available against which the temporary differences can be utilised.

除下列情況外，對所有應課稅暫時差額確認遞延稅項負債：

- 當遞延稅項負債源於初始確認商譽或一項並非業務合併的交易中的資產或負債，且於該項交易進行時不影響會計溢利及應課稅損益時；及
- 就與於附屬公司的投資有關的應課稅暫時差額而言，當暫時差額的撥回時間可予控制且該暫時差額於可見未來可能不會撥回時。

遞延稅項資產乃就所有可扣減暫時差額、結轉未動用稅項抵免及任何未動用稅項虧損予以確認。遞延稅項資產在有可能出現應課稅溢利用作抵銷該等可扣減暫時差額、結轉未動用稅項抵免及未動用稅項虧損的情況下，方予以確認，惟下列情況除外：

- 有關可扣減暫時差額的遞延稅項資產源於初始確認一項並非業務合併的交易中的資產或負債，且於該項交易進行時不影響會計溢利及應課稅損益；及
- 就與於附屬公司的投資有關的可扣減暫時差額而言，遞延稅項資產僅會於暫時差額有可能會於可預未來撥回及存在應課稅溢利可用作抵銷該暫時差額的情況下予以確認。

The carrying amount of deferred tax assets is reviewed at the end of each reporting period and reduced to the extent that it is no longer probable that sufficient taxable profit will be available to allow all or part of the deferred tax asset to be utilised. Unrecognised deferred tax assets are reassessed at the end of each reporting period and are recognised to the extent that it has become probable that sufficient taxable profit will be available to allow all or part of the deferred tax asset to be recovered.

Deferred tax assets and liabilities are measured at the tax rates that are expected to apply to the period when the asset is realised or the liability is settled, based on tax rates (and tax laws) that have been enacted or substantively enacted by the end of the reporting period.

Deferred tax assets and deferred tax liabilities are offset if and only if the Group has a legally enforceable right to set off current tax assets and current tax liabilities and the deferred tax assets and deferred tax liabilities relate to income taxes levied by the same taxation authority on either the same taxable entity or different taxable entities which intend either to settle current tax liabilities and assets on a net basis, or to realise the assets and settle the liabilities simultaneously, in each future period in which significant amounts of deferred tax liabilities or assets are expected to be settled or recovered.

### Government grants

Government grants are recognised at their fair value where there is reasonable assurance that the grant will be received and all attaching conditions will be complied with. When the grant relates to an expense item, it is recognised as income on a systematic basis over the periods that the costs, for which it is intended to compensate, are expensed.

### 所得稅(續)

遞延稅項資產的賬面值於各報告期末檢討，並減少至不再可能擁有足夠應課稅溢利以動用全部或部分遞延稅項資產為限。未確認遞延稅項資產於各報告期末重新評估，並於可能有足夠應課稅溢利可收回全部或部分遞延稅項資產時予以確認。

遞延稅項資產及負債按預期適用於資產變現或負債清償期間的稅率計量，並以各報告期末已制定或實質已制定的稅率(及税法)為基準。

倘及惟倘本集團擁有合法可執行權利將即期稅項資產及即期稅項負債抵銷，而即期稅項資產及即期稅項負債與同一稅務機關向同一應課稅實體或不同應課稅實體(該等實體擬於預期將清償或收回重大金額遞延稅項負債或資產的各未來期間按淨額結算即期稅項負債及資產，或於變現資產的同時清償負債)徵收的所得稅有關。

### 政府補助

倘能合理肯定收到政府補助及遵守補助附帶的所有條件，有關補助會按公平值確認。倘有關補助與一項開支項目有關，則補助於擬用作補償成本支銷的期間有系統地確認為收入。

### Revenue recognition

#### *Revenue from contracts with customers*

Revenue from contracts with customers is recognised when control of goods or services is transferred to the customers at an amount that reflects the consideration to which the Group expects to be entitled in exchange for those goods or services.

When the consideration in a contract includes a variable amount, the amount of consideration is estimated to which the Group will be entitled in exchange for transferring the goods or services to the customer. The variable consideration is estimated at contract inception and constrained until it is highly probable that a significant revenue reversal in the amount of cumulative revenue recognised will not occur when the associated uncertainty with the variable consideration is subsequently resolved.

When the contract contains a financing component which provides the customer with a significant benefit of financing the transfer of goods or services to the customer for more than one year, revenue is measured at the present value of the amount receivable, discounted using the discount rate that would be reflected in a separate financing transaction between the Group and the customer at contract inception. When the contract contains a financing component which provides the Group with a significant financial benefit for more than one year, revenue recognised under the contract includes the interest expense accreted on the contract liability under the effective interest method. For a contract where the period between the payment by the customer and the transfer of the promised goods or services is one year or less, the transaction price is not adjusted for the effects of a significant financing component, using the practical expedient in IFRS 15.

#### *Sale of goods*

Revenue from the sale of goods is recognised at the point in time when control of the asset is transferred to the customer, generally on delivery of the goods.

### 收益確認

#### *來自客戶合約的收益*

來自客戶合約的收益於商品或服務的控制權轉讓予客戶時確認，該金額能反映本集團預期就交換該等商品或服務有權獲得的代價。

當合約中的代價包含可變金額時，代價金額於本集團向客戶轉讓商品或服務而有權獲得交換時估計。可變代價於合約開始時估計並受到約束，直至與可變代價相關的不確定因素其後得到解決時，確認的累積收益金額極有可能不會發生重大收益回撥為止。

當合約中包含融資成分，該融資成分為客戶提供超過一年的商品或服務轉讓融資的重大利益時，收益按應收款項的現值計量，並使用將反映在本集團與客戶在合約開始時的單獨融資交易中的貼現率貼現。當合約中包含融資部分，該融資部分為在本集團提供了一年以上的重大財務利益時，合約項下確認的收益包括按實際利率法在合約負債上加算的利息。就客戶付款至轉讓承諾商品或者服務的期限為一年或者更短的合約而言，交易價格採用國際財務報告準則第15號中實際可行權宜方法，不會對重大融資部分的影響作出調整。

#### *銷售貨品*

銷售貨品的收益於資產控制權轉移至客戶的時間點(一般於交付貨品時)確認。

### Revenue recognition (Continued)

#### Other income

Interest income is recognised on an accrual basis using the effective interest method by applying the rate that exactly discounts the estimated future cash receipts over the expected life of the financial instrument or a shorter period, when appropriate, to the net carrying amount of the financial asset.

Rental income is recognised on a time proportion basis over the lease terms. Variable lease payments that do not depend on an index or a rate are recognised as income in the accounting period in which they are incurred.

Other income from distribution services is recognised when services are completed at an amount that reflects the consideration to which the Group expects to be entitled in exchange for those services.

### Contract liabilities

A contract liability is recognised when a payment is received or a payment is due (whichever is earlier) from a customer before the Group transfers the related goods or services. Contract liabilities are recognised as revenue when the Group performs under the contract (i.e., transfers control of the related goods or services to the customer).

### Share-based payments

The Company operates a share option scheme for the purpose of providing incentives and rewards to eligible participants who contribute to the success of the Group's operations. Subject to shareholders' agreement, the Company may also allot and issue certain new shares in the Company for the purpose of providing incentives for specific employees to remain employed in the Group and to motivate them to strive for the further development and expansion of the Group. Employees (including the directors) of the Group receive remuneration in the form of share-based payments, whereby employees render services as consideration for equity instruments ("equity-settled transactions").

### 收益確認(續)

#### 其他收入

按照應計基準利用實際利率法確認利息收入，即在金融工具的預期壽命或更短期間(如適當)將估計未來現金收入準確貼現至金融資產賬面淨值的利率。

租金收入於租期內按時間比例確認。並非取決於指數或利率的可變租賃付款於產生的會計期間確認為收入。

分銷服務所得其他收入於服務完成時確認，其金額反映本集團預期有權以該等服務交換的代價。

### 合約負債

合約負債於本集團轉讓相關貨品或服務前自客戶收取付款或付款到期(以較早者為準)時確認。合約負債於本集團履行合約(即將相關貨品或服務的控制權轉讓予客戶)時確認為收益。

### 以股份為基礎的付款

本公司運作購股權計劃，旨在為對本集團業務成功作出貢獻的合資格參與者提供獎勵及回報。根據股東協議，本公司亦可向特定僱員配發及發行本公司若干新股份作為其繼續受僱於本集團的獎勵，並激勵彼等為本集團的進一步發展及擴充而努力。本集團僱員(包括董事)按以股份為基礎的付款方式收取薪酬，據此僱員提供服務作為收取股本工具的代價(「股權結算交易」)。

### Share-based payments (Continued)

The cost of equity-settled transactions with employees is measured by reference to the fair value at the date at which they are granted. The fair value is determined by an external valuer using a binomial model, further details of which are given in note 27 to the financial statements.

The cost of equity-settled transactions is recognised in employee benefit expense, together with a corresponding increase in equity, over the period in which the performance and/or service conditions are fulfilled. The cumulative expense recognised for equity-settled transactions at the end of each reporting period until the vesting date reflects the extent to which the vesting period has expired and the Group's best estimate of the number of equity instruments that will ultimately vest. The charge or credit to profit or loss for a period represents the movement in the cumulative expense recognised as at the beginning and end of that period.

Service and non-market performance conditions are not taken into account when determining the grant date fair value of awards, but the likelihood of the conditions being met is assessed as part of the Group's best estimate of the number of equity instruments that will ultimately vest. Market performance conditions are reflected within the grant date fair value. Any other conditions attached to an award, but without an associated service requirement, are considered to be non-vesting conditions. Non-vesting conditions are reflected in the fair value of an award and lead to an immediate expensing of an award unless there are also service and/or performance conditions.

For awards that do not ultimately vest because non-market performance and/or service conditions have not been met, no expense is recognised. Where awards include a market or non-vesting condition, the transactions are treated as vesting irrespective of whether the market or non-vesting condition is satisfied, provided that all other performance and/or service conditions are satisfied.

Where the terms of an equity-settled award are modified, as a minimum an expense is recognised as if the terms had not been modified, if the original terms of the award are met. In addition, an expense is recognised for any modification that increases the total fair value of the share-based payments, or is otherwise beneficial to the employee as measured at the date of modification.

### 以股份為基礎的付款(續)

與僱員進行的股權結算交易成本乃參考於授出日期的公平值計量。公平值乃由外部估值師使用二項式模式釐定，進一步詳情載於財務報表附註27。

股權結算交易成本連同股本的相應增加乃於達致表現及／或服務條件的期間內於僱員福利開支中確認。於各報告期末直至歸屬日期為止就股權結算交易確認的累計開支反映歸屬期已屆滿及本集團對最終歸屬的股本工具數目的最佳估計。於期內扣除自或計入損益的金額指於期初及期末所確認的累計開支變動。

於釐定獎勵在授出日期的公平值時並不考慮服務及非市場表現條件，惟能達成條件的可能性則被評定為將最終歸屬的本集團股本工具數目的最佳估計的一部分。市場表現條件將於授出日期的公平值內反映。獎勵附帶的任何其他條件(惟並無相關服務要求)被視為非歸屬條件。非歸屬條件於獎勵的公平值中反映，並直接支銷獎勵，惟另有服務及／或表現條件則除外。

因未能達至非市場表現及／或服務條件而導致最終並無歸屬的獎勵並不會確認開支。倘獎勵包括一項市場或非歸屬條件，無論市場或非歸屬條件是否達成，該等交易均會被視為已歸屬，前提是所有其他表現及／或服務條件須已達成。

倘若股權結算獎勵的條款有所變更，則在達致獎勵原定條款的情況下，所確認的開支最少須達到猶如條款並無任何變更的水平。此外，倘若按變更日期計算，任何變更導致以股份為基礎的付款總公平值有所增加，或為僱員帶來其他利益，則應該等變更確認開支。

Where an equity-settled award is cancelled, it is treated as if it had vested on the date of cancellation, and any expense not yet recognised for the award is recognised immediately. This includes any award where non-vesting conditions within the control of either the Group or the employee are not met. However, if a new award is substituted for the cancelled award, and is designated as a replacement award on the date that it is granted, the cancelled and new awards are treated as if they were a modification of the original award, as described in the previous paragraph.

The dilutive effect of outstanding options is reflected as additional share dilution in the computation of earnings per share.

### Other employee benefits

#### Pension schemes

The employees of the subsidiaries in Mainland China are required to participate in a defined central pension scheme managed by the local municipal government of the areas in Mainland China in which they operate. These subsidiaries are required to contribute a certain percentage of the relevant part of the payroll of these employees to the central pension scheme. The Group has no obligation for the payment of retirement benefits beyond the annual contributions. The contributions are charged to profit or loss as they become payable in accordance with the rules of the central pension scheme.

In addition to the above, the Group also participates in a defined contribution Mandatory Provident Fund retirement benefit scheme (the "MPF Scheme") under the Mandatory Provident Fund Schemes Ordinance for its employees in Hong Kong. The Company's contributions have been capped to up to HK\$1,500 per month since 1 June 2014 for each of its employees in Hong Kong and are charged to profit or loss as they become payable in accordance with the rules of the MPF Scheme. The assets of the MPF Scheme are held separately from those of the Group in an independently administered fund. The Group's employer contributions vest fully with the employees when contributed into the MPF Scheme.

### 以股份為基礎的付款(續)

倘股權結算獎勵註銷，則視為已於註銷日期歸屬，任何尚未確認的獎勵(包括未能符合本集團或僱員可控制的非歸屬條件的任何獎勵)開支，均即時確認。然而，若已授出新獎勵代替已註銷的獎勵，並於授出日期指定為替代獎勵，則如前段所述，已註銷獎勵及新獎勵均視為原有獎勵的變更。

於計算每股盈利時，尚未行使購股權的攤薄影響反映為額外股份攤薄。

### 其他僱員福利

#### 退休金計劃

中國內地附屬公司的僱員須參與由經營所在中國內地地方市政府管理的定額中央退休金計劃。該等附屬公司須按該等僱員相關部分薪資的若干百分比向中央退休金計劃作出供款。除每年供款外，本集團並無支付退休福利的責任。供款於根據中央退休金計劃的規則應付時，自損益中扣除。

除上述者外，本集團亦根據強制性公積金計劃條例為其香港僱員參與定額供款強制性公積金退休福利計劃(「強積金計劃」)。自2014年6月1日起，本公司就各香港僱員作出的供款上限為每月1,500港元，並於根據強積金計劃的規則應付時自損益中扣除。強積金計劃的資產與本集團的資產分開持有，並由獨立管理的基金管理。本集團的僱主供款於向強積金計劃作出供款時全數撥歸僱員所有。

### Other employee benefits

#### Housing fund

Contributions to a defined contribution housing fund administered by the Public Accumulation Funds Administration Centre in Mainland China are charged to profit or loss as incurred.

### Borrowing costs

Borrowing costs directly attributable to the acquisition, construction or production of qualifying assets, i.e., assets that necessarily take a substantial period of time to get ready for their intended use or sale, are capitalised as part of the cost of those assets. The capitalisation of such borrowing costs ceases when the assets are substantially ready for their intended use or sale. Investment income earned on the temporary investment of specific borrowings pending their expenditure on qualifying assets is deducted from the borrowing costs capitalised. All other borrowing costs are expensed in the period in which they are incurred. Borrowing costs consist of interest and other costs that an entity incurs in connection with the borrowing of funds.

### Dividends

Final dividends are recognised as a liability when they are approved by the shareholders in a general meeting. At a meeting of the Board held on 31 March 2021, the Directors resolved not to pay final dividends to shareholders for the Reporting Period.

Interim dividends are simultaneously proposed and declared, because the Company's memorandum and articles of association grant the Directors the authority to declare interim dividends. Consequently, interim dividends are recognised immediately as a liability when they are proposed and declared. In the event that the interim dividends are paid out of the share premium account, shareholders' approval at an extraordinary general meeting is needed. When these interim dividends have been approved by the shareholders and declared, they are recognised as a liability.

### 其他僱員福利(續)

#### 住房公積金

向中國內地住房公積金管理中心管理的定額供款住房公積金作出的供款於產生時自損益中扣除。

### 借款成本

收購、建設或生產合資格資產(即需一段時間預備方可作擬定用途或出售的資產)直接應佔的借款成本,會撥充資本作為該等資產的部分成本。當資產已大致備妥作擬定用途或出售時,借款成本不再撥充資本。就特定借款用作合資格資產開支前進行臨時投資所賺取的投資收入,會自撥充資本的借款成本扣除。所有其他借款成本在產生期間列作開支。借款成本包括實體因借入資金所產生的利息及其他成本。

### 股息

末期股息於獲股東在股東大會批准時確認為負債。董事已於2021年3月31日舉行的董事會會議上決議不會就報告期向股東派付末期股息。

由於本公司組織章程大綱及細則賦予董事權力宣派中期股息,故中期股息的建議派付及宣派同時進行。因此,中期股息於建議派付及宣派時立即確認為負債。倘以股份溢價賬派付中期股息,則須於股東特別大會上獲得股東批准。該等中期股息獲股東批准及宣派後,方確認為負債。

### Foreign currencies

These financial statements are presented in RMB, which is the Company's functional currency. Each entity in the Group determines its own functional currency and items included in the financial statements of each entity are measured using that functional currency. Foreign currency transactions recorded by the entities in the Group are initially recorded using their respective functional currency rates prevailing at the dates of the transactions. Monetary assets and liabilities denominated in foreign currencies are translated at the functional currency rates of exchange ruling at the end of the reporting period. Differences arising on settlement or translation of monetary items are recognised in profit or loss.

Non-monetary items that are measured in terms of historical cost in a foreign currency are translated using the exchange rates at the dates of the initial transactions. Non-monetary items measured at fair value in a foreign currency are translated using the exchange rates at the date when the fair value was measured. The gain or loss arising on translation of a non-monetary item measured at fair value is treated in line with the recognition of the gain or loss on change in fair value of the item (i.e., translation difference on the item whose fair value gain or loss is recognised in other comprehensive income or profit or loss is also recognised in other comprehensive income or profit or loss, respectively).

In determining the exchange rate on initial recognition of the related asset, expense or income on the derecognition of a non-monetary asset or non-monetary liability relating to an advance consideration, the date of initial transaction is the date on which the Group initially recognises the non-monetary asset or non-monetary liability arising from the advance consideration. If there are multiple payments or receipts in advance, the Group determines the transaction date for each payment or receipt of the advance consideration.

### 外幣

該等財務報表以人民幣呈列，而人民幣為本公司的功能貨幣。本集團旗下各實體釐定其各自的功能貨幣，而各實體的財務報表所載項目均以該功能貨幣計量。本集團旗下實體記錄的外幣交易初始以交易當日現行各自功能貨幣匯率記錄。以外幣計值的貨幣資產及負債按報告期末的功能貨幣匯率換算。結算或換算貨幣項目產生的差額於損益中確認。

以歷史成本計量並以外幣計值的非貨幣項目使用首次交易當日的匯率換算。按公平值計量並以外幣計值的非貨幣項目使用計量公平值當日的匯率換算。換算按公平值計量的非貨幣項目產生的收益或虧損的處理方式，與有關項目公平值變動的收益或虧損的確認方式一致(即公平值收益或虧損於其他全面收益或損益中確認的項目的換算差額，亦會分別於其他全面收益或損益中確認)。

為釐定有關預付代價的終止確認非貨幣資產或非貨幣負債的相關資產、開支或收入於初始確認時的匯率，初始交易日期為本集團初始確認預付代價產生的非貨幣資產或非貨幣負債的日期。倘有多項預付或預收款項，則本集團釐定每項預付或預收代價的交易日期。

### Foreign currencies (Continued)

The functional currencies of certain overseas subsidiaries are currencies other than RMB. As at the end of the reporting period, the assets and liabilities of these entities are translated into RMB at the exchange rates prevailing at the end of the reporting period and their profit or loss is translated into RMB at the weighted average exchange rates for the year.

The resulting exchange differences are recognised in other comprehensive income and accumulated in the exchange fluctuation reserve. On disposal of a foreign operation, the component of other comprehensive income relating to that particular foreign operation is recognised in profit or loss.

## 3. Significant Accounting Estimates

The preparation of the Group's financial statements requires management to make judgements, estimates and assumptions that affect the reported amounts of revenues, expenses, assets and liabilities, and their accompanying disclosures, and the disclosure of contingent liabilities. Uncertainty about these assumptions and estimates could result in outcomes that could require a material adjustment to the carrying amounts of the assets or liabilities affected in the future.

### Judgements

#### Revenue recognition

To determine the timing of revenue recognition, the Group applies judgements in determining the point in time at which customers obtains control of promised pharmaceuticals and the Group satisfies the performance obligations. Depending on the nature and terms of the agreements, the Group may recognise revenue when the pharmaceuticals inspection report is obtained or when pharmaceuticals are received by customers.

### Estimation uncertainty

The key assumptions concerning the future and other key sources of estimation uncertainty at the end of the reporting period, that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year, are described below.

### 外幣(續)

若干海外附屬公司的功能貨幣為人民幣以外的貨幣。於報告期末，該等實體的資產及負債均按報告期現行匯率換算為人民幣，而其損益則按年內的加權平均匯率換算為人民幣。

因此產生的匯兌差額於其他全面收益確認，並於匯兌波動儲備累計。於出售海外業務時，與該海外業務相關的其他全面收益成份於損益確認。

## 3. 重要會計估計

編製本集團財務報表須管理層作出判斷、估計及假設，而該等判斷、估計及假設影響收益、開支、資產及負債的呈報金額及隨附披露，以及有關或然負債的披露。該等假設及估計的不確定因素可導致日後須對受影響資產或負債的賬面值進行重大調整。

### 判斷

#### 收益確認

為釐定確認收益的時間，本集團於釐定客戶取得所承諾藥品的控制權及本集團達成履約責任的時間點時應用判斷。根據協議的性質及條款，本集團或於取得藥品檢驗報告或客戶收取藥品時確認收益。

### 估計不確定因素

於報告期末關於未來的主要假設及估計不確定因素的其他主要來源具有導致下一財政年度內資產及負債賬面值須作出重大調整的重大風險，論述如下。

#### Estimation uncertainty (Continued)

##### *Provision for expected credit losses on trade receivables*

The Group uses a provision matrix to calculate ECLs for trade receivables. The provision rates are based on days past due for groupings of various customer segments that have similar loss patterns (i.e., by customer type and rating).

The provision matrix is initially based on the Group's historical observed default rates. The Group will calibrate the matrix to adjust the historical credit loss experience with forward-looking information. For instance, if forecast economic conditions (i.e., gross domestic product) are expected to deteriorate over the next year which can lead to an increased number of defaults, the historical default rates are adjusted. At each reporting date, the historical observed default rates are updated and changes in the forward-looking estimates are analysed.

The assessment of the correlation among historical observed default rates, forecast economic conditions and ECLs is a significant estimate. The amount of ECLs is sensitive to changes in circumstances and forecast economic conditions. The Group's historical credit loss experience and forecast of economic conditions may also not be representative of a customer's actual default in the future. The information about the ECLs on the Group's trade receivables is disclosed in note 18 to the financial statements.

##### *PRC corporate income tax ("PRC CIT") and Hong Kong corporate income tax ("HK CIT")*

The Group's operating subsidiaries in Mainland China are subject to PRC CIT and the operating subsidiary in Hong Kong is subject to Hong Kong CIT. As a result of the fact that certain matters relating to PRC CIT and HK CIT have not been confirmed by the relevant local tax authorities, objective estimates based on currently enacted tax laws, regulations and other related policies are required in determining the provision for PRC CIT and HK CIT to be made. Where the final tax outcome of these matters is different from the amounts originally recorded, the differences will impact the income tax expense and tax provision in the period in which the differences realise. The carrying amount of tax payable as at 31 December 2020 was RMB21,999,000 (31 December 2019: RMB11,361,000).

#### *Net realisable value of inventories*

Net realisable value of inventories is the estimated selling price in the ordinary course of business, less estimated costs to be incurred to completion and disposal. These estimates are based on the current market condition and the historical experience of selling products of a similar nature. Management reassesses these estimates at the end of each reporting period. The carrying amount of inventories as at 31 December 2020 was RMB242,561,000 (31 December 2019 (restated): RMB259,266,000) and the impairment provision for inventories for the year ended 31 December 2020 was RMB3,248,000 (2019: nil) (note 7).

#### *Deferred tax assets*

Deferred tax assets are recognised for all deductible temporary differences and unused tax losses to the extent that it is probable that sufficient taxable profit will be available against which the deductible temporary differences and unused tax losses can be utilised based upon the likely timing and level of future taxable profits together with future tax planning strategies. The carrying amount of deferred tax assets at 31 December 2020 was RMB646,000 (31 December 2019: RMB721,000). Further details are given in note 16 to the financial statements.

#### *Impairment of non-financial assets*

The Group assesses whether there are any indicators of impairment for all non-financial assets at the end of each reporting period. Non-financial assets with definite lives are tested for impairment when there are indicators that the carrying amounts may not be recoverable. An impairment exists when the carrying value of an asset or a cash-generating unit exceeds its recoverable amount, which is the higher of its fair value less costs of sell and its value in use. The calculation of the fair value less costs of disposal is based on available data from binding sales transactions in an arm's length transaction of similar assets or observable market prices less incremental costs for disposing of the asset. When value-in-use calculations are undertaken, management must estimate the expected future cash flows from the asset or cash-generating unit and choose a suitable discount rate in order to calculate the present value of those cash flows.

As of 31 December 2020, no deferred tax liability has been recognised for withholding taxes that would be payable on the unremitted earnings that are subject to withholding taxes of the Group's subsidiaries established in Mainland China. In the opinion of the Directors, it is not probable that these subsidiaries will distribute such earnings in the foreseeable future after their assessment based on factors which included the dividend policy, the level of working capital required for the Group's operations and the expansion of the Group's operations in Mainland China. The aggregate amount of temporary differences associated with investments in subsidiaries in Mainland China for which deferred tax liabilities have not been recognised totalled approximately RMB62,851,000 (2019: RMB25,259,000).

According to the Rules for the Implementation of Foreign-funded Enterprise Law of the PRC and articles of association of Sichuan Sinco Pharmaceuticals, Sinco Shanghai and Qingdao Yusheng, they are required to allocate 10% of their profit after tax in accordance with PRC GAAP to the statutory reserve fund (the "SRF") until such reserve reaches 50% of their respective registered capital.

The SSR and the SRF are non-distributable except in the event of liquidation and subject to certain restrictions set out in the relevant PRC regulations. They can be used to offset accumulated losses or capitalised as paid-up capital.

**(d) Share option reserve**

The share option reserve comprises the fair value of share options granted which are yet to be exercised, as further explained in the accounting policy for share-based payments in note 2.5 to the financial statements. The Group does not enter into any hedging transactions to manage the potential fluctuation in foreign currencies. Management monitors the Group's foreign currency exposure and will consider hedging significant foreign currency exposure when the need arises.
