COMPANY PROFILE

公司簡介

China Financial Leasing Group Limited (Stock Code: 2312, “CFLG” or the “Company”, with its subsidiaries, collectively the “Group”) is an investment company. Incorporated in the Cayman Islands, the Company’s shares have been listed on The Stock Exchange of Hong Kong Limited (the “Stock Exchange”) since October 2002.

CFLG strives to create value for its shareholders, leveraging on favourable market conditions. With strong government industry support, unique investment approach, and in-depth knowledge of the investment market, CFLG would remain highly adaptive to market conditions and would continue to look out for opportunities in potential sectors.

CHAIRMAN'S STATEMENT

Dear Shareholders,

The board (the "Board") of directors (the "Directors") is pleased to present you with the 2020 Annual Report of China Financial Leasing Group Limited (the "Company"), with its subsidiaries (collectively the "Group") for the year ended 31 December 2020.

During the year of 2020, the market sentiment was affected by (i) the COVID-19 pandemic; and (ii) the unclear political environment along the world. Hang Seng Index fluctuated between 21,000 to 29,000 level, recorded a decrease of approximately 3% throughout the year of 2020.

PRC ECONOMY

The People's Republic of China's (the "PRC") economy has recorded a positive economic growth of 2.3% in 2020, compared with 6.1% in 2019, which was a rare success among major economies. The PRC government successfully handled the COVID-19 pandemic by taking vigorous action, restored the economy activities much earlier compared to other countries, and recorded a satisfying growth in the last quarter of 2020.

The COVID-19 pandemic made a huge impact to the world economy, driven down the demand of both finished and semi-finished products significantly. As a result, export of the PRC was facing tremendous pressure. On top of that, the unstable political environment along the world, especially the tension between the PRC and the Western countries created wide range of uncertainty to the PRC's economy.

In order to alleviate the external pressure on the PRC's economy, Conference of the Politburo of the Chinese Communist Party ("PCCP") held in July 2020 emphasized the importance of sustainable economic development and promote the internal cycle to achieve economic growth without bearing unexpected external risk.

董事(「董事」)會(「董事會」)欣然向閣下呈報中國金融租賃集團有限公司(「本公司」)及其附屬公司(統稱「本集團」)截至二零二零年十二月三十一日止年度之二零二零年年報。

於二零二零年，市場氣氛受到(i)新型冠狀病毒疫情；及(ii)世界政治環境不明朗所影響。於二零二零年，恆生指數在21,000點至29,000點之間波動，全年錄得約3%的降幅。

中國經濟

中華人民共和國(「中國」)經濟於二零二零年錄得2.3%的正增長，而二零一九年則為6.1%，這在主要經濟體中是罕見的成功。中國政府採取有力行動，成功地應對新型冠狀病毒疫情，恢復經濟活動的時間較其他國家更早，並於二零二零年最後一個季度取得了令人滿意的增長。

新型冠狀病毒對世界經濟產生了巨大影響，極大地降低了成品及半成品的需求。因此，中國的出口面臨著巨大的壓力。除此之外，世界政治環境的不穩定，特別是中國與西方國家之間的緊張關係，給中國經濟帶來廣泛的不確定性。

為緩解中國經濟面臨的外部壓力，於二零二零年七月召開的中國共產黨中央政治局(「中共中央政治局」)會議強調了經濟可持續發展的重要性，並推動內部循環，以實現經濟增長而不承擔意外的外部風險。

Furthermore, on the 3rd Conference of The 13th National People's Congress of the PRC, the PRC prime minister stated there will not be a target set for the PRC's gross domestic product ("GDP"), which was the first time since the PRC first defined it in 1994. Looking forward to the future, the severity of COVID-19 pandemic and the vaccination rate are expected to be important factors to the PRC's economic policy.

UNITED STATES AND EUROPEAN ECONOMY

The real GDP growth in the United States of America (the "United States") decreased by 3.5% in 2020 compared with 2.2% increase in 2019, the rapid deceleration in real GDP growth rate primarily reflected decelerations in non-residential fixed investment and personal consumption expenditures, which was believed to be highly related to the severeness of COVID-19 pandemic in the United States. Moreover, the Federal Reserve had announced in 2020 that they will not hike the rate until a steadily inflation rate is achieved in the future in order to stimulate the economy in the United States.

The European Central Bank (the "ECB") not only continued the negative territory and debt-buying programme from 2019, but also cancelled the 750 billion Euro limit in the debt-buying programme in March 2020 in order to counter the impact brought by the COVID-19 pandemic.

The eurozone economic growth was negative 7.4%, which was much worse than the ECB expected in 2019.

此外，中國總理於中國第十三屆全國人民代表大會第三次會議上表示，將不會為中國的國內生產總值（「國內生產總值」）設定目標，這是自一九九四年中國首次確定該目標以來首次。展望未來，新型冠狀病毒疫情的嚴重程度及疫苗接種率將成為影響中國經濟政策的重要因素。

美國及歐洲經濟

美利堅合眾國（「美國」）的實際國內生產總值增速於二零二零年下降3.5%，而二零一九年則增長2.2%，實際國內生產總值增長率快速下降主要反映非住宅固定投資及個人消費支出的下降，據信，這與美國嚴重的新型冠狀病毒疫情高度相關。此外，美聯儲於二零二零年宣佈，為刺激美國經濟，在未來實現穩定通脹率之前將不會加息。

歐洲中央銀行（「歐洲央行」）不僅從二零一九年起繼續實施負數範圍利率及債務購買計劃，並於二零二零年三月取消債務購買計劃7,500億歐元的限額，以應對新型冠狀病毒疫情帶來的影響。

歐元區經濟增長率為負7.4%，遠低於歐洲央行於二零一九年的預期。

PROSPECT

The COVID-19 pandemic is expected to be gradually passed as the vaccination rate is anticipated to increase in 2021. It is believed that vaccination rate will become an important index of the world to determine the economic growth in 2021. At the same time, central banks are expected to continue the loosen monetary policy to stimulate the economic growth and support the capital market.

Given the uncertainties and expectations on the global economy, the Group will maintain cautious management of the investment portfolio. The Group will continue to explore investment opportunities to maximize the shareholders' return.

BUSINESS REVIEW

During the year ended 31 December 2020, China Financial Leasing Group Limited (the “Company”) with its subsidiaries (collectively the “Group”) was mainly engaged in short to medium term capital appreciation by investing in a diversified portfolio of investments in listed and unlisted securities.

Global economy declined severely due to the COVID-19 pandemic. Measures to encounter the transmission of the virus severely damaged the real economy activities in the world. Hang Seng Index recorded its lowest price in March 2020, which was approximately 25% lower than 2019. Although the central banks enhanced their loosening monetary policies in 2020 to support the economy, Hang Seng Index still recorded a loss of approximately 3.4% after recovery. The realised losses and unrealised gains (2019: unrealised losses) on financial assets at fair value through profit or loss (“FVTPL”) for the year ended 31 December 2020 are approximately HK\$54,067,000 (2019: HK\$23,854,000) and HK\$39,953,000 (2019: HK\$23,609,000) respectively.

During the year, the Group disposed of the entire issued share capital in Peaceful Gain Limited (“Peaceful Gain”) at a cash consideration of approximately HK\$13,000,000. Peaceful Gain is holding 3% of the registered capital of 深圳聯合能源控股有限公司 through its indirect wholly-owned subsidiary. The Group recorded a gain on disposal of approximately HK\$1,206,000 with a gain of release of foreign currency translation reserve of approximately HK\$1,134,000.

業務回顧

截至二零二零年十二月三十一日止年度，中國金融租賃集團有限公司（「本公司」）及其附屬公司（統稱「本集團」）主要業務為透過多元化投資組合，投資於上市及非上市證券，以獲取短中期資本升值。

由於新型冠狀病毒的疫情持續蔓延，全球經濟嚴重下滑。應對病毒傳播的措施嚴重損害世界實體經濟活動。恒生指數於二零二零年三月創最低價，較二零一九年下跌約25%。儘管各國央行於二零二零年加強了寬鬆貨幣政策以支持經濟，但恒生指數於經濟復蘇後仍錄得約3.4%的跌幅。截至二零二零年十二月三十一日止年度，透過損益按公平值計算（「透過損益按公平值計算」）之財務資產之已變現虧損及未變現收益（二零一九年：未變現虧損）分別約為54,067,000港元（二零一九年：23,854,000港元）及39,953,000港元（二零一九年：23,609,000港元）。

年內，本集團以現金代價約13,000,000港元出售利和有限公司（「利和」）的全部已發行股本。利和通過其間接全資附屬公司持有深圳聯合能源控股有限公司註冊資本的3%。本集團錄得出售收益約1,206,000港元，包含解除外幣換算儲備收益約1,134,000港元。

OUTLOOK

The International Monetary Fund revised up the global growth for 2021 from 5.2% to 5.5%, the upward revision reflects expectations of a vaccine-powered strengthening of activity later in the year and additional policy support in a few large economies. The global growth would be dependent on access to medical interventions, effectiveness of policy support, exposure to cross-country spillovers, and structural characteristics entering the crisis. Since Hong Kong market is expected to remain volatile in 2021, the Group will remain cautious on the stock market and the global market environment. The Group will monitor the market movement closely and explore investment opportunities in order to enhance the investment return for shareholders of the Company.

FINANCIAL REVIEW

As at 31 December 2020, the carrying value of the Group's listed equity investments was approximately HK\$74,514,000 (2019: HK\$68,867,000) while carrying value of the Group's unlisted equity investment was nil (2019: HK\$12,270,000).

The Group recorded sales proceeds from disposals of trading listed equity securities of approximately HK\$65,477,000 (2019: HK\$90,860,000) for the year ended 31 December 2020. The realised losses and unrealised gains (2019: unrealised losses) on financial assets at fair value through profit or loss for the year ended 31 December 2020 were approximately HK\$54,067,000 (2019: HK\$23,854,000) and HK\$39,953,000 (2019: HK\$23,609,000) respectively. Loss for the year was approximately HK\$19,807,000 (2019: HK\$65,683,000) which was mainly attributable to the operating expenses and equity investments losses. During the year, the deposit received from the yacht buyer of HK\$2,550,000 was forfeited and recognised as other income by the Group.

展望

國際貨幣基金組織已將二零二一年全球經濟增長預測由5.2%上調至5.5%，上調反映隨著疫苗接種計劃的推行，加上一些大型經濟體將提供更多的政策支持，預計將有助提振今年較後時間的經濟活動。全球增長將取決於獲得醫療干預的機會、政策支持的有效性、跨國溢出風險敞口及進入危機的結構性特徵。由於預計二零二一年香港市場仍將震蕩，本集團對股市及全球市場環境仍將保持審慎態度。本集團將密切監察市場走勢，尋求投資機會，以提高本公司股東的投資收益。

財務回顧

於二零二零年十二月三十一日，本集團上市股本投資之賬面值約為74,514,000港元（二零一九年：68,867,000港元）及本集團非上市股本投資之賬面值約為零（二零一九年：12,270,000港元）。

本集團於截至二零二零年十二月三十一日止年度出售上市股本證券錄得出售款項約為65,477,000港元（二零一九年：90,860,000港元）。截至二零二零年十二月三十一日止年度，透過損益按公平值計算之財務資產之已變現虧損及未變現收益（二零一九年：未變現虧損）分別約為54,067,000港元（二零一九年：23,854,000港元）及39,953,000港元（二零一九年：23,609,000港元）。本年度之虧損約為19,807,000港元（二零一九年：65,683,000港元），虧損主要由於營運開支以及股本投資虧損所致。於年內，從遊艇買家收取的已收按金2,550,000港元予以沒收，並由本集團確認為其他收入。

The net fair value losses on listed investments and fair value loss on unlisted investment amounted to approximately HK\$14,033,000 and HK\$81,000 respectively for the year ended 31 December 2020.

For the listed investments held as at 31 December 2020, the net fair value losses attributable to realised losses and unrealised gains were approximately HK\$54,067,000 and HK\$40,034,000 respectively. For those listed investments held but were sold during the year ended 31 December 2020, the net fair value losses attributable to realised losses and unrealised gains were approximately HK\$32,498,000 and HK\$20,615,000 respectively.

For the unlisted investment held during the year, the fair value loss attributable to unrealised loss was approximately HK\$81,000.

(a) Hing Ming

The Investment Committee of the Company (“Investment Committee”) noted that Hing Ming acquired additional tower cranes in order to capture the market demand of rental services of tower crane and meet the needs of customers. It retained technicians and sales person in order to support operation in the tower crane rental business and diversify Hing Ming income stream.

The Investment Committee considered that Hing Ming acquired new motors and other necessary components for replacement of old temporary suspended working platforms, which would strengthen the market position in the suspended working platform industry.

截至二零二零年十二月三十一日止年度，於上市及非上市投資分別約為公平值虧損淨額14,033,000港元及公平值虧損81,000港元。

於二零二零年十二月三十一日之所持有上市投資，已變現虧損及未變現收益所佔公平值虧損淨額分別約為54,067,000港元及40,034,000港元。而截至二零二零年十二月三十一日止年度所持但於期內出售之上市投資，已變現虧損及未變現收益所佔公平值虧損淨額分別約為32,498,000港元及20,615,000港元。

於年內所持有之非上市投資，未變現虧損所佔公平值虧損約為81,000港元。

(a) 興銘

本公司投資委員會（「投資委員會」）注意到為捕捉塔式起重機租賃服務的市場需求及滿足客戶需求，興銘購置額外的塔式起重機，以及挽留技術及銷售人員，以支持塔式起重機租賃業務的營運，使其收入來源多元化。

投資委員會認為興銘購置新的馬達及其他所需零部件，以更換舊的臨時吊船，鞏固興銘於吊船行業的市場地位。

(b) ISP

The Investment Committee noted that the revenue of ISP decreased because there were less projects being awarded to the Group in the integrated sales of sound and communication segment.

The Investment Committee considered that ISP accepted more maintenance and other service contracts for sound and communications system solutions as part of the effort to maintain direct stakeholder relationships with institutions in the healthcare and education sectors. It intended to strengthen the team by employing technical expertise to remain innovative in the integrated systems solutions.

(c) RMH

The Investment Committee noted that the revenue of RMH decreased mainly due to the outbreak of COVID-19 infection in Singapore and worldwide leading to the implementation of various travel restriction and social distancing measures in Singapore posing operational challenges for clinics, the number of patient visits was decreased.

The Investment Committee considered that RMH started operation at both the specialist and aesthetic centre in Hong Kong with encouraging initial result. It incorporated unique feature of immediate and sustained protection from the COVID-19 virus. This has contributed the revenue and mitigated the drop in revenue at clinics due to the restriction imposed by the circuit breaker period.

(b) ISP

投資委員會注意到ISP收入減少主要由於音響及通訊分部綜合服務中獲授的項目減少所致。

投資委員會認為ISP已接獲更多音響及通訊系統解決方案維護及其他服務合約，致力維持與醫療及教育行業機構的直接持份者關係。ISP計劃通過聘請工程師加強我們的團隊實力，以便提供創新的集成系統解決方案。

(c) 德斯

投資委員會注意到德斯收益減少主要由於新加坡及全球爆發新型冠狀病毒感染，導致新加坡實施多種旅行限制及保持社交距離措施，這對診所的營運構成挑戰，求診患者人數減少。

投資委員會認為德斯於香港的專科及美容中心開始營運，初步業績令人鼓舞。該產品融合了對新型冠狀病毒的即時及持續保護的獨特功能。這貢獻了收益，並減輕了由於阻斷措施期間所實施的限制而導致診所收益的下跌。

(d) Miji International

The Investment Committee noted that Miji International reduced the adverse impact of COVID-19 and stimulated its sales performance. The close down of non-profitable consignment stores upon expiry of lease, the delay of opening new consignment stores, the offer of more attractive incentivized to its customers and the increase in the number of product exhibited and other marketing evented to enhance the recognition of its brands and products.

The Investment Committee considered that it would take time for the consumers to regain confidence and the retail industry to fully recover. Miji International would remain prudent on business development and continued to implement appropriate measures to improve its sales performance. It would carefully study the needs and preference of consumers and offered a wider range of products and services.

(e) WAC

The Investment Committee noted that the revenue of the WAC increased which was mainly due to the increase in revenue contribution from structural and geotechnical engineering consultancy service of construction of new properties and e-commerce retail online platform.

The Investment Committee considered that WAC was focusing on developing business opportunities from existing clients and was looking for increasing the types of consultancy services to be provided to various clients. WAC will continually expand its market share by securing more engineering consultancy service contracts.

(f) C&N

The Investment Committee noted that the revenue of the C&N decreased, the decrease was mainly attributable to the declining global trade economy with the emergence of COVID-19, which greatly decreased trading volume and closure of ports around the world, it affected the performance of C&N.

(d) 米技國際

投資委員會注意到米技國際降低新型冠狀病毒的不利影響並刺激其銷售表現。關閉租約到期的不盈利代銷店、延遲新代銷店開業、向客戶提供更具吸引力的待遇及優惠以及增加產品展覽及其他市場推廣活動的次數，以提升其產品及品牌的認知度。

投資委員會認為，消費者恢復信心及零售業完全恢復仍需時日。米技國際將繼續審慎發展業務，及繼續實施適當措施改善銷售表現。米技國際將仔細研究消費者需求及偏好，並提供更加廣泛的產品及服務。

(e) WAC

投資委員會注意到WAC收益增加主要由於興建新物業及電子商務零售在線平台的結構及岩土工程顧問服務的收益貢獻增加所致。

投資委員會認為WAC專注於自現有客戶發現商機，並正尋求增加將提供予各種客戶的顧問服務類型。WAC會繼續爭取更多工程顧問服務合約，以擴大市場份額。

(f) 春能

投資委員會注意到春能收益減少，該減少主要由於新型冠狀病毒的出現導致全球貿易經濟下降，從而使貿易量顯著減少並使世界各地港口關閉，影響了春能的業績。

The Investment Committee considered that C&N continued to strive towards providing customers with timely delivery and storage of their containers, and increased service capacity through the acquisition of new vehicles and enhanced overall competitiveness and market share in Singapore.

(g) LHN

The Investment Committee noted that the increase in the revenue of LHN was mainly due to the increase in revenue from the residential properties under the space optimisation business, as well as the facilities management business.

The Investment Committee considered that taking into consideration the challenges affecting the overall operating environment as a result of the COVID-19 pandemic worldwide and fresh hopes of a gradual economic recovery in the coming year due to the news of COVID-19 vaccines reaching new milestones, LHN continued to focus on its efforts to acquire new and retained existing customers, it had business presence in while cautiously exploring new opportunities to expand its current business offerings.

(h) Future Bright Mining

The Investment Committee noted that the increase in the revenue of Future Bright Mining was mainly due to the exploration of new customers during the period. However, due to the outbreak of COVID-19, both production work and delivery of marble blocks were temporarily suspended in the first few months. As a result, the revenue for the period was adversely affected.

The Investment Committee considered that Future Bright Mining was actively exploring new customers by different ways including through the network of the senior management, it would increase product varieties and recognition through industry exchanges, it expected the business would have a stable growth in the coming years.

投資委員會認為春能繼續努力為客戶提供及時運送及儲存集裝箱服務，通過購買新車輛增加服務能力，加強整體競爭力及擴大於新加坡的市場份額。

(g) 賢能

投資委員會注意到賢能收益增加主要由於間優化業務項下住宅物業及設施管理業務的收益增加所致。

投資委員會認經考慮全球新型冠狀病毒疫情帶來的影響整體經營環境的挑戰，以及新型冠狀病毒疫苗取得新進展的新聞所帶來的經濟在來年逐步復甦的新希望，賢能繼續專注於努力取得新客戶及留住現有客戶，在保持業務存在的同時，審慎物色新機遇，以擴展其現有業務。

(h) 高鵬礦業

投資委員會注意到高鵬礦業收入增加主要由於期間內發掘新客戶。然而由於新型冠狀病毒爆發，大理石荒料的生產工作及交付於首幾個月內暫時停止。因此本期間內收入受到不利影響。

投資委員會認為高鵬礦業通過高級管理層網絡等不同方式積極開拓新客，以及透過行業交流增加產品種類及知名度，預計業務將於未來幾年穩定增長。

(i) National Investments

The Investment Committee noted that the loss of National Investments decreased which was mainly due to the decrease in loss on change in fair value of financial assets at fair value through profit or loss and it had successfully implemented the cost control plans during the period.

On 19 March 2020, National Investments received a winding up petition from an individual on the ground that National Investments was unable to pay its debts. On 8 February 2021, National Investments was ordered to be wound up by the High Court of Hong Kong pursuant to the provisions of the Companies (Winding Up and Miscellaneous Provisions) Ordinance (Chapter 32, Laws of Hong Kong). On the same date, trading in National Investments' shares has been suspended. The Investment Committee will monitor the update information published by National Investments.

(j) Wan Leader

The Investment Committee noted that the increase of the revenue of Wan Leader was mainly due to (i) the security screening services brought in additional revenue; (ii) the increase in the overall selling prices of air cargo spaces, which resulted from the limited supply of air cargo spaces, coupled with surging demand from customers.

The Investment Committee considered that benefiting from the opportunities of the increased demand in air cargo space amid the COVID-19 pandemic, it successfully secured air spaces at compatible prices for its customers. It's extensive network of airlines and other forwarders was able to meet the demands of its customers, and strengthen its competitiveness in the logistics industry.

(k) 聯合能源

The Investment Committee decided to dispose the investment of 聯合能源 during the year and seek for other potential investment opportunities.

(i) 國盛投資

投資委員會注意到國盛投資虧損減少主要由於透過損益按公平值計算之財務資產的公平值變動的虧損減少以及成功實施成本控制計劃所致。

於二零二零年三月十九日，國盛投資接獲一名個人提出的清盤呈請，國盛投資可能因無力償還債務。於二零二一年二月八日，香港高等法院根據《公司(清盤及雜項條文)條例》(香港法例第32章)的規定，下令對國盛投資進行清盤。於同日，國盛投資的股票交易被暫停。投資委員會將監察國盛投資發佈的最新信息。

(j) 萬勵達

投資委員會注意到萬勵達收益增加主要由於(i)安檢服務帶來額外收入；(ii)空運艙位的供應有限加上客戶需求大幅上升導致空運艙位的整體售價上升。

投資委員會認為萬勵達受惠於新型冠狀病毒疫情期間空運艙位需求殷切的機會，成功幫助客戶以適宜的價格取得空運艙位。萬勵達與航空公司及其他貨運代理的廣泛網絡能夠滿足客戶需求，以增強其於物流行業的競爭力。

(k) 聯合能源

投資委員會於年內決定出售聯合能源之投資並尋求其他潛在投資機會。

LIQUIDITY, FINANCIAL RESOURCES AND FUNDING

As at 31 December 2020, the Group maintained cash and cash equivalents of approximately HK\$120,000 (2019: HK\$862,000) which were mainly denominated in Hong Kong dollars. The Group will monitor the exposure and take prudent measures when necessary.

As at 31 December 2020, the gearing ratio for the Group was 5.36% (2019: 17.24%) which represents the ratio of the Group's total interest-bearing liabilities to the total equity of the Group.

As at 31 December 2020, the Group had net assets of approximately HK\$80,477,000 (2019: HK\$69,214,000). Except for the margin payable of approximately HK\$2,666,000 (2019: HK\$11,934,000) and borrowings of approximately HK\$1,650,000 (2019: Nil), the Group had no other borrowings or long-term liabilities as at 31 December 2020.

CAPITAL STRUCTURE

As at 31 December 2020, the Company's total issued shares was 1,927,649,882 (2019: 1,606,649,882) of HK\$0.02 each. The Group had no debt securities or other capital instruments as at 31 December 2020.

On 30 December 2019, the Company entered into a placing agreement with Orient Securities Limited ("Orient") as placing agent where Orient agreed to place on a best effort basis a maximum of 321,000,000 new shares of the Company ("Placing Share") of HK\$0.02 each at HK\$0.1 per Placing Share to at least six placees who were professional investors according to the definition of the Securities and Futures Ordinance. The intended and actual use of proceeds from the share placement was for general working capital of the Company and potential investments to be identified. The placing transaction was completed on 23 January 2020 and a total of 321,000,000 shares were issued. The gross and net proceeds were approximately HK\$32,100,000 and HK\$31,137,000 respectively. The net price was approximately HK\$0.097 per Placing Share.

EVENTS AFTER THE REPORTING PERIOD

The realised gains and unrealised losses on financial assets at FVTPL from changes in fair value on financial assets at FVTPL held as at 31 December 2020 to the date of approval of this Annual Report were amounted to approximately HK\$89,000 and HK\$12,568,000 respectively.

Except for above mentioned, there were no material events occurred after the financial report date.

MATERIAL ACQUISITION AND DISPOSAL OF SUBSIDIARIES

- (a) On 9 October 2020, the Group disposed of the entire issued share capital in China Financial Leasing Investments Limited at a cash consideration of approximately HK\$569,000.
- (b) On 15 September 2020, the Company entered into a share transfer agreement with an independent third party (the "Purchaser") to dispose of the entire issued share capital in Peaceful Gain at a cash consideration of approximately HK\$13,000,000 of which an amount of approximately HK\$9,000,000 shall be settled on or before 31 December 2020 and the remaining balance of approximately HK\$4,000,000 shall be settled on or before 30 June 2021.

On 31 December 2020, the Company entered into a supplementary agreement with the Purchaser to agree that the whole consideration of HK\$13,000,000 shall be settled on or before 30 April 2021. If the Purchaser is unable to settle the consideration on or before 30 April 2021, an independent guarantor will transfer a property located in the PRC to the Company or dispose of the property according to the Company's instructions. The transaction was completed on 31 December 2020.

Except for above mentioned, the Group has not made any material acquisition or disposal of subsidiaries during the year under review.

EMPLOYEE BENEFITS

As at 31 December 2020, the Group had 5 employees. Total employee benefits expenses (excluding Directors' emoluments) and Directors' emoluments for the year ended 31 December 2020 were approximately HK\$1,621,000 (2019: HK\$5,583,000) and HK\$1,698,000 (2019: HK\$1,700,000) respectively. For the year ended 31 December 2020, COVID-19 related government grants amounted to approximately HK\$538,000 have been offset adjust employee benefits expense. The remuneration policy of the Group is reviewed annually and employees are remunerated based on their performance, experience and the prevailing market practice. No Director or executive is involved in dealing with his own remuneration.

In addition to salary payments, the Group has participated in the Mandatory Provident Fund Scheme (the "MPF Scheme") in Hong Kong. The MPF Scheme is registered with the Mandatory Provident Fund Schemes Authority under the Mandatory Provident Fund Schemes Ordinance. The assets of the MPF Scheme are held separately from those of the Group in funds under the control of an independent trustee. Pursuant to the rules of the MPF Scheme, the Group and its employees are each required to make contributions to the MPF Scheme at 5% of each employee's monthly relevant income subject to a monthly maximum amount of HK\$1,500.

The Company maintains a share option scheme, pursuant to which share options are granted to selected directors, employees or other eligible participants of the Group, with a view to attract and retain quality personnel and to provide them with incentive to contribute to the business and operation of the Group. During the year, there were no share options exercised, granted, lapsed or cancelled.

CHARGES ON GROUP'S ASSETS

As at 31 December 2020, listed securities of approximately HK\$74,514,000 (2019: HK\$66,322,000) were pledged to secure margin payable. Except for above mentioned, there were no charges on the Group's assets.

PRINCIPAL RISKS AND UNCERTAINTIES

The Group is principally engaged in short to medium term capital appreciation by investing in a diversified portfolio of investments in listed and unlisted securities, which are exposed to certain market risks including price risk, credit risk, liquidity risk and interest rate risk. The details are set out in note 6 to the consolidated financial statements under the section headed “Financial Risk Management”.

FOREIGN EXCHANGE EXPOSURE

During the year, the Group’s exposures to foreign currencies mainly arises from its investments in financial assets denominated in RMB. The Group currently does not have any foreign currency hedging policy. However, the Group monitors foreign exchange exposure and will consider hedging significant foreign currency exposure should the need arise.

CONTINGENT LIABILITIES

During the year, there were no contingent liabilities noted by the Directors (2019: Nil).

SIGNIFICANT INVESTMENTS

As at 31 December 2020, the significant investments of the Group are included in the Management Discussion and Analysis under the section headed “Equity Investments”.

CHAIRMAN, VICE CHAIRMAN AND EXECUTIVE DIRECTOR

The major duties of the chairman of the Board are to provide leadership to the Board and spearhead overall corporate development and strategic planning. The vice chairman of the Board will assist the chairman for the management of the Board. Therefore, a clear division of responsibilities is in place and a balance of power and authority is ensured.

INDEPENDENT NON-EXECUTIVE DIRECTORS

The three independent non-executive Directors are persons of high caliber, with academic and professional qualifications, and extensive experience in several fields including accounting, financial, management, etc. With their extensive experience, they provide strong support towards the effective discharge of the duties and responsibilities of the Board.

All independent non-executive Directors have given their annual confirmation of independence to the Company, and the Company considered that they are independent under Rule 3.13 of the Listing Rules.

All independent non-executive Directors are not appointed for a specific term, but they are subject to retirement by rotation in accordance with the Articles.

- (iv) to develop, review and monitor the code of conduct and compliance manual (if any) applicable to employees and Directors; and

RISK MANAGEMENT AND INTERNAL CONTROL

The Board acknowledges its responsibility for overseeing the Group's risk management and internal control systems and reviewing their effectiveness at least annually.

As a part of the Group's risk management and internal control systems, appropriate policies and controls have been designed and established by the Group to ensure that assets are safeguarded against improper use or disposal, relevant rules and regulations are adhered to and complied with, reliable financial and accounting records are maintained in accordance with relevant accounting standards and regulatory reporting requirements, and key risks that may impact on the Group's performance are appropriately identified and managed.

However, the risk management and internal control systems can only provide reasonable and not absolute assurance against material misstatement or loss, as they are designed to manage, rather than eliminate the risk of failure to achieve business objectives.

The Group has adopted a three-tier risk management approach to identify, evaluate and manage significant risks. The operating units of the Group, as a first line of defence, identify, evaluate, mitigate and monitor the risks, and report such risk management activities to the Group's management on a regularly basis. The Group's management, as the second line of defence, provides support to the operating units and ensure that the significant risks are properly managed and within the acceptable range and report the situation to the Board at each regularly scheduled meeting. The Board, as the final line of defence, conducts an annual review of the overall effectiveness of the Group's risk management and internal control systems.

The Group does not have an internal audit function and is currently of the view that there is no immediate need to set up an internal audit function within the Group in light of the size, nature and complexity of the Group's business. It was decided that the Board would be directly responsible for internal control of the Group and for reviewing its effectiveness. Procedures have been designed for safeguarding assets against unauthorised use or disposition, ensuring the maintenance of proper accounting records for the provision of reliable financial information for internal use or for publication, and ensuring compliance with applicable laws, rules and regulations. The situation will be reviewed from time to time.

During the year, the Board has reviewed and discussed the risk management and internal control systems and no material internal control failings, weaknesses or deficiencies have been identified during the course of the review.

Based on the above, the Board were not aware of any areas of concern that would have a material impact on the Group's financial position or results of operations and considered the risk management and internal control systems to be generally effective and adequate including the adequacy of resources, staff qualifications and experience, training programs and budget of the accounting, internal control and financial reporting functions.

With respect to the monitoring and disclosure of inside information, the Group has formulated its guidelines, with an aim to ensure that the insiders abide by the confidentiality requirement and fulfill the disclosure obligation of the inside information.

The Group endeavours to create sustainable growth and long-term value for its stakeholders, who mainly comprise the Group’s employees and investors. The Group continues to interact with the Group’s stakeholders on ongoing basis in order to understand their views and collect their feedback. The communication channels with stakeholders include annual general meeting and staff meetings, etc.

ENVIRONMENTAL

The Group is committed to acting in an environmentally responsible manner through its office management and daily operation. The Group adheres to the principle of recycling and reducing, and implement green office practices to minimise the impact of businesses on the environment.

Below practices are being implemented by the Group for energy saving measure:

- (i) double-sided printing and copying, promoting using recycled paper and reducing energy consumption by switching off idle lightings and electrical appliance;
- (ii) maintain the temperature at 25.5°C, an optimal temperature for comfort and energy savings;
- (iii) staff is recommended to switch off the lights and air conditioning in the meeting room when it is not in use;
- (iv) widespread adoption of multi-function photocopiers (with printing, scanning and fax functions); and
- (v) promote paperless environment by encouraging the use of soft and electronic copy for the document instead of hard copy.

Being an investment company, the Group is also aware of the investment decisions and its potential impact to the environment. Should the opportunity arise, the Group would consider the risk of the projects and return dynamics as well as the positive environmental effects it will have.

環境

本集團於整個辦公室管理及日常營運過程中秉承對環境負責之態度。本集團堅守循環再用及減少使用的原則，並實踐綠色辦公室常規達至盡量減少公司對環境的影響。

以下是本集團已實施在節能方面的措施：

EMISSION

As a responsible corporate citizen, the Group is committed to protecting natural resources and the global environment. Our commitment to emission reduction, energy and resources conservation encompasses every aspect of the Group's operation, and the Group has complied with laws and regulation related to environmental protection. In light of the Group's business nature, the operation of the Group does not generate air, water or land pollutions or raise any significant environmental issues.

Electricity consumed by the Group in principle place of business is supplied by The Hongkong Electric Company, Limited. The electricity consumption by the Group was approximately 4,000 kWh.

Since the Group's business does not involve manufacturing activities, solid waste is mainly generated in daily office operations without generation of hazardous waste. The Group encourages employees to go paperless as much as possible by limiting print outs as well as communicating via e-mail as opposed to fax. Employees are also encouraged to re-use paper and conserve paper usage by printing double-sided to the extent practicable. During the year, the Group used a total of approximately 233,300 pieces of paper in its normal business operations of which approximately 211,500 pieces of paper were attributable to the printing of the financial statements and materials related to general meetings distributed to shareholders of the Company.

Regulatory compliance

During the year under review, the Group was not aware of any incidents of non-compliance with laws and regulations that have a significant impact on the Group relating to air and greenhouse gas emissions, discharges into water and land, and generation of hazardous and non-hazardous waste.

USE OF RESOURCES

The Group has undertaken various resources saving measures to demonstrate the efforts in efficient use of resources in the daily operations. Employees are encouraged to optimise resources to help the Group to minimise the impact on the environment and natural resources e.g. use of public transportation. The Group disposed the yacht and private motor vehicles that run on gasoline and petrol during the year. During the year, none of gasoline and petrol was used for the yacht and private motor vehicles. Although non-significant amounts of water is consumed through the business activities, the Group also encourages water saving by driving water-saving habits and posting green messages in the workplace to remind the employees to use water effectively.

THE ENVIRONMENTAL AND NATURAL RESOURCES

Since the Groups core operations are confined to the office environment, the impact of the Group on the environment and natural resources is not significant. It is mainly attributed to the use of electricity, water and papers in the office. During the year, the Group set a number of measures to reduce the use of resources (refers to above sections “Environmental” and “Emission” for details). In order to have further reductions on the environmental impact and use of natural resources, the Group will continue to make assessment and minimise the environmental impact.

EMPLOYMENT

The Group provides the employees with fair and competitive remuneration to motivate them. The Group may also at its sole discretion, to grant share options to employees as a long-term incentive aiming to motivate employees pursuing Group’s goal and objectives. Employees and Directors can subscribe shares of the Company based on their performance and contribution to the Group.

資源利用

本集團已進行各種資源節約措施，以證明本集團於日常營運中有效利用資源方面的努力。本集團鼓勵僱員優化使用資源(如使用公共交通工具)以幫助本集團將對環境及自然資源的影響降到最低。年內，本集團已出售使用柴油及汽油的遊艇及私人汽車。年內，本集團的遊艇及私人汽車並無使用柴油及汽油。儘管業務活動消耗水量並不顯著，但本集團亦鼓勵節約用水，推行節水習慣及在工作場所張貼環保標語以提醒僱員有效用水。

DEVELOPMENT AND TRAINING

The Group believes two-way communication is crucial to employee engagement that drives job satisfaction and high productivity. The Group has provided a platform for quality communication between employees and management. Promotion is executed on a fair and open basis and any form of discrimination is not tolerated. Competent employees will be considered for internal promotion in recognition of their efforts and contribution when there is a job vacancy.

HEALTH AND SAFETY

The Group is subject to the health and safety requirements of Hong Kong including, but not limited to, the Occupational Health and Safety Ordinance. The Board believes that it is in compliance with such requirements for the year ended 31 December 2020. The Group's liability to the employees is covered by insurance, which are required by law to take out. The Board further confirmed that there was no material violation of currently applicable safety regulations nor were there any material employee safety issues involving the Group. During the year ended 31 December 2020, no fines or penalties for non-compliance of safety laws and regulations were imposed on the Group.

LABOUR STANDARD

No child or forced labour were employed in the Group's operations during the year which was in compliance with the Employment Ordinance (Chapter 57 of the Laws of Hong Kong) in terms of employment management.

The Group lists specific requirements to hire the most suitable candidate. All resume, original identification card, original certificate should be first checked during interview. The Group may also contact candidate's preceded employer for reference.

The Group adopted a Board diversity policy under which the Board composition includes members with different skills, industry knowledge and experience, education, background and other qualities without discrimination.

LAWFUL GOVERNANCE

The Group has complied with the applicable employment-related laws and regulations currently in force in Hong Kong (including but not limited to those relating to compensation and dismissal, recruitment and promotion, working hours, rest periods, equal opportunity diversity, anti-discrimination, other benefits and welfare), as well as the Group does not employ staffs who are below 18 years of age. The Group provides such rights and benefits to the employees which are no less than those required statutorily. No employees are paid less than the minimum wage specified by the Minimum Wage Ordinance (Chapter 608 of the Laws of Hong Kong). Monthly salary payments are made on time according to respective employment contracts.

SUPPLY CHAIN MANAGEMENT AND PRODUCT RESPONSIBILITY

The Company is an investment company. During the year ended 31 December 2020, the Group mainly engages in investments in listed and unlisted equity securities. It does not have any major supplier of products, raw materials or services.

ANTI-CORRUPTION

With integrity being a core part of the Group's business ethics, the Group strictly complies with the laws and regulations regarding bribery, extortion, fraud and money laundering, such as the Prevention of Bribery Ordinance (Chapter 201 of the laws of Hong Kong). To maintain high standards of corporate governance, the Group fulfills the commitment through abiding by anti-corruption policies and guidelines, such as acceptance of gifts and conflicts of interest. To live up to the anti-corruption commitment, whistleblowing policy is also formulated by the Group. The employees of the Group are encouraged to report any suspected misconduct and violation of rules. Investigation work for whistleblowing reports is handled with strict confidentiality under all circumstances to preserve anonymity.

SHARE OPTION SCHEME

The Company adopted a new share option scheme (the “SO Scheme”) on 12 January 2012. The purpose of the SO Scheme is to enable the Company to grant options to eligible participants as incentives or rewards for their contribution to the Group. Eligible participants of the SO Scheme include, without limitation, any persons who are employees, officers, agents, consultants or representatives of the Group. The SO Scheme became unconditional upon The Stock Exchange of Hong Kong Limited (the “Stock Exchange”) granting on 13 January 2012 the approval of the listing of and the permission to deal in the shares falling to be issued pursuant to the exercise of any options to be granted under the SO Scheme and, unless otherwise cancelled or amended, shall remain in force for 10 years from the adoption date.

The maximum number of shares issuable under share options to each eligible participant in the SO Scheme and the other scheme (if any) in any 12-month’s period shall not exceed 1% of the total number of issued shares of the Company for the time being. Any further grant of share options to any eligible participant in excess of this limit is subject to shareholders’ approval in a general meeting. The total number of shares which may be issued upon exercise of all share options to be granted under the SO Scheme and the other schemes (if any) must not in aggregate exceed 10% of the shares of the Company in issue (the “10% Limit”) as at 12 January 2012, being the date of passing the resolution by the shareholders at the extraordinary general meeting approving and adopting the SO Scheme. The Company may seek approval of its shareholders in a general meeting to refresh the 10% Limit at any time in accordance with the Rules Governing the Listing of Securities (the “Listing Rules”) on the Stock Exchange.

1. GENERAL INFORMATION

China Financial Leasing Group Limited (the “Company”) was incorporated in the Cayman Islands as an exempted company with limited liability under the Companies Law (2007 Revision) of the Cayman Islands. The address of its registered office is Cricket Square, Hutchins Drive, P.O. Box 2681, Grand Cayman KY1-1111, Cayman Islands. The address of its principal place of business is 11/F., Wui Tat Centre, 55 Connaught Road West, Hong Kong. The Company’s shares are listed on the Main Board of The Stock Exchange of Hong Kong Limited (the “Stock Exchange”).

The Company and its subsidiaries (collectively referred to as the “Group”) are principally engaged in short to medium term capital appreciation by investing in a diversified portfolio of investments in listed and unlisted securities on a general perspective. The principal activities of its subsidiaries are set out in note 19 to the consolidated financial statements.

2. BASIS OF PREPARATION

These consolidated financial statements have been prepared in accordance with all applicable Hong Kong Financial Reporting Standards (“HKFRSs”) issued by the Hong Kong Institute of Certified Public Accountants (the “HKICPA”). HKFRSs comprise Hong Kong Financial Reporting Standards (“HKFRS”); Hong Kong Accounting Standards (“HKAS”); and Interpretations. These consolidated financial statements also comply with the applicable disclosure provisions of the Rules Governing the Listing of Securities on the Stock Exchange and with the disclosure requirements of the Hong Kong Companies Ordinance (Cap. 622). Significant accounting policies adopted by the Group are disclosed below.

1. 一般資料

中國金融租賃集團有限公司(「本公司」)根據開曼群島公司法(二零零七年修訂版)於開曼群島註冊成立為獲豁免之有限公司。本公司之註冊辦事處及主要營業地點之地址分別為Cricket Square, Hutchins Drive, P.O. Box 2681, Grand Cayman KY1-1111, Cayman Islands及香港干諾道西55號會達中心11樓。本公司股份在香港聯合交易所有限公司(「聯交所」)主板上市。

本公司及其附屬公司(統稱「本集團」)主要從事全面投資於上市及非上市證券之多元化投資組合以達致短期資本升價，而附屬公司主要業務則載於綜合財務報表附註19。

2. 編製基準

4. SIGNIFICANT ACCOUNTING POLICIES

These consolidated financial statements have been prepared under the historical cost convention, unless mentioned otherwise in the accounting policies below (e.g. certain financial instruments that are measured at fair value).

The preparation of financial statements in conformity with HKFRSs requires the use of certain critical accounting estimates. It also requires management to exercise its judgement in the process of applying the Group's accounting policies. The areas where assumptions and estimates are significant to the consolidated financial statements are disclosed in note 5.

The significant accounting policies applied in the preparation of these consolidated financial statements are set out below.

(a) Consolidation

The consolidated financial statements include the financial statements of the Company and its subsidiaries made up to 31 December. Subsidiaries are entities over which the Group has control. The Group controls an entity when it is exposed, or has rights, to variable returns from its involvement with the entity and has the ability to affect those returns through its power over the entity. The Group has power over an entity when the Group has existing rights that give it the current ability to direct the relevant activities, i.e. activities that significantly affect the entity's returns.

When assessing control, the Group considers its potential voting rights as well as potential voting rights held by other parties. A potential voting right is considered only if the holder has the practical ability to exercise that right.

4. 重大會計政策

(a) 綜合

綜合財務報表包括本公司及其附屬公司截至十二月三十一日的財務報表。附屬公司指本集團有控制權的實體。當本集團承受或享有參與實體所得的可變回報，且有能力透過其對實體的權力影響該等回報時，則本集團控制該實體。當本集團的現有權力賦予其目前掌控有關業務(即大幅影響實體回報的業務)時，則本集團對該實體行使權力。

在評估控制權時，本集團會考慮其潛在投票權以及其他人士持有的潛在投票權。在持有人能實際行使潛在投票權的情況下，方會考慮其權利。

Subsidiaries are consolidated from the date on which control is transferred to the Group. They are de-consolidated from the date the control ceases.

The gain or loss on the disposal of a subsidiary that results in a loss of control represents the difference between (i) the fair value of the consideration of the sale plus the fair value of any investment retained in that subsidiary and (ii) the Company's share of the net assets of that subsidiary plus any remaining goodwill and any accumulated foreign currency translation reserve relating to that subsidiary.

Intragroup transactions, balances and unrealised profits are eliminated. Unrealised losses are also eliminated unless the transaction provides evidence of an impairment of the asset transferred. Accounting policies of subsidiaries have been changed where necessary to ensure consistency with the policies adopted by the Group.

In the Company's statement of financial position, an investment in a subsidiary is stated at cost less impairment loss, unless the investment is classified as held for sale (or included in a disposal group that is classified as held for sale).

附屬公司在控制權轉移至本集團之日綜合入賬，而在控制權終止之日起停止綜合入賬。

因出售附屬公司而導致失去控制權的盈虧指(i)出售代價公平值加上於該附屬公司保留的任何投資公平值與(ii)本公司應佔該附屬公司資產淨值加上與該附屬公司有關的任何餘下商譽及任何累計外幣換算儲備兩者間的差額。

集團內公司間之交易、結餘及未變現溢利均予以對銷。除非交易提供憑證顯示所轉讓資產出現減值，否則未變現虧損亦予以對銷。倘有需要，附屬公司之會計政策會作出調整，以確保符合本集團採納之政策。

(b) Foreign currency translation

(i) *Functional and presentation currency*

Items included in the financial statements of each of the Group's entities are measured using the currency of the primary economic environment in which the entity operates (the "functional currency"). The consolidated financial statements are presented in Hong Kong dollars, which is the Company's functional and presentation currency.

(ii) *Transactions and balances in each entity's financial statements*

Transactions in foreign currencies are translated into the functional currency on initial recognition using the exchange rates prevailing on the transaction dates. Monetary assets and liabilities in foreign currencies are translated at the exchange rates at the end of each reporting period. Gains and losses resulting from this translation policy are recognised in profit or loss.

Non-monetary items that are measured at fair value in foreign currencies are translated using the exchange rates at the dates when the fair values are determined.

When a gain or loss on a non-monetary item is recognised in profit or loss, any exchange component of that gain or loss is recognised in profit or loss.

(iii) Translation on consolidation

The results and financial position of all the Group entities that have a functional currency different from the Company's presentation currency are translated into the Company's presentation currency as follows:

- Assets and liabilities for each statement of financial position presented are translated at the closing rate at the date of that statement of financial position;
- Income and expenses are translated at average exchange rates for the period (unless this average is not a reasonable approximation of the cumulative effect of the rates prevailing on the transaction dates, in which case income and expenses are translated at the exchange rates on the transaction dates); and
- All resulting exchange differences are recognised in other comprehensive income and accumulated in the foreign currency translation reserve.

On consolidation, exchange differences arising from the translation of monetary items that form part of the net investment in foreign entities are recognised in other comprehensive income and accumulated in the foreign currency translation reserve. When a foreign operation is sold, such exchange differences are reclassified to consolidated profit or loss as part of the gain or loss on disposal.

(c) Property, plant and equipment

Property, plant and equipment held for administrative purposes are stated in the consolidated statement of financial position at cost, less subsequent accumulated depreciation and subsequent accumulated impairment losses, if any.

Subsequent costs are included in the asset's carrying amount or recognised as a separate asset, as appropriate, only when it is probable that future economic benefits associated with the item will flow to the Group and the cost of the item can be measured reliably. All other repairs and maintenance are recognised in profit or loss during the period in which they are incurred.

Depreciation of property, plant and equipment is calculated at rates sufficient to write off their cost less their residual values over the estimated useful lives on a straight-line basis. The principal useful lives are as follows:

Furniture and office equipment	2-4 years
Leasehold improvements	Over the lease term

The residual values, useful lives and depreciation method are reviewed and adjusted, if appropriate, at the end of each reporting period.

The gain or loss on disposal of property, plant and equipment is the difference between the net sales proceeds and the carrying amount of the relevant asset, and is recognised in profit or loss.

(d) Leases

At inception of a contract, the Group assesses whether the contract is, or contains, a lease. A contract is, or contains, a lease if the contract conveys the right to control the use of an identified asset for a period of time in exchange for consideration. Control is conveyed where the customer has both the right to direct the use of the identified asset and to obtain substantially all of the economic benefits from that use.

The Group as a lessee

At the lease commencement date, the Group recognises a right-of-use asset and a lease liability, except for short-term leases that have a lease term of 12 months or less and leases of low-value assets. When the Group enters into a lease in respect of a low-value asset, the Group decides whether to capitalise the lease on a lease-by-lease basis. The lease payments associated with those leases which are not capitalised are recognised as an expense on a systematic basis over the lease term.

Where the lease is capitalised, the lease liability is initially recognised at the present value of the lease payments payable over the lease term, discounted using the interest rate implicit in the lease or, if that rate cannot be readily determined, using a relevant incremental borrowing rate. After initial recognition, the lease liability is measured at amortised cost and interest expense is calculated using the effective interest method. Variable lease payments that do not depend on an index or rate are not included in the measurement of the lease liability and hence are charged to profit or loss in the accounting period in which they are incurred.

The right-of-use asset recognised when a lease is capitalised is initially measured at cost, which comprises the initial amount of the lease liability plus any lease payments made at or before the commencement date, and any initial direct costs incurred. Where applicable, the cost of the right-of-use asset also includes an estimate of costs to dismantle and remove the underlying asset or to restore the underlying asset or the site on which it is located, discounted to their present value, less any lease incentives received. The right-of-use asset is subsequently stated at cost less accumulated depreciation and impairment losses.

Right-of-use assets in which the Group is reasonably certain to obtain ownership of the underlying leased assets at the end of the lease term are depreciated from commencement date to the end of the useful life. Otherwise, right-of-use assets are depreciated on a straight-line basis over the shorter of their estimated useful lives and the lease terms.

Refundable rental deposits paid are accounted under HKFRS 9 and initially measured at fair value. Adjustments to fair value at initial recognition are considered as additional lease payments and included in the cost of right-of-use assets.

The lease liability is remeasured when there is a change in future lease payments arising from the reassessment of whether the Group will be reasonably certain to exercise a purchase, extension or termination option. When the lease liability is remeasured in this way, a corresponding adjustment is made to the carrying amount of the right-of-use asset, or is recorded in profit or loss if the carrying amount of the right-of-use asset has been reduced to zero.

The lease liability is also remeasured when there is a change in the scope of a lease or the consideration for a lease that is not originally provided for in the lease contract ("lease modification") that is not accounted for as a separate lease. In this case the lease liability is remeasured based on the revised lease payments and lease term using a revised discount rate at the effective date of the modification. The only exceptions are any rent concessions which arose as a direct consequence of the COVID-19 pandemic and which satisfied the conditions set out in paragraph 46B of HKFRS 16. In such cases, the Group took advantage of the practical expedient set out in paragraph 46A of HKFRS 16 and recognised the change in consideration as if it were not a lease modification.

(e) Recognition and derecognition of financial instruments

Financial assets and financial liabilities are recognised in the consolidated statement of financial position when the Group becomes a party to the contractual provisions of the instrument.

Financial assets and financial liabilities are initially measured at fair value. Transaction costs that are directly attributable to the acquisition or issue of financial assets and financial liabilities (other than financial assets and financial liabilities at fair value through profit or loss (“FVTPL”)) are added to or deducted from the fair value of the financial assets or financial liabilities, as appropriate, on initial recognition. Transaction costs directly attributable to the acquisition of financial assets or financial liabilities at FVTPL are recognised immediately in profit or loss.

The Group derecognises a financial asset only when the contractual rights to the cash flows from the asset expire, or when it transfers the financial asset and substantially all the risks and rewards of ownership of the asset to another entity. If the Group neither transfers nor retains substantially all the risks and rewards of ownership and continues to control the transferred asset, the Group recognises its retained interest in the asset and an associated liability for amounts it may have to pay. If the Group retains substantially all the risks and rewards of ownership of a transferred financial asset, the Group continues to recognise the financial asset and also recognises a collateralised borrowing for the proceeds received.

財務資產及財務負債最初以公平值計算。首次確認時，因收購或發行財務資產及財務負債產生之直接交易成本(透過損益按公平值計算(「透過損益按公平值計算」)之財務資產及財務負債除外)將視乎情況增加或扣減財務資產或財務負債之公平值。收購透過損益按公平值計算之財務資產或財務負債直接產生之交易成本，即時在損益確認。

The Group derecognises financial liabilities when, and only when, the Group's obligations are discharged, cancelled or have expired. The difference between the carrying amount of the financial liability derecognised and the consideration paid and payable, including any non-cash assets transferred or liabilities assumed, is recognised in profit or loss.

(f) Financial assets

All regular way purchases or sales of financial assets are recognised and derecognised on a trade date basis. Regular way purchases or sales are purchases or sales of financial assets that require delivery of assets within the time frame established by regulation or convention in the marketplace. All recognised financial assets are measured subsequently in their entirety at either amortised cost or fair value, depending on the classification of the financial assets.

Debt investments

Debt investments held by the Group are classified into the amortised cost measurement category, if the investment is held for the collection of contractual cash flows which represent solely payments of principal and interest. Interest income from the investment is calculated using the effective interest method.

Equity investments

An investment in equity securities is classified as FVTPL unless the equity investment is not held for trading purposes and on initial recognition of the investment the Group makes an election to designate the investment at fair value through other comprehensive income (“FVTOCI”) (non-recycling) such that subsequent changes in fair value are recognised in other comprehensive income. Such elections are made on an instrument-by-instrument basis, but may only be made if the investment meets the definition of equity from the issuer’s perspective. Where such an election is made, the amount accumulated in other comprehensive income remains in the fair value reserve (non-recycling) until the investment is disposed of. At the time of disposal, the amount accumulated in the fair value reserve (non-recycling) is transferred to accumulated losses. It is not recycled through profit or loss. Dividends from an investment in equity securities, irrespective of whether classified as at FVTPL or FVTOCI, are recognised in profit or loss as revenue.

(g) Other receivable

A receivable is recognised when the Group has an unconditional right to receive consideration. A right to receive consideration is unconditional if only the passage of time is required before payment of that consideration is due.

Receivables are stated at amortised cost using the effective interest method less allowance for credit losses.

(h) Cash and cash equivalents

Cash and cash equivalents comprise cash at bank and on hand, demand deposits with banks and other financial institutions, and short-term, highly liquid investments that are readily convertible into known amounts of cash and which are subject to an insignificant risk of changes in value, having been within three months of maturity at acquisition. Bank overdrafts that are repayable on demand and form an integral part of the Group's cash management are also included as a component of cash and cash equivalents for the purpose of the consolidated statement of cash flows. Cash and cash equivalents are assessed for expected credit losses ("ECL").

(i) Financial liabilities and equity instruments

Financial liabilities and equity instruments are classified according to the substance of the contractual arrangements entered into and the definitions of a financial liability and an equity instrument under HKFRSs. An equity instrument is any contract that evidences a residual interest in the assets of the Group after deducting all of its liabilities. The accounting policies adopted for specific financial liabilities and equity instruments are set out below.

(j) Borrowings

Borrowings are recognised initially at fair value, net of transaction costs incurred, and subsequently measured at amortised cost using the effective interest method.

Borrowings are classified as current liabilities unless the Group has an unconditional right to defer settlement of the liability for at least 12 months after the reporting period.

財務負債及權益性工具按所訂立合約安排的內容及香港財務報告準則中財務負債及權益性工具的定義分類。權益性工具指能證明擁有本集團在減除所有負債後的資產中的剩餘權益的合約。就特定財務負債及權益性工具所採納的會計政策列載如下。

(j) 借貸

借貸初步按公平值扣除所產生的交易成本確認，而其後則採用實際利率法按已攤銷成本計量。

除非本集團有無條件權利延遲償還負債直至報告期後最少十二個月，否則借貸應分類為流動負債。

(k) Other payables

Other payables are recognised initially at their fair value and subsequently measured at amortised cost using the effective interest method unless the effect of discounting would be immaterial, in which case they are stated at cost.

(l) Equity instruments

An equity instrument is any contract that evidence a residual interest in the assets of an entity after deducting all of its liabilities. Equity instruments issued by the Company are recorded at the proceeds received, net of direct issue costs.

(m) Revenue and other income

Revenue is recognised when control over a product or service is transferred to the customer, at the amount of promised consideration to which the Group is expected to be entitled, excluding those amounts collected on behalf of third parties.

Interest income is recognised as it accrues using the effective interest method. For financial assets measured at amortised cost that are not credit-impaired, the effective interest rate is applied to the gross carrying amount of the asset. For credit impaired financial assets, the effective interest rate is applied to the amortised cost (i.e. gross carrying amount net of loss allowance) of the asset.

Dividend income is recognised when the shareholders' rights to receive payment are established.

其他應付款項初步按公平值確認，其後採用實際利率法按攤銷成本計量，除非貼現影響甚微，在此情況下，則按成本列賬。

(l) 權益性工具

權益性工具為任何可作為一項實體之資產經扣除所有負債後有留存權益之實證的合約。本公司發行之權益性工具按已收所得款項扣除直接發行成本列賬。

(m) 收入及其他收入

收入於客戶獲得個別產品或服務的控制權時按本集團預期有權收取之承付代價金額(不包括代表第三方收取之金額)確認。

利息收入以實際利息法隨累計確認。就並未出現信貸減值之按攤銷成本計算之財務資產而言，對有關資產採用實際利率。就出現信貸減值之財務資產而言，對有關資產之攤銷成本(即賬面總值扣除虧損撥備)採用實際利率。

股息收入於股東收取付款之權利確立時予以確認。

(n) Employee benefits

(i) Employee leave entitlements

Employee entitlements to annual leave and long service leave are recognised when they accrue to employees. A provision is made for the estimated liability for annual leave and long service leave as a result of services rendered by employees up to the end of the reporting period.

Employee entitlements to sick leave and maternity leave are not recognised until the time of leave.

(ii) Pension obligations

The Group operates a mandatory provident fund scheme (the “MPF Scheme”) under the Hong Kong Mandatory Provident Fund Schemes Ordinance for all qualifying employees in Hong Kong. The Group’s contributions to the MPF Scheme are calculated at 5% of the salaries and wages subject to a monthly maximum amount of HK\$1,500 per employee and vest fully with employees when contributed into the MPF Scheme.

(iii) Termination benefits

Termination benefits are recognised at the earlier of the dates when the Group can no longer withdraw the offer of those benefits, and when the Group recognises restructuring costs and involves the payment of termination benefits.

(n) 僱員福利

(i) 僱員應享假期

僱員應享年假及長期服務假期隨員工累積假期予以確認。本集團已因僱員提供服務至報告期末的年假及長期服務假期而產生的估計負債作出撥備。

僱員應享病假及產假於僱員放假時方會確認。

根據香港強制性公積金計劃條例，本集團會為所有香港合資格僱員參與強制性公積金計劃（「強積金計劃」）。本集團於強積金計劃供款為薪金及工資的5%，每名僱員的每月最高供款金額為1,500港元，並於注資予強積金計劃時全數歸屬予僱員。

(iii) 終止服務福利

終止服務福利會於本集團無法撤回福利提供及本集團確認重組成本並涉及支付終止服務福利的較早日期予以確認。

(o) Borrowing costs

Borrowing costs directly attributable to the acquisition, construction or production of qualifying assets, which are assets that necessarily take a substantial period of time to get ready for their intended use or sale, are capitalised as part of the cost of those assets, until such time as the assets are substantially ready for their intended use or sale. Investment income earned on the temporary investment of specific borrowings pending their expenditure on qualifying assets is deducted from the borrowing costs eligible for capitalisation.

To the extent that funds are borrowed generally and used for the purpose of obtaining a qualifying asset, the amount of borrowing costs eligible for capitalisation is determined by applying a capitalisation rate to the expenditures on that asset. The capitalisation rate is the weighted average of the borrowing costs applicable to the borrowings of the Group that are outstanding during the period, other than borrowings made specifically for the purpose of obtaining a qualifying assets. Any specific borrowing that remain outstanding after the related asset is ready for its intended use or sale is included in the general borrowing pool for calculation of capitalisation rate on general borrowings.

All other borrowing costs are recognised in profit or loss in the period in which they are incurred.

收購、興建或生產合資格資產(即需較長時間方可用作預定用途或出售的資產)直接應佔的借貸成本撥充資本為該等資產成本的一部份，直至該等資產大致可作預定用途或出售為止。特定借貸在應用於合資格資產之前所作臨時投資賺取的投資收入，於合資格撥充資本的借貸成本中扣除。

倘資金大致為取得合資格資產借入並作此用途，則會對該資產的支出應用資本化率，以釐定合資格資本化的借貸成本金額。資本化率乃適用於期內未償還本集團借貸(特別為取得合資格資產作出的借貸除外)的加權平均借貸成本。在相關資產達成擬定用途或出售後仍未償還的任何特定借款，均計入一般借款池，以計算一般借款的資本化率。

(p) Government grants

A government grant is recognised when there is reasonable assurance that the Group will comply with the conditions attaching to it and that the grant will be received.

Government grants relating to income are deferred and recognised in profit or loss over the period to match them with the costs they are intended to compensate.

Government grants that become receivable as compensation for expenses or losses already incurred or for the purpose of giving immediate financial support to the Group with no future related costs are recognised in profit or loss in the period in which they become receivable.

(q) Taxation

Income tax represents the sum of the current tax and deferred tax.

The tax currently payable is based on taxable profit for the year. Taxable profit differs from profit recognised in profit or loss because of items of income or expense that are taxable or deductible in other years and items that are never taxable or deductible. The Group's liability for current tax is calculated using tax rates that have been enacted or substantively enacted by the end of the reporting period.

當有合理保證本集團將遵守政府補助的附帶條件及將獲得補助時，即確認政府補助。

與收入相關的政府補助會予以遞延，並將於配合擬補助的成本的期間內於損益內確認。

因已產生的開支或虧損或向本集團提供即時財務資助成為應收補償且並無日後相關成本的政府補助，乃於其成為應收款項的期間於損益確認。

(q) 稅項

所得稅為當期稅項與遞延稅項的總和。

當期應付稅項乃按年度應課稅溢利計算。由於其他年度的應課稅或可扣減收入或開支項目以及永遠毋須課稅或不可扣減的項目，應課稅溢利與損益中所確認的溢利不同。本集團的當期稅項負債，應按報告期末前已執行或實質上已執行的稅率計算。

Deferred tax is recognised on differences between the carrying amounts of assets and liabilities in the consolidated financial statements and the corresponding tax bases used in the computation of taxable profit. Deferred tax liabilities are generally recognised for all taxable temporary differences and deferred tax assets are recognised to the extent that it is probable that taxable profits will be available against which deductible temporary differences, unused tax losses or unused tax credits can be utilised. Such assets and liabilities are not recognised if the temporary difference arises from the initial recognition of assets and liabilities in a transaction that affects neither the taxable profit nor the accounting profit.

Deferred tax liabilities are recognised for taxable temporary differences arising on investments in subsidiaries, except where the Group is able to control the reversal of the temporary difference and it is probable that the temporary difference will not reverse in the foreseeable future.

The carrying amount of deferred tax assets is reviewed at the end of each reporting period and reduced to the extent that it is no longer probable that sufficient taxable profits will be available to allow all or part of the asset to be recovered.

Deferred tax is calculated at the tax rates that are expected to apply in the period when the liability is settled or the asset is realised, based on tax rates that have been enacted or substantively enacted by the end of the reporting period. Deferred tax is recognised in profit or loss, except when it relates to items recognised in other comprehensive income or directly in equity, in which case the deferred tax is also recognised in other comprehensive income or directly in equity.

The measurement of deferred tax assets and liabilities reflects the tax consequences that would follow from the manner in which the Group expects, at the end of the reporting period, to recover or settle the carrying amount of its assets and liabilities.

For the purposes of measuring deferred tax for leasing transactions in which the Group recognises the right-of-use assets and the related lease liabilities, the Group first determines whether the tax deductions are attributable to the right-of-use assets or the lease liabilities.

For leasing transactions in which the tax deductions are attributable to the lease liabilities, the Group applies HKAS 12 requirements to right-of-use assets and lease liabilities separately. Temporary differences relating to right-of-use assets and lease liabilities are not recognised at initial recognition and over the lease terms due to application of the initial recognition exemption.

Deferred tax assets and liabilities are offset when there is a legally enforceable right to set off current tax assets against current tax liabilities and when they relate to income taxes levied by the same taxation authority and the Group intends to settle its current tax assets and liabilities on a net basis.

(r) Impairment of non-financial assets

The carrying amounts of non-financial assets are reviewed at each reporting date for indications of impairment and where an asset is impaired, it is written down as an expense through the consolidated statement of profit or loss and other comprehensive income to its estimated recoverable amount. The recoverable amount is determined for an individual asset, unless the asset does not generate cash inflows that are largely independent of those from other assets or groups of assets. If this is the case, recoverable amount is determined for the cash-generating unit to which the asset belongs. Recoverable amount is the higher of value in use and the fair value less costs of disposal of the individual asset or the cash-generating unit.

Value in use is the present value of the estimated future cash flows of the asset/cash-generating unit. Present values are computed using pre-tax discount rates that reflect the time value of money and the risks specific to the asset/cash-generating unit whose impairment is being measured.

Impairment losses for cash-generating units are allocated pro rata amongst the assets of the cash-generating unit. Subsequent increases in the recoverable amount caused by changes in estimates are credited to profit or loss to the extent that they reverse the impairment.

The Group recognises a loss allowance for ECL on other receivable. The amount of ECL is updated at each reporting date to reflect changes in credit risk since initial recognition of other receivable.

The Group recognises lifetime ECL for the financial instruments when there has been a significant increase in credit risk since initial recognition. However, if the credit risk on the financial instrument has not increased significantly since initial recognition, the Group measures the loss allowance for that financial instrument at an amount equal to 12-month ECL.

Lifetime ECL represents the ECL that will result from all possible default events over the expected life of a financial instrument. In contrast, 12-month ECL represents the portion of lifetime ECL that is expected to result from default events on a financial instrument that are possible within 12 months after the reporting date.

Significant increase in credit risk

In assessing whether the credit risk on a financial instrument has increased significantly since initial recognition, the Group compares the risk of a default occurring on the financial instrument at the reporting date with the risk of a default occurring on the financial instrument at the date of initial recognition. In making this assessment, the Group considers both quantitative and qualitative information that is reasonable and supportable, including historical experience and forward-looking information that is available without undue cost or effort. Forward-looking information considered includes the future prospects of the industries in which the Group's debtors operate, obtained from economic expert reports, financial analysts, governmental bodies, relevant think-tanks and other similar organisations, as well as consideration of various external sources of actual and forecast economic information that relate to the Group's core operations.

In particular, the following information is taken into account when assessing whether credit risk has increased significantly since initial recognition:

- an actual or expected significant deterioration in the financial instrument's external (if available) or internal credit rating;
- significant deterioration in external market indicators of credit risk for a particular financial instrument;

Irrespective of the outcome of the above assessment, the Group presumes that the credit risk on a financial asset has increased significantly since initial recognition when contractual payments are more than 30 days past due, unless the Group has reasonable and supportable information that demonstrates otherwise.

Despite the foregoing, the Group assumes that the credit risk on a financial instrument has not increased significantly since initial recognition if the financial instrument is determined to have low credit risk at the reporting date. A financial instrument is determined to have low credit risk if:

- (i) the financial instrument has a low risk of default;
- (ii) the debtor has a strong capacity to meet its contractual cash flow obligations in the near term; and
- (iii) adverse changes in economic and business conditions in the longer term may, but will not necessarily, reduce the ability of the borrower to fulfil its contractual cash flow obligations.

The Group considers a financial asset to have low credit risk when the asset has external credit rating of “investment grade” in accordance with the globally understood definition or if an external rating is not available, the asset has an internal rating of “performing”. Performing means that the counterparty has a strong financial position and there are no past due amounts.

The Group regularly monitors the effectiveness of the criteria used to identify whether there has been a significant increase in credit risk and revises them as appropriate to ensure that the criteria are capable of identifying significant increase in credit risk before the amount becomes past due.

儘管如此，本集團假設倘若債務工具於報告日期確定為信貸風險低，自首次確認後債務工具的信貸風險則尚未大幅增加。倘若：

Definition of default

The Group considers the following as constituting an event of default for internal credit risk management purposes as historical experience indicates that receivables that meet either of the following criteria are generally not recoverable:

- when there is a breach of financial covenants by the counterparty; or
- information developed internally or obtained from external sources indicates that the debtor is unlikely to pay its creditors, including the Group, in full (without taking into account any collaterals held by the Group).

Irrespective of the above analysis, the Group considers that default has occurred when a financial asset is more than 90 days past due unless the Group has reasonable and supportable information to demonstrate that a more lagging default criterion is more appropriate.

Credit-impaired financial assets

A financial asset is credit-impaired when one or more events that have a detrimental impact on the estimated future cash flows of that financial asset have occurred. Evidence that a financial asset is credit-impaired includes observable data about the following events:

- significant financial difficulty of the issuer or the counterparty;
- a breach of contract, such as a default or past due event;
- the lender(s) of the counterparty, for economic or contractual reasons relating to the counterparty's financial difficulty, having granted to the counterparty a concession(s) that the lender(s) would not otherwise consider;
- it is becoming probable that the counterparty will enter bankruptcy or other financial reorganisation; or
- The disappearance of an active market for that financial asset because of financial difficulties.

Write-off policy

The Group writes off a financial asset when there is information indicating that the debtor is in severe financial difficulty and there is no realistic prospect of recovery, including when the debtor has been placed under liquidation or has entered into bankruptcy proceedings, or in the case of other receivable, when the amounts are over two years past due, whichever occurs sooner. Financial assets written off may still be subject to enforcement activities under the Group's recovery procedures, taking into account legal advice where appropriate. Any recoveries made are recognised in profit or loss.

Measurement and recognition of ECL

The measurement of ECL is a function of the probability of default, loss given default (i.e. the magnitude of the loss if there is a default) and the exposure at default. The assessment of the probability of default and loss given default is based on historical data adjusted by forward-looking information as described above. As for the exposure at default, for financial assets, this is represented by the assets' gross carrying amount at the reporting date.

The ECL for financial assets is estimated as the difference between all contractual cash flows that are due to the Group in accordance with the contract and all the cash flows that the Group expects to receive, discounted at the original effective interest rate.

預期信貸虧損的計量為違約概率、違約損失率程度(即倘發生違約時的損失程度)及違約風險敞口的函數。違約概率及違約損失率程度之評估乃按過往數據為依據, 並按前瞻性資料作出調整。至於所面臨違約風險金額, 就財務資產而言, 乃為有關資產於報告日期之賬面總值。

If the Group has measured the loss allowance for a financial instrument at an amount equal to lifetime ECL in the previous reporting period, but determines at the current reporting date that the conditions for lifetime ECL are no longer met, the Group measures the loss allowance at an amount equal to 12-month ECL at the current reporting date, except for assets for which simplified approach was used.

The Group recognises an impairment gain or loss in profit or loss for all financial instruments with a corresponding adjustment to their carrying amount through a loss allowance account and does not reduce the carrying amount of the financial asset in the consolidated statement of financial position.

(t) Provisions and contingent liabilities

Provisions are recognised for liabilities of uncertain timing or amount when the Group has a present legal or constructive obligation arising as a result of a past event, it is probable that an outflow of economic benefits will be required to settle the obligation and a reliable estimate can be made. Where the time value of money is material, provisions are stated at the present value of the expenditures expected to settle the obligation.

(a) Impairment of property, plant and equipment and right-of-use assets

Property, plant and equipment and right-of-use assets are stated at costs less accumulated depreciation and impairment, if any. In determining whether an asset is impaired, the Group has to exercise judgement and make estimation, particularly in assessing: (i) whether an event has occurred or any indicators that may affect the asset value; (ii) whether the carrying value of an asset can be supported by the recoverable amount, in the case of value in use, the net present value of future cash flows which are estimated based upon the continued use of the asset; and (iii) the appropriate key assumptions to be applied in estimating the recoverable amounts including cash flow projections and an appropriate discount rate. When it is not possible to estimate the recoverable amount of an individual asset (including right-of-use assets), the Group estimates the recoverable amount of the cash-generating unit to which the assets belong. Changing the assumptions and estimates, including the discount rates or the growth rate in the cash flow projections, could materially affect the recoverable amounts.

The carrying amounts of property, plant and equipment and right-of-use assets as at 31 December 2020 were HK\$3,000 (2019: HK\$4,198,000) and HK\$339,000 (2019: HK\$714,000) respectively.

(b) Impairment of other receivable

The management of the Group estimates the amount of impairment loss for ECL on other receivable based on the credit risk of other receivable. The amount of the impairment loss based on ECL model is measured as the difference between all contractual cash flows that are due to the Group in accordance with the contract and all the cash flows that the Group expects to receive, discounted at the effective interest rate determined at initial recognition. Where the future cash flows are less than expected, or being revised downward due to changes in facts and circumstances, a material impairment loss may arise.

As at 31 December 2020, the carrying amount of other receivable is HK\$13,000,000 (2019: HK\$Nil).

6. FINANCIAL RISK MANAGEMENT

The Group's activities expose it to a variety of financial risks: price risk, credit risk, liquidity risk and interest rate risk. The Group's overall risk management programme focuses on the unpredictability of financial markets and seeks to minimise potential adverse effects on the Group's financial performance.

(a) Price risk

The Group is exposed to equity price risk mainly through its investment in equity securities. The management manages this exposure by maintaining a portfolio of investments with different risk and return profiles. The Group's equity price risk is mainly concentrated on equity securities quoted on the Stock Exchange.

If equity prices had been 10% (2019: 10%) higher/lower, loss after tax for the year ended 31 December 2020 would decrease/increase by approximately HK\$7,451,000 (2019: HK\$6,887,000). This is mainly due to the changes in fair value of held-for-trading investments.

(b) Credit risk

Credit risk is the risk that a counterparty will not meet its obligations under a financial instrument or customer contract, leading to a financial loss. The Group is exposed to credit risk from its operating activities and from its financing activities, including equity instruments and deposits with banks and financial institutions, foreign exchange transactions and other financial instruments. The Group's exposure to credit risk arising from cash and cash equivalents is limited because the counterparties are banks and financial institutions with high credit-rating assigned by international credit-rating agencies, for which the Group considers to have low credit risk.

All of the Group's financial assets at amortised cost are considered to have low credit risk, and the loss allowance, if any, recognised during the period was therefore limited to 12-month expected losses. Financial instruments are considered to be low credit risk when they have a low risk of default and the issuer has a strong capacity to meet its contractual cash flow obligations in the near term. Financial assets at amortised cost include deposits and other receivable.

Pursuant to a sale and purchase agreement dated 5 November 2019 entered into between CFL Investments and an independent third party (the “Yacht Buyer”), CFL Investments disposed of the yacht at a consideration of approximately HK\$5,100,000. The transfer of yacht would only be completed when the consideration was fully settled. As at 31 December 2019, only half of the consideration was received from the Yacht Buyer and the settlement date of the remaining balance was extended to 31 January 2020 by supplemental agreements.
