## **VOLUNTARY ANNOUNCEMENT**

Reference is made to (i) the announcements issued by The Sincere Company, Limited ("**Sincere**") dated 29 October 2020 and 4 February 2021 respectively in relation to, among others, the Deed (the "**Deed Announcements**"); (ii) the offer document issued by Realord Group Holdings Limited ("**Realord**") dated 5 May 2021 in relation to the Offer (the "**Offer Document**"); (iii) the announcement issued by Realord on 6 May 2021 in relation to, among others, an update in relation to the Deed; and (iv) the announcement issued by Realord on 7 May 2021 in relation to the Offer becoming unconditional in all respects.

Unless otherwise defined, capitalised terms used in this announcement shall have the same meanings as those defined in the Deed Announcements and the Offer Document.

### UPDATE IN RELATION TO THE DEED

As mentioned in the Offer Document, Realord will use its best endeavours to support the new Sincere Board after the change of control to protect and safeguard the assets and interests of Sincere against the purported cancellation of the Deed by Win Dynamic.

#### Writ of summons

On 10 May 2021, Realord issued a writ of summons with an indorsement of claim in the High Court of Hong Kong against Win Dynamic in relation to the purported cancellation of the Deed. The net proceeds in respect of the SinCo Shares tendered by Win Dynamic for acceptance of the Offer, after deducting the seller's ad valorem stamp duty payable by it, shall amount to HK\$260,435,373 (the "**WD Proceeds**"). Realord claims against Win Dynamic, among others, for an order of specific performance requiring Win Dynamic to forthwith pay Sincere the WD Proceeds, or such other sum as the court may determine.

#### **Injunction order**

On 11 May 2021, Realord further applied to the High Court of Hong Kong for an interlocutory injunction against Win Dynamic that it must not, among others,

- (a) remove from Hong Kong any of its assets which are within Hong Kong, whether in its own name or not, and whether solely or jointly owned, up to the value of the WD Proceeds, or
- (b) in any way dispose of or deal with or diminish the value of any of its assets, which are within Hong Kong, whether in its own name or not, and whether solely or jointly owned, and whether or not Win Dynamic asserts a beneficial interest in them up to the value of the WD Proceeds.

The hearing of the above application is scheduled to be held on 14 May 2021. Further announcement will be made by Realord on the outcome of the hearing. Realord will keep the Realord Shareholders and the public informed of any material development in connection with the above actions as and when appropriate.
