**Letter to New Registered Shareholders**  
**— Election of Language and Means of Receipt of Corporate Communications**

Pursuant to the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited and/or the Bye-laws of Johnson Electric Holdings Limited (“Company”), the Company will make available the following options for you to elect for receipt of future corporate communications of the Company (“Corporate Communications”), which means any document(s) issued or to be issued by the Company for the information or action of any holders of its securities, including but not limited to (a) the directors’ report, its annual accounts together with a copy of the auditor’s report and, where applicable, its summary financial report; (b) the interim report and, where applicable, summary interim report; (c) a notice of meeting; (d) a listing document; (e) a circular; and (f) a proxy form, in the following manner:

- (1) to access all future Corporate Communications through the Company’s website at [www.johnsonelectric.com](http://www.johnsonelectric.com) instead of receiving printed copies and to receive a notification letter of the publication of the Corporate Communications on the Company’s website (“Website Version”); or
- (2) to receive printed English version of all future Corporate Communications only; or
- (3) to receive printed Chinese version of all future Corporate Communications only; or
- (4) to receive both printed English and Chinese versions of all future Corporate Communications.

In support of environmental protection and for the purpose of saving printing and mailing costs, the Company recommends you to elect the Website Version. You may at any time by giving not less than 7 days’ notice in writing to the Hong Kong Share Registrar or by email at [johnsonelectric.ecom@computershare.com.hk](mailto:johnsonelectric.ecom@computershare.com.hk) change the choice of language and means of receipt of the Corporate Communications. Even if you have elected (or are deemed to have elected) the Website Version but for any reason have difficulty in gaining access to the Website Version, the Company will promptly upon receiving your request send the Corporate Communications in printed form to you free of charge.
