### **POLL RESULTS OF THE ANNUAL GENERAL MEETING HELD ON 31 MAY 2021**

The board (the “**Board**”) of directors (the “**Directors**”) of Boer Power Holdings Limited (the “**Company**”) hereby announces that all resolutions set out in the notice of the annual general meeting (the “**AGM**”) dated 21 April 2021 (the “**Notice**”) were duly passed by way of poll at the AGM held on 31 May 2021.

The AGM was held at Room 1, Level 8, The Wave, 4 Hing Yip Street, Kwun Tong, Kowloon, Hong Kong on Monday, 31 May 2021 at 10:30 a.m.

As at the date of the AGM, the issued share capital of the Company was HK\$77,376,900 divided into 773,769,000 shares of HK\$0.1 each (the “**Shares**”), which was the total number of Shares entitling the holders to attend and vote for or against any of the proposed resolutions at the AGM. There was no restriction on any shareholders to attend and vote only against any of the proposed resolutions at the AGM.

Computershare Hong Kong Investor Services Limited, the Company’s branch share registrar in Hong Kong, was appointed and acted as the scrutineer for the vote-taking at the AGM.

All the proposed resolutions as set out in the Notice were duly passed by the shareholders of the Company by way of poll. The poll results in respect of the resolutions were as follows:
