# IV. Confirmations

We hereby confirm to the best knowledge, information and belief that, in relation to each of the securities issued by the issuer during the month as set out in Part III which has not been previously disclosed in a return published under rule 13.25A, it has been duly authorized by the board of directors of the listed issuer and, insofar as applicable:

#### (Note 2)

- (i) all money due to the listed issuer in respect of the issue of securities has been received by it;
- (ii) all pre-conditions for listing imposed by the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited under "Qualifications of listing" have been fulfilled;
- (iii) all (if any) conditions contained in the formal letter granting listing of and permission to deal in the securities have been fulfilled;
- (iv) all the securities of each class are in all respects identical (Note 3);

- (v) all documents required by the Companies (Winding Up and Miscellaneous Provisions) Ordinance to be filed with the Registrar of Companies have been duly filed and that compliance has been made with other legal requirements;
- (vi) all the definitive documents of title have been delivered/are ready to be delivered/are being prepared and will be delivered in accordance with the terms of issue:
- (vii) completion has taken place of the purchase by the issuer of all property shown in the listing document to have been purchased or agreed to be purchased by it and the purchase consideration for all such property has been duly satisfied; and
- (viii) the trust deed/deed poll relating to the debenture, loan stock, notes or bonds has been completed and executed, and particulars thereof, if so required by law, have been filed with the Registrar of Companies.

### Remarks (if any):

Pursuant to the share option scheme adopted by the shareholders of the Company on 5 June 2019, the Company granted 4,000,000 share options to subscribe for an aggregate of 4,000,000 new shares of HK\$0.01 each in the capital of the Company (each a "Share") on 20 September 2019, which shall be vested on 20 September 2022 conditional upon fulfilment of certain performance targets. The Company further granted 4,000,000 share options to subscribe for an aggregate of 4,000,000 new Shares on 8 April 2020, which shall be vested on 8 April 2023 conditional upon fulfilment of certain performance targets. On 9 April 2021, the board of the directors of the Company proposed to amend the vesting date of certain share options previously granted on 8 April 2020 ("Previously Granted Share Options"). It is proposed that 50% of the Previously Granted Share Options and 50% of the Previously Granted Share Options shall be vested on 7 April 2022 and 7 April 2023, respectively, which shall be subject to the Company's shareholders' approval at the forthcoming annual general meeting of the Company. On 9 April 2021, the Company further granted 4,000,000 share options to subscribe for an aggregate of 4,000,000 new Shares. among which 2,000,000 shares options shall be vested on 8 April 2022 with 75% of such conditional upon fulfilment of certain performance targets and 2,000,000 share options shall be vested on 8 April 2023 with 75% of such conditional upon fulfilment of certain performance targets. As of 31 May 2021, there were 9,571,000 outstanding share options, as a total of 313,000 share options were not accepted by the eligible employees and a total of 2,116,000 shares options lapsed as of 31 May 2021 (among which 196,000 share options lapsed in May 2021).
