The Company is endeavouring to identify suitable candidates to fill up the vacancy of independent non-executive director as soon as practicable as required under Rule 3.11 of the Listing Rules. The suitable candidates identified by the Company will also fill the vacancies in the audit committee, remuneration committee and nomination committee. Further announcement(s) will be made by the Company in this regard as and when appropriate.
