## ANNOUNCEMENT POWER GENERATION FOR MAY 2021

The announcement is made by China Datang Corporation Renewable Power Co., Limited\* (the "**Company**") pursuant to Rule 13.09(2) of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited and Inside Information Provisions under Part XIVA of the Securities and Futures Ordinance (Cap. 571 of the Laws of Hong Kong).

The board of directors (the "Board") of the Company announces that, according to the Company's preliminary statistics, the power generation of the Company and its subsidiaries (the "Group") for May 2021 on consolidated basis amounted to 2,556,706 MWh, representing an increase of 28.23% compared with that of the corresponding period of 2020, of which, the wind power generation amounted to 2,441,260 MWh, representing an increase of 24.60% compared with that of the corresponding period of 2020; the photovoltaic power generation amounted to 113,666 MWh, representing an increase of 254.27% compared with that of the corresponding period of 2020; and the gas power generation amounted to 1,780 MWh, representing a decrease of 30.20% compared with that of the corresponding period of 2020. As of 31 May 2021, the total power generation of the Group for 2021 amounted to 12,584,777 MWh, representing an increase of 34.31% compared with that of the corresponding period of 2020, of which, the wind power generation amounted to 12,201,322 MWh, representing an increase of 32.21% compared with that of the corresponding period of 2020; the photovoltaic power generation amounted to 375,928 MWh, representing an increase of 189.14% compared with that of the corresponding period of 2020; and the gas power generation amounted to 7,527 MWh, representing a decrease of 32.19% compared with that of the corresponding period of 2020.
