Reference is made to the announcement of China Pipe Group Limited (formerly known as Softpower International Limited) (the “**Company**”) dated 19 February 2021 and the circular of the Company dated 4 March 2021 (the “**Circular**”) in relation to, among other things, the Change of Company Name. Capitalised terms used in this announcement shall have the same meanings as defined in the Circular unless the context herein requires otherwise.

## **CHANGE OF COMPANY NAME**

The Board is pleased to announce that the English name of the Company has been changed from “Softpower International Limited” to “China Pipe Group Limited” and the secondary name of the Company has been changed from “冠力國際有限公司” to “中國管業集團有限公司”.

Subsequent to the passing of a special resolution in relation to the Change of Company Name by the Shareholders at the SGM held on 29 March 2021, the Certificate of Incorporation on Change of Name and the Certificate of Secondary Name have been issued by the Registrar of Companies in Bermuda certifying the change of the English name and secondary name in Chinese of the Company to “China Pipe Group Limited” and “中國管業集團有限公司” respectively, both with effect from 13 April 2021.

The Registrar of Companies in Hong Kong have also issued the Certificate of Registration of Alteration of Name of Registered Non-Hong Kong Company on 8 June 2021 certifying the new names of the Company have been registered in Hong Kong under Part 16 of the Companies Ordinance (Chapter 622 of the Laws of Hong Kong).

## **CHANGE OF STOCK SHORT NAME**
