### **POSITIVE PROFIT ALERT**

This announcement is made by China Industrial Securities International Financial Group Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) pursuant to Rule 13.09 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”) and the Inside Information Provisions (as defined in the Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

The board of directors of the Company (the “**Board**”) wishes to inform the shareholders of the Company (the “**Shareholders**”) and potential investors that, based on the preliminary assessment of the unaudited consolidated management accounts of the Group for the six months ended 30 June 2021 (the “**Relevant Period**”), the Group is expected to record a net profit of not less than HK\$50 million for the Relevant Period as compared to the net loss of approximately HK\$286 million for the corresponding period in 2020. The Board considers that the aforesaid turnaround from loss to profit is mainly attributable to (i) the revenue of the proprietary business has improved; (ii) increase in revenue from the brokerage services and (iii) reduce in provision of expected credit loss on accounts receivables arising from margin loan compared to corresponding period in 2020.

The information contained in this announcement is only based on the preliminary assessment of the information currently available to the Board, including the unaudited consolidated management accounts of the Group for the Relevant Period, which have not been audited or reviewed by the Company’s auditors and/or the audit committee of the Company, and are subject to adjustments and amendments. The interim results of the Group for the Relevant Period is expected to be published in August 2021. Shareholders and potential investors are advised to read carefully 2021 interim results announcement of the Company when published.
