# (1) GENERAL MANDATES TO ISSUE AND REPURCHASE SHARES (2) RE-ELECTION OF RETIRING DIRECTORS AND

## (3) NOTICE OF ANNUAL GENERAL MEETING

#### 1. INTRODUCTION

The purpose of this circular is to provide you with information with respect to the resolutions to be proposed at the AGM to be held on Monday, 30 August 2021 relating to, among other things, (i) the granting of the Repurchase Mandate and the Issue Mandate to the Directors; (ii) the re-election of the retiring Directors; and (iii) give you the notice of the AGM.

#### 2. GENERAL MANDATES TO ISSUE AND REPURCHASE SHARES

At the last annual general meeting of the Company held on 26 August 2020, the resolutions were passed granting general mandates to the Directors to exercise all the powers of the Company to issue and repurchase Shares. Such general mandates will lapse at the conclusion of the AGM. Ordinary resolutions will be proposed at the AGM to approve the granting of new general mandates to the Directors as follows:

- (1) to allot, issue or deal with additional Shares of not exceeding 20% of the total number of issued Shares as at the date of the passing of the proposed resolution at the AGM;
- (2) to repurchase Shares of not exceeding 10% of the total number of issued Shares as at the date of the passing of the proposed resolution at the AGM; and
- (3) to extend the Issue Mandate by adding the aggregate number of Shares repurchased by the Company pursuant to the Repurchase Mandate.

The Issue Mandate and the Repurchase Mandate shall continue to be in force during the period from the date of the passing of the resolutions for the approval of the Issue Mandate and the Repurchase Mandate up to (i) the conclusion of the next annual general meeting of the Company; (ii) the expiration of the period within which the next annual general meeting of the Company is required to be held by the Bye-laws or any applicable laws of Bermuda; and (iii) the date upon which such authority is revoked or varied by an ordinary resolution of the Shareholders in a general meeting of the Company.

As at the Latest Practicable Date, the total number of issued Shares was 765,373,584 Shares. Subject to the passing of the ordinary resolution approving the Issue Mandate and on the basis that no further Shares are issued or repurchased before the AGM, the Company would be allowed under the Issue Mandate to issue up to a maximum of 153,074,716 new Shares representing approximately 20% of the total number of issued Shares as at the date of the passing of such ordinary resolution.

An explanatory statement relating to the Repurchase Mandate is set out in Appendix I to this circular. The explanatory statement contains all the requisite information required under the Listing Rules to be given to the Shareholders to enable them to make an informed decision on whether to vote for or against the resolution approving the Repurchase Mandate.

The Directors wish to state that they have no immediate plan to repurchase any Shares pursuant to the Repurchase Mandate and to issue any new Shares pursuant to the Issue Mandate.

#### 3. RE-ELECTION OF RETIRING DIRECTORS

In accordance with bye-law 87 of the Bye-laws, Mr. Wang Xiangfei ("Mr. Wang") and Mr. Chan Yiu Fai Youdey ("Mr. Chan") will retire by rotation at the AGM and will be eligible for re-election at the AGM. Each of Mr. Wang and Mr. Chan, being eligible, will offer himself for re-election as an executive Director and an independent non-executive Director respectively at the AGM.

The proposal of re-election took into account a wide range of diversity perspective, including but not limited to gender, age, cultural and educational background, professional experience, skills, knowledge and length of services, with due regard of the benefits of diversity as set out in the board diversity policy of the Company.

The nomination committee of the Company (the "Nomination Committee") has considered the extensive experience of Mr. Chan's legal background, his career profile and other experience and factors as set out in Appendix II to this circular. Having duly considered Mr. Chan's qualifications, skills, experience, age, culture, gender, past contributions, and all other relevant factors, the Nomination Committee is of the view that Mr. Chan continues to be a suitable candidate to serve in the Board.

As at the Latest Practicable Date, Mr. Chan has served as an independent non-executive Director for more than 9 years. Pursuant to the code provision A.4.3 of the Corporate Governance Code set out in Appendix 14 to the Listing Rules, (a) having served the Company for more than 9 years could be relevant to the determination of a non-executive director's independence and (b) if an independent non-executive director has served more than 9 years, his further appointment should be subject to a separate resolution to be approved by shareholders. The Company has received from Mr. Chan annual confirmation of independence pursuant to Rule 3.13 of the Listing Rules. During his appointment, Mr. Chan has not involved in the daily management of the Company nor in any relationships which interfere with his independent judgment, and he demonstrated his abilities to provide independent, balanced and objective view to the Company's affairs. The Nomination Committee is of the view that Mr. Chan meets the independence guidelines set out in Rule 3.13 of the Listing Rules and is regarded as independent in accordance with the terms of the guidelines. The Board considers that Mr. Chan to be independent under the Listing Rules despite the fact that he has served the Company for more than 9 years, therefore, with the recommendation from the Nomination Committee, recommends Mr. Chan for re-election at the AGM.

Details of the retiring Directors are set out in Appendix II to this circular.

#### 4. ANNUAL GENERAL MEETING AND PROXY ARRANGEMENT

The notice of the AGM is set out on pages 15 to 19 of this circular. At the AGM, ordinary resolutions will be proposed to approve, among other things, (i) the granting of the Repurchase Mandate and the Issue Mandate to the Directors; and (ii) the re-election of the retiring Directors.

According to bye-law 66 of the Bye-laws, at any general meeting, a resolution put to the vote shall be decided on a show of hands unless (before or on the declaration of the results of the show of hands or on the withdrawal of any other demand for a poll) a poll is demanded by, among others, the chairman of such meeting. Pursuant to Rule 13.39(4) of the Listing Rules, any vote of shareholders at a general meeting must be taken by poll except where the chairman decides to allow a resolution relating to a procedural or administrative matter to be voted on by a show of hands. In order to comply with the Listing Rules and bye-law 66 of the Bye-laws, all votes at the AGM will be taken by poll and the Company will announce the poll results after the AGM in the manner prescribed under Rule 13.39(5) of the Listing Rules.

A form of proxy for use at the AGM is enclosed with this circular and such form is also published on the website of the Stock Exchange at www.hkexnews.hk. Whether or not you are able to attend the AGM, you are requested to complete the accompanying form of proxy in accordance with the instruction printed thereon and return the same to the Company's Hong Kong branch share registrar and transfer office, Union Registrars Limited, at Suites 3301-04, 33/F., Two Chinachem Exchange Square, 338 King's Road, North Point, Hong Kong as soon as possible but in any event not less than 48 hours before the time appointed for the holding of the AGM or any adjournment thereof. #### 6. RESPONSIBILITY STATEMENT

This circular, for which the Directors collectively and individually accept full responsibility, includes particulars given in compliance with the Listing Rules for the purpose of giving information with regard to the Company. The Directors having made all reasonable enquiries, confirm that, to the best of their knowledge and belief: (i) the information contained in this circular is accurate and complete in all material respects and not misleading or deceptive; and (ii) there are no other matters the omission of which would make any statement herein or this circular misleading.

#### 7. RECOMMENDATION

The Directors consider that the proposed resolutions set out in the notice of AGM are in the best interests of the Company and its Shareholders as a whole. Accordingly, the Directors recommend the Shareholders to vote in favour of the relevant resolutions to be proposed at the AGM.

The following is an explanatory statement which contains all the information required pursuant to Rule 10.06(1)(b) of the Listing Rules to be given to all Shareholders relating to the resolution to be proposed at the AGM in relation to the granting of the Repurchase Mandate.

#### 1. SHARE CAPITAL

As at the Latest Practicable Date, the total number of issued Shares comprised 765,373,584 Shares.

Subject to the passing of the ordinary resolution to approve the granting of the Repurchase Mandate and on the basis that no further Shares are issued or repurchased by the Company prior to the AGM, the Directors will be allowed under the Repurchase Mandate to repurchase a maximum of 76,537,358 Shares, representing approximately 10% of the total number of issued Shares as at the date of the AGM.

#### 2. REASON FOR REPURCHASE

The Directors believe that the Repurchase Mandate is in the best interests of the Company and the Shareholders as a whole. Such repurchase may, depending on the market conditions and funding arrangements at the time, lead to an enhancement of the net asset value per Share and/or its earnings per Share and will only be made when the Directors believe that such repurchases will benefit the Company and the Shareholders as a whole.

#### 3. FUNDING OF REPURCHASES

In repurchasing Shares, the Company intends to apply funds from the Company's internal resources legally available for such purpose in accordance with the Bye-laws, the laws of Bermuda and the Listing Rules.

There might be material adverse impact on the working capital and gearing position of the Company (as compared with the position disclosed in the audited accounts contained in the annual report of the Company for the year ended 31 March 2021) in the event that the Repurchase Mandate was to be carried out in full at any time during the proposed repurchase period. However, the Directors do not propose to exercise the Repurchase Mandate to such an extent as would, in the circumstances, have a material adverse impact on the working capital or gearing position of the Company.

#### 4. UNDERTAKING OF THE DIRECTORS

The Directors have undertaken to the Stock Exchange to exercise the powers of the Company to repurchase Shares pursuant to the Repurchase Mandate in accordance with the Listing Rules, the Bye-laws and all applicable laws of Bermuda.

#### 5. EFFECT OF TAKEOVERS CODE

If as a result of a repurchase of Shares pursuant to the Repurchase Mandate, a Shareholder's proportionate interest in the voting rights of the Company increases, such increase will be treated as an acquisition of voting rights for the purposes of Rule 32 of the Takeovers Code. As a result, a Shareholder or a group of Shareholders acting in concert, depending on the level of increase in the interest of such Shareholder(s), could obtain or consolidate control of the Company and become obliged to make a mandatory offer in accordance with Rule 26 of the Takeovers Code.

As at the Latest Practicable Date, to the best knowledge of the Company, Ascent Goal Investments Limited which held approximately 74.42% of the total number of issued Shares was the only substantial Shareholder. In the event that the Directors should exercise in full the powers to repurchase Shares which is proposed to be granted pursuant to the resolution, the shareholding of Ascent Goal Investments Limited in the Company would be increased to approximately 82.69% of the total number of issued Shares and such increase would not give rise to an obligation to make a mandatory offer under Rule 26 of the Takeovers Code. Save as aforesaid, the Directors are not aware of any consequences which would arise under the Takeovers Code as a consequence of any repurchases pursuant to the Repurchase Mandate.

The Directors also will not make share repurchase on the Stock Exchange if such repurchase would result in the minimum public float requirements under Rule 8.08 of the Listing Rules not being complied with.

# 6. DIRECTORS, THEIR CLOSE ASSOCIATES AND CORE CONNECTED PERSONS

None of the Directors nor, to the best knowledge of the Directors having made all reasonable enquiries, any of their close associates (as defined in the Listing Rules) have any present intention, in the event that the relevant proposed resolution is approved by Shareholders in the AGM, to sell Shares to the Company.

No core connected person (as defined in the Listing Rules) of the Company has notified the Company that he/she/it has a present intention to sell Shares to the Company nor has he/she/it undertaken not to sell any of the Shares held by him/her/it to the Company in the event that the Company is authorised to make purchases of Shares.

## 7. SHARE REPURCHASES MADE BY THE COMPANY

The Company has not repurchased any Shares (whether on the Stock Exchange or otherwise) in the six months preceding the Latest Practicable Date.

# DETAILS OF RETIRING DIRECTORS PROPOSED TO BE RE-ELECTED

The details of the retiring Directors, who will retire and, being eligible, offer themselves for re-election at the AGM, are set out below:

Mr. Wang Xiangfei, aged 69, is an executive Director appointed on 25 March 2008. Mr. Wang is also a director of certain subsidiaries of the Company. Mr. Wang graduated from Renmin University of China with a bachelor degree in economics in 1982. Mr. Wang is now a senior accountant. Mr. Wang serves as the financial advisor of CSIH Limited. Mr. Wang is also an independent non-executive director of Tianjin Capital Environmental Protection Group Company Limited, a company whose shares are listed on the Stock Exchange (stock code: 1065) and the Shanghai Stock Exchange. Mr. Wang is a director of Ascent Goal Investments Limited, the controlling shareholder of the Company. Mr. Wang is the father of Mr. Wong Sze Wai, an executive Director, and the brother of Mr. Wang Xiaoyao, the alternate Director to Mr. Wang. In addition, Mr. Wang and Mr. Wong Sze Wai have cross-directorships in Ascent Goal Investments Limited, Alpha Apex Global Limited, Brilliant Kirin Limited, Starry Bridge Limited, Outstanding Pro Investments Limited, True Spirit Holdings Limited, Pallotta Limited, CIF Petrochemical Co., Limited, CIF Airport Company Limited and Golden Access International Limited.

In addition, Mr. Wang was an independent non-executive director of Chongqing Iron & Steel Company Limited, a company whose shares are listed on the Stock Exchange (stock code: 1053) and the Shanghai Stock Exchange, from July 2002 to June 2009 and China CITIC Bank Corporation Limited, a company whose shares are listed on the Stock Exchange (stock code: 998) and the Shanghai Stock Exchange, from December 2006 to November 2012. Mr. Wang was an independent non-executive director of Shandong Chenming Paper Holdings Limited from April 2010 to May 2013, a company whose shares are listed on the Stock Exchange (stock code: 1812), and the Shenzhen Stock Exchange. Mr. Wang was an independent non-executive director of SEEC Media Group Limited (stock code: 205), a company whose shares are listed on the Stock Exchange, from June 2003 to May 2015 and China Development Bank International Investment Limited (stock code: 1062), a company whose shares are listed on the Stock Exchange, from March 2012 to January 2021. Mr. Wang was also an external supervisor of Shenzhen Rural Commercial Bank from April 2009 to May 2015.

The service agreement of Mr. Wang was extended for one year commencing from 25 March 2021 and subsequent to a review of directors' duties and responsibilities in the Company as well as the market conditions, his monthly emolument has been changed to HK\$65,409 with effect from 1 April 2021. Mr. Wang is entitled to a monthly allowance of HK\$4,000 for acting as a director for each of 10 subsidiaries respectively, with effect from the date of appointment as director of each of the such subsidiaries. Pursuant to Mr. Wang's original service agreement signed in 2008, he may be entitled to an annual management bonus of a sum to be determined by the board of directors of the Company at its discretion and limited to 5% of the consolidated net profits after taxation and minority interests but before extraordinary items as shown in the Group's audited consolidated accounts for that financial year. Mr. Wang is subject to retirement by rotation and re-election at the annual general meeting of the Company in accordance with the bye-laws of the Company.

# DETAILS OF RETIRING DIRECTORS PROPOSED TO BE RE-ELECTED

As at the date hereof, Ms. Lo Fong Hung, the wife of Mr. Wang, owns 30% shareholding interests in New Bright International Development Limited, which currently holds 70% shareholding interests in CSIL Limited. CSIL Limited is the holding company of Ascent Goal Investments Limited, the controlling shareholder of the Company. Mr. Wang is deemed to be interested in the shares of the Company held by New Bright International Development Limited under the SFO.

Save as disclosed above, Mr. Wang does not have any other interests in the securities of the Company within the meaning of Part XV of the SFO.

Save as disclosed above, Mr. Wang does not (i) hold any other directorships in any public companies the securities of which are listed on any securities market in Hong Kong or overseas in the past 3 years; (ii) hold any other positions in the Company and its subsidiaries; (iii) have any other relationship with any directors, senior management, substantial shareholders or controlling shareholders of the Company; and (iv) have other major appointments or professional qualifications.

Save as disclosed above, there are no other matters that need to be brought to the attention of the Shareholders in connection with Mr. Wang's re-election and there is no other information that needs to be disclosed pursuant to any of the requirements of Rules 13.51(2)(h) to (v) of the Listing Rules.

Mr. Chan Yiu Fai Youdey, aged 51, is an independent non-executive Director appointed on 25 March 2008. Mr. Chan is a member of each of the audit committee, remuneration committee and nomination committee of the Company. Mr. Chan graduated from the University of Hong Kong with a bachelor degree in laws and a postgraduate certificate in laws. Mr. Chan also holds master degrees in laws from the City University of Hong Kong and from the People's University of China. Mr. Chan is currently a partner of Messrs. David Y.Y. Fung & Co., a law firm in Hong Kong. Mr. Chan has extensive experience in civil and commercial crime litigation and also handles various transactions for corporate clients and banks in Hong Kong. Mr. Chan is also an independent non-executive director of Qinqin Foodstuffs Group (Cayman) Company Limited (stock code: 1583), a company whose shares are listed on the Main Board of the Stock Exchange.

The service agreement of Mr. Chan was extended for one year commencing from 25 March 2021. Mr. Chan is entitled to a director's remuneration of HK\$336,000 per annum, which was determined with reference to his experience, duties and responsibilities and the prevailing market rate of companies of comparable size and similar operation. Mr. Chan is subject to retirement by rotation and re-election at the annual general meeting of the Company in accordance with the bye-laws of the Company.

As at the date hereof, Mr. Chan does not have any interests in the securities of the Company within the meaning of Part XV of the SFO.
