- To be valid, this form of proxy, together with the power of attorney or other authority (if any) under which it is signed (or a notarially certified copy of that power of attorney or authority), must be deposited at the Company's branch share registrar in Hong Kong, Tricor Investor Services Limited, at Level 54, Hopewell Centre, 183 Queen's Road East, Hong Kong, not later than 48 hours before the time appointed for the holding of the AGM (i.e. not later than Tuesday, 24 August 2021 at 10:00 a.m. (Hong Kong time)) (or any adjourned meeting thereof).
- Where there is joint holding of any Share(s), any joint holder may vote at the AGM, either personally or by proxy, in respect of such Share(s) as if he were solely entitled thereto; but if more than one of such joint holders be present at the AGM personally or by proxy, that one of the joint holders so present whose name stands first on the register of members of the Company in respect of such Share(s) will alone be entitled to vote in respect thereof.
- Any alteration made to this form of proxy should be initiated by the person who signs the form.
- Completion and deposit of this form of proxy will not preclude you from attending and voting at the AGM in person (or any adjourned meeting thereof) should you so wish.
- Shareholders or their proxies attending the meeting shall produce their identity documents.
- The Chinese translation of this form of proxy is for reference only and in case of any inconsistency, the English version shall prevail.
